To make your election, please complete the attached Request Form and sign and return it to the share registrar of the Company, Link Market Services (Hong Kong) Pty Limited (the “**Share Registrar**”) at Suite 1601, 16/F., Central Tower, 28 Queen’s Road Central, Hong Kong by post using the mailing label provided. You do not need to affix a stamp if it is posted in Hong Kong. Otherwise, please affix an appropriate stamp. If your email address provided is non-functional, until such time that a functional email address is received by the Share Registrar, you may (i) be unable to receive any notifications regarding the publication of Corporate Communications; and (ii) need to proactively check the Company’s website at www.cwtinternational.com and Hong Kong Exchanges and Clearing Limited’s website at www.hkexnews.hk (the “**HKEX’s website**”) to keep up with the publication of Corporate Communications.

If the Company does not receive a duly completed and signed Request Form from you by 30 June 2024 and until you inform the Share Registrar by reasonable prior notice in writing according to the relevant laws and regulations, you are taken to have agreed to access all future Corporate Communications posted on the Company’s website and to receive (i) only a notification of the publication of the Corporate Communications on the Company’s website by post, and (ii) all future Actionable Corporate Communications in printed form.

With respect to all future Corporate Communications, please note that you are entitled, at any time by sending a notice in writing to the Share Registrar or by email to LMSHK@linkmarketservices.com, to change your choice of means of receipt of Corporate Communications in accordance with the relevant laws and regulations. Your request for the printed form will remain valid until the instruction has been revoked, superseded, or expired, or for one year from the date of receiving your instruction (whichever is earlier).
