### **INTRODUCTION**

Reference is made to the prospectus of Flying Financial Service Holdings Limited dated 28 June 2024 in relation to the Rights Issue (the “**Prospectus**”). Terms defined in the Prospectus shall have the same meanings when used herein unless the context otherwise requires. In accordance with the terms set out in the Prospectus, the Directors have provisionally allotted to you a number of Rights Shares on the basis of three (3) Rights Shares for every one (1) Share held on the Record Date and registered in your name(s) as at the Record Date (i.e. Thursday, 27 June 2024) at a subscription price of HK\$0.25 per Rights Share.
