Delayed Settlement

The PFIS component of the PFIS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the PFIS1 deliverable until the cash in lieu of

fractional PFIS shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On March 22, 2024, Shareholders of FNCB Bancorp, Inc. (FNCB) voted concerning the proposed merger with Peoples Financial Services Corporation (PFIS). The merger was approved and subsequently consummated before the open on July 1, 2024. As a result, each existing FNCB Common Share will be converted into the right to receive 0.146 PFIS Common Shares. Cash will be paid in lieu of fractional PFIS shares.
