Subject: Cambridge Bancorp – Cash In Lieu Settlement
Adjusted Option Symbol: EBC1

Cambridge Bancorp options were adjusted on July 15, 2024 (See OCC Information Memo #54869). The new deliverable became 1) 495 Eastern Bankshares, Inc. (EBC) Common Shares, and 2) Cash in lieu of 0.6 fractional EBC shares. Only settlement of the cash portion of EBC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$13.97 per whole EBC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.6 \times \$13.97 = \$8.38 \text{ per EBC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 15, 2024 through July 26, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the EBC1 options are as follows:

New Deliverable

Per Contract: 1) 495 Eastern Bankshares, Inc. (EBC) Common Shares
2) \$8.38 Cash

Strike Prices: Unchanged

CUSIP: EBC: 27627N105

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The EBC component of EBC1 exercise/assignment activity from July 15, 2024 through July 25, 2024, has settled through National Security Clearing Corporation (NSCC). The \$8.38 cash amount will be settled by OCC.

Pricing

The underlying price for EBC1 will be determined as follows:

$$\text{EBC1} = 4.95 (\text{EBC}) + 0.0838$$

For example, if EBC closes at 16.32, the EBC1 price would be calculated as follows:

$$\text{EBC1} = 4.95 (16.32) + 0.0838 = 80.87$$
