Subject: Adjusted Benson Hill, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: BHIL1

Adjusted Benson Hill, Inc. options were adjusted on July 19, 2024 (See OCC Information Memo #54894). The new deliverable became 1) 2 Benson Hill, Inc. (BHIL) Common Shares and 2) Cash in lieu of approximately 0.8571 fractional BHIL Shares. Only settlement of the cash portion of BHIL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.44 per whole BHIL share will be used to determine the cash in lieu amount at a rate of 0.8571. Accordingly, the cash in lieu amount is:

 $0.8571 \times \$6.44 = \$5.52 \text{ per BHIL1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 19, 2024 through August 05, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BHIL1 options are as follows:

New Deliverable

Per Contract: 1) 2 Benson Hill, Inc. (BHIL) Common Shares

2) \$5.52 Cash

Strike Prices: Unchanged

CUSIP: BHIL: 082490202

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The BHIL component of BHIL1 exercise/assignment activity from July 19, 2024 through August 2, 2024, has settled through National Security Clearing Corporation (NSCC). The \$5.52 cash amount will be settled by OCC.

Pricing

The underlying price for BHIL1 will be determined as follows:

$$BHIL1 = 0.02 (BHIL) + 0.0552$$

For example, if BHIL closes at 6.41, the BHIL1 price would be calculated as follows:

BHIL1 =
$$0.02(6.41) + 0.0552 = 0.18$$
