Subject: Adjusted Scorpius Holdings, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: SCPX1

Adjusted Scorpius Holdings, Inc. options were adjusted on July 18, 2024 (See OCC Information Memo #54881). The new deliverable became cash in lieu of 0.5 fractional SCPX Shares. Settlement of the cash portion of SCPX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.26 per whole SCPX share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$5.26 = \$2.63 \text{ per SCPX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 18, 2024 through August 05, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

NOTE: Expiration dates of SCPX1 options will not be accelerated under OCC Rule 807.

Terms of the SCPX1 options are as follows:

Settlement

The \$2.63 cash amount will be settled by OCC.

The underlying price for SCPX1 will be determined as follows:

SCPX1 = 0.03
