On September 4, 2024, Shareholders of Alimera Sciences, Inc. (ALIM) will vote concerning the proposed merger with ANIP Merger Sub INC., a wholly owned subsidiary of ANI Pharmaceuticals, Inc. If the merger is approved and consummated, each existing ALIM Common Share will be converted into the right to receive \$5.50 cash plus one non-transferable Contingent Value Right (“CVR”).

Note: The CVRs represent a non-transferable contractual right to receive the Milestone Payments as described in the ALIM Proxy Statement dated August 8, 2024. The adjusted ALIM option deliverable will not include the non-transferable CVRs.

Exercise Consideration – ALIM options will not call for delivery of the CVRs. Call option holders who wish to receive the CVRs should exercise their options in sufficient time in advance of the contract adjustment. In all cases, it is the sole responsibility of persons holding call options seeking to receive the underlying securities to determine when to exercise their options.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur late in the third quarter of 2024.

New Deliverable
Per Contract: \$550.00 Cash (\$5.50 x 100)

Settlement in ALIM options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an **acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
