Adjusted Desktop Metal, Inc. (adjusted option symbol DM1) options were adjusted on June 11, 2024 (See OCC Information Memo #54691). The new deliverable became 10 Desktop Metal, Inc. (DM) Class A Common Shares.

On October 2, 2024, Shareholders of Desktop Metal, Inc. (DM) will vote concerning the proposed merger with Nano US I, Inc., a wholly owned subsidiary of Nano Dimension Ltd. If the merger is approved and consummated, each existing DM Class A Common Stock will be converted into the right to receive \$5.50 net cash per share, subject to downward adjustment as described in the DM Proxy Statement, dated August 15, 2024 (“Proxy”).

NOTE: Desktop Metal, Inc. has filed an application to the Israeli Tax Authority which includes a request that non-Israeli shareholders be exempt from Israeli withholding, if such stockholders will provide the paying agent in Israel with certain declarations and supporting documents regarding their residency and the date on which their shares were purchased, and satisfy other conditions as stated in the Proxy. Investors are referred to the Proxy for a complete discussion of relevant tax considerations. As indicated below, the deliverable of adjusted DM options will be based on the merger consideration net of applicable withholding taxes, if any.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the fourth quarter of 2024.

**New Deliverable
Per Contract:** \$55.00 Cash (\$5.50 x 10), subject to downward adjustment as described in
the Proxy, less withholdings, if any

Settlement in DM options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
