I herewith to present to shareholders the report of Cheuk Nang (Holdings) Limited (the "Company", together with its subsidiaries, the "Group") for the year ended 30 June 2024.

業績及股息

本集團截至二零二四年六月三十日止年度錄得之綜合盈利為171,004,000港元, 去年二零二三年為53,040,000港元, 業績已詳列於綜合損益表中。

RESULTS AND DIVIDEND

The consolidated profit after income tax of our Group for the year ended 30 June 2024 is HK\$171,004,000 comparing to last year 2023: HK\$53,040,000. Details are set out in the consolidated statement of profit or loss.

董事會現建議派發末期股息每股4.00港仙(二零二三年: 3.00港仙)予於二零二四年十一月二十八日在股東名冊內登記之股東, 連同已派發之中期股息每股2.25港仙(二零二三年: 1.75港仙), 本年度合共派發股息每股6.25港仙(二零二三年: 4.75港仙)較去年增加32%。

The Directors resolved to recommend the payment of a final dividend of HK4.00 cents (2023: HK3.00 cents) per share payable to those shareholders whose names appeared in the register of members as at the close of business on 28 November 2024, which together with the interim dividend of HK2.25 cents (2023: HK1.75 cents) per share, makes a total distribution of HK6.25 cents (2023: HK4.75 cents) per share this year, which is 32% increase when compare to last year.

業務回顧及展望

香港物業

儘管政府取消了房地產的稅務辣招措施, 但房價仍未能復甦。這是由於利率、購買力不足以及較大量未售出的庫存造成。

REVIEW OF OPERATIONS AND PROSPECTS

Hong Kong Properties

Despite the government removing property tightening measures, the recovery in property prices is still weak. This is due to the high interest rate, insufficient purchasing power, and relatively abundance of unsold inventory.

相較之下, 在本地需求和海外頂尖人才的支持下, 住宅租賃市場略有升幅。預計大型住宅租金和豪宅租金將保持較為樂觀。

In contrast, the residential leasing market increased slightly, supported by local demand and from overseas top talents. We expect both the mass residential rents and luxury rents more optimistic.

主席報告書 Chairman's Statement

美國聯邦儲備局已減息0.5厘，料年內再減的機會很大，我們希望這有助於穩定住宅價格。

本集團主要項目的總述如下：

1. 壹號九龍山頂，荃灣汀九寶豐臺8號

此住宅項目劃分為兩期。

第一期為一幢21層高大廈，提供49個住宅單位（包括6個複式單位）及39個停車位，單位實用面積由約1,075平方呎至2,095平方呎。第二期包括會所、29個停車位及五幢三層高的花園別墅，別墅實用面積約由1,497平方呎至2,329平方呎，會所提供康樂設施及游泳池。

該項目的滿意紙已於二零二四年一月二十六日發出。部分買家已於二零二四年三月完成買賣。

2. 趙苑二期，薄扶林域多利道192號

此住宅項目包括三座4層高低密度住宅大廈提供29個住宅單位，住宅單位實用面積約由876平方呎至3,099平方呎。

二期的租用率維持在60%。

The U.S. Federal Reserve decreased interest rate by 0.5%, and there is a high chance of another decrease within this year. We hope this will help to stabilize the residential price.

The progress of our projects in Hong Kong are as follows:–

1. One Kowloon Peak at No. 8 Po Fung Terrace, Ting Kau, Tsuen Wan

Residential project developed in two phases.

Phase 1 comprised of a block of 21-storey building with 49 residential units (including 6 duplex units) and 39 car parking spaces. The net floor area of the units ranged from 1,075 square feet to 2,095 square feet. Phase 2 comprised of clubhouse, 29 car parking spaces and five 3-storey garden villas. The net floor area of the villas ranged from approximately 1,497 square feet to 2,329 square feet. The clubhouse provides recreational facilities and swimming pool.

The Certificate of Compliance of the development was issued on 26 January 2024. Some purchasers have completed the sale and purchase in March 2024.

2. Villa Cecil Phase II, 192 Victoria Road, Pokfulam

Residential development comprised of three blocks of 4-storey low density residential building provides 29 residential units. The net floor area of the apartments ranged from approximately 876 square feet to 3,099 square feet.

The occupancy rate of Phase 2 maintained at 60%.

3. 趙苑三期·薄扶林域多利道216號

住宅項目包括兩座4層高的住宅大廈。可租售樓面總建築面積為97,000平方呎(實用面積約為68,973平方呎)。第一座提供9個住宅單位及第二座提供32個住宅單位。單位建築面積由760平方呎至3,800平方呎(實用面積由586平方呎至2,555平方呎)。

兩座樓宇的入住率達61%。

4. 卓能山莊·山頂施勳道30號

住宅物業包括兩座三層高的豪華住宅別墅，分別為紫棠居及紫薇居。兩座別墅的翻新裝修已告完成。我們現正計劃以公開招標方式出售這兩座物業。

5. 新趙苑·長洲西堤路33號

住宅項目劃分為兩期，可售總樓面建築面積為約58,000平方呎，實用面積約31,266平方呎。

第一期包括19座兩層高的住宅別墅已獲發出入伙紙，面積由1,450平方呎至2,700平方呎(實用面積由1,106平方呎至2,070平方呎)。第二期包括四座兩層高的住宅別墅，別墅面積由2,000平方呎至12,000平方呎(實用面積由1,564平方呎至9,260平方呎)。康樂設施包括游泳池及園景花園。

3. Villa Cecil Phase III, 216 Victoria Road, Pokfulam

Residential development comprised of two blocks of 4-storey building for rental purpose. The total marketable gross floor area is about 97,000 square feet (net floor area is about 68,973 square feet). Block 1 provides 9 residential units and Block 2 provides 32 units. The gross floor area of the apartments ranged from 760 square feet to 3,800 square feet (net floor area ranged from 586 square feet to 2,555 square feet).

The occupancy rate of the two blocks has reached 61%.

4. Cheuk Nang Lookout, 30 Severn Road, The Peak

A residential premises comprised of two deluxe 3-storey residential villas, namely Villa Begonia and Villa Crocus. The renovation of the two villas to enhance the quality is completed. We are planning to proceed public tender for sale of both properties.

5. New Villa Cecil, No. 33 Cheung Chau Sai Tai Road, Cheung Chau

A residential project developed into 2 phases with total marketable gross floor area approximately 58,000 square feet, the net sales area is approximately 31,266 square feet.

Phase I comprised of 19 blocks of 2-storey residential villas has already received Occupation Permit. The gross floor area of the villas ranged from 1,450 square feet to 2,700 square feet (net floor area ranged from 1,106 square feet to 2,070 square feet). Phase II comprised of 4 blocks of 2-storey residential villas. The gross floor area of the villas ranged from approximately 2,000 square feet to 12,000 square feet (net floor area from 1,564 square feet to 9,260 square feet). Recreational facilities including swimming pool and landscape garden are provided.

The occupancy rate of the villas in Phase 1 has reached 40%.

中國物業

二零二四年五月，中國宣布了一系列提振房地產市場的措施，包括降低最低首付比例、建立保障性房屋再貸款機制以及承諾交付爛尾樓。針對購屋者的多樣化需求，各城市採取了具體措施。

China Properties

In May 2024, China announced a raft of measures to boost the property market, cutting minimum down payment ratios, setting up a re-lending facility for affordable housing and pledging to deliver unfinished homes. Different cities adopted specific measures to address the diverse demands of home buyers.

在最新舉措中，上海當局宣布了九項具體措施，包括放寬非上海居民和離婚夫婦購房限制、允許有兩個及以上孩子的家庭購買額外住房、降低個人最低首付比例等。房地產市場對這些措施反應正面。

In the latest move, authorities in Shanghai announced nine specific measures, including easing home-purchase restrictions for non-Shanghai residents and divorced couples, allowing families with two or more children to purchase an additional home, and lowering the minimum down payment ratio for individual commercial housing mortgages. The property market reacted positively to these measures.

除上海外，北京、天津、杭州、西安、成都等城市也調整了房地產政策，推出了放寬限購、商品房以舊換新等措施。

Apart from Shanghai, cities including Beijing, Tianjin, Hangzhou, Xi'an and Chengdu have also adjusted their real estate policies, announcing measures such as eased purchase restrictions and the trade-ins of commercial housing.

這些國家和地方的措施呼應了四月三十日召開的中共中央政治局會議，要求研究減少房屋庫存、提高新增房屋品質的政策。

These national and local measures echoed a Communist Party of China (CPC) Central Committee Political Bureau meeting on April 30, which demanded research on policies to reduce housing inventory and improve the quality of newly added housing.

深圳是四個一線城市宣布放寬購屋限制的措施之一，這些措施包括將首付比例從50%降低至35%以及抵押貸款利率。

深圳龍華

銷售活動仍在持續。截至目前，已累計銷售793伙，銷售額達3,872,000,000元人民幣。

杭州

杭州也在二零二四年五月取消了新建房屋限購。在新政策下，不再審核本市內購買新房的資格，在杭州購買住房的非城市戶主可申請「戶口」，即常住戶口，可用於享受基本福利以及中國的公共服務。

根據新政策，在所購買的城市地區沒有房屋或只有一套在售房屋的個人，在為新房申請較低的抵押貸款時，可以符合首次購房者的資格。

卓能 • 河畔軒

杭州餘杭區

該項目位於杭州餘杭區土地面積為38,983平方米（約419,613平方呎），已批准建築面積為122,483平方米（約1,318,407平方呎）。已興建多座多層大廈提供849個住宅單位和22戶河邊特色花園別墅、780個停車位、會所、康樂設施及商舖。住宅單位面積由65平方米（700平方呎）至270平方米（2,906平方呎）。

Shenzhen

Shenzhen is one of the four Tier 1 cities announced measures to ease restrictions on homebuying including lower both the down payment ratio from 50% to 35% and the mortgage interest rates.

Cheuk Nang Garden

Longhua, Shenzhen

The sale campaign is still continued. Uptill now, a total of 793 units were sold and the sales amount to RMB3,872 million.

Hangzhou

Hangzhou also removed the restrictions on new housing purchases in May, 2024. Under the new policy, qualifications for purchasing new houses within the city will no longer be reviewed, and non-city householders who have purchased houses in Hangzhou can apply for "Hukou", or permanent local residence, which can be used to obtain access to basic welfare and public services in China.

According to the new policy, individuals who do not have a home in the urban area they are buying, or with just one home there that is up for sale, may qualify as first-time homebuyers when applying for a lower mortgage for their new homes.

Cheuk Nang • Riverside

Yue Hang Qu, Hangzhou

The development comprised land area of 38,983 square metres (approximately 419,613 square feet). The total net floor area is 122,483 square metres (approximately 1,318,407 square feet) with multi-storey buildings provides 849 residential units, 22 deluxe villas by the riverside, 780 car parking spaces, clubhouse, recreational facilities and shopping centre. The size of the residential units and villas ranged from 65 square metres (700 square feet) to 270 square metres (2,906 square feet).

澳門物業

澳門政府推動實施「1+4」經濟適度多元策略，發布《澳門特別行政區經濟適度多元發展規劃（2024-2028年）》。政府持續改善民生，加速城市基礎建設，提升整體治理品質與水準。

星光大路一號

路環石排灣

土地工務局已於二零二四年一月下旬發出提案，同意我們所申請的土地用途變更，但標有「A2」和「B2」的土地除外。我們當地的律師已於二零二四年三月向土地工務局提出異議，但政府要求我們重新提交開發提案。

土地工務局已於二零二四年八月十四日至八月二十八日期間開展意見收集活動，就我們位於石排灣的土地的詳細城市規劃收集公眾意見。目前，尚未有任何消息公佈。

The construction work of the entire project has been substantially completed, and the planning acceptance has been approved. However, the building acceptance and the property certificate for strata ownership have not yet been completed.

Macau Properties

The Macau government advanced the implementation of the “1+4” strategy for appropriate economic diversification, and released the Development Plan for Appropriate Economic Diversification of the Macao Special Administrative Region (2024-2028). The Government continued to enhance people’s livelihoods, accelerate urban infrastructure construction, enhance overall quality and standards of governance.

Golden Cotai No. 1

Estrada de Seac Pai Van, Coloane

The Direcção dos Serviços de Solos e Construção Urbana (DSSCU) has issued a proposal at the end of January 2024 consenting to the change of land use as applied by us with the exception of the land marked “A2” and “B2”. Objection has been made by our local lawyer to the DSSCU in March 2024 but the Government requested us to re-submit the development proposal.

DSSCU has launched an opinion collection campaign during 14 August to 28 August 2024 to collect opinion from the public regarding the details urban planning of our land in Seac Pai Van. At the present moment, no information was announced yet.

Malaysia Properties

Outweighed by high interest rates, global growth is moderate as it remained supported by resilient labour market.

The unemployment rate remained low at its pre-pandemic level. Labour supply continued to be forthcoming as the labour force participation rate increased further in the working age population in the 2nd quarter of 2024.

Phase I "Parkview"

Lot 1359, Section 57, Lorong Perak, Kuala Lumpur

The development is a ready built 41-storey residential building providing 417 residential units and 163 car parking spaces. Most units have been sold by our Parkview joint venture partner. The remaining 27 unsold units are operated as serviced apartments.

The occupancy of the serviced apartments currently is 60% and upgrading of the property to improve occupancy is still in progress. We will launch a website (www.martego.com.my) to enable travellers to book our serviced apartments in a more convenient way. A new leasing agent was employed to promote the leasing activity.

Phase II "Cecil Central Residence"

Lot 11385 and 11386, Section 57, Lorong Perak, Kuala Lumpur

The development currently comprised of 4 blocks of residential condominium with total approved gross floor area is 1,708,648 square feet.

The investment in Bond market as at 30 June 2024 was HK\$49,876,000. During the year, a total of HK\$2,290,000 was redeemed and no Bond was purchased and sold.

The market price of our investment in the Hong Kong stocks as at 30 June 2024 was HK\$54,263,000. During the year, no stock was purchased and sold.

The investment in Fund as at 30 June 2024 was HK\$2,953,000. During the year, a total of HK\$3,000,000 was purchased.

OUTLOOK

The Hong Kong economy continued to record moderate growth in the second quarter of 2024.

Looking ahead, the economy should continue to grow in the remainder of the year, but various factors including geopolitical tensions and global economic may pose uncertainties on different fronts.

As regards inbound tourism and private consumption, the Central Government's various measures benefitting Hong Kong. The Government's efforts to boost market sentiment and improving employment earnings would provide support, but the changes in the consumption patterns of visitors and residents and the relatively strong Hong Kong dollar may continue to pose challenges.

財務回顧

業績摘要

截至二零二四年六月三十日止年度（「本年度」）的營業額為188,042,000港元（二零二三年：45,156,000港元），較去年同期增加316.4%。主要由於本年度深圳及香港銷售物業增加155,629,000港元。

在物業租賃方面，本年度的租金收入較二零二三年同期減少22.4%，與二零二三年同期相比，租金收入為31,794,000港元（二零二三年：40,997,000港元）。

本年度的毛利為106,796,000港元，去年同期毛利為27,752,000港元。其他收入較去年增加38.8%至22,132,000港元，本年度的其他收入主要來自股息收入及利息收入。按公允價值計入損益之金融資產公允價值增加6,000,000港元（二零二三年：2,353,000港元）。投資物業公允價值減少154,070,000港元（二零二三年：公允價值增加145,091,000港元）。按公允價值計入其他全面收益之金融資產之預期信用虧損為4,975,000港元（二零二三年：14,210,000港元）與債券拖欠利息支付及信用評級下調有關。行政開支較去年同期減少18.8%至56,570,000港元。財務成本較去年同期增加197.3%至53,831,000港元，增加主要由於年內並無利息資本化於發展中待售物業中。

FINANCIAL REVIEW

Financial Highlights

Revenue for the year ended 30 June 2024 (the "Year") amounted to HK\$188,042,000 (2023: HK\$45,156,000), a 316.4% increase as compared with last year. It was mainly due to increase in properties sold in Shenzhen and Hong Kong amounted to HK\$155,629,000 during Year.

For property leasing, the Year recorded a decrease of 22.4% in rental income as compared with the corresponding year in 2023, amounting HK\$31,794,000 (2023: HK\$40,997,000).

Gross profit for the Year amounted to HK\$106,796,000, as compare to a gross profit of HK\$27,752,000 with the corresponding year. Other income recorded an increase of 38.8% to HK\$22,132,000 when compared with last year. The other income for the Year were mainly attributed to dividend income and interest income. Positive change in fair value of financial assets at fair value through profit or loss amounted to HK\$6,000,000 (2023: HK\$2,353,000). Negative change in fair value of investment properties amounted to HK\$154,070,000 (2023: Positive change in fair value of HK\$145,091,000). Expected credit loss of financial assets at fair value through other comprehensive income amounted to HK\$4,975,000 (2023: HK\$14,210,000) which related to debentures default in interest payment and downgrading on credit rating. Administrative expenses decreased by 18.8% to HK\$56,570,000 as compared with last year. Finance costs increased by 197.3% to HK\$53,831,000 as compared with last year. The increase was mainly due to no capitalisation of interest to properties under development for sale during the Year.

於二零二四年六月三十日，權益持有人應佔本集團之權益總額約為6,684,368,000港元(二零二三年:6,573,558,000港元)，較二零二三年六月三十日增加110,810,000港元或1.7%。根據二零二四年六月三十日的已發行普通股總數652,676,781股(二零二三年:652,676,781股)計算，權益持有人應佔的每股權益為10.24港元，較二零二三年六月三十日10.07港元增加1.7%。

除現有項目及年報中所披露者外，本集團並無重大投資或購買資本資產的未來計劃。

Profit attributable to owners of the Company for the Year was HK\$171,678,000 (2023: Profit HK\$21,202,000). Basic earnings per share was HK\$0.26 (2023: HK\$0.03) and fully diluted earnings per share was HK\$0.26 (2023: HK\$0.03).

A final dividend of HK4.00 cents (2023: HK3.00 cents) was proposed together with the interim dividend of HK2.25 cents (2023: HK1.75 cents) a total of HK6.25 cents (2023: HK4.75 cents) for the year ended 30 June 2024.

Total Equity Attributable To The Owners Of The Company

As at 30 June 2024, the Group's total equity attributable to the owners of the Company amounted to approximately HK\$6,684,368,000 (2023: HK\$6,573,558,000), an increase of HK\$110,810,000 or 1.7% when compared with 30 June 2023. With the total number of ordinary shares in issue of 652,676,781 as at 30 June 2024 (2023: 652,676,781 shares), the total equity attributable to the owners of the Company per share was HK\$10.24, representing an increase of 1.7% compared to HK\$10.07 as at 30 June 2023.

Other than the existing projects and those disclosed in the annual report, the Group did not have any confirmed future plans for material investment or acquiring capital assets.

在二零二四年六月三十日，投資上市證券、基金及永久票據及債券的公允價值分別為54,263,000港元、2,953,000港元及49,876,000港元，分類為按公允價值計入損益之金融資產及按公允價值計入其他全面收益之金融資產。年內，上市證券投資組合因公允價值獲利益5,953,000港元（二零二三年：2,353,000港元）。就基金投資而言，本年度內共購買了3,000,000港元（二零二三年：零），公允值虧損為47,000港元（二零二三年：零）。就永久票據及債券而言，總額2,290,000港元（二零二三年：88,583,000港元）已被贖回，預期信用虧損4,975,000港元（二零二三年：14,210,000港元）已作撥備。在二零二四年六月三十日，金融資產投資佔總資產的1.1%（二零二三年：1.3%），構成本集團現金管理活動的一部分。

Investment In Financial Assets At Fair Value Through Profit Or Loss And Other Comprehensive Income

As at 30 June 2024, the fair value of investment in listed securities, fund and perpetual note and debentures amounted to HK\$54,263,000, HK\$2,953,000 and HK\$49,876,000 respectively were classified as the financial assets at fair value through profit or loss and fair value through other comprehensive income. During the Year, the portfolio on listed securities was increased by gain on fair value of HK\$5,953,000 (2023: HK\$2,353,000). For investment in fund, a total of HK\$3,000,000 (2023: Nil) was purchased during the Year and the loss on fair value was HK\$47,000 (2023: Nil). For perpetual note and debenture, a total of HK\$2,290,000 (2023: HK\$88,583,000) was redeemed and an expected credit loss of HK\$4,975,000 (2023: HK\$14,210,000) was provided. The investment in financial assets as at 30 June 2024 represented 1.1% (2023: 1.3%) of the total assets, which formed part of the Group's cash management activities.

Equity

The number of issued ordinary shares as at 30 June 2024 and 30 June 2023 were 652,676,781 and 652,676,781 respectively.

Debts And Gearing

As at 30 June 2024, the Group's bank and other borrowings amounted to HK\$1,343,125,000 (2023: HK\$1,036,449,000). Cash and bank balances amounted to HK\$881,792,000 (2023: HK\$323,525,000) and net borrowing of HK\$461,333,000 (2023: HK\$712,924,000).

總債務及股本權益比率為20.1% (二零二三年：15.8%) 而債務淨額與股本權益比率為6.9% (二零二三年：10.8%)。總債務與股本的比率增加主要由於年內銀行及其他借貸增加，至於淨債務與股本的比率減少主要由於年內銀行結存增加。

於二零二四年六月三十日，本集團的銀行及其他借貸均以港元計值。於本集團的銀行及其他借貸總額1,343,125,000港元 (二零二三年：1,036,449,000港元) 中，根據貸款合同的預定還款時間表可要求即時還款條款，100%需於一年內 (二零二三年：39.2% 及60.8% 分別須於一年內及一至二年內) 償還。本集團的銀行及其他借貸利率主要參照香港銀行同業拆息。

資產抵押

於二零二四年六月三十日，本集團投資物業及土地及樓宇賬面值分別為2,546,738,000港元 (二零二三年：2,737,895,000港元)、及186,254,000港元 (二零二三年：38,866,000港元) 已作抵押令本集團獲得一般銀行貸款。

財務成本

財務成本包括銀行及其他貸款、安排、信貸及承擔費用支出。本年度沒有資本化之利息 (二零二三年：資本化之利息為21,095,000港元)，本年度之利息支出為53,831,000港元，較去年同期錄得的利息支出18,105,000港元增加197.3%。利息開支增加主要由於本年度銀行貸款利率上升及其他借貸成本增加的綜合影響所引致。於回顧年度內之平均利率為4.5% (二零二三年：1.8%)，乃以總利息支出除以平均借貸總額得出。

Total debts to equity ratio was 20.1% (2023: 15.8%) and net debts to equity ratio was 6.9% (2023: 10.8%). The increase in the total debt to equity ratio was mainly due to increase in bank and other borrowings during the Year and decrease in net debts to equity was mainly due to increase in bank balances during the Year.

As at 30 June 2024, the Group's bank and other borrowings were denominated in Hong Kong dollars. Of the Group's total bank and other borrowings HK\$1,343,125,000 (2023: HK\$1,036,449,000), 100% repayable within 1 year (2023: 39.2% and 60.8% were repayable within 1 year and 1 to 2 years respectively) by reference to the repayment on demand clause based on scheduled repayments of the loan agreement. The Group's bank and other borrowings carried interest rates by reference to Hong Kong Interbank Offer Rate ("HIBOR.")

Pledge Of Assets

As at 30 June 2024, the Group's investment properties and land and building with carrying values of approximately HK\$2,546,738,000 (2023: HK\$2,737,895,000) and HK\$186,254,000 (2023: HK\$38,866,000) respectively were pledged to secure general banking facilities of the Group.

Finance Costs

Financial costs included interest expenses on bank and other loans, arrangement, facility and commitment fee expenses. No interest was capitalized for the Year (2023: interest capitalized was HK\$21,095,000). Interest expenses for the Year amounted to HK\$53,831,000, representing 197.3% increase over the interest expenses of HK\$18,105,000 recorded for the last year. The increase in interest expense was mainly due to the combined effect of increase in bank loans interest and other borrowing cost during the Year. The average interest rate over the year under review was 4.5% (2023: 1.8%) which was expressed as a percentage of total interest expenses over the average total borrowing.

本集團於二零二四年六月三十日的投資物業及若干物業、機器及設備已由專業估值師羅馬國際評估有限公司及廖敬棠測計師行有限公司負責重估並於製訂二零二四年財務報表中使用其估值。本集團的投資物業及發展中投資物業估值分別為 3,512,769,000 港元及 1,852,298,000 港元，總數為 5,365,067,000 港元（二零二三年：投資物業及發展中投資物業分別為 5,012,375,000 港元及 1,857,631,000 港元，總數為 6,870,006,000 港元），公允價值減少約為 154,070,000 港元（二零二三年：公允價值增加 145,091,000 港元已計入本年度損益表中利潤）已支出在本年度損益表中。本集團提供予董事作宿舍之土地及樓宇公允價值 186,254,000 港元（二零二三年：38,866,000 港元）列賬，公允價值增加 593,000 港元（二零二三年：2,763,000 港元）已在年度物業重估儲備中列賬。本集團待售發展中物業以成本值或可變現淨值兩者之較低者在財務報表中列賬。

風險管理

本集團設有足夠風險管理程序，以識別、衡量、監察及控制其面對的各種風險，同時輔以積極管理、有效的內部監控及足夠的內部審核，以保障本集團的最佳利益。

酬金政策及購股權計劃

於二零二四年六月三十日，本集團共有僱員 47 人（截至二零二三年六月三十日：54 人）。

Property Valuation

A property valuation has been carried out by Messrs. Roma Appraisals Limited and K.T. Liu Surveyors Limited in respect of the Group's investment properties and certain property, plant and equipment as at 30 June 2024 and that valuation was used in preparing 2024 financial statements. The Group's investment properties and investment properties under development were valued at HK\$3,512,769,000 and HK\$1,852,298,000 respectively making the total HK\$5,365,067,000 (2023: investment properties and investment properties under development were valued at HK\$5,012,375,000 and HK\$1,857,631,000 making the total HK\$6,870,006,000). The decrease in fair value of approximately HK\$154,070,000 (2023: The increase in fair value of approximately HK\$145,091,000 was credited to the income statement for the Year) was debited to the income statement for the Year. The Group land and building held for the directors' quarter carried at fair value were valued at HK\$186,254,000 (2023: HK\$38,866,000). The increase in fair value of HK\$593,000 (2023: HK\$2,763,000) for the Year were recorded in property revaluation reserves. Properties under development for sale of the Group were stated at lower of cost or net realizable value in the financial statements.

RISK MANAGEMENT

The Group has established adequate risk management procedures that enable it to identify, measure, monitor and control the various types of risk it faces. This is supplemented by active management involvement and effective internal controls in the best interests of the Group.

REMUNERATION POLICIES AND SHARE OPTION SCHEME

As at 30 June 2024, the Group employed a total of 47 (as at 30 June 2023: 54) staff.

In performing this role, the Chairman's responsibilities include chairing meetings of the Board; ensuring the board meetings receive accurate, complete, timely and clear information concerning affairs of the Company; ensuring constructive relations between executive and non-executive directors; formulating for discussion and decision, questions which have been moved for the consideration of the Board; ensuring that all directors are properly briefed on issues arising at board meetings; acting as liaison between the Board and management; in consultation with the Chief Executive Officer and the company secretary or his/her designated delegates, drawing up and approving the agenda for each board meeting taking into account, where appropriate, any matters proposed by the other directors for inclusion in the agenda; and at least annually hold meetings with non-executive directors (including independent non-executive directors) without the presence of the executive directors.

The Chief Executive Officer is primarily responsible for recommending policy and strategic directions for Board approval, implementing the strategies and policies adopted by the Board and conducting the day-to-day operation of the Company.

The Company currently cannot comply with the requirement to separate the role of Chairman and Chief Executive Officer. We are, through different channels, still looking for a suitable person to act as Chief Executive Officer and with a hope to comply with the requirement in the next financial year.

A.3 董事會之組成

A.3 BOARD COMPOSITION

The Board is chaired by Dr. Chao Sze Tsung Cecil (the “Chairman”). The Board comprises three Independent Non-Executive Directors, one Non-Executive Directors and four Executive Directors. The names, biographical details of the directors are set out in the “Profiles of Directors and Senior Management” on pages 20 to 26 to the annual report. All Independent Non-Executive Directors and Non-Executive Directors bring a variety of experience and expertise to the Company. The Board includes a balanced composition of executive and non-executive directors (including independent non-executive directors) so that there is an independent element on the Board which can effectively exercise independent judgment, and that non-executive directors should be of sufficient caliber and number for their views to carry weight.

The independent non-executive directors are identified in all corporate communications that disclose the names of the directors.

An updated list of directors of the Company and their role and function is maintained on the websites of the Company and the Hong Kong Exchanges and Clearing Limited.

A.4 董事之委任、重選及罷免

本公司已與本公司所有董事訂立委任書。根據該等委任書，各董事並非以固定任期委任，但須在本公司股東周年大會上輪值退任及膺選連任。根據本公司之組織章程細則，新委任董事之任期至本公司下一次股東大會（如屬填補臨時空缺或新增之董事名額）為止，而屆時將符合資格在該股東大會上膺選連任，但不能計算在該股東大會上需輪值告退的董事之中。

董事會一直遵守上市規則第3.10A及3.10(2)條之規定，委任至少三名獨立非執行董事，且當中至少一名獨立非執行董事持有適當專業資格或會計或相關財務管理專長。

本公司已接獲各獨立非執行董事作出之書面年度確認。本公司認為所有獨立非執行董事根據上市規則定義均具獨立性。獨立非執行董事之身份是明確註明在所有公司信函中。

A.4 APPOINTMENT, RE-ELECTION AND REMOVAL OF DIRECTORS

The Company has entered into appointment letters with all the directors of the Company. Pursuant to such appointment letters, each of the directors of the Company is not appointed on fixed term but is subject to retirement by rotation and re-election at the annual general meeting of the Company. In accordance with the Company's Articles of Association, all newly appointed Directors (either to fill a casual vacancy or as an addition to the Board) shall hold office only until the next annual general meeting of the Company and shall then be eligible for re-election, but shall not be taken into account determining the Directors who are to retire by rotation at such meeting.

The Board at all times met the requirements of Rules 3.10A and 3.10(2) of the Listing Rules relating to the appointment of at least three Independent Non-Executive Directors with at least one Independent Non-Executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise.

The Company has received from each of the Independent Non-Executive directors an annual written confirmation of his independence. The Company considers all of the independent non-executive directors are independent within the definition of the Listing Rules. The Independent Non-Executive Directors are explicitly identified in all corporate communications.

根據本公司章程細則第107條，股東可於任何股東大會上提名候選董事，股東須於股東大會日期至少7日前向本公司提交一份書面通知書，其內表明他擬提議推選該人士出任董事之職，以及一份由該人士所發出的表示願意接受推選的書面通知。股東提名候選董事的程序已載於本公司網頁以供查閱。

每屆股東周年大會上，三分之一的在任董事應輪值退任，或者，在董事人數並非三或三之倍數的情況下，則為最接近但不超過三分之一之人數。每年輪值退任之董事應為自彼等上次獲委任起計任期最長者，如果不同人士於同日成為董事，則抽籤決定何者退任。退任之董事應有資格候選連任。

Independent non-executive director serving more than 9 years could be relevant to the determination of his independence. According to Code Provision B.2.3 of Part 2 of Appendix C1, if an independent non-executive director serviced more than 9 years, his further appointment should be subject to a separate resolution to be approved by the shareholders. The papers to shareholders accompanying that resolution should state why the Board believes that the director is still independent and should be re-elected, including the factors considered.

At the annual general meeting held on 22 November 2023, no independent non-executive directors was subject to retirement.

Pursuant to Article 107 of the Company's Articles of Association, a shareholder can propose a person for election to the office of Director at any general meeting by giving the Company notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been given to the Company at least seven days before the date of the general meeting. The procedures for shareholders of the Company to propose a person for election as a Director are available and accessible on the Company's website.

In addition, at each annual general meeting, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest one-third, shall retire from office. The Directors to retire on every year shall be those who have been longest in office since their last election but as between persons who became Directors on the same day those to retire shall be determined by lot. The retiring Directors shall be eligible for re-election.

A.5 NOMINATION COMMITTEE

The Nomination Committee currently consists of two Independent Non-Executive Directors namely Mr. Sun Dai Hoe Harold and Mr. Lee Tsung Hei David Chris and one Executive Director namely Dr. Chao Sze Tsung Cecil. Dr. Chao Sze Tsung Cecil is the Chairman of the Committee.

The terms of reference of the Nomination Committee are posted on the websites of the Company (www.cheuknang.com.hk) and the Stock Exchange.

The Nomination Committee will review the structure, size and composition of the Board, identify suitable candidates to the Board, and to make recommendations on any matters in relation to the appointment or re-appointment of members of the Board and succession planning for director, in particular, the chairman and the chief executive. The Nomination Committee will also assess the independence of independent non-executive directors. Appointment of new Directors is reserved for the Board's approval.

Where vacancies on the Board exist, the Nomination Committee ensures that the Board comprises members with mixed skills and experience with appropriate knowledge necessary to accomplish the Group's business development, strategies, operation, challenges and opportunities. The Nomination Committee take into account of that person's skill, qualifications and expected contributions to the Company before making any recommendations to the Board in relation to the appointment or re-appointment of members of the Board.

A.6 董事責任

The directors have access to the Company Secretary who is responsible to the Board for ensuring that Board procedures, and all applicable rules and regulations, are followed.

The Company Secretary prepares written resolutions or minutes and keeps records of matters discussed and decisions resolved at all Board and Board Committee meetings.

The Board and Board Committee minutes/resolutions are sent to all Directors/Board Committee members within a reasonable time after each Board and Board Committee meeting and are available for inspection by Directors/Board Committee members.

The Board having considered the attendance records of the Directors is satisfied that each Director spends sufficient time performing his responsibilities.

A.8 TERMS OF DIRECTORS

Code provision B.2.2 of the Code requires every director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years, which is in line with the provision of the Company's Articles of Association. Three out of the four non-executive directors have remunerated at HK\$71,266 per year and the remaining has remunerated at HK\$171,300 per year.

B.1 REMUNERATION COMMITTEE

The Company has established a Remuneration Committee to advise the Company on the directors' remuneration policy and other remuneration related matters.

The Remuneration Committee currently comprised of three members includes two Independent Non-Executive Directors namely Mr. Lam Ka Wai Graham, Mr. Sun Dai Hoe Harold and one Executive Director namely Dr. Chao Sze Tsung Cecil. Mr. Sun Dai Hoe Harold is the Chairman of the Committee.

The terms of reference of the Remuneration Committee are posted on the websites of the Company (www.cheuknang.com.hk) and the Stock Exchange.

The Remuneration Committee is primary responsible for formulating and making recommendation to the Board on the Group's policy and structuring the remuneration of the directors of the Company and the senior management of the Group. No Directors or any of his associates is involved in deciding his own remuneration. The remuneration package of the Directors includes salary, bonus and pension. The remuneration level is determined by reference to the expertise, performance and experience possessed by each Director.

The Remuneration Committee shall meet at least once a year or as requested by the director responsible for resources function.

All members of the board are provided with monthly updates giving and balanced and understandable assessment of the Company's performance, position and prospects in sufficient details to enable the board and each director to discharge their duties.

The Directors confirm that, to the best of their knowledge, information and belief, having made specific enquiries of all directors, they are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

C.2 INTERNAL CONTROLS AND RISK MANAGEMENT

The Board has the responsibility to review annually the effectiveness of the Group's risk management and internal control systems covering all material controls, including financial, operational and compliance controls. In 2024, the Board, through the Audit Committee, had reviewed the adequacy of resources, qualifications and experience of staff of the Company's accounting, internal audit and financial reporting functions.

風險管理方法

本集團在本集團風險管理框架下採取「自上而下」的方針，董事會、審計委員會、高級管理人員和部門負責人對風險管理政策的製定和維護進行了嚴密的監督。

風險治理結構

本集團的風險治理結構由以下各方組成：

- i. 董事會
 - 評估和確定其願意為實現集團戰略目標而採取的風險的性質和程度；
 - 持續管理風險管理體系的设计，實施和監督管理；
 - 確保至少每年對本集團及其子公司風險管理體系的有效性進行審查，並向公司報告其在公司治理報告中已經這樣做的情況。

Risk management is defined as the continuing process to identify, analyse, evaluate, and treat loss exposures and monitor risk control and financial resources to mitigate the adverse effects of loss. Risk Appetite is the amount of risk that the Board and the management are willing to accept in the pursuit of the Group's value.

Risk Management Approach

The Group adopts a "Top-Down" approach in the Group's risk management framework which the Board, the Audit Committee, the senior management and the department heads exercise strong oversight on the establishment and maintenance of the risk management policy.

Risk Governance Structure

The Group's risk governance structure consists of the following parties:

- i. The Board of Directors
 - evaluate and determine the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives;
 - oversee management in the design, implementation and monitoring of the risk management systems on an ongoing basis;
 - ensure that a review of effectiveness of the Group's and its subsidiaries' risk management system has been conducted at least annually and report to shareholder that it has done so in Corporate Governance Report.

- identify risks to the achievement of their unit's business plan which might also be corporate risks, and to advise senior management and Board of Directors of such risks;
- identify any relevant mitigating actions, to include these within their unit's business plan, and to ensure the objective of business plan is achieved;
- be alert to other risks that might develop.

- v. 所有員工
 - 警惕可能的企業風險，並向管理層報告他們確定的風險。

本集團的風險管理流程包括4個核心階段：

- (1) 風險識別
各部門負責人通過考慮與其流程有關的風險，通過評估市場，競爭環境和日常運作來確定影響公司的潛在風險。然後將風險記錄在風險登記冊中，用於總結公司整體風險，分為四個風險類別，即報告、操作、戰略和合規風險。

風險登記冊在完成後提交內部審計職能和審計委員會審查。

識別過程每年進行一次，以響應不斷變化的商業環境，並確定是否需要對風險識別結果進行調整。

- (2) 風險評估和優先排序
 - (2.1) 風險評估
在各部門之間部署了一套共同的評估標準，以評估可能性和後果方面的風險。部門負責人必須根據評估標準對風險的可能性和後果進行評級。施加的等級範圍為1到5。

- v. All Staffs
 - be alert to possible corporate risks and report the risks that they have identified to their managers.

The Group's risk management process comprises 4 core stages:

- (1) Risk identification
Each of the head of department is responsible to identify potential risks that affect the Group through assessing the market, competition environment and the daily operations by considering the risks relating to their processes. The risks are then recorded into the risk register, which serves to summarize the risks of the Group as a whole by four risk categories, namely reporting, operational, strategic and compliance risk.

The risk register is submitted to the internal audit function and the Audit Committee for review upon completion.

The identification process is performed annually to respond to the changing business environment and to determine whether adjustment is required for the risk identification result.

- (2) Risk Assessment and Prioritization
 - (2.1) Risk Assessment
A common set of assessment criteria is deployed across departments to assess the risks in terms of likelihood and consequences. The head of departments are required to assign the ratings on the likelihood and the consequences of the risks in accordance with the assessment criteria. The rating applied ranges from 1 to 5.

(2.3) 評估標準

評估標準由管理層決定，經董事會批准。

(3) 風險回應

風險緩解計劃包括以下部分：

公司將根據風險評估結果，由小至大排列十大風險。風險的描述和風險的影響需要納入本節。

(2.2) Risk Prioritization

Risks are prioritized in descending order after the overall ratings are calculated. The design of risk mitigation plan is based on the risk prioritization and the details of the plan are described in “(3) Risk Response” sections.

(2.3) Assessment Criteria

The assessment criteria is determined by the management and approved by the Board.

(3) Risk Response

(3.1) Risk Mitigation Plan

Each department head is responsible to formulate the risk mitigation plan upon the completion of risk prioritization.

The risk mitigation plan includes the following sections:

(i) Risk Identified

The Group will list out the top 10 risks in descending order by using result from the risk assessment. Description of the risks and the impact of the risks are required to be included under this section.

The Company has developed its disclosure policy to provide the general guideline on handling confidential information, monitoring of information disclosure and response to queries to its directors, officers, senior management and the relevant employees. The Company has executed supervision programs to confirm the strict prohibition from unauthorized access to and use of inside information.

The Group does not have an internal audit function as the Board has reviewed the effectiveness of the internal control system of the Company and is currently of the view that there is no immediate need to set up an internal audit function within the Group in light of the size, nature and complexity of the Group's business. The situation will be reviewed from time to time.

The Board also contracted Grant Thornton Advisory Services Limited to conduct the risk management and internal control reviews of the financial reporting & disclosure controls, revenue management and inventory management for the year ended 30 June 2024. The reports were distributed to the Audit Committee and the Board for their review.

For the year ended 30 June 2024, the Board considered the Group's risk management and internal control system as adequate and effective and that the Company has complied with the code provisions on internal control of the Code.

C.3 AUDIT COMMITTEE

The Audit Committee currently comprises of two independent non-executive directors and one non-executive director, namely Mr. Lam Ka Wai Graham, Mr. Lee Ding Yue Joseph and Mr. Sun Dai Hoe Harold. Mr. Lam Ka Wai Graham is the chairman of the Audit Committee. The composition and members of the Audit Committee complies with the requirements under Rule 3.21 to the Listing Rules.

The terms of reference of the Audit Committee are posted on the websites of the Company (www.cheuknang.com.hk) and the Stock Exchange.

The Audit Committee annually assesses the appointment of the external auditor, taking into account the quality and rigor of the audit, the quality of the auditor service provided, the audit firm's quality control procedures, relationships between the external auditors and the Company and the independence of the external auditors.

As required by Code Provision D.2.6, details of arrangements for employees to raise concerns about improprieties in financial reporting, internal control and other matters have been included in the terms of reference of the Audit Committee in February 2012.

No member of the Audit Committee is a former partner of the existing auditing firm of the Company during the one year after he/she ceases to be a partner of the auditing firm.

For all other general meetings, notice will be sent to shareholders with at least 10 clear business days. The Chairman and/or Directors are available to answer questions on the Group's business at the meetings. At general meetings, separate resolutions are proposed on each substantially separate issue such as the election of individual directors and re-appointment of auditors.

Details of poll voting procedures and the rights of shareholders to demand a poll is included in a circular to shareholders accompanied the annual report. The circular also includes relevant details on proposed resolutions, and biographies of each candidates standing for re-election.

The constitutional document of the Company was posted in the Company's website and of the Stock Exchange. There has not been change in the constitutional document during the year.

At the 2023 annual general meeting of the Company, the external auditors and all directors were attended to answer the questions from the shareholders. The Chairman of the meeting has explained the detailed procedures for conducting a poll, and answered questions from shareholders.

The Chairman of the meeting exercised his power under the Company's Articles of Association to put each resolution set out in the notice to be voted by way of a poll. Representatives of the Share Registrar of the Company were appointed as scrutineers to monitor and count the poll votes cast at the 2023 annual general meeting. Since the Company's 2009 annual general meeting, all the resolutions put to vote at the Company's general meetings were taken by poll. Poll results were posted on the websites of the Company and the Stock Exchange.

5. 公司秘書

5. COMPANY SECRETARY

The Company Secretary, Ms Ho Sau Fun Connie, is responsible to the Board for ensuring that the Board procedures are followed and the Board activities are efficiently and effectively conducted. These objectives are achieved through adherence to proper Board procedures and the timely preparation and dissemination of meeting agendas and papers to the Directors. Minutes of all meeting of the Board and the Board committees are prepared and maintained by the Company Secretary to record in sufficient details the matters considered and decisions reached by the Board or the Board Committee. All minutes are sent to the Directors and are available for inspection by any Director upon request.

The Company Secretary is responsible for ensuring that the Board is fully apprised of all legislative, regulatory and corporate governance developments relating to the Group and that it takes these into consideration when making decisions for the Group.

The Company Secretary is also directly responsible for seeking to ensure the Group's compliance with all obligations under the Listing Rules and The Codes on Takeovers and Mergers and Share Repurchases, including the preparation, publication and dispatch of annual reports and interim reports within the time limits set out in the Listing Rules and the timely dissemination of the same to the Shareholders.

Furthermore, the Company Secretary advises the Directors on their obligations for disclosures of interests and dealings in the Group's securities, connected transactions and price-sensitive information and ensures that the standard and disclosures required by the Listing Rules are observed and, where required, reflected in the annual report of the Company.

The appointment and removal of the Company is subject to Board approval in accordance with the Articles of Association of the Company. All members of the Board have access to the advice and service of the Company Secretary.

Ms. Ho Sau Fun Connie was appointed as the Company Secretary of the Company in February 1996 and has day-to-day knowledge of the Group's affairs. Ms. Ho Sau Fun Connie has confirmed, following specific enquiry made by the Company that she has complied with all the qualifications, experience and training requirements of the Listing Rules.

6. SHAREHOLDERS' RIGHTS

Set out below are procedures by which Shareholders may: (1) calling for extraordinary general meeting; (2) putting forward enquiries to the Board and (3) putting forward proposals at general meetings. These procedures are generally governed by the provisions of the Company's Articles of Association and applicable laws, rules and regulations, which prevail over what is stated in this section in case of inconsistencies.

1. 股東召開股東特別大會之程序

根據香港法例第622章《公司條例》(「公司條例」)，佔全體有權在股東大會上表決的股東的總表決權最少5%之本公司登記股東，可要求召開本公司股東特別大會(「股東特別大會」)。有關呈請(a) 須列明該會議上處理之事務之概略性質，(b) 須由各呈請人簽署，及(c) 須送交本公司位於香港灣仔港灣道18號中環廣場49樓4901室之註冊辦事處(「註冊辦事處」)，並註明收件人為公司秘書。倘決議案將以特別決議案形式提出，則有關呈請必須包含該議決案之文本，並指明擬採用特別議決案形式提出該議決案之意向。有關呈請可包含若干份格式相近之文件，每份文件由一位或多位呈請人簽署。

董事須於有效呈請遞交日期起計21日內召開股東特別大會。有關大會將於召開大會通告發出日期起計28日內舉行。倘董事未能按上述方式召開股東特別大會，呈請人或佔全體該等呈請人的總表決權過半數的呈請人，可自行召開股東特別大會。股東特別大會須於呈請遞交日期起計3個月內召開。呈請人因董事未有妥為召開股東特別大會而產生之任何合理費用，須由本公司償付予呈請人。

1. Calling for Extraordinary General Meeting by Shareholders

Under the Companies Ordinance, Chapter 622 of the Laws of Hong Kong (the “CO”), registered shareholder(s) of the Company representing at least 5% of the total voting rights of all the shareholders having a right to vote at general meetings may request to call an extraordinary general meeting (“EGM”) of the Company. The request (a) must state the general nature of the business to be dealt with at the meeting, (b) must be signed by the requisitioner(s), and (c) must be deposited at the registered office of the Company (the “Registered Office”) at Suite 4901, 49/F., Central Plaza, 18 Harbour Road, Wanchai, Hong Kong for the attention of the Company Secretary. If the resolution is to be proposed as a special resolution, the request should include the text of the resolution and specify the intention to propose the resolution as a special resolution. The request may consist of several documents in like form, each signed by one or more requisitioner(s).

The Directors must call an EGM within 21 days from the date of the deposit of the valid request. Such meeting should be held on a date not more than 28 days after the date of the notice convening the meeting. If the Directors fail to call the EGM as aforesaid, the requisitioner(s), or any of them representing more than one-half of the total voting rights of all of them, may themselves call the EGM. The EGM must be called for a date not more than 3 months after the date of the deposit of the request. Any reasonable expenses incurred by the requisitioner(s) by reason of the failure of the Directors duly to call an EGM shall be reimbursed to the requisitioner(s) by the Company.

The Company must ensure that the copy of proposed written resolution is accompanied by guidance as to how to signify agreement to the resolution and the day by which the resolution must be passed.

7. INSURANCE FOR DIRECTORS' AND OFFICERS' LIABILITIES

During the year, the Company has arranged for the renewal of an insurance policy on directors' and officers' liabilities in respect of legal actions against the Directors and officers of the Company and its subsidiaries arising out of corporate activities of the Group.

During the year, the fees paid or payable to external auditors of the Company, Grant Thornton Hong Kong Limited, was approximately HK\$780,000 for statutory audit services rendered to the Group. The Group has also engaged external auditor to perform non-audit services and the fee paid was approximately HK\$150,000.

The Group also appointed other external auditors for the statutory audit purposes of certain overseas subsidiaries and their remuneration for audit services rendered was approximately HK\$84,000.

9. CORPORATE SOCIAL RESPONSIBILITIES

Environmental Policy

Our commitment to protect the environment is well reflected by our continuous efforts in promoting green measures and awareness in all business practices. The Group has introduced a green policy to enhance the awareness of environmental protection among staff with the aims of saving energy, fully utilizing resources and recycling wastes in daily office operation.

For the past years, the Group had undertaken initiatives to reduce paper usage including usage of electronic devices, and encouraging the use of websites and online version of corporate communications. To reduce the power consumption, lighting and equipment will be turned off when not in use. Our Group is using office equipment carries Energy Label issued by the Electrical and Mechanical Services Department which save the energy in the offices.

重要性評估

卓能重視持份者所提出的意見。考慮到持份者的期望，我們分析了多項環境、社會及管治報告事宜的重要性。為識別業務營運的影響，已考慮多項因素，包括業務策略目標和政策、行業標準、法律及監管責任、環境保護、資源使用、質量控制及僱員保障。

重要性評估的程序如下：

第1步：識別—參考《環境、社會及管治報告指引》所載列之可持續發展議題以及行業內可持續發展之最新趨勢，已識別16項對持份者及我們的業務營運具有較高重要性的環境、社會及管治事宜：

MATERIALITY ASSESSMENT

Cheuk Nang values the opinion given by stakeholders. Taking the stakeholders' expectations into consideration, we analysed the importance of various ESG issues. Factors such as business strategy objectives and policies, industry standards, legal and regulatory responsibilities, environmental protection, use of resources, quality control and employee protection, etc. were considered in order to identify the impact of the business operations.

The procedures for the materiality assessment are as follow:

Step 1: Identification – With reference to the sustainability topics listed in the ESG Reporting Guide and the latest sustainability trends in the industry, 16 ESG issues were identified where they posed higher importance to both stakeholders and our business operation:

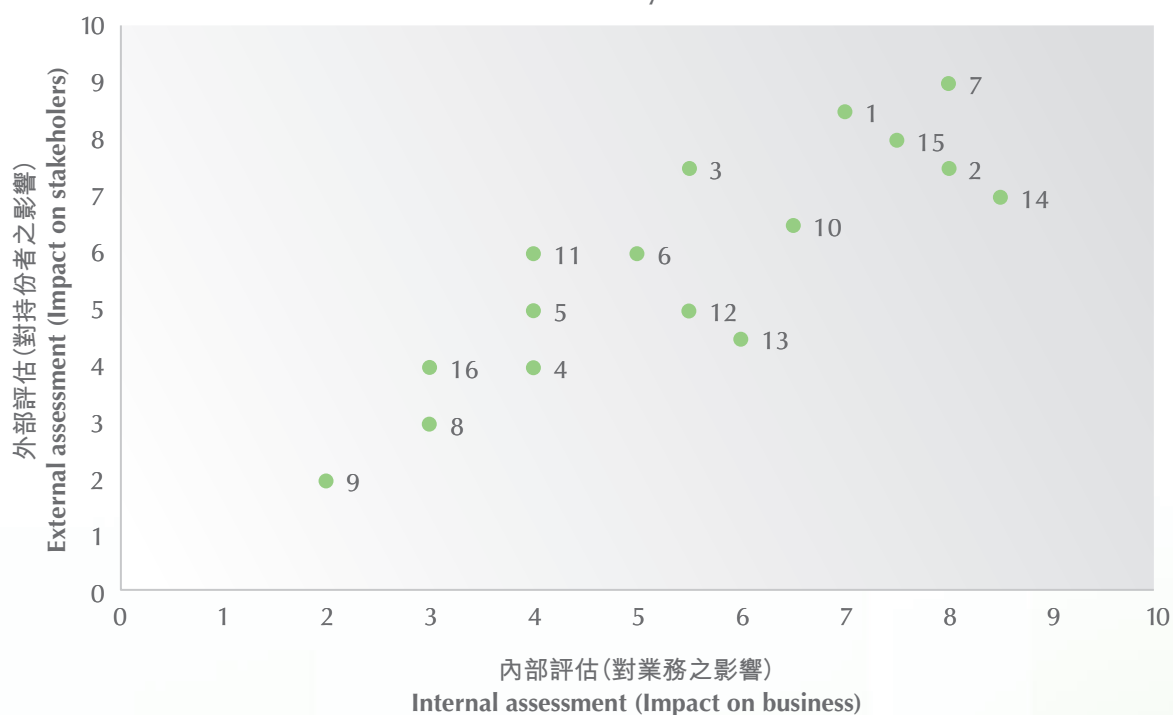

第3步：應用 – 為處理對我們及持份者最重要的事宜，卓能對該等重要事宜的回應於本報告以下章節進行更詳細闡述。

Step 3: Application – To address the most mattered issues to us as well as our stakeholders, Cheuk Nang's responses to these important issues have been elaborated in more details in the following sections of this report.

A. 環境

卓能明白，業務運作會對周圍環境產生一定的影響，並且明白，為減少環境影響，其有責任在發展的各項業務中採用環保做法。為實現減少對環境的不利影響，追求長期可持續發展的目標，本集團積極融入綠色環保概念，並在項目和日常辦公室運作中實施一系列環保措施。

A. Environmental

Cheuk Nang understands that business operation will exert certain impacts on the surrounding environment, and it is our responsibility to adopt environment-friendly practices across business development in order to minimize impacts on the environment. In order to achieve the goal to alleviate adverse impacts on the environment and pursuing long-term sustainable developments, the Group actively integrates green protection concepts and implemented a series of environmental protection measures into our projects and daily office operations.

與去年相似，於本報告年度，卓能持續進行中的建築項目有限，業務營運以物業租賃及提供物業管理服務為主，而其主要在辦公室環境營運。

A1: 排放

溫室氣體 (溫室氣體) 排放

汽車的燃料消耗及商務差旅航班是我們營運中廢氣排放的主要來源。為了減少溫室氣體排放，我們的汽車須定期保養，以確保燃料效益，我們亦鼓勵僱員使用視像及電話會議設備，以減少面對面開會。這些做法不僅為本集團帶來節省成本的好處，亦有助降低本集團的碳足跡及減少排放。

我們的營運的另一個主要溫室氣體排放來源是辦公室的用電。本集團通過提供持續的培訓及張貼節能提示，教育和鼓勵員工致力於良好的節能常規。

我們致力遵守香港《空氣污染管制條例》，加強污染管制及保護環境。於本報告年度，卓能產生83.90噸二氧化碳當量排放，及產生6.27千克氮氧化物、0.37千克硫氧化物及0.46千克顆粒物。本年度溫室氣體排放總量較上一報告年度輕微增加1%，主要原因為在旗下日常營運中使用汽車及航空差旅。

Similar to last year, Cheuk Nang had limited number of ongoing construction projects during the Reporting Year, and the business operation were mainly focused on property leasing and provision of property management services that mainly operated in an office setting.

A1: Emissions

Greenhouse Gas (GHG) Emissions

Fuel consumption by motor vehicles and flights taken for business trips are the main sources of air emissions in our operation. With the aim to reduce greenhouse gas emissions, our vehicles are required to take regular maintenance to ensure fuel efficiency, while we also encourage employees to utilize video and phone meeting equipment to reduce face-to-face meetings. Not only do these practices bring cost-saving benefit to the Group, it also contributes in lowering the carbon footprint and emission reduction of the Group.

Another main source of GHG emissions from our operation comes from the electricity consumption in our office. The Group have educated and encouraged our staff to commit on good energy-saving practices by providing continuous training and affixing energy saving reminders.

We commit to comply with the Air Pollution Control Ordinance in Hong Kong to strengthen pollution control and protect the environment. During the Reporting Year, Cheuk Nang generated 83.90 tons of carbon dioxide equivalent emissions, produced 6.27 kg of nitrogen oxides, 0.37 kg of sulphur oxides and 0.46 kg of particulate matter. This year, the total greenhouse gas emission was slightly increased by 1% comparing with the last reporting year, which was mainly due to the use of vehicles and business air travels within our daily operations.

本集團於二零二一／二二財政年度已設定目標，最遲於二零二六年將溫室氣體排放減少最少5%。為實現此目標，本集團一直積極揀選清潔及效益高的能源，並致力於減少能源消耗，以減少直接及間接的溫室氣體排放。儘管由於旗下經營業務有所增加，導致我們的溫室氣體排於本年度內有所增加，然而，與二零二一／二二財政年度相比，我們的溫室氣體排放密度下降11%。展望未來，我們將會繼續評估我們的溫室氣體排放及分別對我們的持份者及旗下業務的影響，並調整我們的排放目標（如適用）。

廢棄物

於本報告年度，卓能在香港的建築工程有限且主要外判予外部承建商。建築地盤的大部分有害及無害廢棄物已由第三方承建商按照香港《廢物處置條例》處理及處置，因此，有關建築廢棄物的可得資料有限。就辦公室環境的日常運作而言，卓能主要產生可回收廢棄物，即紙張及生活垃圾，乃由物業管理服務供應商處理。

為盡量減少紙張浪費及生活垃圾，本集團向前邁進一步，應用「4R」概念（即減少使用、廢物利用、替代使用及循環再造的方法），有關措施如下：

- 盡量採用電子通訊方式（例如電郵、流動裝置及網站）及以電子方式存檔；
- 雙面列印文件及於列印前調整列印範圍；

The Group have set the target in FY2021/22 to reduce GHG Emissions by at least 5% by 2026. In order to achieve the target, the Group has been actively choosing clean and efficient energy and is committed to downsizing energy consumption to reduce direct and indirect GHG emissions. While our GHG Emissions have increase this year due to our increase in operations, we have a reduction of 11% on the Intensity of greenhouse gas emission comparing to FY2021/22. Looking ahead, we will continue to assess our GHG emissions and influence on our stakeholders and our business respectively, and adjust our emission targets if applicable.

Wastes

During the Reporting Year, Cheuk Nang had limited construction works in Hong Kong and they were mainly outsourced to external contractors. Most of the hazardous and non-hazardous wastes in construction sites have been handled and disposed by third-party contractors in accordance with the Waste Disposal Ordinance in Hong Kong, hence there is limited information available regarding the construction waste. For the daily operation in office setting, Cheuk Nang mainly generated recyclable wastes – papers and domestic garbage, which are handled by the property management service provider.

To minimize the waste of papers and domestic garbage, the Group applies the concept of “4R” (i.e. Reduce, Reuse, Replace and Recycle approach) by taking a step forward as below:

- Adopt electronic means of communications (such as email, mobile and website) and electronic filing of documents as far as possible;
- Use duplex printing for documents and adjusting the print area before printing;

- 重複使用廢紙，將其用作列印文件的草擬本；
 - 收集已經使用的紙張以供循環再造；
 - 評估材料的使用情況，以免存貨過多；及
 - 就廢物源頭分類為僱員提供指導及指示。
- Reuse waste paper for printing draft documents;
 - Collect used paper for recycling;
 - Evaluate the usage of material to avoid overstock; and
 - Provide guidance and instruction to employees on source separation of waste.

於本報告年度，本集團消耗0.70噸紙張，較去年增加17%。為保護自然環境，並防止資源浪費，本集團的目標為最遲於二零二六年將紙張浪費減少最少5%。我們已經在整個業務運作中採用綠色辦公管理，以進一步減少在日常營運中產生的廢棄物。本集團將會繼續鼓勵員工使用電子文件，而非紙本文件；及使用雙面打印方法。另外亦在辦公室複印機附近放置回收箱，以收集可重用的紙張（即只打印了一面的紙張）。

During the Reporting Year, the Group consumed 0.70 tons of paper, which accounts for an increase of 17% when compared to the previous year. In order to protect the natural environment and prevent waste of resources, the Group aims to reduce waste of paper by at least 5% by 2026. We have adopted green office management on our entire business operations to further reduce waste generation in the daily operations. The Group will continue to encourage the staff to use electronic documents rather than paper copies; and use double sided printing method. Recycling boxes near office photocopiers are also placed to collect paper that can be reused (i.e. those printed on only one side).

A2: 資源使用

能源、水及其他消耗

電力是我們營運使用的主要資源，其主要用於各辦公室設備，例如電腦、打印機及燈泡。我們積極採取了一系列節能措施，以實現資源的高效使用，例如將辦公室的溫度保持在24至26攝氏度，關閉不必要的照明，並採用帶有能源效益標籤的節能設備。卓能明白，減少能源消耗不僅可減少溫室氣體排放，亦可以為本集團減少不必要的開支，我們計劃在未來更換為設有自動低電量模式或節能模式的電燈或設備，以達到儘量減少能源消耗的目標。於本報告年度，本集團的用電量為16.20兆瓦時，較二零二二／二三年度減少8%，因此有望實現最遲於二零二六年將能源消耗減少最少5%的目標。

由於供水由物業管理服務供應商控制，因此目前並無有關辦公室運作用水的資料。儘管如此，卓能鼓勵僱員儘量減少用水，以建立節約用水意識。此外，我們亦在辦公場所張貼節水告示，以宣傳及提醒旗下僱員減少水的浪費。於報告期內，本集團在求取水源上並無任何問題。另一方面，作為物業發展商，由於卓能的日常業務營運過程並無涉及包裝，故於本報告年度包裝材料使用量並不適用。

A2: Use of Resources

Energy, water and other consumption

Electricity is the main resource used in our operation, which is consumed by various office equipment, e.g. computers, printers and light bulbs. We have proactively taken a series of energy-saving measures to achieve efficient use of resources, such as to keep the office temperature at 24 to 26 degrees Celsius, turning off unnecessary lighting, and deploying energy-efficient devices which carry energy efficiency label. Cheuk Nang understands that reducing energy consumption not only cut greenhouse gas emissions but also reduces unnecessary expense for the Group, we plan to replace lighting or equipment with automatic low power mode or energy-saving mode with the objective of minimizing energy consumption in the future. During the Reporting Year, the Group consumed 16.20 MWh of electricity, which was reduced by 8% compared to 2022/23, and are therefore on track to meet the target of reducing energy consumption by at least 5% by 2026.

As the water supply is controlled by the property management service provider, information on the consumption of water incurred from our daily office operation is currently unavailable. Nevertheless, Cheuk Nang have encouraged its employees to minimize their water usage in order to build awareness of water conservation. Water-saving signs were also put up within the office premises in order to promote and remind our employees to reduce water wastage. During the Reporting Period, the Group did not encounter any issues in sourcing water. On the other hand, since packaging is not involved in the usual course of Cheuk Nang's business operations as a property developer, the use of packaging material during the Reporting Year is not applicable.

A3: 環境及天然資源

誠如上文所披露，由於本集團對環境的主要影響來自日常辦公室運作使用汽車、用電及紙張消耗，因此，香港業務營運的環境影響有限。儘管如此，卓能知道保護環境對社會及下一代的福祉的重要性。我們致力通過盡可能採用更多節約資源及環保的方法，在未來進一步減輕對環境的不利影響，並提高我們的員工及業務夥伴的環保意識，進而共同為實現可持續發展的目標作出貢獻。

A4: 氣候變化

隨著氣候變化問題在近年變得更為常見，各國亦回應公眾的要求，在不同行業進行合作以實行可持續發展。與此同時，公司亦加強力度推行其節能及減排措施。卓能明白，氣候變化的不同風險可能會對其業務運作產生潛在財務影響，因此，我們努力識別其業務活動的環境影響，並小心管理旗下經營業務，以在可能情況下儘量減少有關影響。此外，我們希望將更多的可持續發展元素及行動融入我們的業務運作中，為我們應對氣候變化可能產生的問題做好準備。於二零二一／二二財政年度，我們根據二零二一／二二財政年度溫室氣體排放、廢物及能源消耗的水平訂立了未來五年有關減少溫室氣體排放、廢物及能源消耗的目標，減少最少5%，目前正步入正軌實現目標。展望未來，我們將會繼續每年披露實現目標的進展，並於必要時不斷評估及更新我們的可持續發展目標。

A3: Environment and Nature Resources

As disclosed above, since the major environmental impact of the Group are mainly contributed by the use of mobile vehicles, usage of electricity and the consumption of paper in our daily office operations, our environmental impacts regarding the business operation in Hong Kong are limited. However, Cheuk Nang is aware of the importance in protecting the environment for the well-being of the society and the future generations, and are committed to further alleviate the adverse impact on the environment in the future by adopting more resource-saving and environmentally-friendly measure whenever possible, and enhance the environmental awareness of our staff and business partners, and contribute to the collective goal of sustainable development.

A4: Climate Change

As climate change is becoming a more prevalent issue in recent years, countries have been cooperating to implement sustainable development in different industries in responding to public demand. Meanwhile, there is also an increase in effort from companies with its energy conservation and emission reduction measures. Cheuk Nang understands that various risks of climate change may potentially have a financial impact on our business operations, hence we took effort in identifying the environmental impacts attributable to its business activities, and have carefully managed our operation in order to minimize these impacts where possible. Furthermore, we are hoping to incorporate more sustainable development elements and actions to our business operations to prepare us from issues that may arise from climate change. In FY2021/22, we established our reduction target by reducing our GHG emissions, waste and energy consumption by at least 5% in the next 5 years based on FY2021/22 levels for GHG Emissions, waste and energy consumption, and are currently on track to achieve the targets. Looking forward, we will continue to disclose our progress in achieving the targets annually, and will continuously assess and update our sustainability targets if necessary.

除減少本集團業務營運所造成的環境影響外，卓能已識別氣候變化所造成而會對本集團的業務產生重大影響的實體及過渡風險。

實體風險

我們相信，氣候變化帶來的極端天氣變化將會是商業活動無可避免的氣候風險之一，極端天氣事件如大型山火、地震及颱風將會為生活環境帶來危險，並影響到我們的財產及營運，其最終會導致收入損失。為處理該等實體風險，本集團訂有內部指引，讓僱員及部門應對大型災害及緊急情況，其將會定期檢討及改善，以降低業務運作的氣候風險。

過渡風險

由於市場目標為邁往低碳及更加氣候友善的未來，監管機構正在並將繼續透過收緊環境規例及氣候相關立法，要求公司須就可持續發展報告依循越趨嚴格的披露規定，並要求公司對排放進行更多控制。此外，投資者、客戶及其他持份者越趨意識到公司的可持續發展表現以及其對綠色業務經營的承諾。本集團意識到，倘若不能應對該等變化，將面臨失去市場競爭力、潛在聲譽風險以及法律風險等潛在的風險。

Other than reducing the environmental impact caused by the Group's business operations, Cheuk Nang have identified the physical and transition risks caused by climate change that may have material impact on the Group's business.

Physical Risks

We believe that extreme weather changes brought about by climate change will be one of the unavoidable climate risks for business activities, and extreme weather events such as large-scale wildfires, earthquakes and typhoons will bring dangers to the living environment and affect our properties and operations, which ultimately result in loss of revenue. In response to these physical risks, the Group has internal guidelines in place for employees and departments to respond to major disasters and in cases of emergency, which will be regularly reviewed and improved to reduce the climate risk to the business operations.

Transition Risks

As the market is aiming towards a low-carbon and more climate-friendly future, regulators are and will continue to tighten environmental regulations and climate-related legislations, where companies are required to follow increasingly stringent disclosure for sustainability reporting, and are required to assert more control to their emissions. Moreover, investors, customers and other stakeholders are becoming more aware of the sustainability performance from corporations and their commitment to conduct green businesses. The Group recognises the potential risks such as losing market competitiveness and potential reputational risks and legal risks when failing to respond to such changes.

為處理該等過渡風險，本集團密切監察商業環境及相關法律及規例的改變，並已考慮氣候相關財務披露工作小組(Task Force on Climate related Financial Disclosures, TCFD)的建議，以加強管治程序，並將環境及氣候相關風險及機遇的考慮融入我們未來的風險評估。

B. 社會

卓能知道發展互惠互利的社區對於實現可持續發展和繁榮的重要性，並將社會責任植根於業務的各個方面。本集團將繼續透過改善我們的貢獻和服務來奉獻社會。

B1: 僱傭

員工是我們長期業務成功的基礎。卓能致力為員工營造一個尊重、和諧的工作環境，以提升員工的工作積極性及動力。

本集團以具競爭力的薪酬待遇、慷慨的福利及利益吸引及留住人才。本集團亦理解並尊重不同文化。我們依循平等就業的原則，讓僱員能夠享有公平合理的就業及競爭機會。在安排工作及調職時，卓能為所有僱員提供平等機會，不會因為性別、年齡、人種、國籍、籍貫、種族、宗教、政治聯繫、性傾向、婚姻狀況及其他方面的多元性而對不同的背景或身份差別對待。我們亦通過公平及非歧視的評估程序進行晉升及薪酬調整。

In order to deal with these transition risks, the Group closely monitors the changes in the business environment and relevant laws and regulations, and have taken account into the recommendations of Task Force on Climate-related Financial Disclosures (TCFD) to enhance the governance processes and integrate the consideration of the environmental and climate-related risks and opportunities into our future risk assessment.

B. Social

Acknowledging the significance of developing a mutually beneficial community for sustainability and prosperity, Cheuk Nang ingrains social responsibility into all aspects of operations. The Group will continue to devote to the society through improving our contribution and services.

B1: Employment

Employees are the foundation of our long-term business success. Cheuk Nang is dedicated to build a respectful and harmonious workplace in order to enhance the working incentives and motivations of our staff.

The Group attracts and retains talents with competitive remuneration packages, generous welfare and benefits. The Group also understands and respects different cultures. We adhere to the principle of equal employment so that employees can enjoy fair and reasonable employment and competitive opportunities. When arranging jobs and repositioning, Cheuk Nang provides equal opportunity to all employees regardless of gender, age, ethnicity, nationality, native place, race, religion, political affiliation, sexual orientation, marital status and other aspects of diversity and treat different backgrounds or identities differently. We also promote and make salary adjustment by a fair and non-discriminatory evaluation procedure.

本集團為員工提供有競爭力的薪酬、假期福利及酌情花紅。所有員工均根據香港《僱傭條例》、《最低工資條例》及香港《強制性公積金計劃條例》享有醫療福利、五天半工作周安排、強積金計劃、退休福利、年假、婚假、產假及其他休假。為了解我們需要改進的地方，我們會努力解決員工的關注或投訴。正如本集團的「操守準則」政策所述，投訴可直接向執行主席提出，而所有的反饋及投訴均會在保密的情況下處理。對於離職員工，我們會與彼等進行離職面談，以聽取他們對卓能的意見及反饋。解僱員工須按香港《僱傭條例》及／或其他相關的本地法律及法規執行。

The Group provides employees with competitive compensation, holiday benefits and discretionary bonus. All of our staff are entitled to the medical benefits and a 5.5 working days arrangement, MPF schemes, retirement benefits, annual leaves, marriage leave, maternity leave and other leaves in line with the Employment Ordinance of Hong Kong, Minimum Wage Ordinance and Mandatory Provident Fund Schemes Ordinance of Hong Kong. To understand our areas of improvement, we try to address the concern or complaints from our staff. As stated in the Group's policy "Code of Conduct", complaints could be sent directly to the Executive Chairman, and all the feedback and complaints will be handled with confidentiality. For leaving staff, we organise an exit interview with them in order to listen to their opinions and feedbacks towards Cheuk Nang. Dismissal of employees is executed in compliance with the Employment Ordinance of Hong Kong and/or other relevant local laws and regulations.

B2: 健康與安全

卓能關心員工的才能，並將員工的健康和安全放在首位。我們始終嚴格遵守《職業安全及健康條例》，在建築地盤採取必要的安全措施，以避免職業危害，包括預防酷熱及嚴寒氣候之工具、消音耳塞、絕緣鞋及手套以及防靜電衣服。此外，卓能定期檢驗地盤的滅火器及其他消防設備，以確保其有效運作。每宗受傷或事故個案及隱患均須及時上報，並須就此採取補救行動，以提高工作場所的安全性。於二零二一／二二、二零二二／二三及二零二三／二四財政年度內，並無因工死亡及因工傷而損失的工作日的報告個案。

為確保工作環境衛生，本集團定期聘請專業服務供應商為辦公室進行空調系統清潔、滅蟲及地毯消毒處理，以殺滅病毒及細菌。作為安全措施，我們亦為所有員工提供急救箱及醫療保險。卓能亦鼓勵員工參與由物業管理服務供應商舉辦的消防演習，以訓練彼等在火警緊急情況時作出反應的能力。本集團亦已就緊急情況下的工作安排設立指引，例如颱風、暴雨警告、罷工、示威及其他情況。

B2: Health and safety

Cheuk Nang cares about employees' talent and places their health and safety at the top position. We strictly comply with the Occupational Safety and Health Ordinance at all times and take necessary safety measures in construction sites to prevent occupational hazards, including precautionary tools against extreme summer heat and winter coldness, noise cancelling earplugs, insulated boots and gloves, and antistatic clothing. In addition, Cheuk Nang periodically inspects the fire extinguishers and other fire prevention equipment at sites to ensure their effectiveness. Every case of injury or accident and potential danger must be reported, and remediation action shall be taken to improve the safety of workplaces. There was no reported case for work-related fatalities and lost days due to work injury in the financial year of 2021/22, 2022/23 and 2023/24.

To ensure a hygienic working environment, the Group periodically engages professional service providers to carry out air-conditioning system cleaning, pest control and carpet disinfection treatment in the office for the killing of viruses and bacteria. We also provide first-aid kits as well as medical insurance to all staff as safety measures. Cheuk Nang also encourages staff to join the fire drill organised by the property management service provider to train their readiness in responding to fire emergencies. The Group has also set up guidance for work arrangements in emergencies, such as typhoons, rainstorm warnings, strikes, protests and other circumstances.

B3: 發展及培訓

本集團明白為了讓員工以高水準履行職責以及為了其本身之事業發展，有需要為僱員提供培訓。為支持員工發展及維持其競爭力，我們向員工提供在職培訓。有關培訓涵蓋不同課題，不僅包括有關其職位的職業技能，亦包括健康及安全以及操守準則。此外，本集團亦鼓勵員工參與由政府或相關認可機構（例如職業訓練局及職業安全健康局）舉辦的外部培訓計劃，以提升其工作相關技能、保持知識與時並進及分享經驗及其他專業知識。

B4: 勞工準則

人權被認為是基本權利，而我們完全同意聘用童工及強制勞工違反國際勞工公約之基本人權協議。因此，卓能非常重視公平，並嚴格遵守香港《僱傭條例》及相關法律及法規。在簽訂僱傭合約前，卓能會檢視身份證明文件及對應徵者進行背景審查，以防止與15歲以下人士建立僱傭關係。此外，本集團嚴格遵守僱傭合約，且不會強制員工在違背意願或受任何脅迫的情況下工作。我們向超時工作的員工提供補償休假，且彼等可在向本集團發出通知後隨時辭職。

B3: Development and training

The Group understands the need for staff training to carry out their duties at a high standard and for their own career development. To support the development of employees and maintain their competitiveness, we provide on-the-job training to employees. The training covers a range of topics that not only include technical skills relevant to their positions, but also on health and safety and codes of conduct. Besides, the Group also encourages employees to attend external training programs held by the government or relevant recognised institutes, such as Vocation Training Council and Occupational Safety and Health Council, to enhance their work-related skills, maintain up-to-date knowledge, and share experiences among other expertise.

B4: Labour standards

Human rights are considered to be a fundamental right, and we fully agree that hiring child labour and forced labour violates the fundamental human rights protocol of international labour conventions. Thus, Cheuk Nang places great emphasis on fairness and strictly abide by the Employment Ordinance and relevant laws and regulations in Hong Kong. Cheuk Nang reviews the identity documents and conducts background checks relating to candidates prior to signing an employment contract to prevent having an employment relationship with a person under 15. Also, the Group strictly follows our employment contracts and will not force our staff to work against their will or under any kind of threat. We offer compensation of leave to staff who works overtime and they are free to resign upon notice to the Group.

B5: 供應鏈管理

作為物業發展商，卓能聘請承建商進行建築工程，並自行購買部分物料及消耗品。正如本集團的政策「操守準則」所述，我們提倡公平及公開的競爭，並致力與供應商及承建商建立長期互信的關係。為確保我們的承建商及供應商同樣有以公平及有誠信的方式營商的商業理念，供應商及承建商與卓能進行業務往來前，其必須通過嚴格的評估程序或招標程序。

除了財務及質量方面，供應商及承建商對環境和社會的態度亦是評估標準之一。本集團不會考慮曾牽涉賄賂案件或發生重大安全相關事件或環境事故的供應商或承建商。本集團會對承建商的工程進行持續及定期檢討，確保建築工程的質量符合本集團的標準，以降低環境及社會風險。於本報告年度，本集團在香港分別聘請了4家承建商及10家供應商。今後，本集團將考慮在可行的情況下優先考慮具有環境管理體系證書的供應商及承建商。

此外，本集團將會採取措施，以加強「綠色供應鏈」的發展。我們亦鼓勵供應商採納最佳的環境及社會做法，並透過制定節能減耗政策，將對可持續發展的追求傳播到核心業務。

B5: Supply chain management

As a property developer, Cheuk Nang engages contractors to carry out the construction work and purchase some of the materials and consumables ourselves. We promote fair and open competition, and aims at developing long-term relationship with suppliers and contractors based on mutual trust as stated in the Group's policy "Code of conduct". To ensure our contractors and suppliers share the same business philosophy in running the business with a fair and integrity manner, suppliers and contractors are required to pass through strict assessment procedures or tendering procedures before engaging in business activities with Cheuk Nang.

In addition to the financial and quality aspects, suppliers' and contractors' attitudes toward the environment and the society will also be a part of the assessment criteria. The Group will not consider suppliers or contractors who have been in bribery cases or have incurred incidents related to material safety or environmental incidents. The Group performs on-going and regular reviews on the contractors' works to ensure the quality of the construction works are within the Group's standard to lower the environmental and social risks. During the Reporting Year, the Group engaged 4 contractors and 10 suppliers in Hong Kong respectively. In the future, the Group will consider giving priorities to suppliers and contractors with Environmental Management System Certificates when feasible.

Besides, the Group will adopt initiatives, to enhance the development of "green supply chain". Our suppliers are also encouraged to adopt the best environmental and social practices and to disseminate the pursuit of sustainability into the core business, through develop energy-saving and consumption-reducing policies.

B6: 產品責任

保證產品的質量和安全至為重要。卓能關心客戶，並制定高標準，以確保物業的建築質量和商業價值。產品質量的控制貫穿於整個建築過程和持續的管理與維護中。在項目開始階段，我們對物料、供應商及承建商進行嚴格的篩選程序。我們充分注意監督承建商進行的工作，並在項目完成後採取詳細的驗收程序，以確保我們的全部要求均已獲嚴格遵守。在進行一系列的質量審核以確保產品安全及符合標準後，於本報告年度，我們並無任何有關產品安全的召回記錄。

鑒於公眾對數據私隱的關注，本集團收到的所有與業務運營有關的個人資料均按照《個人資料(私隱)條例》及類似法規的規定謹慎處理，以滿足主要持份者對資料安全及保密的期望。正如「操守準則」政策所強調，每位董事及員工均有責任提供足夠的保護措施，以防止客戶、商業夥伴、股東和客戶的個人資料被濫用或誤用。為了保護數據的機密性，只有經授權的人員方能取得此等個人資料。

本集團尊重所有知識產權。為避免侵犯知識產權及遵守相關許可條款，本集團已禁止員工使用盜版軟件，以及複製、安裝或使用違反其版權或許可條款的軟件。

B6: Product responsibility

Assuring the quality and safety of our products are the topmost important. Cheuk Nang cares about customers and set high standards to ensure the architectural quality and commercial values of the properties. Product quality is controlled throughout the construction processes and ongoing management and maintenance. We perform tight selection procedures of materials, suppliers and contractors at the beginning stages of the projects. We pay full attention to monitoring the work performed by the contractors and take detailed acceptance procedures upon completion of the project to ensure all our requirements have been strictly followed. After taking a series of quality audits to ensure our products were safe and up to standard, we did not record any product recall concerning the products safety during the Reporting Year.

In view of the matters of public concern over data privacy, all the personal information received from the Group regarding our business operations has been handled with due care and in accordance with the Personal Data (Privacy) Ordinance and similar regulations to fulfil key stakeholders' expectations on information security and confidentiality. As emphasized in the policy "Code of Conduct", it is the responsibility of each director and employee to provide adequate safeguards to prevent the personal data of customers, business partners, shareholders and customers to be abused or misused. To preserve the confidentiality of the data, only authorised persons have access to such personal data.

The Group respects all intellectual property rights. To avoid infringing intellectual property rights and to comply with relevant licensing terms, the Group has prohibited employees from using a pirate version of software as well as duplicating, installing or using the software in violation of its copyright or license terms.

In case of any complaints related to product quality, data privacy or intellectual property rights, Cheuk Nang will strictly follow the complaints handling procedures as stated in the policy “Code of Conduct” to ensure the complaints will be investigated and handled with due care.

B7: 反貪污

所有員工(包括董事)均須按照本集團的「操守準則」政策及香港法例第21章《防止賄賂條例》的規定，恪守道德規範，提倡公平競爭，並採取行動反對賄賂。本集團對任何類型的非法活動(包括貪污、賄賂、洗錢、偽造、盜用公款及勾結個案)採取零容忍態度。本集團已設立明確的舉報渠道，供所有員工舉報任何個人或部門的違法行為。本集團致力保護舉報人，並對其身份進行保密。此外，所有員工不得就其職責及本集團的業務接受或索取任何個人利益或好處。任何有利益衝突的人士必須申報並獲得本集團的事先書面批准。

B7: Anti-Corruption

All employees, including directors, shall uphold the code of ethics, advocate fair competition and act against bribery according to the Group’s policy “Code of Conduct” and Prevention of Bribery Ordinance (Cap.21) of Hong Kong. The Group takes zero-tolerance towards all kinds of illegal activities, such as corruption, bribery, money laundering, forgery, embezzlement and collusion case. The Group has set up a clear reporting channel for all staff to report any violation noted from an individual or its departments. The Group is committed to protect the whistle-blower and keep his identity confidential. In addition, all staff shall not accept or request any personal benefit or advantage in connection with his or her duties and with the business of the Group. Anyone who has conflicts of interest must declare and obtain prior written approval of the Group.

對於任何違反法律或本集團制定的「操守準則」的行為，卓能均會毫不猶疑地採取紀律行動而不會姑息。於本報告年度，並無就貪污行為針對卓能或其僱員提起的法律案件，而我們已嚴格遵守《防止賄賂條例》。

In case of any violation of laws or “Code of Conduct” established by the Group, Cheuk Nang adopts disciplinary actions with no mercy and hesitation. During the Reporting Year, there was no legal case regarding corrupt practices that was brought against Cheuk Nang or its employees, and we strictly complied with the Prevention of Bribery Ordinance.

卓能透過電子培訓、文章及視頻為董事及僱員提供反貪污培訓，以加強全體僱員的誠信意識及專業道德，從而創造公平及誠實的工作環境。由於人力資源部的資源有限，因此，卓能於本報告年度內並無就僱員的反貪污培訓保存培訓記錄。

Cheuk Nang provides anti-corruption training to Directors and employees through e-training, articles and video in order to strengthen the integrity awareness and professional ethics of all employees, so as to create a fair and honest working environment. Due to limited resources of the Human Resources Department, Cheuk Nang did not maintain training record in the anti-corruption training by employees during the Reporting Year.

BUSINESS REVIEW

Key Audit Matter

Assessment of the net realisable value of properties held for sale

Refer to Notes 2.9, 4.1 and 19 to the consolidated financial statements.

As at 30 June 2024, the Group had properties held for sale amounting to approximately HK\$2,980,122,000.

Properties held for sale are stated at the lower of cost and net realisable value. Net realisable value represents the estimated selling price less estimated costs of completion and costs to be incurred in selling the property. The net realisable value was determined by the Group with reference to the valuation performed by independent qualified external valuers. Given the significant judgements and estimates used in assessing the net realisable value of properties held for sale, such assessment is considered significant to our audit.

Management concluded no impairment on the properties held for sale was recognised for the year ended 30 June 2024.

We focused on this area because the significant estimates and judgement involved in determining the property valuations warrants specific audit focus and attention on this area.

OTHER INFORMATION

The directors are responsible for the other information. The other information comprises all the information in the annual report of the Company, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

1. GENERAL INFORMATION

Cheuk Nang (Holdings) Limited (the “Company”) is a limited liability company incorporated and domiciled in Hong Kong. The address of its registered office is disclosed in the Corporate Information section of the annual report and, its principal place of business is Hong Kong and the People’s Republic of China (the “PRC”). The Company’s shares are listed on The Stock Exchange of Hong Kong Limited.

The Company and its subsidiaries (the “Group”) are controlled by Yan Yin Company Limited (“Yan Yin”), a limited liability company incorporated and domiciled in Hong Kong. At the reporting date, the directors consider the ultimate parent company of the Group is also Yan Yin.

The Group is principally engaged in property development and investment and provision of property management and related services.

The consolidated financial statements for the year ended 30 June 2024 were approved for issue by the board of directors on 24 September 2024.

於二零二四年六月三十日，本集團須於十二個月內償還的計息借款為1,131,508,000港元，而本集團的銀行結餘及現金為881,792,000港元。董事已評估自報告日期起十二個月現金流量預測中使用的相關現有資料及主要假設(更多詳情請參閱附註4.2)，並考慮利用本集團可獲得的剩餘銀行融資約465,103,000港元。此外，雖然若干現有銀行融資將於二零二四年十一月到期，但董事認為，本集團擁有良好的往績記錄及與銀行的良好關係，且本集團將能夠在到期時更新現有銀行融資或獲得其他額外借款融資如有必要。本集團目前正在辦理銀行貸款續約手續。

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 4.

As at 30 June 2024, the Group's interest-bearing borrowings repayable within twelve months of HK\$1,131,508,000 while the Group's bank balances and cash was HK\$881,792,000. The directors have evaluated the relevant available information and key assumptions (see Note 4.2 for more details) used in the cash flow projections for the twelve months since the reporting date and considered utilising remaining banking facilities of approximately HK\$465,103,000 available to Group. In addition, although certain existing banking facilities will expire in November 2024, the directors consider that there are good track records and good relationships with banks, and the Group will be able to renew existing banking facilities upon expiry or to obtain other additional borrowing facilities as necessary. The Group is currently in the progress of renewing of bank loans.

因此，如附註33.3所述，董事認為，考慮到目前可用的借款融資以及成功更新銀行融資的可能性以及本集團的內部財務資源，本集團有足夠的營運資金來滿足未來到期的財務需求。董事認為，不存在可能對本集團持續經營能力產生重大疑問的重大不確定性。因此，綜合財務報表是在持續經營的基礎上編製的。

若本集團無法持續經營業務，則必須在綜合財務報表中進行調整，將資產價值減記至其可變現淨值，並為可能產生的任何進一步負債做好準備，以及將非流動資產和非流動負債分別重分類為流動資產和流動負債。該等調整的影響並未反映在綜合財務報表上。

Therefore, as stated in Note 33.3, the directors are of the opinion that, taking into account the present available borrowing facilities and possibility of successful renewal of banking facilities and internal financial resources of the Group, the Group has sufficient working capital to meet its financial obligation as they fall due for the foreseeable future. The directors consider there are no material uncertainty exist that may cast significant doubt on the Group's ability to continue as a going concern. Accordingly, the consolidated financial statements have been prepared on a going concern basis.

Should the Group be unable to continue in business as a going concern, adjustments would have to be made in the consolidated financial statements to write down the values of the assets to their net realisable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities respectively. The effect of such adjustments has not been reflected in the consolidated financial statements.

綜合財務報表包括本公司及其附屬公司截至每年六月三十日之財務報表。

附屬公司為本集團控制的實體。本集團控制一個實體，當它被暴露或具有權利時，可以從其參與的實體中獲得可變的回報，並有能力通過對該實體的權力影響這些回報。在評估集團在該實體是否具有權力時，僅考慮實質性權利(由集團及其他方持有)。

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries made up to 30 June each year.

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power over the entity, only substantive rights relating to the entity (held by the Group and other parties) are considered.

The Group includes the income and expenses of a subsidiary in the consolidated financial statements from the date it gains control until the date when the Group ceases to control the subsidiary.

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on sales of intra-group asset are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statement of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

非控股權益代表不屬於本公司的直接或間接附屬公司的權益，而本集團並無與該等權益持有人同意任何附加條款，導致本集團整體合約對符合金融負債定義的利益的義務。對於每項業務合併，本集團可以選擇以公允價值或該附屬公司可辨認淨資產的比例分配來衡量任何非控股權益。

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at their proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from the equity attributable to the owners of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income respectively for the year between non-controlling interests and the owners of the Company.

本公司計算附屬公司的業績根據在報告日收到及應收到的股息計算。被收購方之前或之後收到的所有股息在本公司的損益中確認。

2.3 外幣換算

財務報表以港元呈報，其亦為本公司之功能貨幣。

綜合入賬實體之個別財務報表內所示外匯交易按照交易日之市場匯率折算為該個別實體之功能貨幣。於結算日，以外幣計值之貨幣資產及負債按結算日匯率換算。結算此類交易及於結算日重新換算貨幣資產及負債所產生匯兌溢利或虧損，均於損益表中確認。

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost also includes direct attributable costs of investment.

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

2.3 Foreign currency translation

The consolidated financial statements are presented in Hong Kong dollars (HK\$), which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

以公允價值計量且以外幣計值的非貨幣項目以公允價值決定當日的現行匯率重新換算，並作為公允價值損益的一部分報告。以外幣歷史成本計量的非貨幣性項目不進行重新換算(即僅使用交易日的匯率換算)。當非貨幣項目的公允價值收益或損失計入損益時，該收益或損失的任何交換部分也計入損益。當非貨幣性項目的公允價值利得或損失在其他綜合收益中確認時，該利得或損失的任何匯兌部分也會在其他綜合收益中確認。

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transactions date). When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is also recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income.

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into Hong Kong dollars. Assets and liabilities have been translated into Hong Kong dollars at the closing rates at the reporting date. Income and expenses have been converted into the Hong Kong dollars at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the exchange reserve in equity.

2.4 Property, plant and equipment

Property, plant and equipment (other than cost of right-of-use assets as described in Note 2.13) are initially recognised at acquisition cost (including any cost directly attributable to bringing the assets to the location and condition necessary for them to be capable of operating in the manner intended by the Group's management). Except for land and building held for administrative purpose as described below, they are subsequently stated at cost less accumulated depreciation and accumulated impairment losses, if any.

Land and building held for administrative purpose are stated at fair value less accumulated depreciation and accumulated impairment losses (Note 2.17), if any. Any revaluation surplus remaining in equity is transferred to retained profits upon disposal of land and building and is not reclassified to profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance, are charged to profit or loss during the financial period in which they are incurred.

2.5 Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see Note 2.13) to earn rental income and/or for capital appreciation. These include land held for currently undetermined future use and property that is being constructed or developed for future use as investment property.

The club debenture is tested for impairment (see Note 2.17) at each reporting date and not to be amortised. Its useful life is also reviewed at each reporting date to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Instruments within the scope included loans and other debt-type financial assets measured at amortised cost and FVTOCI and financial guarantee contracts (for the issuer) that are not measured at FVTPL.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk (“Stage 1”); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low (“Stage 2”).

“12-month ECL” are recognised for the Stage 1 category while “lifetime ECL” are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade receivables

For trade receivables, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the days past due.

The Group measures the loss allowance for other receivables, debt investment at FVTOCI and bank balances and cash equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

不管上述結果如何評估，當合同付款逾期超過 30 天，本集團假設信用風險自初始確認以來顯著增加，除非本集團有合理及理據支持的資料另有所指時，則作別論。

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in regulatory, business, financial, economic conditions, or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

就內部信用風險管理而言，當(i)內部開發或從外部來源獲得的資訊表明債務人不太可能全額償付包括本集團在內的債權人(不考慮任何抵押品)時，本集團認為發生違約事件。(ii)該金融資產為銀行結餘以及以公允價值計量且其變動計入綜合收益的現金及債務投資已逾期90天；(iii)該金融資產為其他應收款已逾期365天。

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group); or (ii) the financial asset is 90 days past due for bank balances and cash and debt investment at FVTOCI; or (iii) the financial asset is 365 days past due for other receivables.

Detailed analysis of the ECL assessment of trade receivables, debt investment at FVTOCI and other financial assets measured at amortised cost are set out in Note 33.2.

(i) 發展中之待售物業

Financial guarantee contracts

For a financial guarantee contract, the Group is required to make payments only in the event of a default by the debtor in accordance with the terms of the instrument that is guaranteed. Accordingly, the ECL is the present value of the expected payments to the holder for a credit loss that it incurs less any amounts that the Group expects to receive from the holder, the debtor or any other party.

2.9 Properties held for sale

Properties held for sale include completed properties for sale and properties under development for sale and are stated at the lower of cost and net realisable value.

(i) *Properties under development for sale*

The cost of properties under development for sale comprises specifically identified cost, including the acquisition cost of land, aggregate cost of development, materials and supplies, wages and other direct expenses, an appropriate proportion of overheads and borrowing costs capitalised (see Note 2.19). Net realisable value represents the estimated selling price less estimated costs of completion and costs to be incurred in selling the property.

若由本集團發展之已落成物業，其成本乃根據未出售單位所佔有關發展項目之總建築成本獲分攤之有關部份而釐定。可變現淨值乃按估計銷售收入扣除估計銷售費用而計算。

已落成之待售物業成本包含所有購入成本、轉換成本及使存貨達致現存地點及狀態之其他成本。

2.10 現金及現金等價物

現金及現金等價物包括銀行存款及持有現金，銀行活期存款。就綜合現金流量表而言，現金及現金等價物包括銀行透支，該透支可隨時要求償還，及為本集團現金管理的重要部份。

2.11 合約負債

當客戶在本集團確認相關收入前支付代價時，確認合同負債。倘本集團於本集團確認相關收入前擁有無條件接納代價之權利，則亦將確認合約負債。在這種情況下，相應的應收款也將被確認。

(ii) Completed properties for sale

In the case of completed properties developed by the Group, cost is determined by apportionment of the total development costs for that development project, attributable to the unsold properties. Net realisable value represents the estimated selling price less costs to be incurred in selling the property.

The cost of completed properties for sale comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

2.10 Cash and cash equivalents

Cash and cash equivalents include cash at bank and on hand, demand deposits with banks. For the purpose of the consolidated statement of cash flow presentation, cash and cash equivalents include bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

2.11 Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

對於與客戶的單一合同，列報淨合同資產或淨合同負債。對於多份合同，與合同無關的合同資產和合同負債則不以淨額列報。

2.12 財務擔保合約

財務擔保合約為因指定債務人未能按債務工具之條款如期付款時，發行人或擔保人須支付指定金額予持有人以補償其所蒙受損失之合約。

當本集團發出財務擔保時，擔保的公允價值最初在「其他應付賬款」中確認為遞延收入。金融擔保的公允價值是根據債務工具所要求的合同付款與無擔保所需要的付款之間的現金流量差額的現值確定的，或評估義務而應支付給第三方的預計金額。當收到或應收擔保發行的代價時，代價根據本集團適用於該類資產的政策予以確認。倘未收或應收有關代價，則即時開支在初步確認任何遞延收入時在損益中確認。

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

2.12 Financial guarantees issued by the Company

A financial guarantee contract is a contract that requires the issuer (or guarantor) to make specified payments to reimburse the holder for a loss it incurs because a specified debtors fails to make payment when due in accordance with the terms of a debt instrument.

Where the Company issues a financial guarantee, the fair value of the guarantee is initially recognised as deferred income within “other payables”. The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instruments and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assessing the obligations. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Company’s policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

At inception of a contract, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'. To apply this definition, the Group assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;
- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and

The Group also assess the right-of-use asset for impairment when such indicator exists. Those right-of-use assets meeting the definition of investment properties or relating to a class of property, plant and equipment to which revaluation model was applied are subsequently measured at fair value, in accordance with the Group's accounting policies.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments.

For lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of modification.

如果租賃實質上轉移了與基礎資產所有權有關的所有風險和報酬，則分類為融資租賃；如果不轉移，則分類為經營租賃。

本集團亦從其投資物業的經營租賃賺取租金收入。租金收入在租賃期內按直線法確認。

When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit or loss if the right-of-use asset is already reduced to zero.

The Group has elected to account for short-term leases using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these lease are recognised as an expense in profit or loss on a straight-line basis over the lease term. Short-term leases are leases with a lease term of 12 months or less.

Right-of-use assets are presented included in property, plant and equipment of the consolidated statement of financial position.

(b) The Group as a lessor

As a lessor, the Group classifies its leases as either operating or finance leases.

A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset, and classified as an operating lease if it does not.

The Group also earns rental income from operating leases of its investment properties. Rental income is recognised on a straight-line basis over the term of the lease.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

2.15 Share capital

Ordinary shares are classified as equity. Share capital is recognised at the amount of consideration of shares issued, after deducting any transaction costs associated with the issuing of shares (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

4. Allocating the transaction price to the performance obligations.
5. Recognising revenue when/as performance obligation(s) are satisfied.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

(i) Sales of properties

Revenue from sales of properties recognised when (or as) the control of the property is transferred at a point in time. Revenue is recognised when the customer obtains the physical possession or the legal title of the completed property and the Group has present right to payment and the collection of the consideration is probable.

Deposits received from customers prior to delivery of the properties to the customers are contract liabilities.

For contract where the period between the payment by the customer and the transfer of the promised property or service exceeds one year, the transaction price is adjusted for the effects of a significant financing component.

(ii) Rental income

Accounting policies for rental income are set out in Note 2.13(b).

(iii) Estate management income

Revenue is recognised in the period when services are rendered.

物業、機器及設備，其他非流動資產及本公司財務狀況報表內於附屬公司的權益均需作減值測試，當有顯示該資產之賬面值可能不能回收，所有此類資產均需進行減值測試。

當一項資產之賬面值高於其可回收金額時，減值虧損將即時確認為開支入賬。可收回金額為反映市況之公允價值減銷售成本與使用價值兩者之較高者。評估使用價值時，估計未來現金流量採用稅前折現率折算至其現值，以反映現時市場對金錢時間值及有關資產特有風險之評估。

(iv) Interest income

Revenue is recognised on a time proportion basis using the effective interest method. For financial assets measured at amortised cost or FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of ECL allowance) of the asset.

(v) Dividend income

Revenue from investments is recognised when the shareholders' right to receive payment is established.

2.17 Impairment of non-financial assets

Property, plant and equipment, other non-current asset and interests in subsidiaries in the statement of financial position of the Company are subject to impairment testing. All such assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

在評估減值時，當一項資產在獨立於其他資產後不能大量賺取現金流入，其可回收金額以該最小組別的資產可獨立賺取現金來釐定(即為個別產生現金單位)，因此，有些資產作個別減值測試，有些則以個別產生現金單位作減值測試。在合理及持續的分配能夠識別時，公司資產分配至個別產生現金單位，或者以其他方式分配給最小組別的產生現金單位，當合理及持續的分配能夠識別時。

減值虧損乃按該資產在產生現金單位之比例列賬，除非該資產之賬面值不能低於其個別之公允值減去出售成本或使用價值。

如果用於確定資產可收回金額的估計發生有利變化，且僅在資產的帳面金額不超過本應確定的扣除折舊或攤銷的帳面金額的範圍內，減損損失會轉回，如果沒有確認減值損失。

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level. Corporate assets are allocated to individual cash-generating units, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Impairment losses is charged pro rata to the assets in the cash-generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

員工退休福利透過多項固定繳款計畫提供。此外，根據香港僱傭條例受僱的僱員，如符合資格，亦有權領取長期服務金(「LSP」)。LSP是固定福利計畫。

(a) 設定提存計畫

本集團依據強制公積金計畫條例為所有符合資格參加強積金計畫的員工設立定額供款退休福利計畫。再者，按法例規定，馬來西亞公司向國家養老金計畫僱員公積金繳納費用。繳款是根據僱員基本工資的一定百分比進行的。

本集團於中國經營的附屬公司的員工須參加由當地市政府運作的中央退休金計畫。該子公司須將其薪資成本的10%向中央退休金計畫供款。

當僱員於年內提供服務時，供款在損益表中確認為開支。本集團在這些計畫下的義務僅限於應付的固定百分比繳款。

Retirement benefits

Retirement benefits to employees are provided through several defined contribution plans. In addition, the employees employed under the Hong Kong Employment Ordinance are also entitled to long service payment (“LSP”) if the eligibility criteria are met. The LSP are defined benefits plans.

(a) Defined contribution plans

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund Schemes Ordinance in Hong Kong for all of its employees who are eligible to participate in the MPF Scheme. Moreover, as required by law, companies in Malaysia make contributions to the national pension scheme, the Employee Provident Fund (“EPF”). Contributions are made based on a percentage of the employees’ basic salaries.

The employees of the Group’s subsidiaries that operate in the PRC are required to participate in a central pension scheme operated by the local municipal government. This subsidiary is required to contribute 10% of its payroll costs to the central pension scheme.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group’s obligations under these plans are limited to the fixed percentage contributions payable.

管理層每年估計LSP義務。這是根據貼現率、薪資成長率、週轉率及可抵銷強積金累算權益的預期投資回報而計算。折現係數是在每個年度報告期末時參考政府債券確定的，這些債券以支付福利的貨幣計價，且到期期限與相關設定福利負債的條款相近。

The amount of long service benefit that an employee will receive on cessation of employment in certain circumstances is defined by reference to the employee's length of service and corresponding salary. The legal obligations for any benefits remains with the Group.

The LSP obligations recognised in the consolidated statement of financial position is the present value of the LSP obligation at the reporting date.

Management estimates the LSP obligations annually. This is based on the discount rate, the salary growth rate, turnover rate and the expected investment return on offsetable MPF accrued benefits. Discount factors are determined close to the end of each annual reporting period by reference to government bonds that are denominated in the currency in which the benefits will be paid and have terms to maturity approximating the terms of the related defined benefit liability.

Service cost on the Group's defined benefit plan is included in employee benefits expense. Employee contributions, all of which are independent of the number of years of service, are treated as a reduction of service cost.

Net interest expense on the net defined benefit liability is included in employee benefits expenses.

Gains and losses resulting from remeasurements of the net defined benefit liability, comprising actuarial gains and losses, are included in other comprehensive income and are not reclassified to profit or loss in subsequent periods.

員工享有年假的權利在員工累積時予以確認。為截至報告日期僱員提供的服務而產生的年假估計負債提列了準備金。

病假和產假等非累積帶薪缺勤直到請假時才會確認。

2.19 借貸成本

購置、建造或生產任何符合條件的資產所產生的借貸成本(扣除從特定借貸的臨時投資獲得的任何投資收益後的淨額)在完成和準備該資產作其預期用途所需的期間內予以資本化。合資格資產為一項資產需在一段時間始能完成及達至其擬定的用途。其他借貸成本在產生時支出。

借貸成本在發生合資格資產支出、發生借貸成本及進行備妥資產作其預定用途或銷售所需的活動時資本化為合資格資產成本的一部分。當備妥合資格資產供其預定用途或銷售所需的大致上所有活動完成時，停止對這種借貸成本的資本化。

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

2.19 Borrowing costs

Borrowing costs incurred, net of any investment income earned on the temporary investment of the specific borrowing, for the acquisition, construction or production of any qualifying assets are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other borrowing costs are expensed when incurred.

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

政府補助在能夠合理保證收到補助，且集團將遵守所有附加條件的情況下按公允價值確認。與收入有關的政府補助在綜合損益及其他全面收益表的其他收入項下以總額呈列。

2.21 所得稅會計處理

所得稅包括本期稅項及遞延稅項。

本期稅項資產及／或負債包括稅收部門要求繳納涉及目前或以往報告期間但於報告日尚未繳付納稅責任，乃基於該年度應課稅溢利，根據有關財務年度適用之稅率及稅法計算。本期稅項資產或負債之所有變動均於損益中確認為稅項開支之一部份。

2.20 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions. Government grants relating to income is presented in gross under “other income” in the consolidated statement of profit or loss.

2.21 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the consolidated financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from initial recognition of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss and does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

For investment property measured using the fair value model in accordance with the accounting policy above, the measurement of the related deferred tax liability or asset reflects the tax consequences of recovering the carrying amount of the investment property entirely through sale, unless the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies the requirements in HKAS 12 “Income Taxes” (“HKAS 12”) to the lease liabilities and the related assets separately. The Group recognises a deferred tax asset related to the lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

As at 30 June 2024, bank loans of HK\$499,000,000 which contain repayable on demand clause, were drawn under one-year revolving loan facilities were classified as current liabilities, both of the facilities will be renewed in July and November 2024. According to the terms in those revolving loan facilities, the Group has the right to roll over the loan for another year subject to the fulfilment of the net assets value and the bank borrowings to net assets ratio at the maturity date. 香港財務報告準則第18號「財務報表中的呈列和揭露」(「香港財務報告準則第18號」)

2024年7月，香港會計師公會發布了香港財務報告準則第18號，該準則對2027年1月1日或之後開始的年度報告期生效。為財務報表使用者提供有關實體財務狀況的更透明和可比較的資訊。它將取代香港會計準則第1號「財務報表的呈列」，但沿用該香港會計準則的許多要求。此外，還提出了三組新要求，涉及合併損益表的結構、管理層定義的績效指標以及財務資訊的匯總和分解。

In July 2024, the HKICPA issued HKFRS 18, effective for annual reporting periods beginning on or after 1 January 2027. The new accounting standard aims to give users of financial statements more transparent and comparable information about an entity’s financial performance. It will replace HKAS 1 “Presentation of Financial Statements” but carries over many requirements from that HKAS. In addition, there are three sets of new requirements relating to the structure of the consolidated statement of profit or loss, management-defined performance measures and the aggregation and disaggregation of financial information.

While HKFRS 18 will not change recognition criteria or measurement basis, it might have a significant impact on presenting information in the financial statements, in particular the consolidated statement of profit or loss. The Group are currently assessing any impacts as well as data readiness before developing a more detailed implementation plan.

香港會計師公會關於廢除強積金 — 長期服務(「MPF-LSP」)抵銷機制的會計影響的新指引

在2022年6月，香港特別行政區政府(「政府」)刊憲《2022年香港就業及退休計畫法例(對沖安排)(修訂)條例》(「修訂條例」)，該條例將於2025年5月1日生效(「過渡日期」)。《修訂條例》廢除自過渡日期起使用雇主強制性強積金供款所產生的累算權益來抵銷僱員服務的長期服務金(「廢除」)。此外，過渡日期之前的最後一個月的工資用於計算過渡日期之前就業期間的LSP部分。

於2023年7月1日之前，本集團應用香港會計準則第19號「僱員福利」(「香港會計準則第19號」)第93(b)段中的簡便實務處理方法，將可抵銷的強積金福利視為僱員供款進行會計處理，以減少提供相關服務期間的當期服務成本。

New HKICPA guidance on the accounting implications of the abolition of the MPF-LSP offsetting mechanism

In June 2022, the Hong Kong SAR Government (the “Government”) gazetted the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the “Amendment Ordinance”), which will take effect on 1 May 2025 (the “Transition Date”). The Amendment Ordinance abolishes the use of the accrued benefits derived from employers’ mandatory MPF contributions to offset LSP in respect of an employee’s service from the Transition Date (the “Abolition”). In addition, the last month’s salary immediately preceding the Transition Date is used to calculate the portion of the LSP in respect of the employment period before the Transition Date.

Prior to 1 July 2023, the Group applied practical expedient in paragraph 93(b) of HKAS 19 “Employee Benefits” (“HKAS 19”) (the “Practical Expedient”) to account for the offsettable MPF benefits as deemed employee contributions to reduce the current service costs in the period in which the related services were rendered.

香港會計師公會關於廢除強積金 — 長期服務(「MPF-LSP」)抵銷機制的會計影響的新指引(續)

在2023年7月，香港會計師公會發布了《香港廢除MPF-LSP抵銷機制的會計影響》(「《指引》」)，為MPF-LSP抵銷機制的會計處理以及廢除MPF-LSP所產生的影響提供了指引。

為了更好地反映取消抵銷機制的實質內容，集團已應用上述香港會計師公會指引，並更改了與LSP負債相關的會計政策，這應會導致2022年6月對LSP負債進行追趕性損益調整。該日期的服務成本，以及對當前服務成本、利息支出的影響，以及截至年度剩餘時間精算假設變化帶來的重新計量影響，並對LSP負債的比較賬面金額進行相應調整。但由於追趕損益調整金額並不重大，本集團未重述綜合務報表的比較數據。

取消抵銷機制並未對本集團截至2023年6月30日止年度的損益以及本集團及本公司於2023年和2024年6月30日的財務狀況產生重大影響。

In July 2023, the HKICPA published “Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong” (“the Guidance”) that provides guidance for the accounting for the offsetting mechanism and the impact arising from the abolition of the MPF-LSP offsetting mechanism.

To better reflect the substance of the abolition of the offsetting mechanism, the Group has applied the above HKICPA guidance and changed its accounting policy in connection with its LSP liability, which should result in a catch-up profit or loss adjustment in June 2022 for the service cost up to that date and consequential impacts on current service cost, interest expense and remeasurement effects from changes in actuarial assumptions for the rest of the year ended, with the corresponding adjustment to the comparative carrying amount of the LSP liability. However, since the amount of the catch-up profit or loss adjustment was immaterial, the Group did not restate the comparative figure for consolidated financial statements.

The abolition of the offsetting mechanism did not have a material impact on the Group’s profit or loss for the year ended 30 June 2023 and the Group’s and the Company’s financial position as at 30 June 2023 and 2024.

4. 重大會計估計及判斷

估計和判斷會不斷評估，並基於歷史經驗和其他因素，包括對未來事件的預期，這些預期被認為是合理的情況。

4.1 估計不確定性

本集團就未來作出估計及假設。所得會計估算的結果，顧名思義，很少會等於相關的實際結果。估計和有重大風險導致對賬面價值進行重大調整的假設，在下一個財政年度內的資產和負債討論如下：

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

4.1 Estimation uncertainty

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

物業公允價值評估

公允價值的最佳證據為相同地點及狀況的類似物業的活躍市場內的當前價格，並受租賃及其他合約所規限。在作出判斷時，本集團考慮多個來源的資料，包括：

- (i) 有關應收獨立及已辨認買方的代價，投資物業的樓面面積；
- (ii) 性質、狀況或地點不同 (或有關租賃或其他合約不同) 的物業的活躍市場內的當前價格，並作出調整，以反映該等差異；
- (iii) 類似物業活躍程度較低的市場內的最近價格，並作出調整，以反映該等價格有關交易的日期以來經濟狀況的任何變動；及

Fair value of properties

The best evidence of fair value is current prices in an active market for similar property in similar location and condition and subject to lease and other contracts. In making its judgement, the Group considers information from a variety of sources including:

- (i) the floor areas of the properties with respect to the consideration from the independent and identified buyer;
- (ii) current prices in an active market for properties of different nature, condition or location (or subject to different lease or other contracts), adjusted to reflect those differences;
- (iii) recent prices of similar properties in less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and
- (iv) discounted cash flow projections based on reliable estimates of future cash flows, derived from the terms of any existing lease and other contracts and using discount rate that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

物業公允價值評估 (續)

本集團物業已根據市場價值為基礎分別作出估值，這符合了香港測量師學會的評估準則。在估計物業的公允價值時，本集團管理層已考慮物業最高和最佳的使用性能。投資物業及土地及樓宇其賬面值於二零二四年六月三十日分別為5,365,067,000港元及186,254,000港元(二零二三年：分別為6,870,006,000港元及38,866,000港元)。公允價值的詳情已載於附註第14項及第15項內。

發展中之待售物業及已落成之待售物業撥備

在確定是否應向本集團的發展中之待售物業作出撥備，本集團需要考慮在目前的市場環境和估計市場價值(即估計售價減去估計銷售成本)減估計完成物業之成本。如果估計的市場價值低於賬面值需作出撥備。如果發展中之待售物業的實際市場價值由於市場條件的變化和/或重大偏離預算開發成本而低於預期，需作出重大減值虧損撥備。發展中之待售物業於二零二四年六月三十日的賬面值為1,394,106,000港元(二零二三年：1,540,561,000港元)。發展中之待售物業在截至二零二四年六月三十日止之年度內並無減值虧損的確認(二零二三年：無)。

Fair value of properties (Continued)

The Group's properties have been valued individually, on market value basis, which conforms to The Hong Kong Institute of Survey Valuation Standards. In estimating the fair value of the properties, the management of the Group has considered the highest and best use of the properties. The carrying amount of the investment properties and land and buildings as at 30 June 2024 are approximately HK\$5,365,067,000 and HK\$186,254,000 respectively (2023: HK\$6,870,006,000 and HK\$38,866,000 respectively). Details of the fair value information are set out in Notes 14 and 15.

Allowance for properties under development and completed properties for sale

In determining whether allowances should be made for the Group's properties under development for sale, the Group takes into consideration the current market environment and the estimated market value (i.e. the estimated selling price less estimated costs of selling expenses less estimated costs to completion of the properties). An allowance is made if the estimated market value is less than the carrying amount. If the actual market value on properties under development for sale is less than expected as a result of change in market condition and/or significant variation in the budgeted development cost, material provision for impairment losses may result. The carrying amount of the properties under development for sale as at 30 June 2024 is approximately HK\$1,394,106,000 (2023: HK\$1,540,561,000). No impairment loss on properties under development for sale have been written down to net realisable value during the year ended 30 June 2024 (2023: Nil).

Management exercises its judgement in making allowance for completed properties for sale with reference to the existing market environment and the estimated market value of the properties, i.e. the estimated selling price less estimated costs of selling expenses. A specific allowance for completed properties for sale is made if the estimate market value of the property is lower than its carrying amount. If the actual market values of the completed properties for sale are less than expected, as a result of change in market condition, material provision for impairment losses may result. The carrying amount of the completed properties as at 30 June 2024 is approximately HK\$1,586,016,000 (2023: HK\$359,440,000). No completed properties for sale have been written down to net realisable value during the year ended 30 June 2024 (2023: Nil).

Going concern basis for preparation of the consolidated financial statements

As disclosed in Note 2.1, the consolidated financial statements have been prepared on a going concern basis. The appropriateness of the going concern basis is assessed after taking into consideration of all relevant available information about the future of the Group, including the proposed measures as described in Note 2.1 and the cash flow projections for the next twelve months from the date of 30 June 2024. Such projections about the future inherently involve uncertainties in the sale prices of the properties and the renewal of banking facilities. The directors have reviewed the relevant available information and key assumptions used in the cash flow projections for the twelve months after the reporting date, and have concluded that the use of going concern basis for preparation of the consolidated financial statements for the year ended 30 June 2024 remains proper.

Accounting for taxation

The Group is subject to income taxes in Hong Kong, the PRC, Malaysia and Macau. There are transactions and calculations for which the ultimate tax determination is uncertain. Significant management judgement is required in determining the provision of income taxes. Where the final tax outcome is different from the amounts that were initially recorded, such differences will impact the current tax and deferred tax assets and liabilities in the period in which such determination is made.

In measuring the Group's deferred tax on investment properties measured at fair value, management of the Group have determined that the presumption that the carrying amounts of these investment properties measured using the fair value model were recovered entirely through sales was not rebutted. Deferred tax has been provided at tax rates that are expected to apply upon sales of the investment properties held by the subsidiaries of the Group in Hong Kong, Macau, Malaysia and the PRC.

For the properties in the PRC, the tax expenses on changes in fair value of investment properties and properties sales are recognised taking into account the Land Appreciation Tax ("LAT") and Enterprise Income Tax ("EIT") payable upon sales of those properties in the PRC. The LAT is determined based on management's best estimates according to the requirements set forth in the relevant PRC tax laws and regulations and provided at ranges of progressive rates of the appreciation value, with certain allowable deductions including land costs, borrowing costs and the relevant property development expenditures. The final tax outcome could be different from the amounts that were initially recorded, and these differences will impact the income tax expenses and tax provision in periods in which such taxes have been finalised with local tax authorities. As at 30 June 2024, deferred tax liabilities in relation to the fair value changes of investment properties of approximately HK\$704,926,000 (2023: HK\$926,091,000) have been recognised in the Group's consolidated statement of financial position as at 30 June 2024, as set out in Note 27.

Due to the COVID impact, Power Wide SZ has no sale of property which resulted in a tax loss for the year ended 30 June 2022, thereby did not have sufficient assessable income to offset the land appreciation tax. As Power Wide SZ did not have sufficient assessable income to offset the land appreciation tax paid, an overpaid of enterprise income tax in previous years was noted. In accordance with No. 81 Announcement, Power Wide SZ applied for the enterprise income tax paid in previous years to be refunded, the tax refund application was successful and the local tax bureau had agreed to refund approximately RMB328.9 million (equivalents to approximately HK\$351.7 million) to Power Wide SZ. The amount was fully received in July 2023.

33.2 信貸風險

信貸風險指交易對手違約其合約責任導致本集團財務虧損的風險。本集團採取的政策僅與信譽良好的交易對手打交道，並在適當情況下取得足夠的抵押品，以減輕違約所帶來的財務損失風險。

本集團的信貸風險主要來自貿易及其他應收款項。本集團的銀行結餘及現金的信貸風險被視為微不足道，因為交易對手為香港、中國及馬來西亞的主要銀行，並已設定信貸評級，本集團認為該等信用風險較低。鑑於銀行的高信用評級，管理層預計任何交易對手都不會履行其義務。

33.2 Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group has adopted a policy of only dealing with creditworthy counterparties and obtaining sufficient collateral, where appropriate, as a means of mitigating the risk of financial loss from defaults.

The Group's credit risk is primarily attributable to trade and other receivables and other financial assets. The Group's exposure to credit risk on bank balances and cash are considered to be insignificant because the counterparties are the major banks in the Hong Kong, PRC and Malaysia with established credit ratings, for which the Group considers to have low credit risk. Given the high credit ratings of the banks, management does not expect any counterparties to fail to meet its obligations.

33.2 信貸風險 (續)

貿易應收賬款

本集團採用簡化方法以評估香港財務報告準則第9號所規定的預期信用損失。為計量預期信用損失，貿易應收款項已根據共享信貸風險特徵及過往日期分組。在計算預期信用損失費率時，集團考慮歷史要素和前瞻性要素。由於很少有違約記錄並且已收到連續付款，並且在租賃開始之前需要租戶支付租賃押金，因此所有逾期的應收賬款的終身評估預期信用損失率為最低。本集團確定截至二零二四年及二零二三年六月三十日止年度的貿易應收款項的預期信用損失撥備極少，因為客戶的信貸質素並無重大變動。

按攤銷成本計量的其他金融資產包括存款及其他應收款項、按公允價值計入其他全面收益之債券投資及現金及銀行結餘。為盡量降低信用風險，集團管理層將根據歷史結算記錄和過往經驗以及當前外部信息，對可收回性進行定期集體和個人評估。已製定其他監督程序，以確保採取後續行動收回逾期債務。就此而言，存款及其他應收款項的信貸風險被視為低值。

Trade receivables

The Group has applied the simplified approach to assess the ECL as prescribed by HKFRS 9. To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the past due days. In calculating the ECL rates, the Group considers historical elements and forward-looking elements. Assessed lifetime ECL rate of trade receivables is minimal for all ageing bands as there was minimal history of default and continuous payments were received, and rental deposits are required from tenants prior to the commencement of leases. The Group determined that the ECL allowance in respect of trade receivables for the years ended 30 June 2024 and 2023 is minimal as there has not been a significant change in credit quality of the customers.

Other financial assets measured at amortised cost and debt investment at FVTOCI

Other financial assets measured at amortised cost include deposits and other receivables, debt investment at FVTOCI and cash and bank balances. In order to minimise the credit risk, the management of the Group would make periodic collective and individual assessment on the recoverability based on historical settlement records and past experience as well as current external information and adjusted to reflect probability-weighted forward-looking information, including the default rate where the relevant debtors operates. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In these regards, the credit risk of deposits and other receivables are considered to be low.

As set out in note 17 to the consolidated financial statements, In the opinion of the directors, the credit quality of debentures of approximately HK\$33,703,000 deteriorated significantly during the year ended 30 June 2023. During the year ended 30 June 2024 and 2023, there was defaults of interest payments by the debenture issuer. As a result, an additional impairment loss of HK\$4,975,000 (2023: HK\$14,210,000) is recognised in profit or loss accordingly.

The Group's exposure to credit risk on remaining debt investment at FVTOCI are considered to be insignificant because the debt investment at FVTOCI are with good credit rating, for which the Group considers to have low credit risk. Given the good credit ratings of the issuers, management does not expect any counterparties to fail to meet its obligations.

The directors of the Company have assessed that the ECL for other receivables are minimal under the 12-month ECL method as there is no significant increase in credit risk on these financial assets since initial recognition and the risk of default is low during the years ended 30 June 2024 and 2023.

流動性風險乃指本集團無法履行其通過交付現金或其他金融資產結算的金融負債相關的義務的風險有關。本集團在清償應付款項和融資責任以及現金管理方面面臨流動性風險。本集團的政策是通過審查每個經營實體的現金流量預測，定期監控當前和預期的流動資金需求及其對貸款契約的遵守情況，以確保本集團保持充足的現金儲備以及來自主要金融機構和關聯方的充足承諾資金額度以滿足其短期和長期的流動性需求。本集團自過往年度以來一直遵循流動性政策，並被認為已有效管理流動性風險。

33.3 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of its payables and financing obligations, and also in respect of its cash flow management. The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants by reviewing each operating entity's cash flow forecast, to ensure that the Group maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions and related parties to meet its liquidity requirements in the short and longer term. The liquidity policies have been followed by the Group since prior years and are considered to have been effective in managing liquidity risks.

於二零二四年六月三十日，本集團須於十二個月內償還的有息借貸為1,131,508,000港元，而本集團的銀行結餘及現金為881,792,000港元。考慮到短期資金需求，管理階層對本集團自二零二四年六月三十日起未來十二個月的現金流量預測和現金需求進行了詳細、審慎的審查。資金來源。儘管某些現有銀行融資將於二零二四年十一月到期，但管理層相信，根據前幾年的經驗，他們可以成功更新這些融資額度。

考慮到本集團目前可用的借貸融資及內部財務資源，本集團擁有充足的流動資金以滿足本集團未來十二個月的營運資金及資本開支需求。

以下分析為本集團截至二零二四年及二零二三年六月三十日的金融負債的剩餘合同到期日，基於未貼現的現金流量（包括使用合同利率計算的利息支付，或者如果浮動，則根據報告日期的現行利率計算）。當債權人可以選擇何時清償負債時，該負債按本集團可能被要求支付的最早日期計入。倘負債分期清償，則每期分期分配至本集團承諾支付的最早期間。

As at 30 June 2024, the Group's interest-bearing borrowings repayable within twelve months of HK\$1,131,508,000 while the Group's bank balances and cash was HK\$881,792,000. In consideration of the short-term fund requirement, the management has carried out a detailed and careful review of the cash flow projection and cash requirement of the Group for the next twelve months from the date of 30 June 2024. The management considers using bank and other borrowings as a significant source of finance of the Group. Although certain existing bank facilities will be expired in November 2024, the management believes that they can successfully renew these facility lines based on their experience in the previous years.

Taking into account the present available borrowing facilities and internal financial resources of the Group, the Group has adequate liquid funds to finance the working capital and capital expenditure requirements of the Group in next twelve months.

Analysed below is the Group's remaining contractual maturities for its financial liabilities as at 30 June 2024 and 2023, based on undiscounted cash flows (including interest payments computed using contractual rates or, if floating, based on rates current at the reporting date). When the creditor has a choice of when the liability is settled, the liability is included on the basis of the earliest date on when the Group can be required to pay. Where the settlement of the liability is in instalments, each instalment is allocated to the earliest period in which the Group is committed to pay.

33.4 Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rates. Except for bank balances, the Group has no significant interest-bearing assets.

The Group's interest rate risk arises primarily from bank balances and cash and interest-bearing borrowings which includes bank loans and advances from a director. These arrangements issued at variable rates expose the Group to cash flow interest rate risk. In accordance with the terms of the interest-bearing borrowings, the interest rate will be adjusted should the Hong Kong Dollar Prime Rate and HIBOR be changed.

The Group's lease liabilities, perpetual notes and debentures are earning fixed interest rate, therefore it is immaterial to interest rate risk.

The Group has not used any interest rate swaps to hedge its exposure to interest rate risk.

The policies to manage interest rate risk have been followed by the Group since prior year and are considered to be effective.

At 30 June 2024, it is estimated that a general increase/decrease of 50 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's profit after income tax and retained profits by approximately HK\$1,926,000 (2023: decrease/increase the Group's profit after income tax and retained profits by approximately HK\$2,976,000). The 50 basis point increase/decrease represents management's assessment of a reasonably possible change in interest rates over the period until the next annual reporting date.
