Luminar Technologies, Inc. (LAZR) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each LAZR Class A Common Share will be converted into the right to receive approximately 0.066667 (New) Luminar Technologies, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on November 21, 2024. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for LAZR1 will be determined as follows:

$$\text{LAZR1} = 0.066667 (\text{LAZR})$$

Delayed Settlement

The LAZR component of the LAZR1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the LAZR1 deliverable until the cash in lieu of fractional LAZR Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
