On October 21, 2024, Dell Marketing L.P., which as of that date owned approximately 97.4% of the voting power of the issued and outstanding shares of SCWX, executed and delivered written consent approving the merger agreement between SCWX and a wholly owned subsidiary of Sophos Inc. If and when the merger is consummated, each existing SCWX Class A Common Share will be converted into the right to receive \$8.50 net cash per share.

**Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in early 2025.

**New Deliverable  
Per Contract:** \$850.00 Cash (\$8.50 x 100)

Settlement in SCWX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
