Adjusted Singular Genomics Systems, Inc. (adjusted option symbol OMIC1) options were adjusted on June 26, 2024 (See OCC Information Memo #54782). The new deliverable became 4 Singular Genomics Systems, Inc. (OMIC) Common Shares.

On February 19, 2025, Shareholders of Singular Genomics Systems, Inc. (OMIC) will vote concerning the proposed merger with affiliates of an investment fund managed by Deerfield Management Company, L.P. If the merger is approved and consummated, each existing OMIC Common Share will be converted into the right to receive \$20.00 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur during the first quarter of 2025.

**New Deliverable**  
**Per Contract:** \$80.00 Cash (\$20.00 x 4)

Settlement in OMIC1 options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
