Subject: EnLink Midstream, LLC – Cash In Lieu Settlement
Adjusted Option Symbol: OKE2

EnLink Midstream, LLC options were adjusted on January 31, 2025 (See OCC Information Memo #55983). The new deliverable became 1) 14 ONEOK, Inc. (OKE) Common Shares and 2) Cash in lieu of 0.12 fractional OKE shares. Only settlement of the cash portion of OKE2 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$99.87 per whole OKE share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.12 \times \$99.87 = \$11.98 \text{ per OKE2 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 31, 2025 through February 10, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the OKE2 options are as follows:

New Deliverable

Per Contract: 1) 14 ONEOK, Inc. (OKE) Common Shares
2) \$11.98 Cash

Strike Prices: Unchanged

CUSIP: OKE: 682680103

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The OKE component of OKE2 exercise/assignment activity from January 31, 2025 through February 7, 2025, has settled through National Security Clearing Corporation (NSCC). The \$11.98 cash amount will be settled by OCC.

Pricing

The underlying price for OKE2 will be determined as follows:

$$\text{OKE2} = 0.14 (\text{OKE}) + 0.1198$$

For example, if OKE closes at 95.81, the OKE2 price would be calculated as follows:

$$\text{OKE2} = 0.14 (95.81) + 0.1198 = 13.53$$
