主席報告 CHAIRMAN'S STATEMENT

尊敬的列位股東:

本人謹代表訊智海國際控股有限公司(「本公司」,連 同其附屬公司統稱「本集團」)董事(「董事」)會「董事 會」)及其附屬公司欣然向股東(「股東」)提呈本集團截 至二零二四年十二月三十一日止年度之年報。

於二零二四年,本集團取得出色的財務業績,收益約 為351.2百萬港元,較二零二三年的約152.1百萬港元 大幅增加。我們的經營溢利上升至約11.2百萬港元, 而上一年度則為5.7百萬港元,顯著增加約96.5%。

於二零二四年整個年度,我們投入額外資源支持業務 增長。其包括增加銷售及分銷活動的營運資金,並擴 大我們的維修及服務支援團隊,以滿足客戶日益增長 的需求。該等策略舉措顯著提升我們的增長及整體財 務表現,同時多元化發展業務分類,以降低對單一領 域過度依賴的風險。

此外,我們注意到全球可持續發展的趨勢日益增長, 消費者越來越多地選擇翻新IT產品及尋求維修選項以 延長產品生命週期。該消費行為轉變與我們對可持續 發展及減少電子廢棄物的承諾完美契合。我們透過提 供翻新IT產品作為可行替代方案,積極對減少電子廢 棄物及推動循環經濟作出貢獻。

本集團繼續積極探索為第三方IT產品(包括電腦、通訊 設備及消費電子產品)提供售後服務的商機,以對環 境負責的方式管理電子廢棄物。該擴展不僅分散我們 的收入來源,亦有助於可持續管理電子廢棄物。我們 相信,「綠色科技」貿易在不久的將來仍將是一個重要 話題,而我們的目標是將本集團定位為該新興市場的 領導者。

展望未來,我們對日後的機遇及挑戰持樂觀態度。在 努力為股東創造長期價值的同時,我們對可持續發展 及循環經濟的承諾仍將是我們業務營運的核心。

最後,本人謹代表董事會對股東及業務夥伴的信任及 支持表示衷心感謝。本人亦謹此表揚本公司各級管理 人員及盡忠職守的員工,感謝彼等多年來作出的寶貴 貢獻及辛勤努力。

On behalf of the board (the "**Board**") of directors (the "**Director(s)**") of CircuTech International Holdings Limited (the "**Company**", together with its subsidiaries, collectively the "**Group**"), along with its subsidiaries, I am pleased to present the annual report of the Group for the year ended 31 December 2024, to our shareholders (the "**Shareholder(s)**").

In 2024, the Group achieved impressive financial results, reporting revenue of approximately HK\$351.2 million, a significant increase from approximately HK\$152.1 million in 2023. Our operating profit rose to approximately HK\$11.2 million, compared to HK\$5.7 million in the prior year, reflecting a remarkable increase of around 96.5%.

Throughout 2024, we dedicated additional resources to support our business growth. This included increasing our working capital for sales and distribution activities and expanding our repair and service support team to meet the rising demands of our customers. These strategic initiatives significantly enhanced our growth and overall financial performance while diversifying our business segments to mitigate the risks associated with over-reliance on a single area.

Moreover, we have noticed a growing global trend towards sustainability, with consumers increasingly opting for refurbished IT products and seeking repair options to extend product lifecycles. This shift in consumer behavior aligns perfectly with our commitment to sustainability and reducing electronic waste. By providing refurbished IT products as a viable alternative, we are actively contributing to the reduction of e-waste and promoting a circular economy.

The Group continues to actively explore business opportunities in providing after-sales services for third-party IT products, including computers, communications equipment, and consumer electronics, to manage electronic waste in an environmentally responsible manner. This expansion not only diversifies our revenue streams but also contributes to the sustainable management of electronic waste. We believe that the trade of "Green Technology" will remain a significant topic in the near future, and we aim to position the Group as a leader in this emerging market.

Looking ahead, we are optimistic about the opportunities and challenges that await us. Our commitment to sustainability and the circular economy will remain central to our operations as we strive to create long-term value for our Shareholders.

Finally, on behalf of the Board, I would like to express my heartfelt gratitude to our Shareholders and business partners for their trust and support. I would also like to commend the managers at all levels and the dedicated staff of the Company for their invaluable contributions and hard work over the years.

業務回顧

本集團經營兩個業務分類,即銷售及分銷IT產品以及 提供IT產品的維修及其他服務支援。

銷售及分銷IT產品

本集團的核心業務分類集中於銷售及分銷IT產品,尤 其是知名第三方品牌。本集團的業務營運主要集中於 分銷二手及翻新IT產品,透過我們覆蓋北美洲、亞洲 及澳洲的龐大批發網絡進行。

於二零二四年,全球二手IT產品市場在需求及供應方 面均錄得顯著增長。越來越多消費者因為翻新IT產品 經濟實惠及具有環境效益而傾向於購買該等產品。對 循環經濟及可持續發展的日益重視提高對翻新產品 的認識,讓消費者能夠認識到二手設備的優勢。

本集團具備多項主要優勢,令其處於有利位置,能夠 有效地與其他全球分銷商競爭,其中包括我們管理團 隊的專業知識及豐富經驗,以及我們與全球知名實體 富士康科技集團(以其與多個國際品牌的穩固業務關 係而聞名)的合作關係。

於過去一年,本集團致力於不斷評估及重新評估我們 的業務模式,以提高效率及增加溢利。我們時刻關注 市況,使我們能夠在有需要時及時調整策略及營運。

BUSINESS REVIEW

The Group operates in two business segments, namely, the sales and distribution of IT products and the provision of repairs and other service support of IT products.

Sales and distribution of IT products

The core business segment of the Group centers on the sales and distribution of IT products, specifically renowned third-party brands. The Group's business operations primarily focus on distributing used and refurbished IT units, facilitated through our extensive wholesale network covering North America, Asia and Australia.

In 2024, the global market for secondary IT products experienced a notable surge in both demand and supply. Increasingly, consumers are gravitating towards refurbished IT products due to their affordability and environmental benefits. The growing emphasis on the circular economy and sustainability has raised awareness of refurbished products, allowing consumers to recognise the advantages of pre-owned devices.

The Group is well-positioned to compete effectively against other global distributors, attributed to several key advantages. These include the expertise and proven experience of our management team, along with our association with Foxconn Technology Group, a globally respected entity known for its robust relationships with various international brands.

Throughout the past year, the Group has committed to the continuous evaluation and reassessment of our business model to enhance efficiency and boost the profit. We remain vigilant in monitoring market conditions, allowing us to make timely adjustments to our strategies and operations as necessary.

業務回顧 (續)

提供IT產品的維修及其他服務支援

於二零二四年,本集團繼續實施策略計劃,旨在多元 化發展本集團的業務分類,以提升整體表現及韌性。 此舉令我們的維修業務顯著增長,在維修能力及我們 服務的產品類型範圍方面均有所擴展。我們對維修質 量及效率的承擔令我們成為市場上的首選合作夥伴。 我們一直積極尋求新商機,接觸不同行業的潛在客 戶。此主動舉措不僅擴闊我們的客戶基礎,亦鞏固我 們的市場地位。

於二零二三年,本集團就外包其維修業務工作流程與 本公司控股股東(「控股股東」)訂立一份服務框架協 議(構成持續關連交易),包括但不限於電子產品(包 括但不限於手提電話、手提電話顯示屏及藍牙耳機) 之維修及增值服務,包括檢查、維修、組裝、測試、包 裝、倉儲、物流、相關報關服務及採購所需材料。該安 排可擴大本集團維修服務業務的範圍及增加其收入 來源。詳情請參閱本年報第28至29頁所載董事會報告 「持續關連交易」一節。

於二零二四年十月四日,本公司與一名業務合作夥伴 簽署認購協議。此舉旨在透過利用本集團及業務合作 夥伴的專業知識及專長,加快擴充我們的維修業務。 透過合作,本集團目標為創造協同效應,提升服務, 加快維修流程,最終為客戶提供更大價值。

BUSINESS REVIEW (continued)

Provision of repairs and other service support of IT products

In 2024, the Group continues to implement a strategic plan aimed at diversifying the business segments of the Group to enhance overall performance and resilience. This initiative has led to significant growth in our repair business with expansions in both repair capacity and the range of product types we service. Our commitment to quality and efficiency in repairs has positioned us as a preferred partner in the market. We have actively pursued new business opportunities, engaging potential customers across various industries. This proactive approach not only broadens our customer base but also strengthens our market presence.

In 2023, the Group entered into a service framework agreement (which constitutes a continuing connected transaction) with the Company's controlling shareholder (the "**Controlling Shareholder(s)**") for outsourcing its repair business workflow, including but not limited to maintenance and value-added services (including checking, maintenance, assembly, testing, packaging, warehousing, logistic, related custom declaration services and sourcing of required material) for electronic products (including but not limited to mobile phone, mobile phone display, and Bluetooth earpieces). This arrangement can broaden the range of the Group's repair services business and increase its revenue sources. Please refer to the section headed "CONTINUING CONNECTED TRANSACTIONS" included in the Directors' Report set out on pages 28 to 29 of this annual report for details.

On 4 October 2024, the Group signed a subscription agreement with a business partner. This exercise is designed to expedite the expansion of our repair business by leveraging the expertise and specialties of the Group and the business partner. By working together, the Group aims to create synergies that will enhance service offerings, accelerate repair processes, and ultimately deliver greater value to our customers.

業務回顧(續)

按業務線劃分之分類資料

截至二零二四年十二月三十一日止年度,銷售及分銷 IT產品分類的收益仍是本集團的最大收入來源,佔總 收益約92.1%,較二零二三年的約87.4%有所增加。此 收益主要來自第三方IT產品的銷售及分銷。

此外,來自維修及服務支援分類的收益顯著增加至約 27,825,000港元,較二零二三年的約19,133,000港元 有所上升。此增長主要由客戶基礎擴大及IT產品服務 支援提升所帶動。

BUSINESS REVIEW (continued)

Segment information by business line

For the year ended 31 December 2024, revenue from the sales and distribution of IT products segment remained the Group's largest income source, accounting for approximately 92.1% of the total revenue, up from approximately 87.4% in 2023. This revenue primarily stemmed from the sales and distribution of third-party IT products.

Additionally, revenue from the repairs and service support segment rose significantly to approximately HK\$27,825,000, up from approximately HK\$19,133,000 in 2023. This growth was primarily driven by an expanded customer base and enhanced services support for IT products.

截至二零二四年十二月三十一日止年度,香港、日本 及澳洲成為本集團按收益貢獻劃分的前三大市場。香 港為最大市場,貢獻總收益約89.9%,較二零二三年 的約73.5%有所增加。日本市場佔總收益約5.8%,較 二零二三年的約17.3%有所下降,而澳洲市場則佔總 收益約2.3%,較二零二三年的約3.7%有所下降。美國 市場保持相對穩定,貢獻總收益約1.8%,而二零二三 年則約為4.0%。收益組成變化受產品組合變動影響, 並由該等地區的需求及供應變化帶動。

During the year ended 31 December 2024, Hong Kong, Japan and Australia emerged as the Group's top three markets by revenue contribution. The Hong Kong market was the largest, contributing approximately 89.9% of the total revenue, up from approximately 73.5% in 2023. The Japan market accounted for approximately 5.8% of the total revenue, down from approximately 17.3% in 2023, while the Australia market contributed around 2.3% of the total revenue, representing a decrease from approximately 3.7% in 2023. The United States market remained relatively stable, contributing approximately 1.8% of the total revenue, compared to approximately 4.0% in 2023. The shifts in revenue composition were influenced by changes in product mix, driven by demand and supply variations across these geographical locations.

產品及服務發展

基於管理團隊在國際分銷方面的經驗,本集團進一步 擴展其消費電子產品供應,以補充其現有業務。3C產 品主要由二手及翻新單位組成,透過本集團的國際分 銷渠道延長其使用壽命,為可持續的售後循環經濟作 出貢獻。

維修及服務支援分類方面,本集團已與一間國際保險 公司合作,透過提供全面的智能設備維修服務,以提 升其服務。此合作不僅簡化客戶的維修流程,亦確保 其設備得到及時且高質量的維修。此外,本集團致力 在其維修服務中實行環保措施,進一步加深其對可持 續發展及循環經濟的承擔。

有關本集團之業務風險

本集團面臨IT產品行業的快速技術轉變。

在快速變化的IT產品貿易領域,技術行業的特點為 創新週期快,新產品、軟件及硬件不斷開發並推出市 場。此快速的創新或會迅速令舊型號失去吸引力,原 因為消費者傾向於追求最新的電子產品。

本集團已進行全面的市場研究,以預測消費者偏好變 化並相應地調整庫存。我們已實施策略定價模型,以 在確保業務量的同時保持盈利。此外,本集團專注於 翻新及認證二手產品,以提升其吸引力並向買家保證 其質量。

PRODUCT AND SERVICE DEVELOPMENT

Building upon the experience of the management team in international distribution, the Group has further expanded its consumer electronics product offerings, complementing its existing business. The 3C Products, primarily comprising used and refurbished units, experience their useful life extended through the Group's international distribution channels, contributing to a sustainable post-sales circular economy.

In the repairs and service support segment, the Group has collaborated with an international insurance company to enhance its offerings by providing comprehensive smart device repair services. This partnership not only streamlines the repair process for customers but also ensures that their devices receive timely and high-quality maintenance. In addition, the Group is dedicated to implementing eco-friendly practices within its repair services, further reinforcing its commitment to sustainability and the circular economy.

BUSINESS RISK RELATING TO THE GROUP

The Group faces rapid technological changes in the IT products sector.

In the fast-evolving landscape of IT products trading, the technology sector is characterized by swift innovation cycles, with new products, software, and hardware constantly being developed and introduced to the market. This fast pace of innovation can quickly render older models less appealing as consumers gravitate toward the latest gadgets.

The Group has conducted thorough market research to anticipate shifts in consumer preferences and adapt its inventories accordingly. Strategic pricing models have been implemented to maintain profitability while ensuring business volume. Additionally, the Group focuses on refurbishing and certifying used products to enhance their appeal and assure buyers of their quality.

有關本集團之業務風險 (續)

本集團的保險可能不足以涵蓋所有與其業務營運有 關之損失。

本集團為其辦公室的損失或損壞、業務中斷、公共責 任及員工賠償購置保險。然而,該保障範圍可能不足 以應對本集團未來業務營運相關的所有風險。倘發生 未獲承保的損失或超過保險限額的損失(例如自然災 害或其他不可控事件導致的損失)時,本集團可能須 以自身資金支付損失及債務,這可能會對其財務狀況 及營運業績產生重大不利影響。即使保險足以應對直 接損失,本集團仍可能須承擔間接損失。此外,本集 團的索償記錄可能會影響保險公司日後收取的保費。

儘管存在該等憂慮,但本集團認為其目前的保險保障 範圍足以應對現有營運規模。為彌補潛在差距,本集 團將定期審閱其保單,以確保其符合本集團不斷變化 的業務需求及風險。

業務前景

本集團的業務包括兩個不同的業務分類,即銷售及分 銷IT產品以及提供IT產品的維修及其他服務支援。本 集團以戰略性及有條理的方式,有計劃地加強及鞏固 其維修及服務支援分類,旨在提升盈利能力及所用資 本回報率。

展望未來,本集團管理層擬分配額外資源以進一步發 展本集團維修及服務支援分類。此外,本集團將積極 探索「循環經濟」領域內的合適投資機會,履行我們對 可持續發展及負責任的商業行為的承諾,促進「綠色 科技」。

BUSINESS RISK RELATING TO THE GROUP

(continued)

The Group's insurance may be insufficient to cover all losses associated with its business operations.

The Group maintains insurance policies for loss or damage to its office, business interruption, public liability, and employee compensation. However, this coverage may fall short of addressing all the risks associated with the Group's future business operations. In the event of an uninsured loss or a loss exceeding the insured limit, such as those resulting from natural disasters or other uncontrollable events, the Group may have to cover damages and liabilities from its own funds, which could materially and adversely impact its financial condition and operational results. Even if the insurance is adequate for direct losses, the Group may still be responsible for indirect losses. Additionally, the Group's claims history could influence the premiums charged by insurance companies in the future.

Despite these concerns, the Group believes that its current insurance coverage is sufficient for its existing operational scale. To address potential gaps, the Group will periodically review its insurance policies to ensure they align with the Group's evolving business needs and risks.

BUSINESS OUTLOOK

The Group's operations encompass two distinct business segments, namely, the sales and distribution of IT products and the provision of repairs and other services to support IT products. With a strategic and methodical approach, the Group executed a planned process to enhance and fortify its repairs and service support segment, aiming to improve profitability and the return on capital employed.

Looking ahead, the management of the Group intends to allocate additional resources to further develop the repairs and service support segment of the Group. Additionally, the Group will actively explore suitable investment opportunities within the realm of the "Circular Economy", aligning with our commitment to sustainability and responsible business practices to foster "Green Technology".

財務回顧

收入

本集團主要從事兩個業務分類,即(i)銷售及分銷IT 產品;及(ii)維修及服務支援。截至二零二四年十二 月三十一日止年度,本集團總收入約為351,188,000 港元,較截至二零二三年十二月三十一日止年度約 152,137,000港元增加約130.8%。業務量增長歸因於 我們擴充第三方品牌產品供應,帶動亞洲市場快速擴 展。

銷售成本

銷售成本之主要部分為存貨成本。與業務量增加一 致,截至二零二四年十二月三十一日止年度之銷售 成本較截至二零二三年十二月三十一日止年度約 138,346,000港元增加約139.3%至約331,024,000港 元。淨存貨撥備撥回(計入銷售成本)約為319,000港 元,而於截至二零二三年十二月三十一日止年度之淨 存貨撥備約為200,000港元,說明年內滯銷存貨有所 減少。

毛利及毛利率

截至二零二四年十二月三十一日止年度,毛利增加約 6,373,000港元至約20,164,000港元(二零二三年:約 13,791,000港元),與業務量增加一致。整體毛利率 由截至二零二三年十二月三十一日止年度的約9.1% 減少至截至二零二四年十二月三十一日止年度的約 5.7%。整體毛利率減少乃主要由於銷售及分銷分類的 快速增長,而其產生的毛利率低於維修及服務支援分 類。

FINANCIAL REVIEW

Revenue

The Group mainly engages in two business segments, namely, (i) sales and distribution of IT products; and (ii) repairs and service support. The Group's total revenue amounted to approximately HK\$351,188,000 for the year ended 31 December 2024, representing an increase of approximately 130.8% as compared to that of approximately HK\$152,137,000 for the year ended 31 December 2023. The business volume growth was attributable to the rapid expansion of Asian markets fuelled by our expanded range of third-party branded product offerings.

Cost of sales

A major component of the cost of sales was the cost of inventories. In line with the increase in business volume, the cost of sales for the year ended 31 December 2024 increased to approximately HK\$331,024,000, representing an increase of approximately 139.3% as compared to that of approximately HK\$138,346,000 for the year ended 31 December 2023. There was a net reversal of provision of inventories (included in the cost of sales) amounting to approximately HK\$319,000 as compared to a net inventory provision of approximately HK\$200,000 for the year ended 31 December 2023 to account for the decrease in slow-moving inventories during the year.

Gross profit and gross profit margin

Gross profit increased by approximately HK\$6,373,000 to approximately HK\$20,164,000 for the year ended 31 December 2024 (2023: approximately HK\$13,791,000), which was in line with the increase in business volume. The overall gross profit margin decreased from approximately 9.1% for the year ended 31 December 2023 to approximately 5.7% for the year ended 31 December 2024. The decrease in overall gross margin was mainly due to the rapid growth in the sales and distribution segment, which generates a lower gross profit margin than the repairs and service support segment.

銷售及分銷成本

年內,本集團成功將其銷售及分銷成本削減約 45.1%。截至二零二四年十二月三十一日止年度,銷 售及分銷成本減至約914,000港元(二零二三年:約 1,665,000港元)。銷售及分銷成本的主要部分為員工 成本、二手設備回收成本以及倉儲費用。於本年度, 本集團重新設計銷售及分銷業務模式,以提高效率並 節省員工成本。

行政費用

截至二零二四年十二月三十一日止年度,行政費用 由約13,265,000港元減少約21.5%至約10,410,000港 元。憑藉營運效率的提高及嚴格的財務政策,本集團 能夠將其行政費用保持在合理較低水平。

年內純利

儘管總收益增加,惟本集團因衍生金融工具的失效 而確認公平值虧損約8,883,000港元。詳情請參閱下文 「重大投資」一段及綜合財務報表附註12。因此,本集 團呈報純利約272,000港元,較截至二零二三年十二 月三十一日止年度錄得的純利約6,615,000港元減少 6,343,000港元。

於二零二四年,每股基本盈利減少至約0.19港仙,而 二零二三年約為25.14港仙。

存貨及應收賬款

於二零二四年十二月三十一日,存貨水平降至約 67,000港元(二零二三年十二月三十一日:約562,000 港元)。存貨結餘大幅減少乃由於將存貨周轉天數調 低以加強存貨管理。

FINANCIAL REVIEW (continued)

Selling and distribution costs

The Group managed to cut its selling and distribution costs by approximately 45.1% for the year. Selling and distribution costs decreased to approximately HK\$914,000 for the year ended 31 December 2024 (2023: approximately HK\$1,665,000). A major component of the selling and distribution costs was staff costs, take-back cost for used devices and warehousing charges. During the year, the Group has re-designed its business model for the sales and distribution business to improve efficiency and to save staff costs.

Administrative expenses

During the year ended 31 December 2024, administrative expenses decreased by approximately 21.5% from approximately HK\$13,265,000 to approximately HK\$10,410,000. With improvements in operating efficiencies and rigorous financial policy, the Group has been able to keep its administrative expenses reasonably low.

Net profit for the year

Despite an increase in the total revenue, the Group recognised a fair value loss of approximately HK\$8,883,000 due to the lapse of a derivative financial instrument. For details, please refer to the paragraph headed "Significant Investment" below and note 12 to the consolidated financial statements. As a result, the Group reported a net profit of approximately HK\$272,000, reflecting a decrease of HK\$6,343,000 compared to the net profit of approximately HK\$6,615,000 recorded for the year ended 31 December 2023.

Basic earnings per share decreased to approximately HK\$0.19 cents in 2024, compared with approximately HK\$25.14 cents in 2023.

Inventories and trade receivables

As at 31 December 2024, the inventory level decreased to approximately HK\$67,000 (31 December 2023: approximately HK\$562,000). The significant reduction in inventory balance was attributable to strengthened inventory management through reducing the inventory turnover days.

於二零二四年十二月三十一日,應收賬款大幅增加至約79,674,000港元,而二零二三年則約為26,789,000港元。應收賬款增加乃由於本集團向還款紀錄良好的 忠實客戶提供額外的信貸額度。於整個年度內,本集 團的客戶維持良好信貸記錄,故並無確認重大應收賬 款減值。

主要財務表現

選擇於本年報內呈列上述財務數據,是因為其對本集 團本財政年度及/或過往財政年度之綜合財務報表 構成重大財務影響,其變動可能顯著影響收入及溢 利。本集團認為透過呈列該等財務數據之變動可有效 說明本集團本年度之財務表現。

股息

董事會不建議派付截至二零二四年十二月三十一日 止年度之末期股息(二零二三年:無)。

股息政策

Inventories and trade receivables (continued)

Trade receivables increased significantly to approximately HK\$79,674,000 as at 31 December 2024, compared to approximately HK\$26,789,000 in 2023. This increase in trade receivables was attributable to the additional credit limit granted to the Group's loyal customers, who have demonstrated a strong repayment track record. Throughout the year, the Group's customers maintained a good credit history, and no material impairment of trade receivables was recognised.

Key financial performance

The above financial data were chosen to be presented in this annual report as they constitute a material financial impact on the consolidated financial statements of the Group for the current financial year and/or the previous financial year, and that a change of which could affect the revenue and profit conspicuously. It is believed that the Group can effectively explain the financial performance of the Group for the year by presenting the changes of these financial data.

DIVIDENDS

The Board does not recommend the payment of a final dividend for the year ended 31 December 2024 (2023: Nil).

DIVIDEND POLICY

The Company does not have a policy to distribute dividends in a fixed amount or based on a fixed payment ratio. The Company's dividend policy is to consider the following factors before declaring or recommending dividends:

- the general financial condition of the Group;
- the Group's actual and future operations and liquidity position;
- the Group's expected working capital requirements and future expansion plans;
- the Group's debt to equity ratios and the debt level;
- the restrictions on payment of dividends that may be imposed by the Group's lenders (if any);
- the retained earnings and distributable reserves of the Company and each of the members of the Group;
- the general market conditions; and
- any other factors that the Board deems appropriate.

Declaration of dividend by the Company is also subject to any restrictions under the laws of the Cayman Islands, the memorandum and articles of association of the Company and any applicable laws, rules and regulations.

僱員薪酬乃根據個人職責與表現而定,亦已計及現行 市場水平以確保競爭力。本集團向全體僱員提供之其 他附帶福利包括醫療保險、退休福利及酌情花紅。

本集團為員工提供職業發展培訓計劃,使僱員能更好 地裝備自己及更有效率地工作,有利於本集團的長遠 發展。培訓計劃根據目標和目的分為兩類:內部培訓 及外部培訓。例如,專業人士舉辦的外部培訓計劃。 就內部培訓而言,本公司於香港辦公室定期舉辦團隊 建設活動及研討會,以增強團隊精神。本集團透過為 僱員提供在工作天內參與持續專業發展及培訓課程 以及培訓資助來支持員工培訓計劃。

本公司於二零一六年十一月十一日之股東週年大會 上批准及採納一項購股權計劃。

EMPLOYEE AND REMUNERATION POLICY

As of 31 December 2024, the Group employed 11 (31 December 2023: 18) employees in Hong Kong and 21 (31 December 2023: 14) employees in China and overseas offices. The staff costs of the Group, including Directors' emoluments, employees' salaries and commissions, retirement benefit scheme contributions and other benefits amounted to approximately HK\$9,121,000 for the year ended 31 December 2024 (2023: approximately HK\$11,373,000).

Employees are remunerated in accordance with individual's responsibility and performance, also taking into account the prevailing market rates to ensure competitiveness. Other fringe benefits such as medical insurance, retirement benefits and discretionary bonus are offered to all employees.

The Group provides training programmes for staff professional development so that the employees are better equipped and can work efficiently, which are favourable to the long-term development of the Group. Training programmes are classified into two types based on target and purpose: internal training and external training. For example, external training programmes organised by professional party. Whereas for internal training, the Company organizes team building activities and workshops regularly in the Hong Kong office in order to enhance team spirit. The Group supports staff training programmes by offering employees to attend continuing professional development and training courses during working days and training sponsorship.

A share option scheme was approved and adopted at the annual general meeting of the Company on 11 November 2016.

資本架構

於二零二四年十月四日,本公司與香港金鷹國際發展 有限公司(「**認購人**」)訂立認購協議,據此,認購人有 條件同意分兩批認購合共7,811,261股本公司普通股 (「**股份**」),總面值為1,562,252.2港元。有關認購事 項旨在透過利用本集團及認購人的專業知識及專長 加快擴充我們維修業務,並改善本公司的財務狀況。 股份於二零二四年十月四日的收市價為每股3.08港 元。年內,認購人已完成第一批認購,當中本公司發 行2,605,000股股份,認購價為每股股份3.0港元。扣 除相關開支後的淨認購價約為每股股份2.76港元。

第二批按3.9港元認購5,206,261股股份將於條件獲達 成後發行。倘條件獲達成,經扣除相關開支後,估計 淨認購價約為每股股份3.88港元。

預期上述認購事項的所得款項總額約為28.1百萬港 元,扣除相關費用後的認購事項所得款項淨額將約為 27.4百萬港元。

LIQUIDITY, FINANCIAL RESOURCES AND GEARING RATIO

During the year ended 31 December 2024, the Group financed its daily operations with internally generated resources. As at 31 December 2024, the Group had net current assets of approximately HK\$149,511,000 (31 December 2023: approximately HK\$136,060,000) and cash and cash equivalents of approximately HK\$39,678,000 (31 December 2023: approximately HK\$104,485,000). The Group had no borrowings outstanding as at 31 December 2024.

As at 31 December 2024, the gearing ratio, which is calculated on the basis of total debts over total equity of the Group, was approximately 5.7% (2023: approximately 4.2%).

CAPITAL STRUCTURE

On 4 October 2024, the Company and Hong Kong Kintex Worldwide Limited (the "**Subscriber**") entered into a subscription agreement, pursuant to which the Subscriber conditionally agreed to subscribe, in aggregate, 7,811,261 ordinary shares of the Company (the "**Share(s)**") at aggregate nominal value of HK\$1,562,252.2 in two tranches. Such subscription was to expedite the expansion of our repair business by leveraging the expertise and specialties of the Group and the Subscriber, as well as to improve the financial position of the Company. The closing price of our Shares was HK\$3.08 per Share on 4 October 2024. During the year, the Subscriber has completed the subscription of the first tranche, of which the Company issued 2,605,000 Shares in the subscription price of HK\$3.0 for each Share. The net subscription price, after deduction of relevant expenses, was approximately HK\$2.76 per Share.

The second tranche of subscription of 5,206,261 Shares at HK\$3.9 is to be issued when the conditions are fulfilled. If the conditions are fulfilled, the estimated net subscription price, after deduction of relevant expenses, is approximately HK\$3.88 per Share.

The gross proceeds from the aforesaid subscription are expected to be approximately HK\$28.1 million, and the net proceeds from the subscription, after deduction of the relevant expenses, will amount to approximately HK\$27.4 million.

The net proceeds received from the first tranche of the subscription were approximately HK\$7.1 million. The Company intends to use the net proceeds from the first tranche of the subscription by the second quarter of 2025 as to (i) approximately HK\$4.0 million for the expansion of the existing sales and distribution of IT products business by acquisition of relevant tools and consumables, enhancement of information technology system, increase in manpower and expansion in inventory level; (ii) approximately HK\$2.1 million to enhance the capacity of a repair centre in China; and (iii) approximately HK\$1.0 million will be invested in establishing an overseas repair center.

The net proceeds to be received from the second tranche of the subscription are expected to be approximately HK\$20.3 million. The Company intends to use the net proceeds from the second tranche of the subscription within 12 months following the completion of the second tranche of the subscription as to (i) approximately HK\$12.0 million for the expansion of the existing sales and distribution of IT products business by acquisition of relevant tools and consumables, enhancement of information technology system, increase in manpower and expansion in inventory level; (ii) approximately HK\$6.0 million to enhance the capacity of a repair centre in China; and (iii) approximately HK\$2.3 million for further expansion of an oversea repair center established with the funds from the net proceeds received from the first tranche of the subscription.

As at 31 December 2024, none of the net proceeds has been utilized. The Company will gradually utilize the net proceeds from the subscription in accordance with the intended purposes set out in the announcement of the Company dated 4 October 2024.

Details of the subscription were disclosed in the announcements of the Company dated 4 October 2024, 22 November 2024 and 29 November 2024 and the circular of the Company dated 1 November 2024.

As at 31 December 2024, the Company had an authorised share capital of HK\$80,000,000 divided into 400,000,000 Shares of a par value of HK\$0.20 each, of which 26,038,783 Shares were in issue. No convertible securities, options, warrants or similar rights by the Company or its subsidiaries were outstanding during the year.

The Group did not have any borrowings during the year ended 31 December 2024 (2023: Nil).

截至二零二三年十二月三十一日止年度,本集團持 有4Square Return GmbH (「**4Square**」) 21%的股 權,於綜合財務狀況表被分類為本集團於一間聯營 公司之權益。誠如本公司日期為二零一八年六月四 日的公告所披露,本集團以代價1,600,000歐元(相 當於約14,508,000港元) 收購4Square 2股股份,佔 4Square全部已發行股本21%權益。於二零二四年 十二月三十一日,本集團所持4Square權益的賬面值 約為9,774,000港元,約佔本集團於二零二四年十二 月三十一日的綜合資產總額5.7%。4Square主要從事 合規諮詢及提供回收服務等業務。儘管4Square於二 零二四財年並無宣派股息,本集團截至二零二四年 十二月三十一日止年度的綜合財務報表已入賬溢利 約531,000港元(即本集團應佔4Square業績)。於二零 二四年七月十二日,本集團已書面通知4Square現有 股東,本集團不會行使4Square股東於認購期權期間 內授出的認購期權。4Square現有股東可於購回期間 內以購回代價購回本集團持有的所有4Square股份。 4Square股東亦已書面通知本集團其不會行使購回期 權。有關股東協議所界定上述期權條款的詳情,請參 閱本公司日期為二零一八年六月四日的公告。因此, 兩項期權均已於年內失效。本集團於終止確認時已確 認衍生金融工具公平值虧損約8,883,000港元,並已 終止確認衍生金融工具。詳情請參閱綜合財務報表附 註12。

本集團管理層將通過密切監察投資表現及結果,勤勉 監控投資回報並進行全面分析。本集團管理層旨在確 保資源的最佳分配及作出符合本集團目標與發展軌 跡的投資戰略。

除上文所披露者外,截至二零二四年十二月三十一日 止年度,本集團並無持有任何重大投資。

SIGNIFICANT INVESTMENT

During the year ended 31 December 2023, the Group held 21% interest in 4Square Return GmbH ("4Square"), which was classified as the Group's interest in an associate in the consolidated statement of financial position. As disclosed in the announcement of the Company dated 4 June 2018, the Group acquired 2 shares in 4Square, which represents 21% of the entire issued share capital of 4Square, at a consideration of EUR1.600.000 (equivalent to approximately HK\$14,508,000). The carrying amount of the Group's interest in 4Square was approximately HK\$9,774,000 as at 31 December 2024, which represents approximately 5.7% of the total consolidated assets of the Group as at 31 December 2024. 4Square is principally engaged in businesses including compliance consulting and the provision of take back services, etc. While no dividend was declared by 4Square during FY2024, a profit of approximately HK\$531,000 representing the Group's share of results of 4Square was recorded in the consolidated financial statements of the Group for the year ended 31 December 2024. On 12 July 2024, the Group has notified 4Square's existing shareholders in writing that the Group would not exercise the call option granted by 4Square's shareholders during the call option period. 4Square's existing shareholders may buyback all of the shares of 4Square held by the Group within the buy-back period for the buy-back consideration. The 4Square's shareholders have also notified the Group in writing that they would not exercise the buy-back option. Please refer to the Company's announcement dated 4 June 2018 for details on the terms of the above options as defined in the shareholders' agreement. Accordingly, both options were lapsed during the year. The Group has recognised a fair value loss on derivative financial instrument of approximately HK\$8.883,000 upon derecognition and derecognised the derivative financial instrument. For further details, please refer to note 12 to the consolidated financial statements.

The management of the Group will diligently monitor and conduct thorough analyses of the return on investment by closely observing the performance and outcomes of the investments. The management of the Group aims to ensure optimal allocation of resources and make investment strategy that aligns with the Group's objectives and growth trajectory.

Save as disclosed above, the Group did not hold any significant investments during the year ended 31 December 2024.

此外,為增強本集團就IT硬件分銷及履行支援提供創 新收入模式之實力,董事會可於恰當時機出現時考慮 透過股票及/或現金方式進行選擇性策略投資。

外匯風險

It mainly includes managing the foreign exchange exposures and would consider the use of foreign exchange contracts to manage foreign exchange risks, where appropriate. The Company adopted a share option scheme at the annual general meeting held on 11 November 2016. The purpose of the share option scheme is to attract and retain the best available personnel, to provide additional incentive to employees (full-time and part-time), directors and service providers of the Group and to promote the success of the business of the Group.

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), Director or service provider of the Group, options to subscribe for such number of shares as it may determine in accordance with the terms of the share option scheme and the Listing Rules.

The subscription price of a Share in respect of any particular option granted under the share option scheme shall be a price solely determined by the Board and notified to a participant and shall be at least the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the option(s), which must be a business day; (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of grant of the option(s); or (iii) the nominal value of a Share on the date of grant of the option(s).

The total number of Shares issued and to be issued upon the exercise of options granted to any participant (including both exercised and outstanding options) under the share option scheme, in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue. Any further grant of options in excess of such limit must be separately approved by the Shareholders in general meeting with such grantee and his/her close associates (or his/her associates if such grantee is a connected person) abstaining from voting.

An offer for the grant of options must be accepted within seven days, inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of an offer for the grant of option(s) is HK\$1.

Based on the applicable size tests performed with respect to the Caps under the Service Agreement, as the highest applicable percentage ratio in respect of the Caps are more than 5% but less than 25% and the Caps are less than HK\$10,000,000 on an annual basis, the Transactions of Services are only subject to the reporting, annual review and announcement requirements but is exempt from the independent Shareholders' approval requirement under Chapter 20 of the GEM Listing Rules.

Hong Kong Kintex Worldwide Limited (**"Kintex**") is a Hong Kong company principally engaged in trading and repairs of IT products. Mr. Lin Weiru is the sole shareholder and director of Kintex. While Mr. Lin Weiru was appointed as a non-executive Director, he is not involved in the day-to-day management of the Group. The day-to-day management and operations of the Group are performed by its chief executive officer, chief financial officer and global business director based in Hong Kong and Taiwan, and are further monitored by three independent non-executive Directors. As such, the Directors consider that the Group is capable of carrying on its business independently of, and at arms length from, Kintex.

Save as disclosed above, none of the Directors, Controlling Shareholder or their respective close associates (as defined in the GEM Listing Rules) has any interests in a business that competes or may compete either directly or indirectly with the business of the Group as referred to in Rule 11.04 of the GEM Listing Rules.

SUFFICIENCY OF PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the Directors, it is confirmed that there is sufficient public float of at least 25% of the issued Shares at the date of this annual report.

The Director Nomination Policy sets out the selection criteria and process in relation to nomination and appointment of the Directors and the considerations for the Board succession planning and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business.

The Nomination Committee identifies candidates for directorship from various channels, including but not limited to internal promotion, referral by management of the Group and external recruitment agents. The Nomination Committee may also receive nomination of candidates for election as Director(s) from the Shareholder(s).

After the candidates are identified, the Nomination Committee will consider the biographical information of the candidates and evaluate the candidates based on certain criteria and make recommendation to the Board accordingly.

A range of factors are taken into consideration to identify a suitably qualified candidate. These include:-

- character and integrity of the candidate;
- educational background, qualifications (including professional qualifications), knowledge and experience of the candidate which are relevant to the business and operation of the Group;
- time commitment of the candidate to the Group, taking into consideration the other duties of the candidates; and
- the board diversity policy of the Company (the "**Board Diversity Policy**").

The Nomination Committee shall also monitor and review the implementation of the Director Nomination Policy, as appropriate from time to time, and will report to the Board annually. During the year, the Nomination Committee has reviewed the Director Nomination Policy and considered it effective.

The Company recognises and embraces the benefits of having a diverse Board to the quality of its performance. The Board Diversity Policy sets out some guidelines for the composition of the Board in order to achieve diversity in the Board. The Company aims to have a diverse Board composition measurable by objective criteria, including but not limited to gender, age, length of service in the Group, educational background and professional qualifications. Given the nature of the business of the Group, the Company considers that it is beneficial for the Board to have some members with experience and qualification in the information technology industry, in addition to members with financial and legal qualification.

The Director's appointment is made on merits after considering a number of factors, including the educational background, professional experience, skills and knowledge of the candidate. Hence, the Board does not set any particular targets on the minimum number of female representation on the Board. The Board and the Nomination Committee will closely monitor and review from time to time the composition of the Board, identify suitable female candidates from senior management and will take into account the Board Diversity Policy, including gender diversity, in considering appointment to the member of the Board with an aim to maintaining female representation on the Board.

As at 31 December 2024, gender ratio is approximately 24 (male):8 (female) in workforce and approximately 7 (male):1 (female) in senior management, which is regarded by the Board as satisfactory and in line with the industry that the Group operates its businesses in. The Company has not set any objectives for gender ratio in workforce or in senior management. Appointment is primarily made on merits after considering a number of factors, including the educational background, professional experience, skills and knowledge of the candidate. The Group shall further strengthen the gender diversity in the workforce in the future where appropriate.

The Company will continue to use its best efforts to maintain a diverse Board measurable by objectives which are appropriate to the needs of the Company's business. Appointment to the member of the Board will be based on merit and contribution a candidate may bring to the Board, having due regards for the benefits of diversity on the Board.

During the year, the Nomination Committee has reviewed the membership, structure and composition of the Board according to the Board Diversity Policy, and is of the opinion that the structure of the Board is reasonable; gender diversity has been achieved in respect of the Board; and the experiences and skills of the Directors in various aspects and fields can enable the Company to maintain high standard of operation.

Term of Appointment and Rotation

The current Directors (including independent non-executive Directors) are appointed for an initial term of one year and should continue thereafter unless and until terminated by either party by giving to the other not less than three months' notice in writing. Please refer to the paragraph headed "Directors' Letters of Appointment" of the Directors' Report for details on the service contracts/letters of appointment of Directors who served the Company during the year ended 31 December 2024.

Article 84(1) of the articles of association of the Company provides that at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. Accordingly, Mr. Chang Chuan-Wang and Mr. Yeung Wai Hung Peter will retire from office by rotation at the forthcoming annual general meeting of the Company. They, being eligible, will offer themselves for re-election pursuant to Article 84(2) of the articles of association of the Company.

Article 83(3) of the articles of association of the Company provides that any Director appointed by the Board either to fill a casual vacancy on the Board or as an addition to the existing Board from time to time shall hold office until the next following annual general meeting of the Company and shall then be eligible for re-election. Accordingly, Mr. Hsia Ke-Ping and Mr. Lin Weiru who were appointed by the Board during 2024 shall be subject to re-election by the Shareholders at the forthcoming annual general meeting of the Company.

The Nomination Committee has also recommended to the Board that the above-mentioned Directors are eligible for re-election, upon evaluating the respective Director against the selection criteria mentioned above and the independence of Mr. Yeung Wai Hung Peter.

The Audit Committee

The Audit Committee has adopted written terms of reference in compliance with code provisions D.3.3 and D.3.7 of the CG Code.

During the year ended 31 December 2024, members of the Audit Committee were Mr. Li Robin Kit Ling (chairman), Mr. Yeung Wai Hung Peter and Mr. Miao Benny Hua-ben, all of whom are independent non-executive Directors. At the discretion of the Audit Committee, executive Directors and/or senior management personnel overseeing the Group's finance may be invited to attend meetings of the Audit Committee. The Audit Committee normally meets two times a year and also meets the external auditors twice without the presence of the executive Directors. The Audit Committee held four meetings during the year.

The duties of the Audit Committee include, among other things, reviewing and monitoring the financial and internal control systems, risk management system, audit plan and relationship with external auditors, arrangements to enable employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting and internal control or other matters of the Company. The Audit Committee is responsible for reviewing the truth and fairness of the Company's financial statements, annual report, interim report and guarterly reports, discusses with the external auditors the nature and scope of audit before the audit commences as well as the findings and recommendations raised by the auditors during and after completion of the audit. The Audit Committee conducts an assessment, at least annually, of the effectiveness of the Group's internal control and financial controls system, risk management system, scope of work and appointment of external auditors and arrangements for employees to raise concerns about possible improprieties. This allows the Board to monitor the Group's overall financial position and to protect its assets. The chairman of the Audit Committee summarises activities of the Audit Committee, highlights issues arising therefrom, and prepares recommendations for reporting to the Board after each meeting.

The external auditors perform independent statutory audit on the Group's financial statements and as part of the audit engagement, report to the Audit Committee any significant deficiencies (if any) in the Group's internal control system which might come to their attention during the course of audit.

The Board has reviewed the Company's corporate governance policies and practices, continuous professional development of the Directors, the Company's policies and practices on compliance with legal and regulatory requirements, the Company's compliance of the GEM Listing Rules, and the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board has overall responsibility for the design, implementation, monitoring and review of the Group's risk management, and internal control systems to ensure their effectiveness and efficiency. The objective of internal control is to safeguard the Company's assets and ensure its accounting records are properly maintained, so that all the financial information is accurate and reliable. The Group has adopted a series of internal control policies and procedures designed to provide reasonable assurance for achieving the objectives, including effective and efficient operations, reliable financial reporting and compliance with applicable laws and regulations. All employees are committed to continually enhancing the risk management measures to ensure that these measures work in line with the growth of the Group's business strategies and are integrated into day-to-day operation of the business. The Board together with the Audit Committee annually review its risk management and internal control systems.

- establishing and constantly improving the risk management and internal control systems;
- ensuring the Group's risk management and internal control in compliance with the GEM Listing Rules requirements;
- implementing the top-down approach and bottom-up approach that covers every aspect of the business; and
- managing rather than eliminating the risk of failure to achieve business objectives and providing reasonable and not absolute assurance against material misstatement or loss.

In order to continually improve the Group's internal control and risk management system, the Group has established an ongoing process for identifying, evaluating and managing the significant risks faced by the Group. The key procedures that the Group has established and implemented are summarised as follows:

- segregating duties and functions of the respective operational departments of the Group;
- reviewing systems and procedures to identify, measure, manage and control risks; and
- updating the staff handbook, internal control manual and compliance manual where there are changes to business environment or regulatory guidelines.

The Board, by the top-down approach, has a particular focus on determining the nature and extent of significant risks it is willing to take in achieving the business strategies of the Group.

Each department of the Group is responsible for identifying its own risks and designing, implementing and monitoring the relevant risk management and internal control systems. The process involves the maintenance of staff handbook, internal control manual and compliance manual setting out the particulars of material risks together with the control measures as reported by significant departments of the Group. This bottom-up approach is integrated into day-to-day operation and complements the top-down strategic view by identifying the principal risks and ensuring the significant risks to be considered by the Board in determining the risk appetite and the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function. Such risks would include, amongst others, material risks relating to the environment, society and governance.

The Board discussed with the Audit Committee on major findings and control issues. The Board considered that the Group has implemented appropriate procedures in safeguarding the Group's assets and ensuring its accounting records are properly maintained and in compliance with the relevant laws and regulations. In addition, the Board also considered the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting and financial reporting function.

於截至二零二四年十二月三十一日止年度,本集團概 不知悉任何違反有關賄賂、勒索、欺詐及洗錢的法律 及法規因而對本集團構成重大影響的事件。

Internal Audit

Code provision D.2.5 of the CG Code provides that the issuer should have an internal audit function.

The Group does not have an internal audit department for performing internal audit. During the year, the Board reviewed the situation of the Group and considered that setting up an internal audit department within the Group is not cost-effective given the relative small size of the Group. An internal audit function generally carries out the analysis and independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems. Despite the absence of such a department within the Group, the internal audit function is performed by the Board with the advice from Premier Advisory Services Limited, an independent internal control consultant, and the Audit Committee. Please refer to the paragraphs above on the Board's review of the risk management and internal control systems for details.

The Board would review the implementation and effectiveness of the risk management and internal control systems over the past year on an annual basis. Having reviewed the risk management and internal control systems during the year, the Board considers they are effective and adequate for the Group.

ANTI-CORRUPTION POLICY AND WHISTLEBLOWING POLICY

The Group believes in fairness and honesty in business dealing and does not tolerate corruption, bribery, money laundering and other fraudulent activities in connection with any of its business operations. The Group strictly adheres to relevant regulations and laws, such as the Prevention of Bribery Ordinance (Cap. 201 of the Laws of Hong Kong) and the Anti-money Laundering and Counter-terrorist Financing Ordinance (Cap. 615 of the Laws of Hong Kong).

The Group requires employees to strictly conform to the code of business ethics as stipulated in the employment contracts. Cases of conflict of interest must be reported to the Group's management. Employees who engage in business operations and represent the Company's professional image are strictly prohibited from using business opportunities for personal interest or benefit. Service contracts in different amounts are required to be examined and approved by different levels of management.

For the year ended 31 December 2024, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to bribery, extortion, fraud, and money laundering.

The Group has adopted a whistleblowing policy to encourage and enable employees and those who deal with the Group to raise serious concerns within the Group. The policy allows employees to raise genuine concerns about possible improprieties in financial reporting, compliance, and other malpractice, at the earliest opportunity and in an appropriate way with Audit Committee, without fear of reprisal.

The Directors acknowledge their responsibilities in preparing the consolidated financial statements of the Group for the year ended 31 December 2024. The Directors are responsible for overseeing the preparation of financial statements of the Company with a view to ensure that such financial statements reflect a true and fair view of the state of affairs of the Group. The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern. Therefore, the Directors continue to adopt the going concern approach in preparing the consolidated financial statements.

The auditors of the Company acknowledge their reporting responsibilities in the independent auditors' report on the consolidated financial statements for the reporting period.

環境

本集團致力以可持續及負責任之方式營運,並更加重 視環境、社會及管治考慮,以確保其長期成功穩定。

排放物

本集團深知其作為企業公民的責任。我們瞭解環境管 理及社會責任為可持續業務成功所不可或缺的一部 分,並致力於在促進財務增長的同時,盡量減少營運 對環境的影響。

儘管我們的日常營運不會對環境造成重大影響,但我 們瞭解若干過程存在潛在危害。例如,任何產生有害 廢棄物的活動(例如製造IT產品)均外判予經授權及可 靠的合作夥伴。該等合作夥伴擁有專業知識及設施, 能夠以環保及合規的方式處理有關廢棄物。

本集團的溫室氣體(「**溫室氣體**」) 排放主要來自照明、 空調及辦公設備用電。我們深明這一點,且不斷採取 積極措施。我們積極監察及管理所有營運的環境影 響。我們的目標為盡量減少排放,方式為提高能源效 益、採用更多可持續技術以及探索可再生能源。

本集團長期將環境可持續發展納入業務營運。管理層 定期監察生態表現,以確保符合我們的綠色目標。在 採購材料及設備前,本集團會進行全面評估。我們仔 細評估所考慮項目的潛在環境危害及節能能力。此做 法讓我們能夠在不犧牲營運效率的情況下作出優先 考慮可持續發展的決策。在本集團的辦公室內,我們 已實施若干節能措施。例如,室內溫度設置及空調系 統的運行時間均已預先釐定及優化。該等調整乃為減 少能源消耗及盡量減少碳排放。此外,我們鼓勵員工 盡量採用虛擬會議。透過此方式,我們大幅減少商務 差旅,降低碳足跡,並提高整體工作效率。

由於我們的業務營運不涉及工業規模的活動或大量 使用車輛,故我們並無固定或流動燃燒排放記錄。本 集團溫室氣體排放的主要來源為辦公室用電。此消耗 導致間接排放溫室氣體,為我們購買的電力來源在發 電過程中的副產品。儘管我們的營運對環境的影響相 對較低,但我們仍致力於持續改進。我們將繼續探索 並實施新策略,以進一步減少我們的環境足跡,為更 加可持續的未來作出貢獻。

ENVIRONMENT

The Group is committed to conducting its business operations sustainably and responsibly, attaching more significance to ESG considerations to guarantee its long-term prosperity and stability.

Emissions

The Group is acutely aware of its responsibilities as a corporate citizen. Recognizing that environmental stewardship and social responsibility are integral to sustainable business success, we are committed to minimizing the environmental footprint of our operations while fostering financial growth.

Although our day-to-day operations do not cause substantial environmental impacts, we recognize the potential hazards associated with certain processes. For instance, any activities that generate hazardous waste, like manufacturing IT products, are outsourced to authorized and reliable partners. These partners have the expertise and facilities to handle such waste in an environmentally friendly and compliant manner.

The Group's greenhouse gas ("GHG") emissions primarily stem from using electricity for lighting, air conditioning, and office equipment. We are acutely aware of this and are continuously taking proactive steps. We actively monitor and manage the environmental implications of all our operations. We aim to minimize emissions to the greatest extent feasible by improving energy efficiency, adopting more sustainable technologies, and exploring renewable energy sources.

The Group has long incorporated environmental sustainability into business operations. The management regularly monitors ecological performance to ensure alignment with our green goals. Before procuring materials and equipment, the Group conducts a comprehensive assessment. We carefully evaluate the potential environmental harm and the energy-saving capabilities of the items under consideration. This practice allows us to make decisions prioritizing sustainability without sacrificing operational efficiency. Within the Group's offices, we have implemented several energy-conservation measures. For instance, the indoor temperature settings and the running time of the airconditioning systems are pre-determined and optimized. These adjustments are made to reduce energy consumption and minimize carbon emissions. Additionally, we encourage our employees to embrace virtual meetings and conferences whenever possible. By doing so, we significantly reduce business travel, reduce our carbon footprint, and enhance overall work efficiency.

Since our business operations do not involve industrial-scale activities or significant vehicle usage, we have no record of stationary or mobile combustion emissions. The primary source of the Group's GHG emissions is electricity consumption for office use. This consumption leads to indirect GHG emissions, which are a by-product of the electricity generation process from the power sources we purchase. Despite the relatively low-impact nature of our operations, we remain committed to continuous improvement. We will keep exploring and implementing new strategies to further reduce our environmental footprint and contribute to a more sustainable future.

廢棄物管理

Waste Management

在日常辦公營運中,本集團僅產生無害固體廢棄物, 主要由生活垃圾及紙張組成。鑑於所產生的無害廢棄 物量相對較少,物業管理公司負責其管理及處理。因 此,相關關鍵績效指標(「**關鍵績效指標**」)並不適用。

本集團已採取多項積極措施以盡量減少進一步產生 無害廢棄物。首先,我們委聘專業清潔承辦商回收敏 感紙張文件。此舉確保保密資料獲妥善處理,並促進 紙張回收。此外,我們亦加強辦公室內的回收工作。 我們策略性地在辦公室各處設置指定的回收箱,用於 分別收集紙張廢棄物、塑膠瓶及鋁罐。此源頭分離的 做法簡化回收過程,並提高成功回收的可能性。

本集團明白辦公室用紙對林業資源的環境影響,故大 力推行「減少、重複使用及回收」政策以節約用紙。

減少:本集團鼓勵員工採用數碼優先方式。我們敦促 員工盡量閱讀電子文件而非打印文件。當無法避免打 印時,必須雙面打印。為此,本集團亦投資升級其辦 公軟件,令查看電子文件及加上註釋更方便。同時, 於購買打印機時,本集團考慮整合設備功能,減少購 買不必要的設備。打印機結合打印、掃描、影印及傳 真功能。此方法減少設備佔用的空間,並降低能源消 耗。 During daily office operations, the Group generates only non-hazardous solid waste, primarily composed of domestic waste and paper. Given the relatively small volume of non-hazardous waste it produces, the property management undertakes responsibility for its management and processing. As a result, relevant Key Performance Indicators ("**KPIs**") are not applicable.

The Group has taken several proactive steps to minimize the further generation of non-hazardous waste. Firstly, a professional cleaning contractor has been engaged in recycling sensitive paper documents. This ensures the proper disposal of confidential information and promotes paper recycling. Additionally, in-office recycling has been enhanced. Designated recycled boxes are strategically placed throughout the offices for the separate collection of paper waste, plastic bottles, and aluminum cans. This separation at the source simplifies the recycling process and increases the likelihood of successful recycling.

Recognizing the environmental impact of office paper usage on forestry resources, the Group has vigorously promoted a "Reduce, Reuse, and Recycle" policy to conserve paper.

Reduce: The Group encourages its staff to embrace a digital-first approach. Employees are urged to read electronic files instead of printing documents whenever possible. When printing is inevitable, double-sided printing is mandatory. To support this, the Group has also invested in upgrading its office software to make viewing and annotating electronic documents more convenient. Meanwhile, when purchasing printers, the Group considers the integration of device functions and reduces the purchase of unnecessary equipment. The printer combines printing, scanning, copying, and faxing functions. This approach reduces the floor space occupied by the equipment and cuts down on energy consumption.

廢棄物管理(續)

重複使用:為方便紙張使用,我們在打印機及影印機 旁設置箱子收集使用過的單面紙。我們透過內部溝通 及小獎勵,鼓勵員工使用該等紙張打印草稿。此外, 本集團亦展開計劃,員工可申請紙箱作儲物用途,而 非購買新的儲物容器。

回收:我們已將使用過的墨盒及碳粉盒回收系統化。 我們在辦公室內設有特定收集點,建立簡單的收集流 程。本集團亦與獲認證的回收合作夥伴合作,確保該 等墨盒及碳粉盒以環保的方式回收。

除該等節約用紙措施外,本集團亦將 KHAN-NA 紙張 納入營運。該獨特的可持續纖維有助減少用紙對環境 的影響,並為全球減緩氣候變化工作作出貢獻。

Waste Management (continued)

Reuse: To facilitate paper use, boxes are placed beside printers and photocopies to collect single-sided used papers. Employees are incentivized to use these papers for draft printing through internal communication and small rewards. Moreover, the Group has started a program where employees can request paper boxes for storage purposes rather than purchasing new storage containers.

Recycle: The recycling of used ink and toner cartridges from printers has been systematized. A straightforward collection process has been established with specific collection points within the office. The Group also collaborates with certified recycling partners to ensure that these cartridges are recycled in an environmentally friendly manner.

Beyond these paper-saving initiatives, the Group has incorporated KHAN-NA paper into its operations. This unique type of sustainable fiber helps reduce the environmental impact of paper use and contributes to the global effort to mitigate climate change.

資源使用

本集團的業務營運結構令辦公室內的能源、電力及用 水需求基本上影響較小。我們的辦公活動對能源資 源或水供應商的負擔不大。其與我們在環境、社會及 管治框架項下對環境可持續發展的承擔一致,我們致 力於將生態足跡降到最低。在我們的香港和澳洲辦公 室,用水量微乎其微;辦公室所在大廈的水管理基礎設施性 質複雜,且我們辦公室的個別用水量極少,因此無法 獨立計算及取得辦公室的具體用水數據。因此,我們 目前未能披露與用水相關的關鍵績效指標。

鑑於用水量持續處於低位,我們並無制定具體的用水 效率目標。然而,其並不代表我們抱持自滿態度。我 們不斷探索加強節水工作的機會,並將在情況許可時 制定適當目標。於報告期間內,我們在取得符合辦公 室需求的水資源方面並無遇到任何困難。其顯示我們 當地供水系統可靠,並反映我們用水相關的環境、社 會及管治情況相對穩定。我們仍然致力於按照更廣大 的環境、社會及管治目標監察及改進我們的用水相關 常規。

本集團堅定致力於環境管理,積極營造環保的工作環 境,以保護天然資源。就節能措施而言,我們將空調 維持在攝氏25度,並設置定時器在辦公時間外關閉。 我們亦充分利用自然光,並鼓勵員工在不使用時關 閉燈光及電器。就辦公用品而言,我們提借電子文件 處理。在不可避免地紙張使用時,除正式及保密文件 外,我們建議雙面打印。

為進一步減少我們的碳足跡,我們已在辦公室安裝視 像會議系統。此舉不僅減少商務差旅排放,亦提升溝 通效率。通過該等工作,我們的目標為盡量減少環境 影響,並樹立可持續業務營運的榜樣。

The Group's business operations are structured in a way that the energy, power, and water usage within its offices is inherently low impact. Our office activities do not place a heavy burden on energy resources or water suppliers. This aligns with our commitment to environmental sustainability under the ESG framework as we strive to minimize our ecological footprint. In our Hong Kong and Australia office, water consumption is negligible; the building management system is responsible for water management in the building where our office is located. Due to the complex nature of the building-wide water management infrastructure and our office's minimal individual usage, it is impossible to segregate and retrieve the specific water consumption data for our office. As a result, we are unable to disclose the relevant KPIs related to water consumption at this time.

Given the consistently low water usage, we have not yet set a specific waterefficiency target. However, this does not mean we are complacent. We continuously explore opportunities to enhance our water conservation efforts and will establish appropriate targets when the situation allows. During the Reporting Period, we did not encounter any difficulties in accessing water that meets our office's requirements. This indicates the reliability of our local water supply systems and reflects our relatively stable water-related ESG situation. We remain committed to monitoring and improving our water-related practices in line with broader ESG goals.

The Group is deeply committed to environmental stewardship, actively cultivating an eco-friendly work environment to safeguard natural resources. Regarding energy conservation, we maintain the air-conditioning at 25 degrees Celsius and programmed timer is set to turn it off outside office hours. We also maximize the use of natural light and encourage employees to switch off lights and electrical devices when not in use. Regarding office supplies, we promote electronic document handling. Double-sided printing is recommended when paper use is inevitable, except for formal and confidential documents.

To further reduce our carbon footprint, we've installed video-conference systems in offices. This not only cuts down on business travel emissions but also boosts communication efficiency. Through these efforts, we aim to minimize our environmental impact and lead by example in sustainable business operations.

Environment and Natural Resources

The Group places a high premium on environmentally friendly operations and is committed to reducing its impact on the environment and natural resources to the greatest extent possible. Given the nature of our business operations, the Group does not directly produce industrial pollutants. Moreover, we have not detected any significant generation of either hazardous or non-hazardous waste. As of 31 December 2024, the Group has not been aware of any material non-compliance cases about the applicable laws and regulations on environmental protection concerning air quality, greenhouse gas emissions, water and land discharges, as well as the generation of hazardous and non-hazardous waste.

Climate Change

The Group highly emphasizes the urgency of climate risk management. The Group has adopted the TCFD framework to safeguard a sustainable homeland. The four major elements of governance, strategy, risk management, and metrics & targets transparently disclose the management of the status of the Group's key climate risks and opportunities.

Governance

The Board holds regular meetings to discuss ESG-related topics, oversees the formulation of goals related to climate-related risks and opportunities, and monitors the progress in achieving these goals. The management is responsible for coordinating and communicating with internal and external stakeholders regarding climate issues, determining countermeasures for climate problems, formulating implementation strategies, and classifying and evaluating the importance of climate-related risks and problems.

Strategy

The Group continuously reviews our climate strategy and identifies climaterelated risks and opportunities over short-term, medium-term, and long-term horizons through scenario analysis

Risk Management

The designated management personnel are responsible for organizing and coordinating relevant units and departments to conduct risk identification and assessment. They integrate a list of the Group's climate-related risk and opportunity topics and hold training and identification meetings. Based on the levels of various risk issues and the function of different units, the Group constructs a hierarchical risk-management process. The Group improves the overall climate-related risk-management process according to different management levels and the impact of risk issues.

Meanwhile, the Group communicates with stakeholders further and conducts comprehensive analyses to summarize the Group's major climate-related risks and opportunities, existing achievements, and corresponding countermeasures. After the final identification results are reviewed by senior management, the major climate-related risks and opportunities are incorporated into the Group's risk control and contingency procedures.

Metrics and Targets

In pursuing environmental sustainability and responding to the global call for climate action, we are meticulously developing a robust set of goals and targets with the overarching aim of significantly reducing energy consumption and GHG emissions, ultimately striving to achieve net-zero emissions.

Their insights and efforts are crucial in implementing our strategies to enhance risk resilience and ensure sustainable business development.

The Group places high regard on the compliance of relevant employment laws and regulations relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, antidiscrimination, and other benefits and welfare in the jurisdictions in which it operates, including but not limited to laws of Hong Kong including the Race Discrimination Ordinance (Cap. 602), the Employment Ordinance (Cap. 57), the Mandatory Provident Fund Schemes Ordinance (Cap. 485), the Minimum Wage Ordinance (Cap. 608); the Labour Law of the People's Republic of China; the Fair Work Act 2009 of Australia; and the Labour Standards Act of Japan, and the relevant administrative rules and measures are strictly enforced. The Employee Handbook clearly states the guidelines relating to employment, labour relations, employees' remuneration and welfare to protect the rights of employees.

For the FY2024, the Group has not identified any non-compliance with laws, regulations, and policies governing employment and labour practices. These regulations are of utmost importance, and any non-compliance could substantially impact the Group. We are confident that our employment and labor-related operations are in full alignment with all relevant requirements, ensuring a fair and legal working environment for all our employees.

勞工準則

Labour Standards

本集團高度重視人權及自由。我們反對於在工作場所 使用童工及強迫勞工的立場堅定不移。為確保合規, 我們嚴格遵守香港法例第57章《僱傭條例》中的《僱用 童工規例》及《僱用青年(工業)規例》。此外,我們亦遵 守澳洲的《二零零九年公平工作法》、《中華人民共和 國勞動法》及日本的《勞動基準法》。

根據香港的相關法律及法規,本集團透過書面僱傭合約與每位員工正式確立僱傭關係。僱傭合約明確規定工作職責、工作地點及工作時間等重要細節。其不僅保障員工權利及權益,亦反映我們對全球範圍內道德 及合法僱傭慣例的承擔。

在聘用任何應徵者前,本集團會實施全面的招聘程 序。首先必須檢查及核實應徵者年齡。應徵者必須出 示有效的身份證明文件,作為該等程序的一部分。其 對於確認彼等已達法定工作年齡及有資格在相關國 家工作而言至關重要。此外,懷疑學歷或工作經驗造 假的應徵者將不獲考慮聘用。本集團致力於為員工提 供安全、健康及舒適的工作環境、勞工保護、合理薪 酬、適當工作時間及各種福利。 The Group places great emphasis on human rights and freedom. We are unwavering in our stance against the use of children and forced labour within our workplace. To ensure compliance, we strictly abide by regulations such as the Employment of Children Regulations and Employment of Young Persons (Industry) Regulations, which are part of the Employment Ordinance (Cap. 57) in the Laws of Hong Kong. Additionally, we adhere to the Fair Work Act 2009 of Australia, the Labour Law of the People's Republic of China and the Labour Standards Act of Japan.

In line with the relevant laws and regulations in Hong Kong, the Group formalizes the employment relationship with each of its employees through written employment contracts. The employment contract clearly outlines important details such as job duties, work locations, and working hours. This not only safeguards the rights and interests of our employees but also reflects our commitment to ethical and legal employment practices on a global scale.

Before hiring any applicant, the Group enforces comprehensive recruitment procedures. First and foremost, checking and verifying the applicant's age is essential. The applicant must present valid proof of identity as part of these procedures. This is crucial to confirm that they have reached legal working age and are eligible for employment in the relevant countries. Additionally, applicants suspected of having false academic qualifications or work experience will not be considered for employment. The Group is committed to providing its staff with a safe, healthy, and comfortable working environment, labour protection, reasonable remuneration, appropriate working hours, and various welfare benefits.

During the Reporting period. The Group was unaware of any non-compliance with laws and regulations related to the prevention of children and forced labour that would have a material impact on the Group. This indicates that the Group's operations are aligned with these crucial legal requirements, which safeguard fundamental human rights and ensure ethical business practices.

Health and Safety

The Group's business operations do not involve high-risk activities. We emphasize the occupational safety, hygiene, and health of our employees and strive to the best of our ability to create a safe and comfortable working environment for them. We have purchased air purifiers to improve air quality and enhance the working environment. To ensure a healthier and more pleasant workplace, we strictly prohibit all employees and visitors from smoking in the office. This measure not only safeguards the health of non-smokers from the risks associated with passive smoking but also helps prevent an increase in fire hazards within the office premises. All employees are provided with the necessary protective equipment.

In addition, the Group has formulated safety procedures for potentially hazardous work. Internal guidelines have been incorporated into the employee handbook to heighten employees' awareness of workplace safety. Employees with health and safety concerns or identifying potential hazards must contact their department heads or senior human resources personnel. Furthermore, they are entitled to medical insurance coverage, which reflects our commitment to their well-being.

In setting up the Group's occupational health and safety measures, we adhere to the guidelines provided by the labour departments of our regional subsidiaries. Our operations are in full compliance with relevant laws and regulations. In Hong Kong, this includes the Occupational Safety and Health Ordinance (Cap. 509) and the Employees' Compensation Ordinance (Cap.282). In Japan, we comply with the Industrial Safety and Health Act (Act No.57 of 1972). In Australia, we adhere to the Work Health and Safety Act 2011. In the People's Republic of China, we adhere to the Law of the People's Republic of China on Prevention and Control of Occupational Diseases.

The Group has maintained a healthy and safe working environment over the past three years, including the Reporting Period. There have been no reported lost days due to work-related injuries, and no work-related fatalities have occurred. As of 31 December 2024, the Group is unaware of any noncompliance with relevant health and safety laws and regulations. This indicates the Group's commitment to ensuring the well-being of its employees and compliance with legal requirements.

發展及培訓

本集團確信員工培訓為提升員工能力、工作技能、專 業知識及工作表現的重要方式。接受專業培訓的員工 可為公眾提供更可靠的保護。同時,他們更能夠滿足 客戶期望及專業要求,從而可提供高質量的服務。因 此,本集團一直致力於全面支持員工的個人成長及職 業發展。

本集團的培訓計劃分為兩大類:內部培訓及外部培 訓。例如,處理敏感資料或精密儀器的員工需參加外 部培訓,瞭解相關法規和操作規範,以減少風險。就 內部培訓而言,本集團定期在香港辦公室舉辦領導 及管理課程。此外,我們亦舉辦團隊建設活動及研討 會,以加強團隊合作。本集團提供工作時間內培訓及 補貼機制,以支持員工的培訓。我們鼓勵員工根據職 業需求計劃自己的培訓,選擇網上課程、研討會或認 證培訓等資源,全部均獲本集團支持。該等工作旨在 激發員工的學習動力及推動職業發展。

Development and Training

The Group firmly believes that employee training is a crucial means to enhance employees' capabilities, work skills, professional expertise, and job performance. Employees who have received professional training can provide more reliable protection to the public. Meanwhile, they can better meet clients' expectations and professional requirements, thereby delivering highquality services. Therefore, the Group has been committed to comprehensively supporting its employees' personal growth and career development.

The Group's training programs fall into two main categories: internal and external. For instance, employees handling sensitive information or precision instruments attend external training on relevant regulations and operation specs to reduce risks. Regarding internal training, the Group regularly holds leadership and management courses in the Hong Kong office. Team-building activities and seminars are also organized to strengthen teamwork. The Group offers work-hour training access and a subsidy mechanism to support employees' training. Employees are encouraged to plan their own training based on career needs and choose resources like online courses, seminars, or certification training, all with the Group's support. These efforts aim to fuel employees' learning drive and career development.

Supply Chain Management

本集團積極探索創新採購策略,以減少環境足跡及提 升資源效率。其目標為與供應鏈合作夥伴共同進步。 本集團的採購策略設計中納入環境、社會及管治考 量。其確保供應鏈活動不僅符合本集團在效率、成本 效益、產品質量及創新能力方面的業務目標,亦準確 回應社會責任及環境保護的需要。本集團的供應商遍 佈多個國家及地區,反映本集團在全球市場的廣泛佈 局。

本集團的供應商管理流程作為一個循環機制運作,分 為四個主要階段:

評估及認證:本集團在供應商合約中設定環境、社會 及管治標準。其加強供應商責任感,減少營運風險, 並提升供應鏈對環境保護及社會責任的重視。

表現監察:本集團對主要供應商進行環境、社會及管 治表現評估。首批評估項目包括實現淨零碳排放及零 綠色產品。分數較低的供應商將被要求改進其表現。 The Group is actively exploring innovative procurement strategies to reduce its environmental footprint and enhance resource efficiency. It aims to progress together with its supply chain partners. The Group's procurement strategies are designed to incorporate ESG consideration. This ensures that supply chain activities not only meet the Group's business objectives in terms of efficiency, cost-effectiveness, product quality, and innovation capabilities but also precisely respond to the needs of social responsibilities and environmental protection. The Group's suppliers are spread across multiple countries and regions, reflecting the Group's extensive presence in the global market.

The Group's supplier management process operates as a cyclic mechanism, which consists of four main stages:

Evaluations and Certification: The Group defines ESG standards in supplier contracts. This strengthens suppliers' sense of responsibility, reduces operational risks, and heightens the supply chain's focus on environmental protection and social responsibility.

Performance Monitoring: The Group initiates ESG performance evaluations for major suppliers. The first batch of evaluation items includes net-zero carbon emissions and zero-green products. Suppliers with low-ranking scores will be urged to improve their performance.

審核及引導:本集團將對「高風險供應商」及環境、社 會及管治表現欠佳的供應商進行進一步審核及引導。 我們對主要供應商實施重要管理。根據缺陷的嚴重程 度,其將決定供應商為失去資格或需在規定時間內提 交改進計劃及實施糾正措施。未能及時改進的供應商 將被列入表現欠佳供應商名單。

適者生存原則:我們根據供應商年度表現排名,識別 出環境、社會及管治表現優秀及欠佳的供應商。對於 表現優秀的供應商將予以獎勵。對於表現欠佳的供應 商,我們將減少其年度採購金額、數量或份額。我們 會報告不配合改進工作的供應商將,並列入本集團表 現欠佳供應商名單,使用該等供應商將受到限制。

在相同條件下,本集團會優先向各業務區域的當地供 應商採購。此舉有多個目的。首先,其縮短供應商的 交貨週期,從而提高供應鏈韌性。其次,其減少產品 運輸中的能源消耗,從而降低碳排放。此外,此舉促 進當地經濟發展,為當地社區居民創造更多就業機 會。

本集團非常重視與供應商的溝通。其涉及日常營運中 的持續互動及建立戰略夥伴關係。本集團透過提供 技術支援並利用其獨特的競爭優勢,旨在實現雙贏局 面,加強與供應商的聯繫。按總數計,本集團與213間 供應商保持密切關係(在二零二三年,數目為180間)。 該等供應商可根據其地理區域分類如下:

Supply Chain Management (continued)

Auditing and Guidance: The Group will conduct further audits and guidance for "high-risk suppliers" and those with poor ESG performance. Key management is implemented for major suppliers. Depending on the severity of the deficiencies, it will be determined whether a supplier loses its qualification or needs to submit an improvement plan and implement corrective measures within a specified time limit. Those that fail to improve on time will be included in the list of suppliers with poor performance.

The Principle of Survival of the Fittest: Based on the annual performance rankings of suppliers, those with excellent and poor ESG performance are identified. Suppliers with excellent performance will be rewarded. For suppliers with poor performance, their annual procurement amounts, quantities, or shares will be reduced. Those who do not cooperate with the improvement efforts will be reported and included in the Group's list of suppliers with poor performance, and their use will be restricted.

Under the same conditions, the Group gives preference to procuring from local suppliers in each business area. This approach serves multiple purposes. Firstly, it shortens the delivery cycle of suppliers, thereby enhancing the supply chain's resilience. Secondly, it reduces energy consumption in transportation products, which in turn lowers carbon emissions. Additionally, this practice promotes local economic development and creates more job opportunities for the residents of local communities.

The Group places great importance on communicating with suppliers. This involves ongoing interaction during routine operations and forging strategic partnerships. By offering technical support and leveraging its unique competitive edge, the Group aims to achieve a win-win scenario, strengthening the bond with suppliers. In total, the Group maintained close relationships with 213 suppliers (in 2023, this number was 180). These suppliers can be categorized according to their geographical regions as follows:

產品責任

本集團全力承擔所有產品相關營運的環境責任。在設 計、銷售及分銷產品時,本集團充分考慮環境因素。 其包括使用可再生及無害的原材料,並採用符合能源 效益的生產流程,以盡量減少碳足跡。我們將包裝簡 化以減少浪費,並優先選擇低碳運輸方式進行分銷; 產品設計環保而耐用,旨在減少客戶在使用過程中對 天然資源及能源的消耗。在產品生命週期結束階段, 盡量提高可回收性及可重用性為確保可持續產品生 命週期的主要考慮。

在銷售及分銷新產品前,本集團會進行深入市場研究 及競爭對手的基準測試。其亦評估整個產品生命週期 的環境及社會風險,方式為分析外部因素(技術趨勢、 環境法規及客戶偏好)及內部因素(企業文化及生產能 力)。我們仔細考慮持份者的關注及期望,以識別新興 風險及機遇,從而及時檢討及調整目標及策略。我們 從合規性、產品可持續性、安全性及不斷變化的客戶 需求等多個方面評估風險。就此,本集團可以在履行 其環境及社會責任的同時保持其競爭力。

本集團十分重視保護私隱。所有技術專家均須簽署保 密協議,以確保客戶資料及數據安全。所有員工均有 責任對客戶資料保密(不論取得方式為何)。我們對私 隱保護的承擔亦延伸至員工及分包商。我們遵守員工 手冊中的指引及相關法例,例如香港法例第486章《個 人資料(私隱)條例》,以極大的謹慎及完全合法的方 式處理所有個人資料,以建立與持份者之間的信任。

Product Responsibility

The Group is fully committed to environmental responsibility in all productrelated operations. The Group fully considers environmental factors when designing, selling, and distributing products. These include using renewable and non-hazardous raw materials and adopting energy-efficient production processes to minimize the carbon footprint. Packaging is simplified to reduce waste, and low-carbon transportation methods are prioritized for distribution; the products are designed to be both eco-friendly and durable, aiming to cut down on customers' natural resources and energy consumption during use. At the end-of-life stage, maximizing recyclability and reusability is a key consideration to ensure a sustainable product life cycle.

Before selling and distributing new products, the Group conducts in-depth market research and benchmarks against competitors. It also assesses environmental and social risks throughout the product life cycle by analyzing external factors like technological trends, environmental regulations, and customer preferences, as well as internal factors such as corporate culture and production capacity. Stakeholder concerns and expectations are carefully considered to identify emerging risks and opportunities, allowing for timely reviews and adjustments of goals and strategies. Risks are evaluated from multiple aspects, including compliance, product sustainability, safety, and changing customer demands. In this way, the Group can maintain its competitiveness while fulfilling its environmental and social responsibilities.

The Group places top priority on safeguarding privacy. All technical specialists are required sign confidentiality agreements to ensure the security of clients' information and data. All employees are duty-bound to keep client data confidential, regardless of how they obtain it. Our commitment to privacy protection also encompasses employees and subcontractors. We adhere to the guidelines in our Employee Handbook and relevant laws like the Personal Data (Privacy) Ordinance (Chapter 486) of Hong Kong Laws, handling all personal data with great care and full legal compliance to build trust among stakeholders.

截至二零二四年十二月三十一日,經過徹底審查及據 本集團所深知,並無產品及服務違反健康及安全、廣 告、標籤以及私隱事宜等方面的法律及法規的事件。 此合規記錄彰顯本集團致力在合法範圍內營運並在 所有業務營運中保持最高標準。

反貪污

The Group is firmly committed to upholding fair advertising practices. To this end, all employees from sales department are strictly required to present customers with precise and truthful details about the Group's products and services. To further enhance customer experience, we offer a hotline and an email address dedicated to answering customer inquiries regarding service particulars, ensuring high-quality pre-sale and post-sale support. During the Reporting Period, the Group didn't involve in any labeling issues relating to the products and services provided.

As of 31 December 2024, after a thorough review and to the best of the Group's knowledge, there were no instances of non-compliance with laws and regulations in areas such as health and safety, advertising, labeling, and privacy matters associated with the products and services. This compliance record underscores the Group's dedication to operating within the bounds of legality and maintaining the highest standards in all business operations.

Anti-corruption

The Group adheres to an enterprise culture of integrity-based operations and adopts a zero-tolerance policy towards any illegal and non-compliant behaviors and activities. It fully complies with anti-corruption and anti-bribery regulatory requirements, such as the Prevention of Bribery Ordinance (Chapter 201), the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Chapter 615) of the Laws of Hong Kong. By strictly abiding by these regulations, the Group aims to ensure the fairness and transparency of its business operations and safeguard all stakeholders' legitimate rights and interests.

The Group's internal anti-corruption policies define strict behavioral norms for employees. The Group commits to publicly disclosing its integrity-based business management policies. The Group subscribes to the Hong Kong Business Ethics Development Center's newsletter to boost employees' awareness of corruption risks and keep them from being corrupted. This center provides free anti-corruption and ethics training to companies. Meanwhile, the Group invites major business partners with whom it has dealings to participate in the training to ensure the effective implementation of the Group's policies. We commit to conducting business activities fairly and transparently. Before engaging in business dealings, the Group will consider the legitimacy of agents, suppliers, customers, or other business counterparts, as well as whether they have a record of dishonest behavior, to avoid transactions with them.

Employees and external third parties are encouraged to actively monitor and report any major behaviors that may violate honest trading. They can directly report to directors or supervisors. For the employees or external third parties reporting clues or evidence, appropriate rewards will be provided once verified to be true. The development trends and cases of integrity-based business norms will be closely followed. Directors, supervisors, managers, and all employees are urged to make suggestions for improvement. Timely revisions will be made to enhance the effectiveness of integrity-based business operations.

As of 31 December 2024, the Group was unaware of any non-compliance with laws and regulations regarding bribery, extortion, fraud, and money laundering that significantly impacted the Group.

Community Investment and Involvement

In 2024, the Group remained committed to fostering strong community bonds and addressing the needs of vulnerable groups within our local area. One of the significant initiatives we undertook was organizing a heartwarming eventtreading the elderly to a "Luck Meal". This activity provided the elderly with a rare opportunity to socialize and enjoy a special meal. Many of them may live alone or have limited social interactions. Gathering for the "Luck Meal" allowed them to break the monotony of daily life, share stories, and strengthen the community bonds.

The Group has always firmly adhered to its social responsibilities and continuously dedicated itself to assisting vulnerable groups. We actively mobilize employees to contribute their personal time and apply their professional skills by engaging in various public welfare activities, creating tangible benefits for the residents of the local community. This provides employees with valuable opportunities to understand social issues deeply and encourages them to enhance their social responsibility. Meanwhile, it also further demonstrates and strengthens the Group's corporate value in practice, propelling the common progress of the Group and society.

We have audited the consolidated financial statements of CircuTech International Holdings Limited (the "**Company**") and its subsidiaries (together the "**Group**") set out on pages 92 to 175, which comprise the consolidated statement of financial position as at 31 December 2024, and the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2024, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

Basis for Opinion

We conducted our audit in accordance with Hong Kong Standards on Auditing ("**HKSAs**") issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Consolidated Financial Statements" section of our report. We are independent of the Group in accordance with the HKICPA's "Code of Ethics for Professional Accountants" (the "**Code**"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

貴集團採用香港財務報告準則第9號的簡化方法計量 預期信貸虧損,其對所有應收賬款使用全期預期虧損 撥備。年內,管理層進行評估,以計量預期信貸虧損, 當中已考慮債務人的背景及歷史付款記錄,以及影響 信貸風險的主要經濟變量,以估計違約風險和預期虧 損率。

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Key Audit Matters

Impairment assessment on trade receivables

As at 31 December 2024, the Group had gross trade receivables of approximately HK\$79,674,000 and no loss allowance is provided. We identified impairment assessment of trade receivables as a key audit matter due to the significance of trade receivables to the Group's consolidated financial position and the involvement of subjective judgement and management estimates in evaluating the expected credit losses ("**ECLs**") of the Groups' trade receivables at the end of the reporting period.

The Group applies the HKFRS 9 simplified approach to measure ECLs which uses a lifetime expected loss allowance for all trade receivables. The management performed assessment to measure the ECLs with consideration of the debtor's background and historical payment record during the year and the key economic variables impacting credit risk to estimate the risk of default and expected loss rates.

Refer to summary of accounting policies of accounting policies in note 2.8.4, financial risk factors on credit risk in note 3.1(b), accounting estimates and judgements in note 4(d) and disclosure of trade receivables in note 19 and 19 (a) to the consolidated financial statements, respectively.

Our response:

Our audit procedures in relation to management's impairment assessment on trade receivables included:

- assessing the appropriateness of the credit loss provisioning methodologies used by the Group;
- challenging management's basis and judgement in determining credit
 loss allowance on trade receivables as at year end date, including their
 identification of credit-impaired trade receivables;
- testing the integrity of information used by management to develop the provision matrix by checking supporting information for the nature and industry of the debtors, on a sample basis; and
- assessing the estimates used to determine the expected credit losses by considering cash collection performance against historical trends and assessing the reasonableness of forward-looking factors included in the expected credit loss model.

1 一般資料

訊智海國際控股有限公司(「本公司」)及其附屬 公司(統稱「本集團」)主要從事IT產品的銷售及 分銷以及提供IT產品的維修及其他服務支援。

本公司為於開曼群島註冊成立之有限公司,其 註冊辦事處地址為Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands。

本公司以聯交所GEM為第一上市地。

除另有所指外,該等綜合財務報表乃以港元 (「**港元**」)呈列,所有數值均約整至最接近千 位。

2 主要會計政策概要

本附註提供編製該等綜合財務報表時所採納之 主要會計政策清單。除另有說明外,該等政策於 所有呈報年度的應用貫徹一致。該等綜合財務 報表乃為本集團(由訊智海國際控股有限公司 及其附屬公司組成)編製。

2.1 編製基準

(i) 合規聲明

該等綜合財務報表已根據香港會計師公會(「**香港會計師公會**」)頒佈之 香港財務報告準則、香港會計準則 (「**香港會計準則」**)及詮釋(以下統 稱「**香港財務報告準則」**)及香港公 司條例之披露規定而編製。此外, 該等綜合財務報表包括聯交所GEM 證券上市規則規定之適用披露事 項。

1 GENERAL INFORMATION

CircuTech International Holdings Limited (the "**Company**") and its subsidiaries (together, the "**Group**") is principally engaged in the sales and distribution of IT products, and the provision of repairs and other service support of IT products.

The Company is a limited liability company incorporated in the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

The Company has its primary listing on GEM of the Stock Exchange.

These consolidated financial statements are presented in Hong Kong dollars ("**HK\$**") and all values are rounded to the nearest thousand, unless otherwise indicated.

2 SUMMARY OF MATERIAL ACCOUNTING POLICIES

This note provides a list of the material accounting policies adopted in the preparation of these consolidated financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. These consolidated financial statements are for the Group consisting of CircuTech International Holdings Limited and its subsidiaries.

2.1 Basis of preparation

(i) Statement of compliance

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("**HKASs**") and Interpretations (hereinafter collectively referred to as the "**HKFRSs**") as issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, these consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on GEM of the Stock Exchange. 2

The preparation of financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires the Group's management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 4.

2.2 Changes in accounting policies and disclosures

(a) New and amendments to standards and interpretations as adopted by the Group from 1 January 2024

在本公司的財務狀況表中,對附屬公司的 投資按成本減減值虧損(如有)計量。附屬 公司的業績由本公司根據已收及應收股 息入賬。

於附屬公司之業績及權益之非控股權益 分別單獨呈列於綜合全面收益表、權益變 動表及財務狀況表。

HKFRS 18 Presentation and Disclosure in Financial Statements, which was issued by the HKICPA in July 2024 supersedes HKAS 1 and will result in major consequential amendments to HKFRS including HKAS 8 Basis of Preparation of Financial Statements (renamed from Accounting Policies, Changes in Accounting Estimates and Errors). Even though HKFRS 18 will not have any effect on the recognition and measurement of items in the consolidated financial statements, it is expected to have a significant effect on the presentation and disclosure of certain items. These changes include categorisation and sub-totals in the statement of profit or loss, aggregation/disaggregation and labelling of information, and disclosure of management-defined performance measures.

Except for the above, the Directors do not anticipate that the application of new or amendments to HKFRS in the future will have a material impact on the consolidated financial statements.

2.3 Subsidiaries and non-controlling interest

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

In the Company's Statement of Financial Position, investments in subsidiaries are measured at cost less impairment loss, if any. The result of the subsidiaries are accounted for by the Company on the basis of dividends received and receivables.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of comprehensive income, statement of changes in equity and statement of financial position respectively.

2.4 聯營公司

聯營公司指本集團對其有重大影響但無 控制權或共同控制權的實體,一般附帶擁 有其20%至50%投票權。於聯營公司的投 資於初步按成本確認後以權益會計法入 賬。

根據權益會計法,投資初步按成本確認, 其後進行調整以於損益確認本集團應佔 投資對象收購後溢利或虧損,並於其他全 面收益確認本集團應佔投資對象其他全 面收益的變動。已收或應收聯營公司的股 息確認為投資賬面值扣減。

權益入賬投資之賬面值乃根據附註2.6所 述政策進行減值測試。

本集團內各實體綜合財務報表內的 項目,均以該實體經營業務之主要 經濟環境之貨幣(「功能貨幣」)計 量。綜合財務報表以港元列賬,其 為本公司之功能及呈列貨幣。

(b) 交易及結餘

外幣交易以交易當日之匯率換算為 功能貨幣。結算該等交易及按年末 匯率換算以外幣計值之貨幣資產及 負債所產生之匯兌收益及虧損一般 於損益內確認。倘彼等歸屬於境外 業務投資淨額的一部分,則於權益 遞延。

與借款有關之匯兌收益及虧損於損 益內「財務成本」呈列。所有其他匯 兌收益及虧損按淨額基準於損益內 「行政費用」呈列。

2.4 Associate

Associate is an entity over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investment in an associate is accounted for using the equity method of accounting, after initially being recognised at cost.

Under the equity method of accounting, the investment is initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from an associate are recognised as a reduction in the carrying amount of the investment.

The carrying amount of equity-accounted investments is tested for impairment in accordance with the policy described in Note 2.6.

2.5 Foreign currency translation

(a) Functional and presentation currency

Items included in the consolidated financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss. They are deferred in equity if they are attributable to part of the net investment in a foreign operation.

Foreign exchange gains and losses that relate to borrowings are presented in profit or loss, within "finance costs". All other foreign exchange gains and losses are presented in profit or loss on a net basis within "administrative expenses". 2

(b) 交易及結餘(續)

因重新換算貨幣金融資產而產生的 匯兌損益被視為公平值變動的獨立 組成部分,並於損益中確認。非貨 幣金融資產(例如透過其他全面收 益按公平值列值(「透過其他全面收 益按公平值列值」)之金融資產)的 匯兌損益構成就該金融工具所確認 其他全面收益(「其他全面收益」)整 體損益的一部分。

於綜合賬目時,海外業務的業績乃 按交易進行時的概約匯率換算為港 元。海外業務的所有資產及負債(包 括因收購該等業務而產生的商譽) 按報告日的匯率換算。按開盤匯價 換算的期初資產淨值與按實際匯率 計算海外業務業績的匯兌差額乃於 其他全面收益中確認,並於外匯儲 備中累計。

2.6 物業、廠房及設備

物業、廠房及設備按收購成本減累計折舊 及減值虧損(如有)計量。折舊乃使用直線 法計算,以於其估計可使用年期內,或倘 為租賃物業裝修則於以下較短租期內分 配其成本或重估金額(扣除其剩餘價值):

(b) Transactions and balances (continued)

Exchange gains and losses arising on the retranslation of monetary financial assets are treated as a separate component of the change in fair value and recognised in profit or loss. Exchange gains and losses on non-monetary financial assets such as financial asset at fair value through other comprehensive income ("**FVOCI**") form part of the overall gain or loss in other comprehensive income ("**OCI**") recognised in respect of that financial instrument.

On consolidation, the results of overseas operations are translated into HK\$ at rates approximating to those ruling when the transactions took place. All assets and liabilities of overseas operations, including goodwill arising on the acquisition of those operations, are translated at the rate ruling at the reporting date. Exchange differences arising on translating the opening net assets at opening rate and the results of overseas operations at actual rate are recognised in other comprehensive income and accumulated in the foreign exchange reserve.

2.6 Property, plant and equipment

Property, plant and equipment are stated at acquisition cost less accumulated depreciation and impairment loss, if any. Depreciation is calculated using the straight-line method to allocate their cost or revalued amounts, net of their residual values, over their estimated useful lives or, in the case of leasehold improvements, the shorter of the lease term as follows:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.7).

2.8.1 分類

本集團將其金融資產劃分為以下計 量類別:

就按透過其他全面收益按公平值列 值之資產而言,收益及虧損將計入 其他全面收益。就並非持作買賣之 權益工具投資而言,其將取決於本 集團是否於最初確認時行使不可撤 銷選擇權,以將權益投資入賬為透 過其他全面收益按公平值列值。

本集團於及僅於管理該等資產之業 務模式改變時,方會重新分類債務 投資。

2.7 Impairment of non-financial assets

Property, plant and equipment, right-of-use assets and interest in an associate are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets ("**cash-generating units**"). Nonfinancial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

2.8 Investments and other financial assets

2.8.1 Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value through profit or loss (Note 2.9),
- those to be measured subsequently at fair value through OCI, and
- those to be measured at amortised cost (Note 2.10),

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows. Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

For assets measured at fair value through OCI, gains and losses will be recorded in OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at FVOCI.

The Group reclassifies debt investments when and only when its business model for managing those assets changes. 2

2.8.3 計量

2.8.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

2.8.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus transaction costs that are directly attributable to the acquisition of the financial asset.

Debt instruments

Debt instruments that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are subsequently measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of comprehensive income.

權益工具

本集團後續按公平值計量所有權益 投資。倘本集團管理層選擇於其他 全面收益呈列權益投資之公平值收 益及虧損,終止確認投資後概無後 續重新分類公平值收益及虧損至損 益。當本集團收取付款的權利確立 時,該等投資之股息繼續於損益內 確認為其他收入。

2.8.4 減值

本集團按前瞻性基準評估與按攤銷 成本列賬之債務工具有關之預期信 貸虧損(「預期信貸虧損」)。應用之 減值方法取決於信貸風險是否大幅 增加。

就應收賬款而言,本集團採用香港 財務報告準則第9號金融工具(「**香** 港財務報告準則第9號」)允許的簡 化方法,規定自初步確認應收款起 確認全期預期虧損,進一步詳情見 附註3.1(b)。

在釐定自初步確認以來金融資產的 信貸風險是否顯著增加及估計預期 信貸虧損時,本集團會考慮無需付 出過多成本或努力便能取得的合理 及有理據的相關資料。這包括根據 本集團的過往經驗及已知信貸評估 作出的定量及定性資料分析,並包 括前瞻性資料。

倘金融資產逾期超過30天,本集團 假設該金融資產的信貸風險已顯著 增加。

當債務人不大可能在本集團並無追 索權採取變現抵押(如持有)等行動 的情況下向本集團悉數支付其信貸 義務;或金融資產逾期超過90天, 本集團認為該金融資產出現違約。

Equity instruments

The Group subsequently measures all equity investment at fair value. Where the Group's management has elected to present fair value gains and losses on equity investment in OCI, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established.

2.8.4 Impairment

The Group assesses on a forward looking basis the expected credit losses ("**ECLs**") associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9 Financial Instruments ("**HKFRS 9**"), which requires expected lifetime losses to be recognised from initial recognition of the receivables, see Note 3.1(b) for further details.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment, including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to action such as realising security (if any is held); or the financial asset is more than 90 days past due. 2

衍生工具於衍生工具合約訂立當日按公 平值初步確認,其後於各報告期末重新計 量至公平值。任何不符合對沖會計處理的 衍生工具之公平值變動即時於損益確認。

2.10 應收賬款

應收賬款指於正常業務過程中出售貨品 或提供服務之應收客戶款項。應收賬款一 般應於15至90日內結清,因此,其獲分類 為流動。

應收賬款初步按公平值確認,隨後使用實 際利率法按攤銷成本減應收賬款減值撥 備計量。有關本集團應收賬款之入賬資料 及本集團減值政策之描述,見附註2.8。

2.11 現金及現金等價物

就呈列現金流量表而言,現金及現金等價物包括手頭現金、金融機構活期存款、原 到期日為三個月或以下且隨時可轉換為 確定金額現金及價值變動風險不重大的 其他短期高流動性投資。

2.12 應付賬款

該等金額指於財政年度結束前提供予本 集團之貨品及服務之尚未支付負債。該等 金額為無抵押且一般於確認後30日內支 付。除非款項並非於報告期後12個月內到 期,否則應付賬款乃呈列為流動負債。其 初步按公平值確認及隨後使用實際利率 法按攤銷成本計量。

收益或虧損於終止確認負債時透過攤銷 過程於損益中確認。

2.9 Derivatives

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured to their fair value at the end of each reporting period. Changes in the fair value of any derivative instrument that does not qualify for hedge accounting are recognised immediately in profit or loss.

2.10 Trade receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. Trade receivables are generally due for settlement ranging from 15 to 90 days and therefore are all classified as current.

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment of trade receivables. See Note 2.8 for further information about the Group's accounting for trade receivables and for a description of the Group's impairment policies.

2.11 Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

2.12 Trade payables

These amounts represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.
2.13 即期及遞延所得稅

(a) 即期所得稅

即期所得稅支出根據本公司附屬公 司營運所在及產生應課稅收入的國 家於報告期末已頒佈或實質頒佈的 稅務法例計算。管理層就適用稅務 法例受詮釋所規限的情況定期評估 報稅表的狀況,並在適用情況下根 據預期須向稅務機關支付的稅款設 定撥備。

(b) 遞延所得稅

對於資產及負債的稅基與其在綜合 財務報表的賬面值之間的暫時性差 額,使用負債法就遞延所得稅悉數 計提撥備。遞延所得稅乃以於報告 期末已頒佈或實質頒佈的稅率(及 稅法)釐定,並預期於變現相關遞延 所得稅資產或償還遞延所得稅負債 時應用。

僅於可能出現可使用該等暫時性差 額及虧損之未來應課稅金額時,方 會確認遞延稅項資產。

倘本公司能夠控制撥回暫時性差額 之時間,且該等差額可能不會於可 見將來撥回,則不會於海外業務之 投資賬面值與稅基之間之暫時性差 額確認遞延稅項負債及資產。

2.13 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future. 2

2.14 僱員福利

(a) 短期責任

僱員直至報告期末之服務獲確認工 資及薪金負債(包括預期在僱員提 供相關服務期間結束後12個月內悉 數結算的非貨幣福利及累計病假) 並按結算有關負債之預期金額計 量。負債於財務狀況表內呈列為即 期僱員福利責任。

(b) 界定供款計劃

根據香港法例第485章《強制性公積 金計劃條例》(「**強積金計劃條例」**) 設立及運作的強制性公積金計劃被 歸類為界定供款計劃。

界定供款計劃為本集團須向獨立實 體支付固定供款之退休金計劃。倘 基金之資產於本期間或過往期間並 不足以向所有僱員支付與僱員服務 有關之福利,則本集團概無任何法 律或推定責任支付額外供款。

對於界定供款計劃,本集團以強制 性、合約性或自願性方式向公開或 私人管理之退休保險計劃供款。本 集團作出供款後,即無進一步付款 責任。供款於到期時確認為僱員福 利開支。預付供款確認為資產,惟 以退回現金或可扣減日後付款金額 為限。

(c) 花紅計劃

本集團按照計及本公司股東應佔溢 利的公式,在作出若干調整後,就 花紅確認責任及支出。本集團會於 有合約責任或根據過往慣例構成推 定責任時確認撥備。

2.14 Employee benefits

(a) Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits and accumulating sick leave that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the statement of financial position.

(b) Defined contribution plan

Mandatory provident fund scheme set up and operated under the Mandatory Provident Fund Schemes Ordinance, Cap. 485 ('**the MPF Schemes Ordinance**') is categorised as a defined contribution plan.

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

For defined contribution plans, the Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(c) Bonus plan

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

(d) 界定福利計劃

《香港僱傭條例》(「條例」)項下的 長期服務金(「長期服務金」) 被歸類 為界定福利計劃。條例項下合資格 僱員在條例規定的若干情況下有權 獲得長期服務金。對僱主並無法律 上的資金要求,本集團亦無任何安 排以清償其日後的付款責任。本集 團的長期服務金承擔按以下方式計 量:長期服務金承擔總額,採用預 測單位信貸法估算,以到期日與負 債條款相近且以港元(長期服務金 承擔的貨幣)計值的優質公司債券 (或政府債券,倘該等優質公司債 券並無深度市場)的市場收益率貼 現為現值;減去負服務成本。根據 條例及強積金計劃條例,本集團可 以本集團強積金供款之累算權益抵 銷本集團的長期服務金承擔。本集 團將該等強積金供款視為僱員對長 期服務金權益的供款,本質屬於負 服務成本。該等視作供款乃按強積 金供款的預期投資回報率估算,然 後採用與長期服務金承擔總額相同 的歸因方法將其歸入服務期。

服務成本於損益確認,包括當期及 往期服務成本(包括計劃修訂的結 果)。

利息於損益確認,並按將年度期初 用於計量長期服務金承擔的貼現率 應用於長期服務金承擔結餘計算, 同時考慮期內福利付款的影響。

長期服務金承擔的重新計量(包括 精算損益)於其他全面收益確認。

(d) Defined benefit schemes

Long service payment ("LSP") under the Hong Kong Employment Ordinance (the "Ordinance") is categorised as a defined benefit plan. Employees qualified under the Ordinance are entitled to LSP in certain circumstances specified in the Ordinance. There are no legal funding requirements on employers and the Group does not have any arrangement in place to settle its payment obligation in the future. The Group's obligation to LSP is measured at: Gross LSP obligation which is estimated using the projected unit credit method discounted to its present value using market yields available on high quality corporate bonds (or government bonds if there is no deep market in such high quality corporate bonds) that have maturity dates approximating to the terms of the liabilities and are denominated in Hong Kong Dollars which is the currency of the LSP obligations; less negative service costs. Under the Ordinance and the MFP Schemes Ordinance, the Group can offset the accrued benefits derived from the Group's MPF contributions against the Group's LSP obligations. The Group regards these MPF contributions are deemed contributions by employees towards the LSP benefits. The nature is negative service costs. These deemed contributions are estimated by applying an expected investment return rate on the MPF contributions and then attributed to periods of service using the same attribution method for gross LSP obligation.

Service costs are recognised in profit or loss, and include current and past service costs (including result from a plan amendment).

Interest expense is recognised in profit or loss, and is calculated by applying the discount rate used to measure the LSP obligation at the beginning of the annual period to the balance of the LSP obligation, considering the effects of benefit payments during the period.

Remeasurements of the LSP obligation, including actuarial gains and losses, are recognised in other comprehensive income.

2.15 撥備

當本集團因過往事件現時負有法律或推 定責任,而可能須流出資源以清償責任, 且其金額能可靠估計時確認撥備。並無就 未來經營虧損確認撥備。

如有多項類似責任,清償責任時須流出資 源的可能性乃經考慮整體責任類別後確 定。即使就同一責任類別所包含的任何一 個項目而言流出資源的可能性甚微,仍須 確認撥備。

銷售及分銷產品之收入於產品控制 權經已轉移之時點(即產品已獲交 付並已獲接納之時點)確認,且概 無會影響客戶接納產品之未履約責 任。僅有一項履約責任。當產品經 已運送至指定地點或由客戶於倉庫 提取,報廢及損失風險經已轉移至 客戶,及客戶已根據銷售合約接納 產品、接納條文經已失效或本集團 擁有客觀證據顯示所有接納標準已 獲達成時,方發生交貨。

該等銷售之收入乃根據合約指定 價格扣除折扣、回報及增值稅後確 認。

應收款於交付產品及客戶接納該等 產品時確認,因付款到期前僅需待 時間推移,故代價於該時點為無條 件。

2.15 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

2.16 Revenue and other income

(a) Sale and distribution of IT products

Revenue from the sales and distribution of products is recognised at a point in time when control of the products has transferred, being at the point the products are delivered to and have been accepted, and there is no unfulfilled obligation that could affect the customer's acceptance of the products. There is only one performance obligation. Delivery occurs when the products have been shipped to the specified location or picked up by the customer in warehouse, the risks of obsolescence and loss have been transferred to the customer, and either the customer has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

Revenue from these sales is recognised based on the price specified in the contract, net of discounts, returns and value added taxes.

A receivable is recognised when the products are delivered and the customers have accepted the products, as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

本集團提供IT產品之維修、維護及 支援服務。本集團已釐定,於服務 支援之客戶合約中僅有一項履約責 任。就提供服務而言,收益乃於完 全提供服務及獲客戶接受的時間點 確認。

(c) 經營租賃之租金收入

經營租賃之租金收入乃按租賃年期 以直線法確認。當本集團向租戶提 供減免時,減免成本在租賃年期按 直線法確認為租金收入的減少額。

(d) 利息收入

利息收入就未償還本金按適用利率以時間基準累算。

Principal versus agent

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified good or service before that good or service is transferred to a customer.

The Group is an agent if its performance obligation is to arrange for the provision of the specified good or service by another party. In this case, the Group does not control the specified good or service provided by another party before that good or service is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

(b) Rendering of repairs and service support

The Group provides repair, maintenance and support services for IT products. The Group has determined that for contracts with customers under services support, there is only one performance obligation. For the provision of services, revenue is recognised at the point in time when the services are fully rendered and accepted by customers.

(c) Rental income under operating leases

Rental income from operating leases is recognised on a straight-line basis over the lease term. When the Group provides incentives to its tenants, the cost of the incentives is recognised over the lease term, on a straight-line basis, as a reduction of rental income.

(d) Interest income

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate.

Accounting as a lessee

All leases are required to be capitalised in the statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The Group has elected not to recognise right-of-use assets and lease liabilities for low-value assets and leases for which at the commencement date have a lease term of 12 months or less and do not contain purchase option. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

Right-of-use asset

The right-of-use asset should be initially recognised at cost and would comprise: (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability); (ii) any lease payments made at or before the commencement date, less any lease incentives received; (iii) any initial direct costs incurred by the lessee and (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories. The Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

Lease liability

The lease liability is recognised at the present value of the lease payments that are not paid at the date of commencement of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Group uses the lessee's incremental borrowing rate.

The following payments for the right-to-use on the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments: (i) fixed payments less any lease incentives receivable; (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date; (iii) amounts expected to be payable by the lessee under residual value guarantees; (iv) the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liability by: (i) increasing the carrying amount to reflect interest on the lease liability; (ii) reducing the carrying amount to reflect the lease payments made; and (iii) remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect revised in-substance fixed lease payments.

Accounting as a lessor

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the leased assets to the lessee. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

Any changes in the scope or the consideration for a lease that was not part of the original terms and conditions of the lease are accounted for as lease modifications. The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, recognising the remaining lease payments as income on a either a straight-line basis or another systematic basis over the remaining lease term.

This note explains the Group's exposure to financial risks and how these risks could affect the Group's future financial performance. Current year profit and loss information has been included where relevant to add further context. The Group's risk management is carried out by a central treasury department ("**Group Treasury**") under policies approved by the board of directors. Group Treasury identifies, evaluates and mitigates financial risks in close co-operation with the Group's operating units. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

3.1 Financial risk factors

(a) Market risk

(i) Foreign exchange risk

Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities denominated in a currency that is not a functional currency of the relevant group entities. The Group currently does not have a foreign currency hedging policy and has not used any forward contracts, currency borrowings or other means to hedge its foreign currency exposure. The Group manages its foreign currency risk by closely monitoring the movement of the foreign currency rates.

Management believes that the appreciation/ depreciation of RMB and AUD against HK\$ would not have a material impact on the Group's profit/(loss) after income tax and other components of equity for the year. Therefore, no sensitivity analysis is presented for RMB and AUD against HK\$.

(ii) Cash flow interest rate risk

Cash flow interest rate risk is the risk that the future cash flows associated with a financial instrument will fluctuate because of changes in market interest rates. The Group's income and operating cash flows are substantially independent of changes in market interest rates, except for interest income derived from bank deposits. Apart from the bank deposits held at financial institutions, the Group has no significant interest bearing assets and liabilities.

(b) Credit risk

The Group is exposed to credit risk in relation to its financial assets of trade and other receivables and cash and cash equivalents. The carrying amounts of trade and other receivables and cash and cash equivalents, represent the Group's maximum exposure to credit risk in relation to financial assets.

The Group expects that there is no significant credit risk associated with cash deposits at banks since they are substantially deposited at medium or large-sized listed banks with good reputation and credit rating.

本集團的大部分收入乃自與已出 售IT產品相關的個別客戶收取,且 以現金或信用卡進行交易。本集團 的應收賬款來自銷售予客戶的IT產 品。

於二零二四年十二月三十一日,三 大債務人及最大債務人佔本集團應 收賬款結餘約97.4%及94.7%(二零 二三年:90.4%及43.0%)。鑒於過 往與債務人的業務往來及應收該等 債務人款項的良好收款記錄,管理 層認為,本集團尚未收回的應收該 等債務人款項結餘本質上並無重大 信貸風險。管理層根據顧客的背景 及聲譽、債務人的過往付款記錄、 過往經驗、逾期時長、財務實力及 是否與債務人存有任何糾紛,定期 評估應收賬款及其他應收款的減 值撥備。董事認為本集團的預期虧 損率低,且截至二零二四年及二零 二三年十二月三十一日並無就應收 賬款減值作出撥備。

應收賬款在合理預期無法收回時被 撇銷。合理預期無法收回之指標包 括(其中包括)債務人未能履行本集 團之還款計劃,且無法就逾期超過 90天期間的款項作出合約付款。

於二零二四年及二零二三年十二 月三十一日,本集團評估其他應收 款的預期虧損率並不重大。因此, 概無確認任何其他應收款的虧損撥 備。

(b) Credit risk (continued)

The Group applies the simplified approach to provide for expected credit losses prescribed by HKFRS 9, which requires the use of the lifetime expected credit loss provision for impairment of all trade receivables. To measure the expected credit losses, trade receivables have been grouped based on shared credit risk characteristics. The Group has performed historical analysis and identified the key economic variables impacting credit risk and expected credit loss. It considers available reasonable and supportable forwardinglooking information.

Majority of the Group's revenue is received from individual customers in relation to IT products sold and are transacted in cash or credit. The Group's trade receivables arise from sales of IT products to the customers.

As at 31 December 2024, the top three debtors and the largest debtor accounted for approximately 97.4% and 94.7% (2023: 90.4% and 43.0%), of the Group's trade receivables balance. In view of the history of business dealings with the debtors and the sound collection history of the receivables due from them, management believes that there is no material credit risk inherent in the Group's outstanding receivable balance due from these debtors. Management makes periodic assessment on the provision for impairment of the trade and other receivables based on background and reputation of the customers, historical payment records, past experience, the length of overdue period, the financial strength of the debtors and whether there are any disputes with the debtors. The directors consider that the Group's expected loss rate to be low and no provision for impairment of trade receivables was made as of 31 December 2024 and 2023.

Trade receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include, amongst others, the failure of a debtor to engage in a repayment plan with the Group, and a failure to make contractual payments for a period of greater than 90 days past due.

As at 31 December 2024 and 2023, the Group has assessed that the expected loss rate for other receivables was immaterial. Thus, no loss allowance for other receivables was recognised.

本集團旨在使用其自身資本及盈利 用作經營資金及於年內並無動用任 何重大借款或信貸融資。本集團保 留其本身之司庫職能部門以監督當 前及預期流動資金需求並旨在透過 存置營運產生之充足現金及現金等 價物維持靈活性。於報告期末,本 集團分別持有現金及現金等價物以 及應收賬款,預期可就管理流動資 金風險即時產生現金流入。

下表根據報告日期至合約到期日的 剩餘期間將本集團非衍生金融負債 分為有關到期組別進行分析。該表 所披露金額乃合約未貼現現金流 量。由於貼現影響並不重大,於12 個月內到期之結餘及超過一年但不 遲於兩年到期的結餘等於其賬面結 餘。

(c) Liquidity risk

The Group aims to finance its operations with its own capital and earnings and did not have any significant borrowings or credit facilities being utilised during the year. The Group maintains its own treasury function to monitor the current and expected liquidity requirements and aims to maintain flexibility by keeping sufficient cash and cash equivalents generated from operations. At the end of the reporting period, the Group held cash and cash equivalents and trade receivables, respectively, that are expected to readily generate cash inflows for managing liquidity risk.

The table below analyses the Group's non-derivative financial liabilities into relevant maturity groupings based on the remaining period at the reporting date to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Balances due within 12 months and balances due more than 1 year and not later than 2 years equal their carrying balances as the impact of discounting is not significant.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

The finance department of the Group performs valuations of non-property items required for financial reporting purposes, including level 3 fair values. They report directly to the management. Discussions of valuation processes and results are held at each interim and annual reporting date.

The main level 3 inputs used by the Group are derived and evaluated as follows:

- Discount rates for financial asset is determined using a capital asset pricing model to calculate a pre-tax rate that reflects current market assessments of the time value of money and the risk specific to the asset.
- Risk adjustments specific to the counterparties (including assumptions about credit default rates) are derived from credit risk gradings determined by the Group's internal credit risk management group.
- Annual revenue growth rate and terminal growth rate for unlisted equity securities are estimated based on market information for similar types of companies.
- DLOM is a discount applied to reflect the lack of marketability of an asset, typically for minority interests in private companies or restricted securities.
- DLOC is a discount applied to reflect the lack of control associated with a minority interest in a business.

Changes in level 3 fair values are analysed at the end of each reporting period during the half-yearly valuation discussion between the management and the finance department. As part of this discussion, the finance department presents a report that explains the reason for the fair value movements.

倘管理層認為未來應課稅溢利將可用作 抵銷可動用臨時差額或稅項虧損時,則確 認有關若干可扣減臨時差額及稅項虧損 的遞延所得稅資產。當預期與原估計不同 時,有關差額將對估計變動期間的遞延所 得稅資產及所得稅支出的確認構成影響。

4 CRITICAL ESTIMATES AND JUDGEMENTS

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Group's accounting policies.

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the Group and that are believed to be reasonable under the circumstances.

(a) Estimation of fair value of financial assets at FVOCI

The fair value of financial instrument that is not traded in an active market is determined using valuation techniques. The Group uses its judgement to select a variety of methods and make assumptions that are mainly based on market conditions existing at the end of each reporting period. For details of the key assumptions used and the impact of changes to these assumptions, see Note 3.3(a).

(b) Income taxes

Significant judgement is required in determining the provision for income taxes. There are transactions and calculations during the ordinary course of business for which the ultimate tax treatment is subject to judgement. If the Group considers it is probable that these judgements will result in different tax positions, the most likely amounts or expected value of the outcome will be estimated and adjustments to the income tax expense and income tax liabilities will be made accordingly.

Deferred income tax assets relating to certain deductible temporary differences and tax losses are recognised when management considers it is probable that future taxable profits will be available against which the temporary differences or tax losses can be utilised. When the expectations are different from the original estimates, such differences will impact the recognition of deferred income tax assets and income tax charges in the period in which such estimates have been changed.

(c) Impairment of interest in an associate

Interest in an associate is reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts have been determined based on value-in-use calculations or fair value less costs of disposal. These calculations require the use of judgements and estimates. 4

本集團採用撥備矩陣計算不作個別評估 的應收賬款的預期信貸虧損。撥備率乃根 據具有類似虧損模式的多個客戶分部組 別的逾期天數計算。撥備矩陣初步基於本 集團過往觀察到的違約率。本集團會校準 矩陣,以前瞻性資料調整過往信貸虧損經 驗。於報告日期,會更新過往觀察到的違 約率,並分析前瞻性估計的變動。評估歷 史觀察違約率、預測經濟狀況及預期信貸 虧損之間的相關性是一項重要估計。預期 信貸虧損金額對情況變動及經濟狀況預 測敏感。本集團過往的信貸虧損經驗及對 經濟狀況預測亦未必能代表客戶日後的 違約情況。有關本集團應收賬款的預期信 貸虧損及相關信貸風險的資料分別披露 於附註19及3.1(b)。

Management judgement is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying value of asset can be supported by its recoverable amount, being the higher of fair value less costs of disposal and value-in-use; and (iii) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management in assessing impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test and as a result affect the Group's reported financial condition and results of operations. If there is a significant adverse change in the projected performance and resulting future cash flow projections, it may be necessary to take an impairment charge to the consolidated statement of comprehensive income.

(d) Impairment assessment of trade receivables

The Group uses provision matrix to calculate ECLs for trade receivables which are not assessed individually. The provision rates are based on days past due for grouping of various customer segments that have similar loss patterns. The provision matrix is initially based on the Group's historical observed default rates. The Group calibrates the matrix to adjust the historical credit loss experience with forward-looking information. At the reporting date. the historical observed default rates are updated and changes in the forward-looking estimates are analysed. The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast in economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's default in the future. The information about ECLs on the Group's trade receivables and related credit risk is disclosed in notes 19 and 3.1(b), respectively.

The employee of the subsidiary of the Group operating in Republic of China is a member of the labour pension system, which is a defined contribution retirement plan operated by the government. The Group is required to make contributions calculated as a prescribed percentage of the employee's relevant income, subject to certain ceilings imposed. The applicable percentages for the labour pension system are listed below:

Labour pension: 6% Labour insurance: 8% Health insurance: 4.9%

The Group contributes Individual Retirement Arrangement (the "**IRA**") for the employee employed in the United States. The Group made contributions calculated as 16% of the employee's gross income to the pension arrangement.

The Group contributes a pension fund governed by the Pensions Law for the employee employed under the jurisdiction of Netherlands. The pension fund is a defined contribution retirement plan operated by independent trustees. The Group made contributions calculated as approximately 8.1% of the employee's gross income to the pension scheme.

On 4 June 2018, the Group entered into a sale and purchase agreement to acquire 21% of the issued share capital of 4Square Return GmbH ("**4Square**") from independent parties by cash consideration of EUR1,600,000 (equivalent to approximately HK\$14,508,000). In return, the Group is entitled to (i) 21% of equity interest in 4Square at a cost of HK\$6,569,000 and (ii) a call option and buy-back option at fair value of approximately HK\$7,939,000 at the date of the acquisition. The transaction was completed on 19 July 2018.

The call option allows the Group to acquire all the remaining shares of 4Square in the exercise period at an exercise price determined in accordance with the terms set out in shareholders' agreement. The exercise period is from the date that the audited consolidated financial statements of 4Square for year ended 31 December 2023 are filed in Germany until the Business Day that falls six months thereafter ("**Call Option Period**"). If the Group does not exercise the call option before the expiry of Call Option Period, the other 4Square existing shareholders may buy-back all of the shares in the 4Square held by the Group within three months from the expiry of the Call Option Period for the consideration of EUR1,600,000. The call option and buy-back option were treated as a single component derivative financial instrument at fair value through profit and loss under HKFRS 9.

The excess of the cost of investment over the Group's share of the net fair value of the identifiable assets and liabilities of 4Square at the date of acquisition was recognised as goodwill and included the interest in an associate.

A profit of approximately HK\$531,000 representing the Group's share of results of the associate was recorded for the year ended 31 December 2024 (2023: approximately HK\$1,593,000).

On 8 November 2021, the Group entered into a supplemental agreement to revise the Call Option Period due to the change of 4Square's reporting period from 31 January 2023 to 31 December 2023 and the call option price will be based on 5 times the earnings before interest, taxes, depreciation and amortisation of the 4 Square minus the aggregate amount by which the net profit of the 4Square as set out in the 2019, 2020, 2021, 2022 audited consolidated financial statements. Save for the above, all other terms of the shareholders's agreement remain unchanged.

On 12 July 2024, the Group has notified the 4Square shareholder in writing that it would not exercise the Call Option. The Call Option was lapsed. The 4Square shareholder has also notified the Group in writing that they would not exercise the buy-back option. Accordingly, both options were lapsed during the year. The Group has recognised a fair value loss on derivative financial instrument of approximately HK\$8,883,000 upon derecognition and derecognised the derivative financial instrument.

The number of shares issued and to be issued in respect of which options granted and may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time, without prior approval from the Company's shareholders. Options granted to substantial shareholders or independent non-executive directors in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5,000,000 must be approved in advance by the Company's shareholders.

Option may be granted at a consideration of HK\$1 and should be accepted within seven days from the date of grant. Options may be exercised at any time during the period as the Board may determine which shall not exceed ten years from the date of grant. The subscription price is determined by the Board and shall not be less than the highest of (i) the closing price of the shares of the Company as stated in the Daily Quotation Sheet on the date of grant, which must be a trading day; (ii) the average closing price of the shares of the Company as stated in the Daily Quotation Sheets for the five trading days immediately preceding the date of grant; or (iii) the nominal value of the Company's share.

Under the Mandatory Provident Fund Schemes Ordinance, Cap. 485, the Group, as an employer, is required to make mandatory MPF contribution at 5% of the employee's monthly salary (capped at HK\$1,500). The Group makes the contribution to separate trustees. MPF scheme has attributes of a defined contribution plan.

In June 2022, Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 was enacted. The Amendment Ordinance abolishes the use of the accrued benefits derived from employers' mandatory MPF contributions to offset LSP. Subsequently, the Government of HKSAR announced that the Abolition will take effect on 1 May 2025.

The following key changes will take effect since the Transition Date:

- Accrued benefits derived from employers' mandatory MPF contributions cannot be used to offset the LSP in respect of the employment period after the Transition Date.
- The pre-transition LSP is calculated using the last month's salary immediately preceding the Transition Date, instead of using the last month's salary of employment termination date.

The accounting policies for the Group's LSP obligation, MPF contribution and the MPF-LSP offsetting is detailed in notes 2.14(b) and 2.14(d).
