Reminder Letter regarding the Arrangement of Electronic Dissemination of Corporate Communications

With reference to the notification letter dated 8 February 2024 titled “Arrangement of Electronic Dissemination of Corporate Communications”, Lianhua Supermarket Holdings Co., Ltd. Pursuant to Rule 2.07A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, the Company shall dispatch to you by electronic means or by post the Actionable Corporate Communications^(Note).
