CHAIRMAN'S STATEMENT 主席報告

Dear shareholders,

On behalf of the board of directors, I hereby present to you the annual results of the Group for the year ended 31 December 2024.

In 2024, the consensus within the property management industry was that quality outweighs quantity in development. Enterprises had been actively exploring new paths for high-quality development, proactively "shedding" projects with low quality and efficiency, low collection rates, high management difficulty and limited development potential, as well as optimizing project portfolios, which demonstrated the enterprises' determination to enhance the quality of their management projects. On the basis of "strengthening the foundation", enterprises had been embarking on high-quality expansion, particularly in acquiring thirdparty projects as a clear direction for corporate development, which also demonstrated their determination to move away from reliance on related parties and towards independent development.

In 2024, the property management industry ushered in policy changes in some cities, with property enterprises experiencing increased pressure in areas such as property fee pricing and service quality requirements. This resulted in intensified stock competition in certain markets under the backdrop of an overall slowdown in industry growth. The competition for high-quality stock projects became fierce, to some extent limiting the growth of the overall management scale of property enterprises.

To address market changes in 2024, the Group adhered to prioritizing quality and practiced long-termism. Under the premises of thoroughly understanding customer demands and listening to their voices, we firmly stuck to development strategies, clearly defined business objectives, and targeted operational directions. The Group understood that winning the "customer mindset" is essential to gaining customer trust, and an excellent brand image could be built through word-of-mouth communication, laying a solid foundation for stable development. The Group achieved quality, sustainable and steady growth in management scale and profitability through technology empowerment, intensive and refined management.

During the Reporting Period, the Group returned to the essence of property basic services. We have established our presence in 58 cities in China, having 322 projects under management with a contracted gross floor area ("**GFA**") of 54.198 million sq.m., representing an increase of 0.55% as compared with 2023 and a total GFA under management of 49.260 million sq.m. (with a commercial GFA under management of 2.719 million sq.m.), representing an increase of 3.79% as compared with 2023. In particular, the GFA of market-oriented expansion reached 21.249 million sq.m., which accounted for 43.1% of GFA under management and represented a decrease of 1.1% as compared with 2023.

尊敬的各位股東:

本人謹代表董事會,提呈本集團截至2024年12月31日 止之年度業績。

2024年,物業管理行業發展質重於量成為行業共識, 企業積極探索高質量發展新路,主動「割捨」低質效、 低收繳率、管理難度大、發展潛力小的項目,優化項 目組合,彰顯企業提升管理項目質量的決心。在「強基 固本」的基礎上,開展高質量外拓,特別是獲取第三方 項目成為企業發展明確的方向,也同樣展現企業擺脱 對關聯方依賴走向獨立發展的決心。

2024年,一些城市物業管理行業迎來了政策變化,物 業企業在物業費定價、服務品質要求等方面進一步承 壓,致使局部市場在存量競爭愈發激烈,在行業規模 整體增速放緩的大背景下,對於優質存量項目的競爭 白熱化,一定程度上也限制了物業公司整體管理規模 增長。

應對市場變局,2024年本集團堅持品質先行,奉行長 期主義。在充分了解客戶訴求聆聽客戶心聲的前提 下,堅定發展戰略,明確經營目標,瞄準經營方向。 本集團深知贏得[客戶心智]才能贏得客戶信任,通過 口碑傳播建立優秀的品牌形象,穩固發展的根基。通 過科技賦能、集約化、精細化管理實現管理規模和盈 利能力有質量、可持續的穩健增長。

報告期內,本集團回歸物業基礎服務本質,已佈局全 國58座城市,在管項目322個,合約建築面積(「建築 面積」)規模5,419.8萬平方米,較2023年增長0.55%,在 管總建築面積4,926.0萬平方米(其中商業在管建築面 積271.9萬平方米),較2023年增長3.79%,其中市場外 拓面積達2,124.9萬平方米,佔在管建築面積43.1%,較 2023年降低了1.1個百分比。





During the Reporting Period, the three major business lines of the Group, namely property management services, value-added services to non-property owners and community value-added services, were affected by unfavourable factors such as the downward trend in the scale of management in the market. We achieved revenue of RMB1,026.7 million, representing a decrease of 3.6% as compared with 2023, and gross profit of RMB199.6 million, representing a decrease of 20.9% as compared with 2023. Our net profit reached RMB15.1 million, representing an increase of 6.3% as compared with 2023.

During the Reporting Period, leveraging the "residential + public construction" dual-driven model, we mapped our non-residential business portfolio and explored our second development track, continuing to establish presence in non-residential projects. In 2024, we have newly developed the representative of the commercial complex project — Hefei Tianyue Centre (合肥天玥中心), the representative of the hospital project — Phase 2 of Wuhan Union Hospital Jinyinhu District (武漢協和醫院金銀湖院區二期), the representative of the IFM office project — the Nanjing Branch of the 11th Science and Technology Research Institute of Information Industry Electronics (資 訊產業電子第十一科技研究院南京分院), the representative of the high-end commerce and office— Wuxi Shengliang Environmental Protection Technology Office Building (無錫生量環保科技辦公樓), the representative of the government office project — Wuhan Product Quality Supervision and Inspection Institute (武漢產品品質監督檢驗 所), the representative of the airport project —the Wuhan Tianhe Airport Aviation Logistics Zone (武漢天河機場航空物流區), the representative of the industrial park project — the Chengdu ChaPanda Industrial Park (成都茶百道產業園), the representative of the catering service project — Jiangning Postal Canteen (江寧郵政食堂), the representative of the urban service project — Taishan Street Complex Parking Lot (泰 山街道綜合體停車場), etc., to achieve leapfrog development in the expansion of non-residential property service-type projects, filling up the gap in property management sub-fields such as IFM office, commercial complex and catering service and continuously broadening the urban service track. At the same time, we also signed a formal contract with the Honghu Municipal Bureau of Housing and Urban Development to establish a joint venture. This cooperation is the first time that Redsun Services has launched a joint venture with a government department, and it serves as a model for the innovation of urban governance model.

報告期內,本集團物業管理服務、非業主增值服務和 社區增值服務三大業務線受市場管理規模增速下行 等不利影響,實現收入人民幣1,026.7百萬元,較2023 年下降3.6%,實現毛利人民幣199.6百萬元,較2023年 下降20.9%,淨溢利人民幣15.1百萬元,較2023年上升 6.3%。

報告期內,我們依託[住宅+公建]的雙輪驅動模式, 佈局非住宅業態,開拓第二賽道,持續進駐非住項 目。2024年,我們新拓了商業綜合體項目代表

一合肥 天玥中心,醫院項目代表-武漢協和醫院金銀湖院區 二期,IFM辦公項目代表一資訊產業電子第十一科技 研究院南京分院,高端商寫代表-無錫生量環保科技 辦公樓,政務辦公項目代表-武漢產品品質監督檢驗 所,機場項目代表-武漢天河機場航空物流區,產 業園項目代表-成都茶百道產業園,餐飲服務項目代 表一江寧郵政食堂,城市服務項目代表一泰山街道綜 合體停車場等,實現了在非住宅物業服務類型項目拓 展的跨越式發展,並填補了IFM辦公、商業綜合體、餐 飲服務等物業管理細分領域的空白,不斷拓寬城市服 務賽道。同時我們還與洪湖市住建局正式簽約成立合 資公司,此次合作是弘陽服務首次與政府部門開展合 資合作,為創新城市治理模式起到示範作用。



During the Reporting Period, with the help of the Group's service, operation and brand, we actively promoted market-oriented expansion, won the trust of third-party tenderers and obtained third-party property management projects. Focused on consolidating basic property services, we accelerated the development of the "property services + life services" model, enriched the value-added services provided to customers, promoted the development of businesses such as Yunda Mechatronics (運達機電), Hongyao Technology (弘耀科技), property decoration, Hongteng Decoration (弘騰裝飾), housing rental and sales, and Hongyang Selection (弘陽優選), and upgraded to high-quality and diversified services.

In 2024, we remained our adherence to the "customer-centered" service philosophy and were quality-driven to provide customers with more refined and targeted services, winning the trust of customers. We built full life cycle service standards, constantly improving the property service brand image. According to a survey conducted by a third-party institution, the customer satisfaction of the Group in 2024 still maintained at a high level despite of the downward trend in the industry. The overall satisfaction rate for non-residential business portfolio property services was above the industry level and reflected that the service quality of the Group has been well-recognized by customers.

During the Reporting Period, we adhered to the original vision of "creating values for customers (為客戶創造價值)" to provide customers with "satisfying + pleasantly surprising" services. We maintained a streamlined and efficient organizational model, in order to strengthen efficiency, and match business development needs. By maximizing the motivation of our employees at the institutional level, we optimized the incentive mechanism from time to time, led the steady and healthy development of business and thus formed a virtuous cycle. The "Hong Elite", "Redsun Housekeeper" (弘管家) and "Hong Master" (弘師傳) services under this model have now been launched in full swing in the Group. Lecturer system and course program under this model have been optimized continuously to do well in knowledge accumulation for furthering team cultivation and enhancing the team resilience and adaptability under pressures. Our efforts to enhance quality and efficacy have achieved satisfactory outcome.

報告期內,我們借助於本集團的服務力、經營力和品 牌力,積極推進市場化外拓,贏得第三方招標方的信 任,獲得第三方物業管理項目。從夯實基礎物業服務 出發,加快發展「物業服務+生活服務」模式,豐富為 客戶提供的增值服務,推動運達機電、弘耀科技、美 居、弘騰裝飾、房屋租售和弘陽優選等業務開展,向 高品質和多樣化服務升級。

2024年,我們依然堅持「以客戶為中心」的服務理念, 以質量為先,為客戶提供更加精細化和精準化服務, 贏得客戶信賴,打造全生命週期服務標準,不斷提升 物業服務品牌形象。根據第三方機構的調查顯示, 2024年本集團客戶滿意度在行業整體下行趨勢之下, 仍保持在行業高位,非住業態物業服務總體滿意度優 於行業水準,凸顯本集團的服務質量備受客戶認可。

報告期內,我們秉承「為客戶創造價值」的初心,為客 戶提供「滿意+驚喜」的服務,保持精簡高效的組織模 式,強化效率,匹配業務發展需求。在制度層面最大 化激發員工積極性,持續優化激勵機制,牽引業務穩 健發展,形成正向循環。目前此模式下的「弘精英」、 「弘管家」、「弘師傅」服務已經在本集團全面落地,不 斷優化的講師體系和課程體系,做好知識沉澱,促進 梯隊培養,夯實團隊腰部力量,提質增效效果顯著。





In terms of smart services, the Group vigorously promoted Intelligent construction, continued to promote digital transformation, integrated advanced technologies and upgraded information platforms. Intelligent equipment was used to improve user experience, iteratively update digital service platforms, improve employee efficiency, and generate synergy and refined management of operations. Through technology empowerment, we offered better service to customers, promoted the Company's steady development, and ensured the implementation of the Company's strategies.

As a socially responsible enterprise, the Group actively fulfilled its social responsibilities in 2024, focusing on the vulnerable and contributing to community construction. The Company regularly conducted community environmental protection activities, advocated green living, and protected the ecological environment. At the same time, the Group actively participated in social welfare activities, conveying social care through measures such as community care activities, thus demonstrating the enterprise's social responsibility.

Looking forward to 2025, the Group will continue to adhere to the "customer-centered" philosophy, continuously innovating management models and enhancing service quality. The Company will further increase its investment in technology to create an intelligent property platform; strengthen community cultural construction to foster a harmonious and livable community atmosphere; at the same time, the Group will continue to focus on social responsibility and sustainable development issues to create a better living environment for property owners. All staff of the Group will work together to improve quality and efficiency, improve customer satisfaction, gain more recognition from property owners and customers, achieve steady scale growth and maintain long-term development.

Finally, on behalf of the board of directors again, I would like to extend my sincere compliment to property owners and all customers for their continuous support, and my wholehearted gratitude to all shareholders and partners for their unfailing support and to all employees for being dedicated to overcoming challenging times together with the Company! 在智慧服務方面,本集團大力推動智能化建設,持續 推動數字化轉型,整合先進技術,對信息平台進行升 級。利用智能化設備,提高用戶體驗,迭代更新數字 化服務平台,提升員工工作效率,促進運營高效協同 和精細化管理。通過科技賦能,更好服務客戶,促進 公司穩健發展,保障公司戰略執行和落地。

MANAGEMENT DISCUSSION AND ANALYSIS

REVIEW FOR 2024

In 2024, the management scale of the property management industry continued to expand and achieved steady growth, but due to the continuous pressure on the upstream real estate market, the competition in the inventory market became more and more fierce, and the overall growth rate of the property management industry was lower than the actual GDP growth rate. Against the backdrop of the industry, property companies are placing greater emphasis on balancing scale and profitability, and the structure of the inventory projects under management is being further optimized.

管理層討論與分析

2024年回顧

2024年,物業管理行業管理規模持續擴大,實現穩步 增長,但受上游房地產市場繼續承壓影響,存量市場 競爭愈發激烈,物業管理行業整體規模增速低於GDP 實際增速。行業大背景下,物業公司在規模和利潤之 間更加注重平衡,在管存量項目的結構也在進一步優 化。





In terms of layout, the Group consolidated its core strategy of "penetrating the Greater Jiangsu Region (做透大江蘇)" in 2024, further increased its investment in Jiangsu, radiating Suzhou, Wuxi, Changzhou, Xuzhou, Zhenjiang, Taizhou, Yangzhou and other cities centered on Nanjing, and adopted "expanding into core cities (做強中心城)" as the keynote of its cross-regional development, identifying Nanjing, Shanghai, Suzhou, Wuxi, Changzhou, Nantong, Xuzhou, Hefei, Wuhan and Chengdu as the ten key cities for its layout. While establishing its presence in the Yangtze River Delta, the Group explored new growth points in the key second-tier cities in the central and western regions.

In 2024, the Group won multiple industry awards, including "Top 100 Property Management Companies in 2024 (2024中國物業服務百強企業)" and "Top 6 of the Top 50 Enterprises by Comprehensive Strength in Property Management Industry in Jiangsu Province (江蘇省物業服務行業綜合實力五十強企業TOP 6)", by virtue of its stable and improving comprehensive strength, professional service capability, operational capacity and brand power. Its overall strength in the industry ranked 17

in China.

在佈局方式上,本集團2024年鞏固「做透大江蘇」的核 心戰略,進一步加大在江蘇的投入,以南京為中心 輻射蘇州、無錫、常州、徐州、鎮江、泰州、揚州等 多個城市,並以「做強中心城」為跨地域發展基調,明 確南京、上海、蘇州、無錫、常州、南通、徐州、合 肥、武漢、成都等十城為重點佈局城市,在深耕長三 角的基礎上,著眼於中西部強二線城市,探索新的增 長點。

本集團2024年憑藉企穩向好的綜合實力,專業的服務 力、經營力和品牌力,榮獲「2024中國物業服務百強企 業」、「江蘇省物業服務行業綜合實力五十強企業TOP 6」等行業大獎,行業綜合實力排名全國第17位。



The business of the Group covers a variety of property types, including residential properties and non-residential properties such as commercial buildings, schools and public construction, and also covers other specialised high-quality consulting services, resulting in collaborated balanced development of residential and commercial projects. As at 31 December 2024, the Group had provided property management services and value-added services to 58 cities in China, with 322 projects under management and contracted GFA of approximately 54.2 million sq.m., which has increased by approximately 0.55% as compared with that as at 31 December 2023, of which the total GFA under management was approximately 49.3 million sq.m., representing an increase of approximately 3.79% as compared with 2023.

During the Reporting Period, affected by unfavorable factors including the overall downturn of the upstream real estate industry, the Group achieved revenue of RMB1,026.7 million, representing a decrease of 3.6% as compared with the corresponding period in 2023, and gross profit of RMB199.6 million, representing a decrease of 20.9% as compared with the corresponding period in 2023. Net profit reached RMB15.1 million, representing an increase of 6.3% as compared with the corresponding period in 2023.

BUSINESS REVIEW

Our Business Model

Upholding the layout strategy of "penetrating the Greater Jiangsu Region, strengthening foothold in the Yangtze River Delta Region and expanding into core cities (做透大江蘇,深耕長三角,做強中心城)" and focusing on the "customer-centered" service philosophy, we continue to enhance the Redsun Mode and are committed to providing customers with warm quality services across the whole country. We provide a wide range of property management services to property owners, residents and tenants, value-added services to non-property owners, primarily property developers, and other property management companies, and community value-added services to residential property owners and residents.

報告期內,受上游地產行業整體下行等不利因素影響,本集團實現收入人民幣1,026.7百萬元,較2023年 同期下降3.6%,毛利人民幣199.6百萬元,較2023年同 期下降20.9%,淨溢利人民幣15.1百萬元,較2023年同 期增加6.3%。

Our portfolio of managed properties comprises of residential, commercial and other properties. In addition to residential properties, we are expanding our service scopes for non-residential markets. Not only do we provide property management services to a variety of commercial properties, such as shopping malls, operators' business halls, home improvement and furnishings malls, hotels and theme parks, but we also provide property management services to properties such as office buildings, industrial parks and schools.
- Value-added services to non-property owners: We also provide value-added services to non-property owners, including (1) consulting services to other property management companies;
 (2) preliminary planning and design consultancy services to property developers for property development projects; (3) sales assistance services to property developers to assist with their sales and marketing activities at property sales venues and display units, including visitor reception, cleaning, security inspection and maintenance; and (4) other value-added services to property developers, such as inspection services.
- 3. Community value-added services: We provide community valueadded services to residential property owners and residents to improve their living experiences with an aim to preserve and increase the value of their properties. Our community valueadded services for residential properties primarily include, among others, (1) property brokerage services, (2) property decoration services, (3) community convenience services, (4) common area value-added services, (5) intelligent services, (6) retail services, (7) assets management services and (8) home decoration services.

FINANCIAL REVIEW

Revenue

During the Reporting Period, the Group's revenue amounted to RMB1,026.7 million, representing a decrease of 3.6% from RMB1,063.6 million for the corresponding period in 2023. The decrease was mainly attributable to the decrease in the Group's revenue from providing value-added services to non-property owners.

Property management services

During the Reporting Period, the Group's revenue from providing property management services amounted to RMB822.8 million, representing a decrease of 2.1% from RMB840.2 million for the corresponding period in 2023. This was mainly attributable to the decrease in revenue from commercial property management services as a result of the Group's withdrawal from certain commercial property management projects.

Value-added services to non-property owners

During the Reporting Period, the Group's revenue from value-added services to non-property owners amounted to RMB42.7 million, representing a decrease of 36.2% from RMB66.9 million for the corresponding period in 2023. The decrease in revenue from value-added services to non-property owners was mainly attributable to the decrease of sales venue projects caused by the real estate projects being delivered one after another.

Community value-added services

During the Reporting Period, the Group's revenue from community value-added services achieved substantial growth, amounting to RMB161.2 million, representing an increase of 2.9% from RMB156.6 million for the corresponding period in 2023. During the Reporting Period, the increase in revenue from community value-added services was mainly attributable to the increase in revenue from project common area resource.

Cost of sales and services

During the Reporting Period, the Group's cost of sales and services amounted to RMB827.1 million, representing an increase of approximately 2.0% from RMB811.2 million for the corresponding period in 2023. This was mainly attributable to the increase in the number of projects under management of the Group and the increase in staff cost and sub-contracting cost.

收入

本集團的社區增值服務在報告期內取得大幅增長,為 人民幣161.2百萬元,較2023年同期收入人民幣156.6百 萬元增加2.9%。於報告期內,社區增值服務收入增加 的主要原因係項目公區資源收入增加所致。

銷售及服務成本

報告期內,本集團的銷售及服務成本為人民幣827.1百 萬元,較2023年同期人民幣811.2百萬元增加約2.0%, 主要由於本集團在管項目增加,員工成本及分包成本 上升所致。



Gross profit

As a result of the aforementioned key factors, the Group's gross profit decreased by approximately 20.9% from RMB252.4 million for the year ended 31 December 2023 to RMB199.6 million for the year ended 31 December 2024. The decrease was mainly attributable to a decrease in revenue from providing value-added services to non-property owners and the increase in the cost of property management services.

During the Reporting Period, the Group's gross profit margin was 19.4%, representing a decrease of 4.3% from 23.7% for the corresponding period in 2023. This was mainly attributable to the withdrawal from certain commercial property management projects and the increase in staff cost and sub-contracting cost.

The gross profit margin of property management services was 17.8%, representing a decrease of 4.5% from 22.3% for the corresponding period in 2023. This was mainly attributable to the withdrawal from certain commercial property management projects and the increase in staff cost and sub-contracting cost during the Reporting Period.

The gross profit margin of value-added services to non-property owners was 10.9%, representing a decrease of 4.9% from 15.8% for the corresponding period in 2023. This was mainly attributable to the decrease in the gross profit margin of sales assistance services provided to property developers by the Group due to the impact of the real estate industry. 報告期內,本集團毛利率為19.4%,較2023年同期的 23.7%下降4.3%,主要由於退出部份商業物業管理項目 和員工成本及分包成本上升所致。

The gross profit margin of community value-added services was 30.3%, representing a decrease of 4.8% from 35.1% for the corresponding period in 2023. This was mainly attributable to the decrease in the gross profit margin due to the increase of costs in parking spaces sales business of the Group during the Reporting Period.

Other income and gains and losses

During the Reporting Period, the Group's other income and other net income amounted to RMB7.2 million, as compared to RMB9.7 million for the corresponding period in 2023, mainly attributable to the decrease in government grants received in the Reporting Period.

Administrative expenses

During the Reporting Period, the Group's administrative expenses amounted to RMB104.3 million, representing an increase of approximately 4.4% from RMB99.9 million for the corresponding period in 2023. This was mainly attributable to the increase of property management projects of the Group.

Net impairment losses on financial assets

The Group's net impairment losses on financial assets primarily include the impairment allowance for trade receivables and other receivables in accordance with the accounting policy. During the Reporting Period, the Group's net impairment losses on financial assets amounted to RMB62.5 million, as compared to RMB119.0 million for the corresponding period in 2023, which was mainly due to the decrease in impairment allowance for receivables from related parties during the period.

Profit before income tax expense

During the Reporting Period, the Group's profit before income tax expense amounted to RMB36.5 million, representing a decrease of approximately 6.2% from RMB38.9 million for the corresponding period in 2023.

Income tax expenses

During the Reporting Period, the Group's income tax expense amounted to RMB21.4 million, representing a decrease of approximately 13.4% from RMB24.7 million for the corresponding period in 2023, which was mainly due to the decrease in profit before tax. 社區增值服務毛利率為30.3%,較2023年同期的35.1% 下降4.8%,主要由於報告期內本集團停車位銷售業務 成本增加、毛利率下降所致。

金融資產減值虧損淨額

本集團的金融資產減值虧損淨額主要包括根據會計政 策計提的貿易應收款項及其他應收款項減值準備。 報告期內,本集團的金融資產減值虧損淨額為人民幣 62.5百萬元,2023年同期為人民幣119.0百萬元,主要 由於本期計提關聯方應收款項減值準備金額減少所 致。

除所得税開支前溢利

報告期內,本集團除所得税開支前溢利為人民幣36.5 百萬元,較2023年同期人民幣38.9百萬元下降約6.2%。

所得税開支

報告期內,本集團所得税開支為人民幣21.4百萬元, 較2023年同期人民幣24.7百萬元下降約13.4%,主要由 於税前溢利減少。



Liquidity, reserves and capital structure

The Group maintained a solid financial position during the Reporting Period. As at 31 December 2024, the current assets amounted to RMB1,375.2 million, representing a decrease of 2.2% as compared to RMB1,406.5 million as at 31 December 2023. The Group's cash and cash equivalents were mainly denominated in RMB and amounted to RMB560.6 million as at 31 December 2024, representing a decrease of 12.1% from RMB638.1 million as at 31 December 2023. The current ratio (current assets divided by current liabilities) of the Group as at 31 December 2024 was 1.91, representing an increase from 1.88 as at 31 December 2023. The gearing ratio (total liabilities divided by total assets) as at 31 December 2024 was 45.2%, representing a decrease of 1.8% from 47.0% as at 31 December 2023.

As at 31 December 2024, the Group's total equity amounted to RMB909.1 million, representing an increase of 1.2% from RMB898.6 million as at 31 December 2023, which was mainly due to the growth in operating profit.

As at 31 December 2024, the Group's interest-bearing bank borrowings amounted to RMB31.1 million, representing a decrease of 30.7% as compared to RMB44.9 million as at 31 December 2023.

The Group's total borrowings were repayable as follows:

As at 31 December 2024, all of the Group's bank borrowings bear interest at fixed interest rates.

The Group actively reviews and manages its capital structure on a regular basis to maintain a balance between the relatively high returns to the owners of the Group and possible high level of borrowings and maintains the advantages and security of a sound capital position. The Group also makes adjustments to the capital structure in light of changes in economic conditions.

Trade receivables

The Group's trade receivables primarily include receivables from customers for property management services and community value-added services. As at 31 December 2024, the Group's trade receivables amounted to RMB289.9 million, representing an increase of approximately 13.9% from RMB254.6 million as at 31 December 2023, which was mainly due to the increase in the number of projects under management of the Group and the lower overall collection rate of newly taken-over projects.

Prepayments, other receivables and other assets

The Group's prepayments, other receivables and other assets primarily consist of prepayments on behalf of customers to utility suppliers, other deposits, amounts due from third parties and other tax recoverable. As at 31 December 2024, the Group's prepayments, deposits and other receivables amounted to RMB133.0 million, representing an increase of 7.8% from RMB123.4 million as at 31 December 2023, primarily due to the increase in prepayments on behalf of customers to utility suppliers resulting from the increase in the number of projects under management.

Trade payables

The Group's trade payables mainly comprise amounts due to subcontractors of property management services. As at 31 December 2024, the Group's trade payables amounted to RMB183.8 million, representing a decrease of approximately 6.2% from RMB195.9 million as at 31 December 2023, which was mainly due to the Group has shortened the account period of the contracted payables to improve the service quality of the project.

本集團的貿易應收款項主要包括就物業管理服務及社 區增值服務來自客戶的應收款項。本集團於2024年12 月31日的貿易應收款項為人民幣289.9百萬元,較2023 年12月31日的人民幣254.6百萬元增加約13.9%,主要由 於本集團在管項目數量的增加,新接管項目的整體收 繳率較低所致。

預付款項、其他應收款項及其他資產

本集團的預付款項、其他應收款項及其他資產主要包 括代表客戶向公用事業供應商支付的預付款項、其他 按金、應收第三方款項及其他可收回税項。本集團於 2024年12月31日的預付款項、按金及其他應收款項為 人民幣133.0百萬元,較2023年12月31日的人民幣123.4 百萬元增加7.8%,主要由於在管項目增加導致的代表 客戶向公用事業供應商支付的預付款項增加。

貿易應付款項

本集團的貿易應付款項主要為應付物業管理服務分 包商的款項。本集團於2024年12月31日的貿易應付款 項為人民幣183.8百萬元,較2023年12月31日的人民幣 195.9百萬元減少約6.2%,主要由於本集團為提升項目 服務品質,縮短外包應付款項賬期所致。



Contract liabilities

The Group's contract liabilities mainly represent the advance payments made by customers while our underlying services are yet to be provided. As at 31 December 2024, the Group's contract liabilities amounted to RMB258.6 million, representing an increase of approximately 2.4% from RMB252.6 million as at 31 December 2023, which was mainly due to the continuous growth in the number of property projects under management as a result of the Group's business expansion.

Other payables and accruals

The Group's other payables and accruals primarily comprise payroll and welfare payable to our employees, receipts on behalf of community residents for utilities, business tax and surcharges, and other payables. As at 31 December 2024, the Group's other payables and accruals amounted to RMB177.7 million, representing a decrease of approximately 13.2% from RMB204.7 million as at 31 December 2023, which was mainly due to the decrease in the number of employees and the balance of the payroll payable as a result of the Group upgrading the management system.

Contingent liabilities

As at 31 December 2024, the Group did not have material contingent liabilities or guarantees.

OUTLOOK

In 2025, the Group will adhere to the original intention of "making life warmer" and listen to the voice of customers. We will actively respond to changes in the market environment, timely adjust the development plan, deeply analyze the achievement of key strategic performance in previous years to provide accurate and targeted services with warmth and thoughtfulness, high quality and stability.

In 2025, the Group will continue to broaden the new track, as well as deeply develop its advantageous fields, balance the complementary relationship between business growth and stock, ensure healthy business development in terms of systems, and achieve sustainable and quality growth in business scale and profits.

合同負債

本集團的合同負債主要為客戶在尚未提供相關服務 時所作出的預付款項。本集團於2024年12月31日的合 同負債為人民幣258.6百萬元,較2023年12月31日的人 民幣252.6百萬元增加約2.4%,主要由於本集團業務擴 張,管理的物業項目數量持續增加。

其他應付款項及應計費用

本集團的其他應付款項及應計費用主要包括應付僱員 的工資及福利、就公用事業向社區住戶收取的收款、 營業税及附加費、其他應付款項。本集團於2024年12 月31日的其他應付款項及應計費用為人民幣177.7百 萬元,較2023年12月31日的人民幣204.7百萬元下降約 13.2%,主要由於本集團升級管理體系,員工人數減 少,應付工資餘額下降所致。

Investment-leading Strategy. The Group has always been committed to the development strategy of "penetrating the Greater Jiangsu Region and strengthening foothold in the Yangtze River Delta Region (做透大 江蘇,深耕長三角)", focusing on the targeted development of other central cities with advantages, seeking new opportunities and new paths in development, constantly expanding the market and gaining customer trust.

In terms of market expansion, the Company will integrate resources with taking Jiangsu Province as the core development area, provide high-quality basic services, and support scale high-quality and steady expansion. We will incubate new products from the basic portfolio, seek increment in new types of businesses, actively develop diversified valueadded services, increase the number of service projects in the region to generate economies of scale, and reduce costs and increase efficiency.

Finance-driven Operation. The Group will, on the one hand, create new sources of income and cut down on expenses, and, on the other hand, focus on risk prevention and control. In terms of creating new sources of income and cutting down on expenses, we will promote the stable income and increasing income of principal businesses while diversifying the operation of community businesses. We will focus on the customer's living service scene to meet the needs and create demands, and help customers develop consumption habits, lead customers to form new consumption concepts so as to create greater value in the change of concepts. In terms of risk prevention and control, our governance combines rules of law and rules of morals, and the sword of law hangs high, so that employees are awed and know the bottom line. Moral education will be conducted regularly, so that employees are aware of honor and shame with high morality. By taking corporate culture as an effective way to guide employees to practice corporate values, we protect employees' passion for work to create better value for the Company.

Operational Quality and Efficiency Enhancement. The Group regards operating capacity as the core capability to strengthen the Company's foundation. Improving corporate governance structure, enhancing operational efficiency and making decisions scientifically are the main approaches for the Company to cope with the external environment and participate in market opportunities. In terms of enhancing customer service capability and on-site service quality, the Company continuously optimizes its services system, quality standards and system construction in line with the changing market environment and business structure, so as to enable the quality control system of the Company to meet the market requirements, which is also an important measure to cater to the needs of customers.

We will continue to strengthen the business training of the "Hong Elite", "Redsun Housekeeper" and "Hong Master", to enhance overall service and improve the profitability of individual projects. We will sort out the efficiency improvement plan on a case by case basis, focusing on the management and improvement of the efficiency of such segments as parking space system management, energy consumption reduction, cost recruitment and procurement management, personnel organization efficiency and digital information system upgrade, so as to realize intelligent replacement of manual management, mechanize and improve operation efficiency, and intelligently improve management efficiency. Efficiency will be improved through refined business, smooth processes, clear rights and responsibilities, and online technology so that overall profitability will be increased. **運營提質增效**。本集團將運營能力視為穩固公司基業 的核心能力,改善公司治理結構、提升運營效率、決 策科學性是公司應對外部環境以及參與市場機會的主 要手段。在提升客戶服務能力和現場服務品質方面, 結合市場環境和業務結構變化,從服務體系、質量標 準和制度建設等方面不斷優化,使公司質量管控體系 適應市場要求,同時也是契合客戶需求的重要舉措。

Taking leading enterprises and enterprises of the same scale as in-depth benchmarking, the Group, in combination with the Group's development path and corporate vision, defines the development direction of residential and non-residential businesses, adheres to quality-oriented, and establishes a quality control system and cost standard system for the whole business landscape and full life cycle. We will actively carry out diversified value-added services, increase the level of project revenue within the unit scale, and with the help of an intelligent platform, we will optimize customer service experience while improving management efficiency, and achieve continuous improvement in our reputation among customers and service quality.

Adhering to the core values of "professionalism and building credibility for the long term", we will reinforce our principle of "being talentoriented, fighter-oriented and contributor-oriented" and uphold our ideals of "health, hard work, humanistic love, practicality, vitality, affinity, coordination and facing problems". Based on such values and principle, corporate cultural development was facilitated and a consensus among employees was reached.

In 2025, as the property management industry advances to a higher quality direction, the Group will rely on its continuously enhancing service capability, operational capacity and brand power, work hard to make new achievements and try its best endeavors to become a venerable good life operator. 本集團同頭部企業及同規模企業深度對標,結合本集 團發展路徑和企業願景,明確住宅和非住業務發展方 向,堅持品質為本,建立全業態、全生命週期的質量 管控體系和成本標準體系。積極開展多元增值服務, 提高單位規模內的項目營收水準,並借助智慧化平 台,在管理提效的同時優化客戶服務體驗,實現客戶 口碑和服務品質的持續提升。

1. Material Investments, Acquisitions and Disposals

There was no material investment, acquisition and disposal of subsidiaries, associates or joint ventures by the Group during the Reporting Period.

2. Employment and Remuneration Policies

As at 31 December 2024, the Group had 2,878 employees in total, of which 2,264 employees were engaged in property management and related services for residential properties, 251 employees were engaged in property management and related services for commercial properties and 363 employees were engaged in property management and related services for public construction properties.

The emolument of the employees of the Group is mainly determined based on their duties, performance and the prevailing market level in the respective regions. The Group has formulated a systematic and market-competitive employee incentive plan and a comprehensive talent cultivation scheme based on its business to attract and retain talents through offering competitive salary packages, comprehensive talent training strategies, internal promotion system and a caring corporate culture. In addition, focusing on the entire process of talent cultivation and development, the Group has also formulated the systematic talent cultivation scheme, for enhancing the quality of talents and broadening its pool of talents. The Group has designed three-tier talent team training projects, namely the "Brigadier Scheme (準將計劃)", "Hong Elite Scheme (弘精英計劃)", and "Hong Yao Scheme (弘耀計劃)" for the key talents which focused on individual development and practical courses, and assisted individuals in formulating development plans, and were conducted in conjunction with the "offline training + classes for the front line (線下集訓+送課去一線)" in an orderly manner. At the same time, we cultivated city companies "Hong Elite", "Redsun Housekeeper" and "Hong Master" for enhancing capabilities of the Company's customer services, in which systematic arrangements are implemented to provide the employees of the Group with clear development path and secure the demand for talents in different business segments and levels.

本集團員工的薪酬主要根據其職責、工作表現 及該地區目前市場水準釐定。本集團基於業務 制定了系統的、有市場競爭力的員工激勵計劃 和完備的人才培養計劃,通過提供具有競爭力 的薪資待遇、完善的人才培養策略、內部晉升 制度和關愛的企業文化來吸引和留住人才。此 外,本集團還圍繞人才培養和發展的全流程形 成了系統的培養計劃,提高人才質量、增加人 才庫;針對關鍵人才設計了「準將計劃」、「弘精 英計劃]及「弘耀計劃」三層人才梯隊培養項目, 聚焦個人發展和實戰課程,協助個人制定發展 計劃,結合「線下集訓+送課去一線」的方式,有 序開展。同時為提升公司對客服務能力,培養 城市公司「弘精英」、「弘管家」、「弘師傅」,實施 體系化的載端,為本集團員工提供了清晰的發 展道路,保障了不同業務模塊、不同層級的人 才需求。





The Group believes that talent cultivation scheme of the Group will enhance team building, improve team capability, and provide talent pipelines for the business development of the Group.

3. Events after the Reporting Period

On 17 February 2025, the Company and Redsun Properties Group entered into a parking spaces transfer framework agreement, pursuant to which the Company conditionally agreed to purchase and Redsun Properties Group conditionally agreed to sell the property right or the right of use (as the case may be) of the target parking spaces at a total consideration of approximately RMB230.92 million, subject to the terms and conditions of the agreement.

On the same day, Nanjing Hong Life Real Estate Consulting Co., Ltd. (an indirect wholly-owned subsidiary of the Company) and each of Chengdu Hong Yang Jin Xing Real Estate Development Co., Ltd., Xuzhou Honggi Real Estate Development Co., Ltd. and Nanjing Hong Tai Pu Yang Property Co., Ltd. (all being indirect wholly-owned subsidiaries of Redsun Properties Group) entered into the respective equity transfer agreements, pursuant to which Nanjing Hong Life Real Estate Consulting Co., Ltd. conditionally agreed to purchase, and each of Chengdu Hong Yang Jin Xing Real Estate Development Co., Ltd., Xuzhou Hongqi Real Estate Development Co., Ltd. and Nanjing Hong Tai Pu Yang Property Co., Ltd. conditionally agreed to sell (a) 70% of the equity interests in the Chengdu Hong Sheng He Ding Real Estate Development Co., Ltd. held by Chengdu Hong Yang Jin Xing Real Estate Development Co., Ltd.; (b) 20% of the equity interests in the Sugian Tong Jin Hong Real Estate Co., Ltd. held by Xuzhou Honggi Real Estate Development Co., Ltd.; and (c) 19% of the equity interests in Jurong Jin Jia Run Real Estate Development Co., Ltd. held by Nanjing Hong Tai Pu Yang Property Co., Ltd., together with all other assets, liabilities and owners' equity attached to the equity interests abovementioned at a consideration of approximately RMB142.4 million, RMB73.95 million and RMB41.34 million, respectively.

於同日,南京弘生活置業顧問有限公司(本公司 間接全資附屬公司)與成都弘陽錦興房地產開發 有限公司、徐州弘琪房地產開發有限公司及南 京鴻泰浦陽置業有限公司(均為弘陽地產集團間 接全資附屬公司)各自訂立各自的股權轉讓協 議,據此,南京弘生活置業顧問有限公司有條 件地同意購買而成都弘陽錦興房地產開發有限 公司、徐州弘琪房地產開發有限公司及南京鴻 泰浦陽置業有限公司各自有條件地同意出售(a) 成都弘陽錦興房地產開發有限公司持有的成都 弘勝和鼎房地產開發有限公司70%股權;(b)徐 州弘琪房地產開發有限公司持有的宿遷市通金 弘置業有限公司20%股權;及(c)南京鴻泰浦陽置 業有限公司持有的句容金嘉潤房地產開發有限 公司19%股權, 連同上述股權所附帶的所有其 他資產、負債及所有者權益,代價分別約為人 民幣142.4百萬元、人民幣73.95百萬元及人民幣 41.34百萬元。

The Group primarily operates in the PRC and the majority of transactions were denominated and settled in RMB. As at the date of this report, the Group has not entered into any hedging transactions to mitigate the exposure to foreign exchange risk. The Group will continue to monitor foreign exchange activities and safeguard the cash value of the Group with its best efforts.

The audit committee consists of four members, including three independent non-executive Directors, namely Mr. Zhao Xianbo, Ms. Wang Fen and Mr. Li Xiaohang; and one non-executive Director, Mr. Zeng Junkai. The audit committee is chaired by Mr. Zhao Xianbo, an independent non-executive Director who possesses appropriate professional accounting and related financial management expertise as required under Rule 3.10(2) of the Listing Rules.

Our audit committee has reviewed the Company's consolidated financial statements for the year ended 31 December 2024 and confirmed that it has complied with all applicable accounting principles, standards and requirements, and made sufficient disclosures. Our audit committee has also discussed the matters of audit and financial reporting.

CORPORATE INFORMATION

The Company was incorporated in the Cayman Islands under the Cayman Companies Law, as an exempted company with limited liability on 12 December 2019. The shares of the Company (the "**Shares**") were listed on the Stock Exchange on 7 July 2020 (the "**Listing Date**").

PRINCIPAL OPERATIONS

The Group is a well-recognized comprehensive community service provider in Jiangsu province, China, with region-leading and balanced property management abilities in the management of residential and commercial properties. Through the Group's continued development over the years, it has established its regional leading position in the property management market of Jiangsu province and are wellrecognized nationwide as it kept expanding its business in the rest of the country. The Group provides a wide range of property management services to property owners, residents and tenants. It also provides valueadded services to non-property owners, primarily property developers and other property management companies and community valueadded services to residential property owners and residents.

Details of the principal activities of the principal subsidiaries of the Group are set out in note 39 to the consolidated financial statements of the Group in this annual report. There were no significant changes in the nature of the Group's principal activities during the year ended 31 December 2024. As at the date of this annual report, the Board has no intention to significantly change the principal business of the Group.

The Group's controlling shareholders, namely, Mr. Zeng Huansha, Hong Yang Group (Holdings), Hong Yang International Limited ("Hong Yang International"), Hong Yang Group Company Limited ("Hong Yang Group Company") and Redsun Services Group (Holdings) Limited ("Redsun Services Group (Holdings)") (together, the "Covenantors") entered into a deed of non-competition (the "Deed of Non-**Competition**") in favor of the Company for ourselves and as trustee for the benefit of each of our subsidiaries on 16 June 2020, pursuant to which each of the Covenantors has, among other things, irrevocably and unconditionally undertaken, jointly and severally, with the Company that, each of the Covenantors shall not, and shall procure that his/its close associates (other than members of our Group) will not, directly or indirectly, carry on, engage in, invest in, participate in, attempt to participate in, render any services to, provide any financial support to or otherwise be involved in or interested in, whether alone or jointly with another person and whether directly or indirectly or on behalf of or to assist or act in concert with any other person, any business or investment activities in the PRC and Hong Kong which are the same as, similar to or in competition with the business carried on or contemplated to be carried on by any member of the Group from time to time (the "Restricted Business").

The Deed of Non-Competition shall expire on the earlier of (i) the date when the Covenantors and, as the case may be, any of their close associates, cease to hold, or otherwise be interested in, beneficially in aggregate whether directly or indirectly, 30% or more (or such other percentage of shareholding as stipulated in the Listing Rules to constitute a controlling shareholder) of the issued share capital of the Company; or (ii) the date on which the Shares cease to be listed on the Stock Exchange (except for temporary suspension of the trading of the shares).

Annual Review

The Covenantors have confirmed that they did not refer, or to procure the referral of, any investment or commercial opportunities relating to the Restricted Business to the Group during the year ended 31 December 2024.

The Company has received a written confirmation from each of the Covenantors in respect of the compliance by them and their close associates with the terms of the Deed of Non-Competition. The independent non-executive Directors have reviewed the Deed of Non-Competition and assessed whether the Covenantors and their close associates have complied with the terms of the Deed of Non-Competition, and were satisfied that each of the Covenantors has complied with its/his undertakings under the Deed of Non-Competition during the year ended 31 December 2024.

1. Provision of Parking Space Sales and Leasing Agency Services to Redsun Properties and its Associates

On 11 March 2020, Nanjing Hong Yang Property Management (together with its subsidiaries, the "Nanjing Hong Yang Property Management Group"), an indirect wholly-owned subsidiary of the Company, entered into a parking space sales and leasing agency services framework agreement with Redsun Properties Group Limited ("Redsun Properties") and its subsidiaries (collectively, the "Redsun Properties Group"), pursuant to which we agreed to provide sales and leasing agency services to Redsun Properties and its associates in respect of the unsold parking spaces of Redsun Properties and its associates (the "Parking Space Sales and Leasing Agency Services Framework Agreement"). The Parking Space Sales and Leasing Agency Services Framework Agreement took effect on 11 March 2020 and would be valid until 31 December, 2022, renewable by mutual agreement of the parties.

Subsequently, on 8 December 2022, the Company entered into a parking space sales and leasing agency services framework agreement with Redsun Properties on substantially the same terms and conditions as the existing Parking Space Sales and Leasing Agency Services Framework Agreement, pursuant to which we agreed to provide sales and leasing agency services to Redsun Properties and its associates in respect of the unsold parking spaces of Redsun Properties and its associates (the "**New Parking Space Sales and Leasing Agency Services Framework Agreement**"). The New Parking Space Sales and Leasing Agency Services Framework Agreement took effect on 1 January 2023 and will be valid until 31 December 2025, renewable by mutual agreement of the parties.

向弘陽地產及其聯繫人提供停車位銷售及 租賃代理服務

於2020年3月11日,本公司間接全資附屬公司南 京弘陽物業管理(連同其附屬公司,「南京弘陽 物業管理集團」)與弘陽地產集團有限公司(「弘 陽地產」)及其附屬公司(統稱「弘陽地產集團」) 訂立停車位銷售及租賃代理服務框架協議,據 此,我們同意就弘陽地產及其聯繫人尚未出售 的停車位向弘陽地產及其聯繫人提供銷售及租 賃代理服務(「停車位銷售及租賃代理服務框架協議於 2020年3月11日生效,有效期至2022年12月31 日,可由雙方相互協商重續。

隨後,於2022年12月8日,本公司與弘陽地產訂 立停車位銷售及租賃代理服務框架協議,其條 款及條件與現有停車位銷售及租賃代理服務框 架協議大致相同,據此,我們同意就弘陽地產 及其聯繫人尚未出售的停車位向弘陽地產及其 聯繫人提供銷售及租賃代理服務(「新停車位銷售 及租賃代理服務框架協議」)。新停車位銷售及 租賃代理服務框架協議於2023年1月1日生效, 有效期至2025年12月31日,可由雙方相互協商 重續。

> On 7 June 2023, the Company and Redsun Properties entered into two supplemental parking space sales and leasing agency services framework agreements (collectively, the "Supplemental Parking Space Sales and Leasing Agency Services Framework Agreements"), pursuant to which members of the Group shall pay to members of Redsun Properties Group the refundable deposits in connection with the sales agency services contemplated under the Parking Space Sales and Leasing Agency Services Framework Agreement and the New Parking Space Sales and Leasing Agency Services Framework Agreement, respectively. The term of the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 1 was from 20 March 2020 to 31 December 2022 with retrospective effect. The term of the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2 would be from 1 January 2023 to 31 December 2025 with retrospective effect, renewable by mutual agreement of the parties.

> On 16 August 2023, the Company and Redsun Properties entered into the supplemental agreement to the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2 (the "Second Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2") to amend and modify certain terms of the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2. Pursuant to the Second Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2, for the parking spaces failed to be sold by the Group, the refundable deposits shall be refunded in full within 30 working days after the expiration of (i) the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 1 on 31 December 2022; and (ii) the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2 on 31 December 2025, respectively, or on the date(s) as agreed by parties under the relevant definitive sales agency services agreement(s) (whichever is earlier).

於2023年6月7日,本公司與弘陽地產簽訂了兩 份補充停車位銷售及租賃代理服務框架協議 (統稱「補充停車位銷售及租賃代理服務框架協議 」),根據該等協議,本集團成員公司應分別 向弘陽地產集團成員公司支付停車位銷售及租 賃代理服務框架協議及新停車位銷售及租賃代 理服務框架協議下的銷售代理服務可退還保證 金。補充停車位銷售及租賃代理服務框架協議1 的期限為自2020年3月20日至2022年12月31日並 具追溯效力。補充停車位銷售及租賃代理服務 框架協議2的期限為自2023年1月1日至2025年12 月31日並具追溯效力,倘雙方同意可續簽。

於2023年8月16日,本公司與弘陽地產簽訂了補 充停車位銷售及租賃代理服務框架協議2的補充 協議(「第二份補充停車位銷售及租賃代理服務 框架協議2」),以修訂及修改補充停車位銷售及 租賃代理服務框架協議2的若干條款。根據第二 份補充停車位銷售及租賃代理服務框架協議2, 對於本集團未售出的停車位,可退還保證金將 分別在(i)補充停車位銷售及租賃代理服務框架 協議1於2022年12月31日期滿;及(ii)補充停車位 銷售及租賃代理服務框架協議2於2025年12月31 日期滿後30個工作日內或各具體銷售代理服務 協議訂約方協定的其他日期(以較早者為準)全 額退還。







As one or more of the applicable percentage ratios of the proposed annual caps in respect of the refundable deposits contemplated under the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 1 exceed 5% but are less than 25%, such payment of the refundable deposits constitutes a discloseable transaction and continuing connected transactions of the Company and is subject to the reporting. annual review, announcement, circular and Independent Shareholders' approval requirements under Chapter 14 and Chapter 14A of the Listing Rules. Meanwhile, as one or more of the applicable percentage ratios of the proposed annual caps in respect of the refundable deposits contemplated under the Supplemental Parking Space Sales and Leasing Agency Services Framework Agreement 2 exceed 25% but are less than 100%, such payment of the refundable deposits constitutes a major transaction and continuing connected transactions of the Company and is subject to the reporting, annual review, announcement, circular and Independent Shareholders' approval requirements under Chapter 14 and Chapter 14A of the Listing Rules.

Pricing policy

The agency fees for the provision of sales and leasing agency services in respect of unsold parking spaces shall be calculated based on the following:

Sales/leasing agency fee = contract prices of the sales/leasing of the subject parking spaces x agreed rate of agency fee

The contract prices of the sales/leasing of the subject parking spaces shall be determined with reference to the prevailing market price charged by other independent third party services providers to Redsun Properties and its associates in respect of comparable locations. The total sales reserve price is calculated according to the formula below:

Principal risks and uncertainties facing the Group include, among others:

(i) We may not be able to grow our property management portfolio as planned, which may have a material adverse effect on our business, financial condition and results of operations. The Group will continue to expand its property management portfolio by proactive market-oriented expansion and strategic acquisition to add to the scale of its properties under management.

(ii) The Group's historical results may not be indicative of its future prospects and results of operation and its future growth may not materialize as planned, and failure to manage any future growth effectively may have a material adverse effect on our business, financial condition and results of operations. The Group will continue to uplift its operation and management capability and market competitiveness and seize market opportunities for achieving continual growth in operating results.

- (iv) A majority of our revenue is generated from property management services the Group provides to projects developed by Redsun Properties Group and properties owned by associates of the controlling shareholders, which the Group does not have control over. The Group will continue to expand its coverage to properties developed by third-party developers and reduce reliance on properties developed by related parties.

COMPLIANCE WITH LAWS AND REGULATIONS

Compliance procedures are in place to ensure adherence to applicable laws, rules and regulations which have a significant impact to the Group. As at the date of this annual report, except as disclosed in the annual report, the Group complied with, in all material respects, all the relevant and applicable PRC laws and regulations governing the business of property management and the Group has obtained all licenses, permits and certificates for the purpose of operating its business.

As at the date of this annual report, the Company's joint ventures and associated company were not involved in and the Board is not aware of any non-compliance incidents that might adversely affect the value of the Company's interests in them.

The Group has formulated a systematic and marketcompetitive employee incentive plan and a comprehensive talent cultivation scheme based on its business to attract and retain talents through offering competitive salary packages, comprehensive talent training strategies, internal promotion system and a caring corporate culture.

In addition, focusing on the entire process of talent cultivation and development, the Group has also formulated the systematic "talent cultivation scheme", for enhancing the quality of talents and broadening its pool of talents. The Group has designed the "Hong Elite Scheme (弘精英計劃)", "Management Trainee programme", and "Hong Yao Scheme (弘耀計劃)" for the key talents, as well as cultivated city companies "Hong Elite", "Redsun Housekeeper" and "Hong Master" for enhancing capabilities of the Company's customer services, in which systematic arrangements are implemented to provide the employees of the Group with clear development path and secure the demand for talents in different business segments and levels. The Group believes that talent cultivation scheme of the Group will enhance team building, improve team capability, and provide talent pipelines for the business development of the Group.

僱員及薪酬政策

截至2024年12月31日,本集團共有2,878名員工,其中 2,264名員工從事住宅物業的物業管理及相關服務, 251名員工從事商業物業的物業管理及相關服務,363 名員工從事公建物業的物業管理及相關服務。

本集團員工的薪酬主要根據其職責、工作表現及相關 地區目前市場水平釐定。本集團基於業務制定了系統 的、有市場競爭力的員工激勵計劃和完備的人才培養 計劃,通過提供具有競爭力的薪資待遇、完善的人才 培養策略、內部晉升制度和關愛的企業文化來吸引和 留住人才。

此外,本集團還圍繞人才培養和發展的全流程形成 了系統的「人才培養計劃」,提高人才質量、拓寬人才 庫:針對關鍵人才設計了「弘精英計劃」、「管培生計 劃」、「弘耀計劃」,同時為提升公司對客服務能力,培 養城市公司「弘精英」、「弘管家」、「弘師傳」,實施體 系化的載端,為本集團員工提供了清晰的發展道路, 保障了不同業務模塊、不同層級的人才需求。本集團 相信,本集團的人才培養計劃將加強團隊建設,提高 團隊能力,並為本集團業務發展提供人才通道。



ENVIRONMENTAL, SOCIAL AND GOVERNANCE

Environmental Protection

The Group is subject to PRC laws in relation to environment protection matters. The Group considers the protection of the environment to be important and have implemented measures in the operation of our businesses to ensure its compliance with all applicable requirements. Given the nature of its operations, the Group believes it is not subject to material environmental liability risk or compliance costs.

During the year ended 31 December 2024 and up to the date of this annual report, no fines or penalties for non-compliance of PRC environmental laws had been imposed on the Group, and the Group had not been subject to any material administrative penalties due to violation of environmental laws in the PRC.

Social Responsibility

The Group has entered into employment contracts with its employees in accordance with the applicable PRC laws and regulations.

The Group maintains social welfare insurance for its full-time employees in the PRC, including pension insurance, medical insurance, personal injury insurance, unemployment insurance and maternity insurance, in accordance with the relevant PRC laws and regulations.

Health and Work Safety

The employees' administrative measures adopted by the Group contain policies and procedures regarding work safety and occupational health issues. The Group provides its employees with annual medical checks and safety training, and the construction sites of the Group are equipped with safety equipment including gloves, boots and hats.

The operational management department of the Group is responsible for recording and handling work accidents as well as maintaining health and work safety compliance records.

During the year ended 31 December 2024 and up to the date of this annual report, the Group did not encounter any material safety accident, there were no material claims for personal or property damages and no material compensation was paid to employees in respect of claims for personal or property damages related to safety accident.

環境保護

The articles of association of the Company provides that the Directors, managing directors, alternate Directors, auditors, secretary and other officers for the time being of the Company and the trustees (if any) for the time being acting in relation to any of the affairs of the Company, and their respective executors or administrators, shall be indemnified and secured harmless out of the assets of the Company from and against all actions, costs, charges, losses, damages and expenses which they or any of them, their or any of their executors or administrators, shall or may incur or sustain by reason of any act done, concurred in or omitted in or about the execution of their duty or supposed duty in their respective offices or trusts. The Company has arranged appropriate directors and officers liability insurance in respect of legal action against Directors.

EQUITY-LINKED AGREEMENTS

No equity-linked agreements were entered into by the Group, or subsisted during the year ended 31 December 2024.

SUFFICIENCY OF PUBLIC FLOAT

Rule 8.08 of the Listing Rules requires there to be an open market in the securities for which listing is sought and a sufficient public float of an issuer's listed securities to be maintained. This normally means that at least 25% of the issuer's total issued share capital must at all times be held by the public.

Based on the information that is publicly available to the Company and to the knowledge of the Directors as at the latest practicable date prior to the issue of this annual report, the Company has maintained a sufficient public float as required under the Listing Rules.

CHARITABLE DONATIONS

During the year ended 31 December 2024, the Group made charitable and other donations in a total amount of RMB0.2 million.

CORPORATE GOVERNANCE

The Group is committed to implementing high standards of corporate governance to safeguard the interests of the Shareholders and enhance the corporate value as well as the responsibility commitments. The Company has adopted the Corporate Governance Code (the "**CG Code**") as set out in Appendix C1 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**") as its own code of corporate governance.

Saved as disclosed above, to the best knowledge of the Directors, the Company has complied with all applicable code provisions set out in Part 2 of the CG Code during the year ended 31 December 2024 and up to the date of this annual report (the "**Relevant Period**"). The directors of the Company (the "**Directors**") will use their best endeavors to procure the Company to continue to comply with the CG Code.

INDUCTION AND CONTINUOUS PROFESSIONAL DEVELOPMENT

Each Director is provided with the necessary induction and information to ensure that he has a proper understanding of the Company's operations and businesses as well as his responsibilities under relevant statutes, by-laws, laws, rules and regulations. The Company will continue to arrange regular seminars to provide the Directors with updates on the latest developments and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. The Directors are also provided with regular updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge his duty.

Mr. Chen Yichun was appointed as the executive Director with effect from 24 June 2024. Mr. Chen obtained the legal advice referred to in Rule 3.09D of the Listing Rules on the appointment date, and such Director confirmed that he understood his obligation as a director of the Company.

The Board assumes the responsibility of leadership and control of the Company, and supervises and approves significant decisions regarding financial performance, strategic development objectives and operations of the Company. The Board delegates to the management authority and responsibility for the Company's daily operations and businesses management according to the Board's instructions. The Board has established three committees, namely, the audit committee, the remuneration committee and the nomination committee of the Board (collectively, the "**Board Committees**"), and has delegated to the Board Committees various duties. All the Board Committees perform their distinct roles in accordance with their respective terms of reference.

All Directors shall at all times ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and the Shareholders.

There is no material financial, business, family or other relationship between any members of the Board. The biographies of the Directors are set out under the section headed "Directors and Senior Management" in this annual report. All the Directors, including the independent non-executive Directors, bring a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. The independent non-executive Directors are invited to serve on the audit committee, remuneration committee and nomination committee of the Company.

The Company has received a confirmation of independence from each of the independent non-executive Directors pursuant to Rule 3.13 of the Listing Rules. The Board has assessed their independence and concluded that all the independent nonexecutive Directors are considered to be independent pursuant to the Listing Rules.

Each of the non-executive Director and independent nonexecutive Directors has entered into an appointment letter with the Company for a term of three years.

3. Chairman and Chief Executive Officer

The roles of the chairman and the chief executive officer of the Company have been separated as required by Code Provision C.2.1 of the CG Code. For the year ended 31 December 2024, Mr. Zeng Junkai served as the Chairman of the Company and Mr. Chen Yichun (appointed on 23 September 2022) served as the Vice President of the Company (presiding over the work) (the "**Vice President**"). He is currently the Executive President of the Company.

4. Board Meetings

Code Provision C.5.1 of the CG Code prescribes that at least four regular Board meetings should be held in each year at approximately quarterly intervals with active participation of majority of directors, either in person or through electronic means of communication.

The Company has adopted the practice of holding Board meetings regularly. Notice of not less than 14 days is given of all regular Board meetings to provide all Directors with the opportunity to attend and include matters in the agenda. For other committee meetings, 7 days' notice is given. The agenda and accompanying board papers are despatched to the Directors or committee members at least 3 days before meetings to ensure that they have sufficient time to review these documents and be adequately prepared. When the Directors or committee members are unable to attend a meeting, they are advised of the matters to be discussed and given an opportunity to make their views known to the chairman prior to the meeting.

Minutes of the Board meetings and committee meetings are recorded in detail and include the matters considered by the Board and the committees and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and committee meeting are sent to the Directors within a reasonable time after the date on which the meeting is held so that they have an opportunity to request amendments.

The Board has established mechanisms to ensure that independent views and input are available to the Board (i) the Chairman will at least hold one meeting annually with independent non-executive Directors and without the presence of other Directors; and (ii) the independent non-executive Directors participate in board committees (including Audit Committee, Nomination Committee and Remuneration Committee) meetings to bring independent views, advice and judgment on important issues relating to the Company's strategy, policy and financial performance. During the Reporting Period, the Board reviewed the implementation of the abovementioned mechanism and considered the mechanism to be appropriate and effective.

4. 董事會會議

Each of these committees has specific written terms of reference which deal clearly with their authority and duties. 1. Audit Committee

Our Board has established an audit committee in compliance with Rules 3.21 and 3.22 of the Listing Rules and Code D.3 of the CG Code, and has adopted written terms of reference. The primary duties of our audit committee are to review and monitor the Group's financial reporting process, risk management and internal control system, to oversee the audit process, to provide advice and comments to our Board, and to perform other duties and responsibilities as may be assigned by the Board. Our audit committee currently consists of one non-executive Director, being Mr. Zeng Junkai, and three independent non-executive Directors, being Ms. Wang Fen, Mr. Li Xiaohang and Mr. Zhao Xianbo. Our audit committee is currently chaired by Mr. Zhao Xianbo, who possesses suitable professional qualifications.

Our audit committee convened 3 meetings during the Relevant Period. The table below sets forth the details of the attendance at these meetings:

Our audit committee has reviewed the Company's audited consolidated financial statements for the years ended 31 December 2023 and 2024 and the Company's interim condensed consolidated statement for the six months ended 30 June 2024, and confirmed that it has complied all applicable accounting principles, standards and requirements, and made sufficient disclosures. Our audit committee has reviewed the remuneration of the auditor and recommended the Board to appoint CCTH CPA Limited as the auditor of the Company following the resignation of Ernst & Young for the year ended 31 December 2024 and has recommended the Board to re-appoint CCTH CPA Limited as the auditor of the Company for the year ending 31 December 2025, subject to approval by the Shareholders at the AGM.

- reviewed the cash flow projections and monitored the Company's overall financial condition;

- (c) commitment in respect of available time and relevant interest;
- (d) diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service;
- (e) fulfilment of independence guidelines for the appointment of independent non-executive Directors as set out in Rule 3.13 of the Listing Rules; and
- (f) any factors as the nomination committee or the Board may from time to time consider appropriate.

The nomination committee will ask proposed candidates to submit the necessary personal information in a prescribed form.

The nomination committee may request candidates to provide additional information and documents, if considered necessary.

The appointment of any proposed candidate to the Board or reappointment of any existing members of the Board shall be made in accordance with the Articles of Association of the Company and other applicable rules and regulations.

Board Diversity Policy

In order to enhance the effectiveness of our Board and to maintain the high standard of corporate governance, the Company has adopted the board diversity policy which sets out the objective and approach to achieve and maintain diversity of our Board. Pursuant to the board diversity policy, the Company seeks to achieve Board diversity through the consideration of a number of factors when selecting the candidates to our Board, including but not limited to gender, skills, age, professional experience, knowledge, cultural, education background, ethnicity and length of service. The ultimate decision of the appointment will be based on merit and the contribution which the selected candidates will bring to our Board.

The Directors have a balanced mix of knowledge and skills, including overall management and strategic development, human resources, information technology, accounting and financial management, risk management and corporate governance. They obtained degrees in various majors including economics, business administration, and accounting studies. The Board has three independent non-executive Directors with different industry backgrounds, representing more than one third of the members of our Board. Furthermore, our Board has two female members, and has a wide range of age, ranging from 31 years old to 58 years old. Taking into account our existing business model and specific needs as well as the different background of the Directors, the composition of our Board satisfies our board diversity policy.

Our nomination committee is responsible for ensuring the diversity of our Board members. Our nomination committee will review the board diversity policy annually to ensure its continued effectiveness and the Company will disclose in its corporate governance report about the implementation of the board diversity policy on an annual basis.

In addition, as at 31 December 2024, the Group had 2,878 employees, of which the number of male and female employees are 1,721 and 1,157, respectively (accounted for 59.8% and 40.2% respectively), the overall headcount remained stable.

DIVIDEND POLICY

The Company has adopted a dividend policy (the "**Dividend Policy**"), pursuant to which the Board has absolute discretion in determining whether to pay dividend, subject to the approval of the Shareholders (if applicable). The Dividend Policy aims to enable the Shareholders to participate in the profits of the Company and for the Company to retain adequate liquidity for grasping future growth opportunities. In determining whether to recommend a declaration of dividend and the amount of dividend to be paid, the Board will evaluate the Company's earnings, cash flow, financial condition, capital requirements, prevailing economic conditions, future prospects and any other factors that the Directors deem relevant. The Board may pay dividend as appeared to the Board to be justified by the profits of the Company. The Board may also from time to time pay interim dividend or special dividend. The Board will review the Dividend Policy from time to time and may make appropriate changes if considered necessary.

RISK MANAGEMENT AND INTERNAL CONTROL

Risk Management

The Board is responsible for the risk management and internal control systems of the Company and for reviewing their effectiveness.

The Company recognizes that risk management is critical to the success of any property management companies in the PRC. Key operational risks that the Company face include changes in general market conditions and the regulatory environment of the PRC property management market, local economic environment, expansion risks relating to entering into new cities or geographic regions, ability to timely complete our projects with sound quality, available financing to support our growth, competition from other property management companies and our ability to promote and serve the property owners in a timely fashion.

In order to meet these challenges, the Company has adopted, a series of internal control policies, procedures and plans that are designed to reasonably assure effective and efficient operations, reliable financial reporting and compliance with applicable laws and regulations.

In order to ensure the effective implementation of such internal control policies, the Company has adopted various on-going measures, including the following:

- The Board is responsible and has general powers over the management and conduct of the business of the Group. Any significant business decision involving material risks are reviewed, analyzed and approved at the Board level to ensure a thorough examination of the associated risks at our highest corporate governance body.
- The Executive President is responsible for the Board regarding the effectiveness of comprehensive risk management, which in turn is accountable to the general meetings of the Company. The Executive President is able to authorize relevant department leaders who take charge of the establishment and daily operation of the risk management systems.

風險管理及內部監控

風險管理

董事會負責本公司的風險管理及內部監控系統,並檢 討其有效性。

本公司深明風險管理對中國的任何物業管理公司的成 功至關重要。本公司面臨的主要經營風險包括整體市 場情況的變化、中國物業管理市場的監管環境變動、 當地經濟環境、進入新城市或地區的擴張風險、及時 優質完成我們項目的能力、支持我們發展的可用融 資、來自其他物業管理公司的競爭,以及我們推廣和 及時服務業主的能力。

為迎接這些挑戰,本公司已經採納一系列內部監控政 策、程序及計劃,旨在合理保證有效和高效的經營、 可靠的財務報告,並遵守適用的法律法規。

為確保有效落實該等內部監控政策,本公司已持續採 納多項措施,其中包括下列各項:

- 董事會對本集團業務的管理和經營負責並擁有 一般權力。任何涉及重大風險的重大業務決 策,都會在董事會層面進行審議、分析及批 准,以確保在本公司最高治理機構對相關風險 進行徹底審查。
- 執行總裁就全面風險管理的有效性對董事會負 責,而董事會對本公司股東大會負責。執行總 裁能夠授權相關部門領導負責風險管理系統的 建立和日常運作。





- The risk management department of the Company is responsible for proposing risk management strategies, formulating rules and regulations on risk management, preparing annual risk management assessments and reports, guiding all departments and subsidiaries on relevant tasks, and conducting risk management trainings. It is also in charge of designing a comprehensive risk management evaluation system, and supervising the implementation of risk management measures.
- Each of functional departments and subsidiaries of the Company is in charge of the daily business operations and risk monitoring, and is responsible for the supervision of the respective fields of operations on a daily basis as well as the supervision and approval of any material business decisions of the city and project companies of the Group.

Internal Control

The internal control system of the Company is designed to provide reasonable and adequate assurance for effective and efficient operations, reliable financial reporting and compliance with applicable laws and regulations.

Our internal control system covers all major aspects of our operations. To effectively implement such processes, the Company has a set of comprehensive policies and guidelines which set out details regarding the internal control standards, segregation of responsibilities, approval procedures and personnel accountability in each aspect. The Company also carries out regular internal assessments and training to ensure our employees are equipped with sufficient knowledge on such policies and guidelines.

The risk management and internal control system of the Company are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board is responsible for the risk management and internal control systems and conducts annual review on its effectiveness. After review, the Board considers that the risk management and internal control systems of the Company are effective and adequate.

本公司的風險管理及內部監控系統旨在管理而非消除 未能達成業務目標的風險,而且只能就不會有重大的 失實陳述或損失作出合理而非絕對的保證。董事會對 本公司的風險管理及內部監控系統負責,並對其有效 性進行了年度審核。經檢討,董事會認為本公司的風 險管理和內部監控系統充分有效。



Anti-Corruption and Whistle-blowing Policy

Business Ethics

The Company is committed corruptions and creating a corruptionfree and transparent working atmosphere. The Group strictly complies with laws and regulations including the Anti-Money Laundering Law of the People's Republic of China, the Anti-Unfair Competition Law of the People's Republic of China and the Interim Regulations Concerning the Prohibition of Commercial Briberies. The Company has devised and implemented anti-corruption policies and systems including the Redsun Group's System of Declaration of Conflict of Interests (弘陽集團利益衝 突申報制度) and the List of Prohibited Acts and Behaviors of Corruption (員工禁止舞弊行為列示一覽表), which set out specific procedures for handling declarations of conflicts of interests. The Group has also organized various activities including seminars on anti-corruption laws and case studies to promote and raise staff awareness regarding anticorruption.

The Group sets up report channels to encourage employees and parties dealing with the Company to raise concerns about suspected misconduct, malpractice or irregularities in confidence. The Group has in place relevant policies and filing channels including Hong Yang's Rules for Administering Complaints and Whistle-blowing (弘陽投訴舉報管理辦法) and its official WeChat account for filing complaints and whistle-blowing, customer service hotline and mailboxes.

The Group will keep the identity of the whistle-blower confidential, and has policies in place to protect whistle-blowers from retaliation.

In terms of procedures for complaining and whistle blowing, whistleblower should first reflect to the management department with the corresponding function or to the risk control centre if the aforementioned reporting channel is not available. Reported cases will be thoroughly investigated and any acts of corruption or mismanagement verified will be duly handled according to the seriousness and the specific situation of the respective cases.

本集團將對舉報人的身份進行保密,並已制定政策以 保障舉報人免受打擊報復。

對於投訴舉報流程,舉報人應先向有對應職能的管理 部門進行反映或於上述舉報渠道不可用時向風控中心 舉報。所報個案將經徹底調查,而對於查實存在舞弊 或管理缺失的行為將根據相應個案的情節輕重及具體 情況進行嚴肅處理。





Information Disclosure

The Company discloses information in compliance with the Listing Rules and other applicable laws, and publishes periodic reports and announcements to the public in accordance with relevant laws and regulations. In particular, the Company has put in place a robust framework for the disclosure of inside information in compliance with the SFO. The framework sets out the procedures and internal controls for the handling and dissemination of inside information in a timely manner so as to allow all the stakeholders to apprehend the latest position of the Company. The framework and its effectiveness are subject to review by the Board on a regular basis.

Internal Audit

The Company has an internal audit function. The primary role of the internal audit function is to help the Board and the senior management of the Company to protect the assets, reputation and sustainability of the Company. The internal audit function provides independent and objective assurance as to whether the design and operational effectiveness of the Company's framework of risk management, control and governance processes, as designed and represented by the Company is independent of the risk management and internal control systems of the Company.

Results of audit work together with an assessment of the overall risk management and control framework are reported to the Audit Committee as appropriate. The internal audit function also reviews the Company's management's action plans in relation to audit findings and verifies the adequacy and effectiveness of the mitigating controls before formally closing the issue.

If the chairmen of the Board or each Board Committee fail to attend the meeting, then other members of each Board Committee will be invited to attend the annual general meeting and answer Shareholders' inquiries thereat. All resolutions proposed at general meetings will be voted by poll. The voting results will be posted on the websites of the Stock Exchange (www.hkexnews.hk) and the Company (www.rsunservice.hk) on the same day of the relevant general meetings.

Procedures for Shareholders to Convene an Extraordinary General Meeting

In accordance with article 64 of the articles of association of the Company, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at the general meetings of the Company shall at all times have the rights, by written requisition to the Board or the company secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. Key estimates involved • in the preparation of cash flow projections for the period covered by the approved financial budgets include the growth rates in revenue, estimated gross profit, estimated profit before tax and pre-tax • discount rates.

Provision for expected credit losses ("ECL") on trade receivables and amounts due from related companies

We identified the estimated provision of ECL of trade receivables and trade nature's amounts due from related companies as a key audit matter due to the significant management estimates involved in assessing the recoverability of trade receivables and amounts due from related companies.

我們將貿易應收款項及貿易性質的應收關聯公司款項的預期 信貸虧損之預計撥備確定為關鍵審核事項,乃由於評估貿易 應收款項及應收關聯公司款項可收回性涉及之重大管理層判 斷。

As disclosed in Note 4 to the consolidated financial statements, the management used provision matrix to calculate the ECL of trade receivables and amount due from related companies and the provision rates are based on groupings of various debtors by their aging, which are considered of similar loss patterns, and taken into consideration the historical default rates and the forward-looking information.

The carrying amount of amounts due from related companies is RMB391,412,000 as at 31 December 2024, after net off of impairment loss of RMB170,276,000, and allowance for credit losses of RMB59,411,000 was recognised in profit or loss for the year ended 31 December 2024.

1. GENERAL INFORMATION

Redsun Services Group Limited (the "Company") was incorporated and registered as an exempted company with limited liability in the Cayman Islands under the Cayman Islands Companies Law on 12 December 2019. The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 7 July 2020. The registered office of the Company is located at Walkers Corporate Limited, 190 Elgin Avenue, George Town, Grand Cayman, KY1–9008, Cayman Islands.

During the year, the Group was mainly involved in the provision of property management services, value-added services to nonproperty owners and community value-added services. Details of the principal activities of its principal subsidiaries are set out in Note 39.

In the opinion of the directors, the holding company of the Company is Redsun Services Group (Holdings) Limited, which is incorporated in the British Virgin Islands. The ultimate controlling party of the Company is Mr. Zeng Huansha.

The consolidated financial statements are presented in Renminbi ("RMB"), which is functional currency of the Company.

The consolidated financial statements have been prepared in accordance with IFRS Accounting Standards issued by the IASB, the disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on the Main Board of the Stock Exchange ("Listing Rules"). For the purpose of preparation of the consolidated financial statement, information is considered material if such information is reasonably expected to influence decisions made by primary users.

The consolidated financial statements have been prepared on historical cost basis. Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

The material accounting policies are set out below.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the noncontrolling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve; and recognises the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its financial assets at fair value through profit or loss at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

於財務報表中計量或披露公平值的所有資產及 負債,均根據對公平值計量整體而言屬重大的 最低級別輸入數據在下述公平值層級內進行分 類:

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets, deferred tax assets, financial assets, investment properties and non-current assets/a disposal group classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Other intangible assets (other than goodwill)

Other intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Software

Purchased software is stated at cost less any impairment loss and is amortised on the straight-line basis over its estimated useful life of 5 years.

其他無形資產(商譽除外)

單獨取得的其他無形資產於初始確認時按成本 計量。通過業務合併取得的無形資產的成本為 收購日期的公平值。無形資產的使用年期分為 有限期或無限期。有限期年期的無形資產隨後 按使用經濟年期攤銷,並於有跡象顯示無形資 產可能出現減值時評估減值。有限期使用年期 的無形資產的攤銷期及攤銷方法至少於每個財 政年度末檢討一次。

軟件

採購的軟件按成本減任何減值虧損列賬,並於5 年的估計使用年期內按直線法攤銷。

Customer relationship is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful life of 5–10 years.

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms.

本集團作為承租人

本集團對所有租賃(短期租賃及低價值資產租賃 除外)採取單一確認及計量方法。本集團確認租 賃負債以作出租賃款項,而使用權資產指使用 相關資產的權利。

(a) 使用權資產

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of lowvalue assets are recognised as an expense on a straightline basis over the lease term.

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

當本集團已轉讓其自資產收取現金流量的權利 或已訂立轉讓安排,其會評估有否保留所有權 的風險及回報,以及其程度。當本集團並無轉 讓或保留該資產的絕大部分風險及回報及並無 轉讓該資產的控制權,本集團以本集團持續滲 入程度為限繼續確認所轉讓資產。在此情況 下,本集團亦確認相關負債。經轉讓資產及相 關負債乃按反映本集團已保留的權利及責任為 基準計量。

持續滲入乃以被轉讓資產作出的一項保證的形 式出現,並以該項資產的原賬面值及本集團或 須償還的代價數額上限(以較低者為準)計算。

金融資產減值

本集團確認對並非按公平值計入損益的所有 債務工具預期信貸虧損(「預期信貸虧損」)的撥 備。預期信貸虧損乃基於根據合同到期的合同 現金流量與本集團預期收取的所有現金流量之 間的差額而釐定,並以原實際利率的近似值貼 現。預期現金流量將包括出售所持抵押的現金 流量或組成合同條款的其他信貸提升措施。

Impairment of financial assets (Continued) General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

預期信貸虧損分兩個階段進行確認。就自初步 確認起未有顯著增加的信貸風險而言,預期信 貸虧損提供予由未來十二個月內可能發生違約 事件而導致的信貸虧損(十二個月預期信貸損 失)。就自初步確認起經已顯著增加的信貸風險 而言,不論何時發生違約,於餘下風險年期內 的預期信貸虧損均須計提虧損撥備(存續期預期 信貸虧損)。

本集團在各報告日期評估相關金融工具的信用 風險自初始確認後是否已顯著增加。於作出評 估時,本集團將報告日期金融工具出現違約事 件之風險與初步確認日期金融工具出現違約事 件之風險進行比較,並會考慮合理且可證實的 資料(毋須過高成本或太多工序便可供查閱), 包括過往經驗及前瞻性資料。

當合同付款已逾期90天,本集團會將金融資產 視為違約。然而,在若干情況,在計及本集團 所持的任何信貸增強時前,當內部或外部資料 指出本集團不大可能悉數收回尚未償還合同金 額,則本集團亦可能將金融資產視為違約。

倘無法合理預期收回合同現金流量,則撇銷金 融資產。

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

- 第一階段 金融工具的信用風險自初始確認後 並未顯著增加,且虧損撥備以等同 於12個月預期信貸虧損的金額計量

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables and interest-bearing bank borrowings.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (trade and other payables, and interest-bearing bank borrowing)

After initial recognition, trade and other payables, and interestbearing bank borrowing are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on the estimated selling prices less any estimated costs to be incurred to completion and disposal.

存貨

存貨成本值及可變現淨值之較低者入賬。成本 以先進先出的原則確定。可變現淨值是基於估 計的售價減去完成和處置所需的任何估計成 本。

Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the Group expects some or all of a provision to be reimbursed, the reimbursement is recognised as a separate asset, but only when the reimbursement is virtually certain. The expense relating to a provision is presented in the statement of profit or loss net of any reimbursement.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

財務狀況表內的現金及現金等價物包括手頭及 銀行現金以及可隨時轉換為已知數額現金、價 值變動風險極低及一般於三個月內到期的短期 高流動性存款,乃為滿足短期現金承擔而持 有。

就綜合現金流量表而言,現金及現金等價物由 手頭及銀行現金以及上文界定的短期存款組 成,減須按要求償還及組成本集團現金管理重 要部分的銀行透支。

撥備

倘因過往事件須承擔現時責任(法定或推定), 而履行該責任可能導致未來資源外流,且該責 任所涉金額能夠可靠估計,則確認撥備。

當本集團預期部分或所有撥備將獲償付時,償 付金額將確認為獨立資產,惟僅在償付金額基 本確定的情況下方會確認。與撥備有關的開支 經扣除任何補償後於損益表呈列。

倘貼現影響重大,則確認撥備的金額為預期履 行責任所需未來開支於報告期末的現值。貼現 現值隨時間流逝而增加的金額,並計入損益中 的融資成本。

Income tax expense

Income tax expense comprises current and deferred tax. Income tax expense relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associates and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

客戶合同收益在貨品或服務轉移至客戶時按反 映本集團就交換該等貨品或服務而預期有權收 取的代價金額確認。

當合同代價包含可變金額,代價估計為本集團 轉讓貨品或服務予客戶時將有權換取的金額。 可變代價於合同訂立時作估計並受限制,直至 已確認的累計收益金額不大可能出現重大收益 撥回,當時可變代價的相關不確定性隨即獲解 決。

當合同包含融資組成部分,其向客戶提供重大 利益,為轉移貨物或服務予該客戶融資超過一 年,則收益按應收款項金額的現值計量,並以 於合同訂立時本集團與該客戶之間的單獨融資 交易反映的折現率折現。當合同包含融資組成 部分,其向本集團提供重大財務利益超過一 年,則合同下確認的收益包括實際利率法下 合同負債的利息支出。對於客戶付款與轉移承 諾貨物或服務之間的時間差距為一年或以下的 合同,使用國際財務報告準則第15號的權宜方 法,即交易價格不就重大融資組成部分的影響 作出調整。

(a) Property management services

The Group charged property management fees in respect of the property management services on a monthly basis and a lump sum basis.

On a monthly basis, the Group bills a fixed amount for services provided on a monthly basis and recognises as revenue in the amount to which the Group has right to invoice and that corresponds directly with the value of performance completed.

On a lump sum basis, the Group is entitled to retain the full amount of the received property management fees. From the property management fees, the Group shall bear expenses associated with, among others, staff, cleaning, garbage disposal, gardening and landscaping, security and general overheads covering the common areas. During the term of the contract, if the amount of the property management fees the Group collected is not sufficient to cover all the expenses incurred, the Group is not entitled to request the property owners to pay the shortfall.

Accordingly, on a lump sum basis, the Group recognises the full amount of the property management fees the Group charged to the property owners and property developers as revenue.

These services are performed by an indeterminate number of acts over a specified period of time. Accordingly, revenue is recognised on a straight-line basis over the specified period unless there is evidence that some other methods better represent the stage of completion, and the costs of services are recognised as incurred in connection with performing such services.

- (a) 物業管理服務
 - 本集團按月制及按包幹制收取物業管理 服務的物業管理費。

於按月制下,本集團本每月就提供的服 務開出固定金額賬單,並將本集團有權 開立發票且與已完成的履約價值直接匹 配的金額確認為收益。

包幹制下,本集團有權保留所收取的全 額物業管理費。就物業管理費而言,本 集團須承擔有關(其中包括)員工、清潔、 垃圾處置、園藝及園林綠化、安保及涵 蓋公用區的一般開銷成本的開支。於合 同期內,倘本集團所收取的物業管理費 金額不足以支付所有產生的開支,本集 團無權要求業主支付不足金額。

因此,於包幹制下,本集團將收益確認 為本集團向業主及房地產開發商收取的 物業管理費全額。

該等服務是由在具體時期不確定次數的 行動所履行。因此,收益按直線法於具 體時期確認,除非有證據證明其他方法 可更佳表示完成階段,而服務成本於履 行相關服務發生時確認。

b) Value-added services to non-property owners

Value-added services to non-property owners mainly include sales assistance services, pre-delivery and consulting services. The term of the contracts for sales assistance is generally set to expire when the counterparties notify the Group that the services are no longer required. Pre-delivery and consulting services are rendered in a short period of time and there were no unsatisfied performance obligations at the end of the respective periods.

(c) Community value-added services

The services are rendered in a short period of time and there were no unsatisfied performance obligations at the end of the respective periods.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Contract assets

If the Group performs by transferring goods or services to a customer before being unconditionally entitled to the consideration under the contract terms, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets. They are reclassified to trade receivables when the right to the consideration becomes unconditional.

- (b) 非業主增值服務
 - 為非業主提供的增值服務主要包括銷售 協助服務、預先交付及諮詢服務。當交 易對方通知本集團不再需要服務時,銷 售協助合同的期限通常定為到期。交付 前及諮詢服務是在很短的時間內提供, 並且在相應期間結束時沒有未履行的履 約義務。

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Contract costs

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify;
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future; and
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to the profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

Other employee benefits

Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees in Hong Kong who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiary which operates in Chinese Mainland are required to participate in a central pension scheme operated by the local municipal government. This subsidiary is required to contribute a certain portion of its payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements. Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a nonmonetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or nonmonetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas subsidiaries, joint ventures and associates are currencies other than the RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Estimated impairment of goodwill and intangible assets

Determining whether goodwill and intangible assets were impaired requires an estimation of the recoverable amount of the cash generating unit (or group of cash-generating units) to which goodwill and intangible assets have been allocated, which is the higher of the value in use or fair value less costs of disposal. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit (or a group of cash-generating units) and a suitable discount rate in order to calculate the present value. Key estimates involved in the preparation of cash flow projections for the period covered by the approved financial budgets include the growth rates in revenue, estimated gross profit, estimated profit before tax and pre-tax discount rates. Where the actual future cash flows are less than expected, or change in facts and circumstances which results in downward revision of future cash flows or upward revision of pre-tax discount rates, a material impairment loss or further impairment loss may arise.

As at 31 December 2024, the carrying amount of goodwill and intangible assets are RMB175,050,000 and RMB57,725,000 respectively (2023: RMB175,050,000 and RMB73,546,000). Details of the recoverable amount calculation are disclosed in Note 16 and 17.

商譽及無形資產估計減值

釐定商譽及無形資產有否減值時須估計已獲分 配商譽及無形資產的現金產生單位(或現金產生 單位組別)的可收回金額(為使用價值則公平值 減出售成本的較高者)。使用價值計算要求本 集團估計現金產生單位(或現金產生單位組別) 預期產生的未來現金流量,以及計算現值所須 的合適的貼現率。編製核准財務預算涵蓋期間 現金流量預測所涉及的主要估計包括收益增長 率、估計毛利、除税前估計溢利及除税前貼現 率。倘實際未來現金流量低於預期,又或事實 稅前貼現率,則可能產生重大減值虧損或更多 減值虧損。

Provision for expected credit losses on trade receivables and amounts due from related companies

The Group uses a provision matrix to calculate ECLs for trade receivables and trade nature's amount due from related companies. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by geography, service type, customer type and rating, and coverage by letters of credit and other forms of credit insurance).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the property management sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables and amounts due from related companies is disclosed in Note 19 and 33 to the consolidated financial statements.

撥備矩陣初始根據本集團過往觀察的違約率計 算。本集團將通過調整矩陣以調整過往信貸虧 損經驗及前瞻性資料。例如,若預測經濟狀況 (即國內生產總值)於未來一年內惡化,從而導 致物業管理行業的違約數量增加,過往違約率 將予調整。於各報告日期,過往觀察的違約率 將予以更新,並分析前瞻性估計的變化。

對過往觀察的違約率、預測經濟狀況及預期信 貸虧損之間的相關性評估乃一項重要的估計。 預期信貸虧損的金額對環境及預測經濟狀況敏 感。本集團的過往信貸虧損經驗及對經濟狀況 的預測亦可能無法代表客戶於日後的實際違約 情況。有關本集團貿易應收款項及應收關聯公 司款項的預期信貸虧損資料於綜合財務報表附 註19及33披露。

The values assigned to the key assumptions on the annual revenue growth rates of Chuzhou Yurun, Huidehang and pre-tax discount rates are consistent with external information sources.

(a) Share premium

The share premium represents the difference between the par value of the shares issued and the consideration received.

(b) Statutory surplus reserve

In accordance with the PRC Company Law and the articles of association of the subsidiaries established in the PRC, the Group is required to appropriate 10% of its net profits after tax, as determined under the Chinese Accounting Standards, to the statutory surplus reserve until the reserve balance reaches 50% of its registered capital. Subject to certain restrictions set out in the relevant PRC regulations and in the articles of association of the Group, the statutory surplus reserve may be used either to offset losses, or to be converted to increase share capital, provided that the balance after such conversion is not less than 25% of the registered capital of the Group. The reserve cannot be used for purposes other than those for which they are created and are not distributable as cash dividends.

(c) Merger reserve

The merger reserve of the Group represents the issued capital of the holding company of the companies now comprising the Group and the capital contributions from the equity holders of certain subsidiaries now comprising the Group before the completion of the reorganisation.

The main purpose of these financial instruments is to raise finance for the Group's operations.

The main risks arising from the Group's financial instruments are foreign currency risk, interest rate risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Foreign currency risk

The Group has transactional currency exposures. Such exposures arise from sales or purchases by operating units in currencies other than the units' functional currencies. None of the Group's sales (2023: Nil) were denominated in currencies other than the functional currencies of the operating units making the sale, whilst 100% (2023: 100%) of costs were denominated in the units' functional currencies.

In addition, the Group has currency exposures from its cash and bank balances.

The Group is exposed to fair value interest rate risk in relation to interest-bearing bank borrowing (note 25) which is carried at fixed rate.

The Group is also exposed to cash flow interest rate risk in relation to variable rate bank balances (note 21). The Group currently does not have an interest rate hedging policy. Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group is not subject to any externally imposed capital requirements. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2024 and 31 December 2023.

The Group monitors capital using a gearing ratio, which is net debt divided by the adjusted capital plus net debt. Net debt represents trade payables, other payables and accruals, less cash and cash equivalents. The Group did not have net debt as at 31 December 2024 and 2023. Capital represents total equity.

37. EVENTS AFTER THE REPORTING PERIOD

On 17 February 2025, the Company entered into parking spaces transfer framework agreement to acquire the parking spaces at a total consideration of approximately RMB230.92 million. On the same day, a indirect wholly-owned subsidiary of the Company entered into equity transfer agreements to acquire equity interest of a subsidiary, an associate and a joint venture. Details are set out in the Company's announcement on 17 February 2025.
