The AGM will be held at Floor 2, Block 1, No. 66 Sibo Road, Songjiang District, Shanghai, the People’s Republic of China on Monday, 23 June 2025 at 10:00 a.m.. The AGM will be a hybrid meeting. In addition to the traditional physical attendance, shareholders have the option of attending, participating and voting at the AGM through online access (the “Online Platform”). Please refer to the “Notice of Annual General Meeting” for the details of the AGM arrangements.

As a non-registered holder, if you wish to attend and participate in the AGM using the Online Platform, please liaise with your bank(s), securities broker(s), custodian(s), nominee(s) or HKSCC Nominees Limited through which your shares are held (collectively, the “Intermediaries”) and provide your email address to your Intermediaries. Details regarding the arrangements of the AGM, including the login details to access the Online Platform and online voting, will be sent by the Company’s Hong Kong Share Registrar to the email address provided by the non-registered holder.
