CHAIRMAN'S STATEMENT 主席報告



Dear Shareholders,

For and on behalf of the board (the "**Board**") of directors (the "**Directors**") of Best Mart 360 Holdings Limited (the "**Company**", together with its subsidiaries, the "**Group**"), I am pleased to present the Group's results for the year ended 31 December 2024 (the "**Financial Year under Review**") to the shareholders of the Company (the "**Shareholders**").

本人謹代表優品360控股有限公司(「本公司」, 連同其附屬公司統稱「本集團」)董事(「董事」)會 (「董事會」)向本公司股東(「股東」)欣然提呈本集 團截至二零二四年十二月三十一日止年度(「回顧 財政年度」)的業績。

During the Financial Year under Review, global interest rates have been on the rise. Coupled with the impact of external negative factors such as the tightening of monetary policy and the Russia-Ukraine conflict, the pace of economic recovery in various regions has been hampered. In the face of the unpredictable business environment, the management of the Group actively adjusted its product portfolio and sales strategy according to market conditions, our revenue, gross profit and net profit for the Financial Year under Review have achieved moderate growth on a year-on-year basis. Upholding the principle of global procurement, we continue to search for a diverse range of products from all over the world and have been stringently selecting product suppliers to ensure strict control over product quality while further enriching our product categories, controlling costs more effectively, and providing products of "Best Quality" and "Best Price" to customers.

Looking ahead, the Hong Kong retail market is expected to remain challenging. The Hong Kong government actively launches various measures in the hope of attracting tourists from all over the world. In the future, the management will remain cautiously optimistic in promoting its business, injecting new impetus into the Group for its future growth, as well as working hard to address market uncertainties. The Group will continue to work closely with our colleagues, suppliers, customers, business partners and shareholders to jointly lead the Group to new heights and strive to become a better brand. Our management will also adhere to our business principle and strive to provide customers with a comfortable and superior shopping experience, meeting the diverse needs of consumers and market trends by global sourcing. 於回顧財政年度,全球利率持續走高。加上緊 縮貨幣政策、俄烏戰事等外圍負面因素影響, 各地經濟復蘇乏力。面對變幻莫測的營商環 境,本集團管理層因應市場情況,積極調整產 品組合和銷售策略,我們回顧財政年度收入、 毛利及淨利潤均同比取得溫和增長。秉持環球 採購的理念,我們持續搜羅世界各地多元化產 品,同時精選產品供應商,務求嚴格監控產品 品質,並進一步豐富產品種類,更有效控制成 本,為顧客提供[優質]和[優價]的產品。

展望未來,香港零售市場預計仍然充滿挑戰。 隨著港府積極推行各種措施,希望可以吸引各 地遊客訪港。未來,管理層將會以審慎樂觀 的態度開展業務,為本集團未來增長注入新 動力,以努力應對市場不明朗的因素。本集團 繼續與同事、供應商、顧客、業務夥伴及股東 緊密合作,攜手推動集團邁向更高峰,成為更 優質的品牌。管理層亦會始終堅持經營宗旨, 透過環球採購,致力為顧客提供舒適及優越的 購物體驗,滿足多樣化的消費者需求及市場 趨勢。

In addition, to elevate the Group's profitability, the management will strive to refine our operational efficiency and further strengthen our cost control measures. We endeavor to keep abreast of the times and make continuous improvements, leveraging our solid business foundation to maintain our leading position and competitiveness in the Hong Kong leisure food retail market, thereby ensuring stable and sustainable returns for our shareholders. The Board has recommended the payment of a dividend of HK10.0 cents per share for the year ended 31 December 2024.

On behalf of the Board, I would like to express my appreciation to the Group's management team and employees for their efforts in contributing to the development of the Group. CHIEF EXECUTIVE OFFICER'S STATEMENT 行政總裁報告



Dear Shareholders,

During the year ended 31 December 2024, the government of Mainland China implemented various measures benefiting Hong Kong, coupled with efforts by the Hong Kong government to uplift the local market atmosphere, driving the number of visitors to Hong Kong to increase continuously. However, affected by the changes of consumption patterns, along with the rising number of Hong Kong citizens spending their long holidays abroad and the rising trend of traveling to Mainland China for consumption, the local retail sector remains weak. During this period, the Group actively responded to changes in the market, including optimizing our retail shop distribution and enhancing our product mix to align with different consumer needs, resulting in growth for both sales and profits of the Group, even amidst an overall retail market downturn.

各位股東:

截至二零二四年十二月三十一日止年度,內地 政府推出多項惠港措施,以及港府提振本地市 場氣氛,帶動訪港旅客人數持續上升。然而, 受消費模式轉變,加上港人長假期外遊數字持 續上升和北上消費熱潮有增無減,讓本地零售 業持續疲弱。在這段時期,本集團積極地應對 市場變化,包括優化零售店舖分佈和加強產品 組合等,以滿足消費者不同需求,令本集團於 整體零售市場低迷的情況下仍然錄得銷售及盈 利增長。 During the Financial Year under Review, the Group recorded a revenue of approximately HK\$2,805,146,000, representing an increase of approximately 8.2% as compared with the unaudited revenue of the same twelve-month period in 2023. During the Financial Year under Review, the profit attributable to owners of the Company was approximately HK\$247,522,000, representing an increase of approximately 5.3% as compared with the unaudited profit attributable to owners of the Company of the same twelve-month period in 2023. Thanks to the hard work of the Group's management and all employees, the Group has remained vigilant in the face of different operating situations and has been able to respond appropriately to the unpredictable market environment.

GENERAL DESCRIPTION

During the Financial Year under Review, the total number of the Group's retail stores increased from 167 stores as at 31 December 2023 to 176 stores. During the year, the Group's global gourmet brand "FoodVille" added 1 new store in Hong Kong, focusing on mid-to-high-end global quality food. Despite the uncertainties in the external economic environment, the Group maintained a steady pace in opening new retail stores, by actively seeking locations with reasonable rents, high customer traffic and geographical advantages for the expansion of our branches. During the Financial Year under Review, the Group strived to optimize our product mix, sourcing more "Best Quality" and "Best Price" as well as widely popular products from around the world, meeting the daily needs of local residents while also introducing distinctive products to inbound visitors.

The Group is committed to building stable cooperative relationships with global suppliers and persistently seeks new suppliers to enrich its product categories and portfolio. The Group further developed its private label products during the Financial Year under Review, bringing a more diverse selection to customers. The private label products are conducive to improving the Group's overall profitability and exclusive brand image as well as strengthening customer loyalty. The related sales increased significantly by approximately 18.1% as compared with the same twelve-month period in 2023, and the proportion of revenue further increased to approximately 17.0%.

於回顧財政年度,本集團錄得收入約 2,805,146,000港元,較二零二三年十二個月同 期未經審核收入增長約8.2%;於回顧財政年 度,本公司擁有人應佔溢利約為247,522,000港 元,較二零二三年十二個月同期未經審核本公 司擁有人應佔溢利增長約5.3%。全賴本集團管 理層與全體員工的努力付出,面對不同經營情 況仍然謹守崗位,並能妥善地應對變幻莫測的 市場環境。

概況

於回顧財政年度,本集團零售店舖總數由二零 二三年十二月三十一日的167間增加至176間。 年內,本集團旗下環球美酒食品品牌[FoodVille] 於本地新增1間分店,主打中高端的環球優質食 品。儘管外圍經濟環境未見明朗,本集團繼續 維持穩健速度新增零售店舖,積極物色相宜合 理的租金、顧客流量較大,以及地理環境優越 的位置拓展分店。本集團於回顧財政年度亦致 力優化產品結構,並積極地在世界各地搜羅更 多[優質]和[優價]及廣受歡迎的產品,既滿足本 地居民日常生活所需,同時為入境旅客帶來具 有特色的商品。

本集團一直致力與全球供應商建立穩定的合作 關係,並持續尋找新的供應商,以豐富產品種 類及產品組合。於回顧財政年度,本集團進一 步開發自家品牌產品,為顧客帶來更多元化的 銷售。自家品牌有利於本集團提升整體利潤率 以至品牌專屬形象,加強顧客忠誠度,相關的 銷售額較二零二三年十二個月同期顯著增加約 18.1%,收入佔比亦進一步提升至約17.0%。 During the Financial Year under Review, the Group actively expanded its Business-to-Business (B2B) operations so as to broaden the Group's revenue streams through diversified businesses. Concurrently, the Group capitalized on the strengths of its existing team to fully harness the synergies and attract more potential customers for the Group.

PROSPECTS

Looking ahead, the global economic environment is filled with uncertainties, and the business environment for the local retail sector remains full of challenges. The management of the Group will pay close attention to the uncertain factors affecting business operations and promptly adjust business strategies according to the actual market conditions. At the same time, the procurement team will uphold the principles of "Best Quality" and "Best Price", adjusting the product portfolio according to market demands to further enhance the market competitiveness of the Group and promote the development of business diversification.

The Group will strive to maintain its competitive advantage in prices through global procurement strategy, offering a diverse range of product choices to the market, and continuously optimize its product mix to fulfil the demands and expectations of local and overseas customers for a variety of products. Moreover, the Group will continue its endeavors in developing its private label products to provide customers with more diversified choices to further boost the sales of the Group. 於回顧財政年度,本集團積極加強拓展企業對 企業(Business-to-Business,B2B)之業務,透過 多元化業務拓展本集團收入來源。同時本集團 妥善利用既有團隊,充份發揮協同效應,為本 集團帶來更多潛在客戶群。

前景

展望未來,全球經濟環境充斥不明朗因素,本 地零售業的營商環境仍然面臨諸多挑戰。本集 團管理層將持續關注各項影響業務營運的不穩 定因素,並因應市場實際情況及時調整業務策 略。同時,採購團隊將堅守「優質」和「優價」的理 念,按市場需求調整產品組合,以進一步強化 本集團市場競爭力,推動多元化業務的發展。

通過環球採購策略,本集團將盡力保持價格競 爭優勢,為市場提供多樣化產品選擇,亦持續 優化產品結構,以滿足本地及海外顧客對各式 各樣產品的需求及期望。此外,本集團將繼續 致力研發自家品牌產品,為顧客提供更豐富的 選擇,進一步提升本集團銷售額。

Retail Network 零售網絡

The Group continues to adopt a dual-brand strategy, consistently seeking suitable opportunities to expand the store network of its key retail brand, "Best Mart 360°" and global gourmet store, "FoodVille". As of 31 December 2024, the Group operated a total of 176 chain retail stores, strategically located in areas with heavy pedestrian flow in Hong Kong and Macau. These locations meet the demands of different customer segments for quality food products. The "Best Mart 360°" brand focuses on serving residential areas and expanding its store network coverage, while "FoodVille" targets large and medium-to-high-end shopping malls in Hong Kong as well as stores with larger area and locations with higher customer traffic and stronger consumer spending power. With the continuous expansion of store networks, the Group's turnover is growing steadily.

集團持續實行雙品牌策略,不斷尋找適當機會拓展旗下主要零售品牌 「優品360°」以及環球美酒食品店「FoodVille」,於2024年12月31日, 集團合共開設了176間零售店舖,遍佈香港及澳門流暢旺的戰略位置,以 滿足不同顧客群對優質食品的需求。其中「優品360°」零售品牌將繼續 主力於民生住宅區開展業務,擴充店舖區域分佈網絡。至於「Food-Ville」則取向於以香港大型中高端購物商場、面積較大、人口流量較大以 及消費力較強的店舖為目標。隨著店舖據點不斷擴展,集團的營業額亦隱 步向上。

The Group is a leisure food retailer operating chain retail stores under the brands "Best Mart 360°" and "FoodVille" in Hong Kong and Macau. The Group offers a wide selection of imported prepackaged leisure foods and other grocery products principally from overseas, which can be broadly categorised into (i) chocolates and confectioneries; (ii) nuts and dried fruits; (iii) packaged bakery products and snacks; (iv) biscuits and pastries; (v) cereals and milk; (vi) beverages and wine; (vii) rice, noodles and groceries; (viii) frozen and chilled food; and (ix) other products, such as personal care products, daily items and anti-epidemic products. It is the Group's business objective to offer "Best Quality" and "Best Price" products to customers through continuous efforts on global procurement, with a mission to provide comfortable shopping environment and pleasurable shopping experience to customers.

As disclosed in the announcement of the Company dated 5 September 2023, the Board resolved to change the financial year end date of the Company from 31 March to 31 December. Accordingly, the current audited consolidated financial statements of the Company covered a period of twelve months from 1 January 2024 to 31 December 2024 whereas the audited comparative figures covered a period of nine months from 1 April 2023 to 31 December 2023. Due to the difference in the length of the reporting periods, the audited comparative figures may not be fully comparable.

BUSINESS REVIEW

For the Financial Year under Review, the Mainland Chinese government introduced a series of economic support measures, including the reinstatement of the "Multiple-Entry Permit" policy, benefiting Hong Kong. Concurrently, the Hong Kong government strove to promote the development of mega events, which boost foot traffic in Hong Kong. However, with challenges such as highinterest rates and geopolitical tensions prevailing, economies across various regions were still in a counter-cyclical phase. Additionally, the rising trend of outbound travel among Hong Kong residents during long holidays, coupled with their enthusiasm in spending in Mainland China, and the evolving consumption patterns of inbound tourists, collectively contributed to weak domestic consumption and a sluggish recovery in the retail sector. 本集團為一間連鎖休閒食品零售商,於香港及 澳門經營「優品360°]及「FoodVille」品牌零售店 舖。本集團提供廣泛系列主要來自海外的進口 預先包裝休閒食品及其他雜貨產品,其可大致 分為:(i)朱古力及糖果;(ii)果仁及乾果;(iii)包 裝烘焙產品及零食;(iv)餅乾及糕點;(v)穀類食 品及牛奶;(vi)飲品及酒類;(vii)米、麵食及糧油 雜貨;(viii)冷凍及急凍食物;及(ix)其他產品例如 個人護理產品、生活用品及防疫產品等。本集 團的經營宗旨是通過環球採購不斷努力,為顧 客提供「優質」和「優價」的產品,以向顧客提供舒 適的購物環境和愉快的購物體驗為使命。

誠如本公司日期為二零二三年九月五日的公告 所披露,董事會決議將本公司的財政年度結算 日由三月三十一日變更為十二月三十一日。因 此,本公司當前經審核綜合財務報表涵蓋二零 二四年一月一日起至二零二四年十二月三十一 日止十二個月期間,而經審核比較數字涵蓋二 零二三年四月一日起至二零二三年十二月三十 一日止九個月期間。因報告期間長度不同,該 經審核比較數字未必完全具有可比性。

業務回顧

於回顧財政年度,內地政府推出一系列提振經 濟政策,其中包括恢復實施「一簽多行」的惠港 措施,加上香港政府大力推動盛事發展,帶動 本地市面人流增長。然而,在高息環境、地緣 政治局勢等陰霾籠罩下,各地經濟仍然處於 逆周期狀態,加上港人長假期外遊數字持續攀 升,並熱衷於北上消費,同時訪港旅客消費模 式轉變,導致本港內部消費仍然表現疲弱,零 售行業復甦乏力。 According to the statistics from the Census and Statistics Department, the provisional estimate for the value of retail sales for the year 2024 decreased by approximately 7.3% as compared to that for the year 2023, while the provisional estimate for total retail sales volume decreased by approximately 9.0%. Meanwhile, according to a spokesperson from the Hong Kong Tourism Board, the provisional visitor arrivals for the year 2024 reached nearly 45 million, representing an increase of approximately 31% as compared with 2023. In December 2024 alone, visitor arrivals totaled 4.26 million, representing a year-on-year increase of approximately 8%.

In response to the challenging business environment, the Group adopted various strategies to navigate these difficulties. These included optimizing product mix and enhancing the offering of basic foodstuffs such as cereals, noodles, canned food, milk, chilled and frozen food, daily necessities as well as basic groceries. Furthermore, the Group also introduced trending brands from Mainland China as well as imported a wide range of specialty food from around the world to satisfy the needs of local consumers and to attract overseas tourists, contributing to the Group's sales growth despite the weak overall retail market during the Financial Year under Review.

For the year ended 31 December 2024, the Group recorded revenue of approximately HK\$2,805,146,000, compared to the unaudited revenue of approximately HK\$2,592,129,000 for the year ended 31 December 2023, representing an increase of approximately 8.2%. The sales from walk-in customers at retail stores in Hong Kong, Macau, and Mainland China accounted for approximately 97.7% of the Group's revenue for the Financial Year under Review, while bulk purchases by customers such as peer firms and trading companies accounted for approximately 2.3% of the Group's revenue for the Financial Year under Review.

The Group's gross profit for the year ended 31 December 2024 was approximately HK\$1,027,997,000, compared to the unaudited gross profit of approximately HK\$929,812,000 for the year ended 31 December 2023. For the Financial Year under Review, the Group's gross profit margin was approximately 36.6%, representing an increase of approximately 0.7 percentage points compared with approximately 35.9% for the unaudited gross profit margin for the year ended 31 December 2023.

面對充滿挑戰的營商環境,本集團因時制宜, 採取不同策略帶領業務走出困局,包括優化產 品結構,除了豐富穀類、麵食、罐頭食品、牛 奶、冰鮮及急凍食物等基本食品、生活必需品 和基本雜貨產品的供應,本集團亦引入多個大 熱國內品牌,同時更進口各類環球特色食品, 以滿足本地消費者的需求,並吸引海外旅客消 費,帶動本集團於回顧財政年度在整體零售市 場疲弱情況下,仍錄得銷售增長。

截至二零二四年十二月三十一日止年度,本集 團錄得收入約2,805,146,000港元,較截至二零 二三年十二月三十一日止年度未經審核的收入 約2,592,129,000港元增加約8.2%。當中來自香 港及澳門及內地零售店舖的公眾街客銷售額佔 本集團於回顧財政年度的收入約97.7%,而大 批量購貨的顧客,如業內的企業顧客及貿易公 司等,其大批量購貨額佔本集團於回顧財政年 度的收入約2.3%。

本集團截至二零二四年十二月三十一日止年度 的毛利約為1,027,997,000港元,截至二零二三 年十二月三十一日止年度未經審核的毛利則約 為929,812,000港元。於回顧財政年度,本集團 毛利率約為36.6%,較截至二零二三年十二月 三十一日止年度未經審核的毛利率約35.9%增 加約0.7個百分點。 Profit attributable to owners of the Company for the year ended 31 December 2024 was approximately HK\$247,522,000 (year ended 31 December 2023: approximately HK\$234,959,000 (unaudited)), a 5.3% year-on-year increment. The increase in profit attributable to owners of the Company was primarily driven by the Group's stable stores expansion strategy.

Chain Retail Stores

As at 31 December 2024, the Group operated a total of 176 chain retail stores, including 170 chain retail stores (31 December 2023: 159 stores) in Hong Kong and 6 chain retail stores (31 December 2023: 7 stores) in Macau respectively. During the Financial Year under Review, the Group closed all its chain retail stores in the Mainland China taking into account the fierce competition in the retail sector of physical food stores in the Mainland China as well as the operating data of these stores. During the Financial Year under Review, the Group opened 15 new retail stores and closed 6 stores upon expiration of their respective lease terms in alignment with the Group's expansion strategy adjustment.

As at 31 December 2024, the Group operated 170 retail stores in Hong Kong, comprising 31 retail stores located on Hong Kong Island, 55 retail stores in Kowloon and 84 retail stores in the New Territories. Among these, 55 retail stores are street-level stores, 114 retail stores are situated in shopping arcades within community or residential districts, and 1 retail stores is situated at a traffic hub easily accessible to tourists, covering all 18 districts of Hong Kong. Rental expense (cash basis) for retail stores was approximately HK\$269,493,000 for the year ended 31 December 2024, as compared with that of approximately HK\$241,986,000 for the year ended 31 December 2023 (unaudited), representing an increase of approximately 11.4%.

The ratio of rental expense (cash basis) to sales revenue of retail stores for the year ended 31 December 2024 was approximately 9.6%, which was higher than that of approximately 9.3% for the year ended 31 December 2023 (unaudited).

截至二零二四年十二月三十一日止年度的本 公司擁有人應佔溢利約為247,522,000港元 (截至二零二三年十二月三十一日止年度: 約234,959,000港元(未經審核)),按年增長 5.3%。本公司擁有人應佔溢利增長,主要受益 於本集團穩定的店舖擴張策略。

連鎖零售店舖

於二零二四年十二月三十一日,本集團合共經 營176間連鎖零售店舖,包括於香港經營170間 連鎖零售店舖(於二零二三年十二月三十一日: 159間)及於澳門經營6間連鎖零售店舖(於二零 二三年十二月三十一日:7間)。於回顧財政年 度,考慮內地食品實體店零售業競爭激烈,以 及該等門店的經營數據,本集團關停了所有內 地經營的連鎖零售店舖。於回顧財政年度,本 集團新開設了15間零售店舖,並因本集團的策 略調整,在相關店舖租期屆滿時關閉了6間店 舖。

於二零二四年十二月三十一日,本集團在香港 經營170間零售店舖中,31間位於香港島、55間 位於九龍及84間位於新界:當中包括55間為街 舖、114間位於社區或住宅區購物商場及1間位 於旅客可輕易到達的交通樞紐,遍佈全港十八 區。截至二零二四年十二月三十一日止年度零 售店舖的租金開支(現金基準)約為269,493,000 港元,較截至二零二三年十二月三十一日止 年度約241,986,000港元(未經審核)增加約 11.4%。

截至二零二四年十二月三十一日止年度的零售 店舗租金開支(現金基準)對銷售收入比率約為 9.6%,高於截至二零二三年十二月三十一日止 年度的約9.3%(未經審核)。

Employees

Employees are crucial to the sustainable development of the Group's business, and in particular, front-line staff constitute the majority of the labour force of the Group's retail business. Although the business environment remained challenging during the Financial Year under Review, the Group maintained a steady pace of expansion. As at 31 December 2024, the total number of employees of the Group was 1,230, which, excluding Directors, comprised 1.005 full-time employees and 225 part-time employees. while the total number of employees of the Group as at 31 December 2023 was 1,322, which, excluding Directors, comprised 863 full-time employees and 459 part-time employees. In order to retain talented and skilled labour force and to appropriately incentivise the Group's employees so as to increase cohesion and loyalty amongst them, the Group regularly reviews and refreshes the employee benefit scheme and remuneration packages with reference to the supply of the labour market, the trend of labour costs and the individual performance of the employees. The staff costs (excluding the Directors' emoluments) for the year ended 31 December 2024 amounted to approximately HK\$277,888,000 (for the year ended 31 December 2023: approximately HK\$236,230,000 (unaudited)). The staff costs (excluding the Directors' emoluments) for the year ended 31 December 2024 represented approximately 9.9% of the revenue of the Group for the Financial Year under Review, while the unaudited staff costs (excluding the Directors' emoluments) for the year ended 31 December 2023 represented approximately 9.1% of the revenue of the Group for the same period. Amongst which, the staff costs of frontline and warehouse staff (including basic salary, commission and other benefits) represented approximately 7.8% and 7.0% of the revenue of the Group for the Financial Year under Review and the year ended 31 December 2023, respectively.

僱員

僱員是本集團業務可持續發展的重要一環,尤 其前線員工是本集團零售業務勞動力的重要組 成部分。雖然於回顧財政年度營商環境仍然充 滿挑戰,本集團維持穩健的拓張步伐。於二零 二四年十二月三十一日,本集團僱員數目合 共1,230名(不計董事,包括1,005名全職及225 名兼職僱員),於二零二三年十二月三十一日 的本集團僱員數目合共1.322名(不計董事,包 括863名全職及459名兼職僱員)。為了挽留才 藝兼備的勞動力,以及給予本集團僱員適當獎 勵以加強僱員凝聚力及忠誠度,本集團參考勞 工市場供應及勞工成本趨勢,並依據僱員個人 表現,定期檢討並更新僱員福利計劃及薪酬待 遇。截至二零二四年十二月三十一日止年度的 員工成本(不包括董事酬金)約為277,888,000港 元(截至二零二三年十二月三十一日止年度:約 236,230,000港元(未經審核))。截至二零二四年 十二月三十一日止年度的員工成本(不包括董事 酬金)佔本集團於回顧財政年度的收入約9.9%, 而截至二零二三年十二月三十一日止年度的未 經審核員工成本(不包括董事酬金)則佔本集團於 同期間的收入約9.1%,當中前線及倉庫員工的 員工成本(包括基本薪金、佣金及其他福利)佔本 集團於回顧財政年度及截至二零二三年十二月 三十一日止年度的收入分別約7.8%及7.0%。

Products

During the Financial Year under Review, the Group continued its global procurement policy and mission by sourcing a broad spectrum of products worldwide that meet and satisfy market trend and demand. To better cater to the daily needs of the local community, the Group further strengthened the supply of basic foodstuffs such as cereals, noodles, canned food, milk, chilled and frozen food, daily necessities and basic grocery products. In addition, the Group continued to strengthen its private label sales in retail stores, including nuts and dried fruits, organic grains, wet tissues, canned food, biscuits and snacks, etc., providing consumers with more diversified choices.

For the year ended 31 December 2024, the Group offers a total of 3,653 stock keeping units ("**SKU**") of products (for the year ended 31 December 2023: 3,945 SKU) from suppliers principally from China and overseas markets as well as brand owners or importers in Hong Kong. For the year ended 31 December 2024, approximately 54.9% of the products were purchased from suppliers and brand owners or importers in Hong Kong (for the year ended 31 December 2023: approximately 54.4%), while imports from Japan, China and Europe accounted for approximately 11.7%, 9.8% and 6.3% of the total purchases respectively (for the year ended 31 December 2023: approximately 13.0%, 6.0% and 8.3% respectively).

As at 31 December 2024, the total amount of inventories of the Group amounted to approximately HK\$339,513,000 (31 December 2023: approximately HK\$276,691,000), a 22.7% year-on-year increment. The increase in the Group's total amount of inventories was mainly due to an increase in the number of retail stores and preparation for increased demand during the peak sales season around the Lunar New Year.

產品

於回顧財政年度,本集團繼續奉行其環球採購 政策及使命,從全世界採購廣泛種類的產品, 以迎合及滿足市場趨勢及需求。為了更迎合本 地社群的日常需要,本集團進一步加強穀類、 麵食、罐頭食品、牛奶、冰鮮及急凍食物等基 本食品、生活必需品和基本雜貨產品的供應。 此外,本集團在零售店持續加強自家品牌銷 售,包括果仁及乾果、有機穀物、濕紙巾、罐 頭食品、餅乾零食及其他產品,為消費者提供 更多元化的選擇。

截至二零二四年十二月三十一日止年度,本集 團向主要來自中國及海外市場的供應商以及香 港的品牌擁有人或進口商進行採購,並銷售合 共3,653個庫存單位(「**SKU**」)的產品(截至二零二 三年十二月三十一日止年度:3,945個SKU)。 截至二零二四年十二月三十一日止年度,約 54.9%產品採購自香港的供應商及品牌擁有人 或進口商(截至二零二三年十二月三十一日止年 度:約54.4%),至於來自日本、中國及歐洲的 進口產品則分別佔整體採購量約11.7%、9.8% 及6.3%(截至二零二三年十二月三十一日止年 度:約13.0%、6.0%及8.3%)。

於二零二四年十二月三十一日,本集團總存貨 量約值339,513,000港元(二零二三年十二月三十 一日:約276,691,000港元),按年增加22.7%。 本集團總存貨量增加主要由於店舖增加以及作 為農曆年前後旺季備貨的準備。 During the Financial Year under Review, the Group continued to actively develop private label products that on one hand allowed the Group to capture pricing advantages and exercise a higher level of quality control over its products and on the other hand further uplift its brand awareness and strengthen customers' loyalty. For the Financial Year under Review, sales derived from private label products was approximately HK\$477,222,000 (for the year ended 31 December 2023: approximately HK\$404,078,000), accounted for approximately 17.0% of the Group's revenue for the Financial Year under Review (for the unaudited year ended 31 December 2023: approximately 15.6%). During the Financial Year under Review, the Group had launched an aggregate of 11 private labels, and the products for sale included nuts and dried fruits, organic grains, wet tissues, canned food, biscuits and snacks, etc.

Membership Scheme

Given that the retail business of the Group is a consumer-driven business, the Group placed substantial efforts in developing and reinforcing its customer base. As such, the Group has established a membership scheme since April 2015 in order to promote consumer loyalty, stimulate sales and expand customer base. To further deepen customer stickiness and expand customers' coverage, the Group used big data analysis and reformulated its marketing strategy to launch a new three-tier membership scheme and a second-generation mobile app in mid-June 2020. The new membership scheme helps to elevate brand positioning and market recognition, and the membership rewards have been fully optimised and enhanced, with more member benefits such as multiple items purchase stamp reward, special offers for selected products and access to the latest market information. Through diversified marketing strategies, the Group aims to internally strengthen the membership core from within and attract new customers through external expansion, so as to effectively and purposefully foster the ties between members and the Group, thereby driving recurring business from members and promoting sustainable growth of the Group's business.

During the Financial Year under Review, the number of the Group's members increased from approximately 2,123,365 as at 31 December 2023 to approximately 2,280,418 as at 31 December 2024, representing an increase of approximately 7.4%.

會員計劃

鑒於本集團零售業務以顧客為導向,故投放了 巨大努力於發展及鞏固其顧客基礎。有見及 此,本集團自二零一五年四月起設立會員計 劃,藉以提升顧客忠誠度、刺激銷售及擴展顧 客基礎。為進一步深化顧客的黏貼度及擴大其 覆蓋面,本集團運用大數據分析及重新制定營 銷策略,並於二零二零年六月中旬推出全新的 三級制會員計劃及第二代手機應用程式。新計 劃有助提升本品牌定位及市場知名度,而會員 獎賞亦全面優化及提升,享有更多會員福利如 印花複購、精選產品優惠及接收最新市場資訊 等。本集團期望透過提供多元化的推廣策略, 向內鞏固會員核心及向外延展吸納新顧客,有 效及具目標性地促進會員與本集團之間的聯 繫,從而促使會員重覆惠顧並帶動本集團業務 的可持續增長。

於回顧財政年度,本集團會員數目由二零二三 年十二月三十一日約2,123,365名,增加至二零 二四年十二月三十一日約2,280,418名,增幅約 7.4%。 To express our gratitude for our customers' support, the Group launched various marketing and promotional activities during the Financial Year under Review including the "Best Price" promotional campaign, which provided customers with a series of special offers for selected quality products from time to time to enhance customer loyalty. Meanwhile, the Group continued to advertise through television, newspapers, social media platforms and other media, which successfully obtained repeat customers, attracted new customers and greatly promoted the discussions about the Group in the market.

PROSPECTS

Looking ahead, economic growth in Hong Kong and globally is expected to remain under pressure as uncertainties surrounding the relationship between China and the United States continues to cloud economic recovery. The Board anticipates that the retail sector in Hong Kong will remain subdued in the near term. Nevertheless, the Group will remain cautiously optimistic in conducting its business by closely monitoring the development of various adverse factors that may impact the Group's performance and timely implementing necessary and appropriate measures through refined operations and management to adapt to the everchanging market environment. The Group will continue to prioritize the Hong Kong market as its core focus, optimize its product structure and enhancing the development of its private label products, with greater emphasis on basic foodstuffs and necessities to cater to the needs of customers. These initiatives aim to bolster the Group's competitiveness in the retail market.

In order to maintain robust operational profitability, the Group will continue to review the regional distribution of its brand stores, and adopt appropriate expansion policies and flexible leasing strategies to look for suitable opportunities to expand the retail network for its major retail brands "Best Mart 360° (優品360°)" and global gourmet brand "FoodVille" in Hong Kong and Macau, with a target of achieving a net increase of 10 retail stores annually under its dual-brand model, catering to the diverse needs of different customer segments for quality food products.

為答謝顧客一直以來的支持,本集團於回顧財 政年度繼續推出不同市場推廣活動,包括「至優 價」優惠活動,不時為顧客提供一系列精選優 質產品價格優惠,以提升顧客忠誠度。另一方 面,本集團繼續透過電視、報紙、社交平台等 媒介進行廣告宣傳,在成功增加顧客回頭率的 同時,吸引新顧客光臨,大大增加本集團於市 場上之討論熱度。

展望

展望未來,中美關係的不確定性為經濟復甦帶 來更多挑戰,本港以至全球經濟增長可能將持 續受壓。董事會預計本港零售業短期內仍然表 現疲弱,將繼續以審慎樂觀的態度開展業務, 密切留意影響本集團營運的各項不利因素的發 當的業務措施,以應對瞬息萬變的市場環境。 本集團將繼續以香港市場為發展重心,透 優化產品組合和加強自家品牌的研發,涵蓋更 多基本食品及必需品,以更好滿足消費者的需 求,提升本集團於零售市場中的競爭力。

為保持穩健的營運效益,本集團將適時審視旗 下品牌店舖的區域分布,並採取適度的擴張政 策及靈活的租店策略,尋找適當機會拓展旗下 主要零售品牌「優品360°」以及環球美酒食品品牌 「FoodVille」於香港及澳門的店舖網絡,目標每年 淨增加10間零售店舖,以雙品牌模式迎合不同 顧客群對優質食品的需求。

Through global sourcing, the Group remains committed to broadening its product categories and maintaining price competitiveness. The Group will continue to source a diverse range of food products worldwide, intensify efforts to develop its private label products, and proactively explore new products to provide customers with a broader range of choices to meet the needs of various consumer groups.

In addition, the Group has entered into a sales and procurement framework agreement with China Merchants Hoi Tung Trading Company Limited ("CMHT"). In 2025, the Group will expand its product sales to and procurement from CMHT and its subsidiaries, facilitating the introduction of several popular brands from Mainland China. The Board believes that through CMHT's robust network of food importers and distributors, the Group will strengthen its procurement as well as Business-to-Business (B2B) operations. In addition, the Group has entered into agreements with China Merchants Bonded Logistics Co., Limited* (招商局保 税物流有限公司) and China Merchants Qian Hai Wan (Shenzhen) Supply Chain Management Co., Ltd.* (招商前海灣(深圳)供應 鏈管理有限公司). Since last year, they have provided customs clearance, warehousing and related logistics services as well as land transportation services of goods between Shenzhen and Hong Kong and other ancillary services. These have alleviated the pressure on the Group's warehouses in Hong Kong and reduce overall goods handling costs.

In the face of a fast-evolving operating environment, the Group remains confident and will continue to work closely with its employees, customers and other stakeholders to deliver better performance for the Group and achieve best returns for our shareholders.

本集團將透過環球採購致力豐富銷售產品之種 類,並保持價格競爭優勢。本集團將繼續從世 界各地搜羅各式各樣食品,並加大力度發展其 自家品牌產品,積極研發更多新產品,為顧客 提供更多元化選擇,以滿足不同消費者的需 求。

此外,本集團已與招商局海通貿易有限公司(「招 商海通」)訂立銷售及採購框架協議,並將於二零 二五年擴大與招商海通及其附屬公司之間的產 品銷售及採購合作,引入多個大熱國內品牌之 產品。董事會相信,透過招商海通強大的食品 進品商和分銷商網絡,將有助本集團加強其採 購及企業對企業(Business-to-Business,B2B)業 務的發展。此外,本集團亦與招商局保税物流 有限公司及招商前海灣(深圳)供應鏈管理有限公 司達成協議,自去年起,分別為本集團貨品提 供報關、倉儲及相關物流服務,同時提供往來 深圳及香港的貨品陸路運輸服務及其他配套服 務。這些措施有助緩解本集團於香港倉庫的壓 力,同時降低整體貨物處理成本。

面對日益複雜的經營環境,本集團充滿信心, 並繼續與員工、顧客及其他持份者緊密合作, 共同為本集團創造更優秀業績,為股東實現最 佳回報。

FINANCIAL REVIEW

Revenue

During the year ended 31 December 2024, the revenue of the Group mainly represented the retail sales to walk-in customers through its retail stores which accounted for approximately 97.7% of the revenue of the Group. For the year ended 31 December 2024, the revenue of the Group was approximately HK\$2,805,146,000 (nine months ended 31 December 2023: approximately HK\$1,930,831,000). Compared with the same period last year, revenue of the Group for the year ended 31 December 2024 increased by approximately 8.2% from approximately HK\$2,592,129,000 for the unaudited revenue for the year ended 31 December 2023, which was mainly attributed to additional revenue from the net opening of 9 new stores by the Group during the Financial Year under Review.

Profit for the Year

Profit of the Group for the year ended 31 December 2024 amounted to approximately HK\$247,522,000 (nine months ended 31 December 2023: approximately HK\$168,335,000). Compared with the same period last year, profit of the Group for the year ended 31 December 2024 increased by approximately 5.3% from approximately HK\$234,959,000 for the unaudited profit for the year ended 31 December 2023, mainly driven by the growth in sales and resulting growth in gross profit from the Group's retail stores, which outweighed the adverse effect from increasing operating cost. Net profit margin before interest and tax for the year ended 31 December 2024 was approximately 11.2%, while the unaudited net profit margin before interest and tax for the same twelve-month period in 2023 was approximately 11.4%. The decrease was mainly due to the rising operating cost.

財務回顧

收入

截至二零二四年十二月三十一日止年度,本集 團的收入主要來自其零售店舖的街客所帶來的 零售銷售額,其佔本集團收入約97.7%。截至 二零二四年十二月三十一日止年度,本集團的 收入約為2,805,146,000港元(截至二零二三年 十二月三十一日止九個月:約1,930,831,000 港元)。相較去年同期,本集團截至二零二四 年十二月三十一日止年度的收入從截至二零二 三年十二月三十一日止年度未經審核的收入約 2,592,129,000港元增加約8.2%,其主要由於來 自本集團在回顧財政年度淨增設的9間新店舖的 額外收入。

年度溢利

本集團截至二零二四年十二月三十一日止年 度的溢利約為247,522,000港元(截至二零二三 年十二月三十一日止九個月:約168,335,000 港元)。相較去年同期,本集團截至二零二四 年十二月三十一日止年度的溢利從截至二零二 三年十二月三十一日止年度未經審核的溢利約 234,959,000港元增加約5.3%,其主要由於本集 團零售店舖的銷售額增長及因而增長的毛利(其 超過營運成本上漲帶來的不利影響)。截至二零 二四年十二月三十一日止年度的除息税前純利 率約為11.2%,二零二三年十二個月同期的未 經審核除息税前純利率則約為11.4%。除息税 前純利率減少主要由於營運成本上漲。

Gross Profit and Gross Profit Margin

For the year ended 31 December 2024, the gross profit of the Group was approximately HK\$1,027,997,000 (nine months ended 31 December 2023: approximately HK\$694,258,000). Compared with the same period last year, the gross profit of the Group for the year ended 31 December 2024 increased by approximately 10.6% from approximately HK\$929,812,000 for the unaudited gross profit for the year ended 31 December 2023. The gross profit margin was approximately 36.6% (year ended 31 December 2023: approximately 35.9% (unaudited)). The rise in gross profit margin of the Group for the Financial Year under Review was largely attributed to our adaptive sales strategy and product mix optimisation.

Other Income and Other Gains, Net

For the year ended 31 December 2024, the Group recorded net other income and other gains of approximately HK\$6,385,000 (nine months ended 31 December 2023: approximately HK\$4,676,000), which mainly comprised (i) interested income from bank deposits of approximately HK\$5,975,000 (nine months ended 31 December 2023: approximately HK\$5,074,000) and (ii) net losses on written-off or disposal of property, plant and equipment of approximately HK\$14,000 (nine months ended 31 December 2023: approximately HK\$14,000).

Selling and Distribution Expenses

For the year ended 31 December 2024, selling and distribution expenses of the Group amounted to approximately HK\$635,736,000 (nine months ended 31 December 2023: approximately HK\$422,722,000). Compared with the same period last year, selling and distribution expense of the Group for the year ended 31 December 2024 increased by approximately 14.1% from approximately HK\$556,971,000 for the unaudited selling and distribution expense for the year ended 31 December 2023, which was mainly due to the increase of rental expenses and other store operating expenses resulting from the expansion of retail store network, together with more frontline and warehouse staff hired to support the growth in scale as well as escalating staff cost. Selling and distribution expenses represented approximately 22.7% of total revenue for the year ended 31 December 2024 (year ended 31 December 2023: approximately 21.5% (unaudited)).

毛利及毛利率

截至二零二四年十二月三十一日止年度,本集 團的毛利約為1,027,997,000港元(截至二零二 三年十二月三十一日止九個月:約694,258,000 港元)。相較去年同期,本集團截至二零二四 年十二月三十一日止年度的毛利從截至二零二 三年十二月三十一日止年度未經審核的毛利約 929,812,000港元增加約10.6%。毛利率則約 為36.6%(截至二零二三年十二月三十一日止年 度:約35.9%(未經審核))。本集團於回顧財政 年度的毛利率上升,主要有賴於靈活的銷售策 略及產品組合優化。

其他收入及其他收益淨額

截至二零二四年十二月三十一日止年度,本集 團錄得其他收入及其他收益淨額約6,385,000港 元(截至二零二三年十二月三十一日止九個月: 約4,676,000港元),其主要包含:(i)銀行存款利 息收入約5,975,000港元(截至二零二三年十二月 三十一日止九個月:約5,074,000港元)及(ii)撇銷 或出售物業、廠房及設備的淨虧損約14,000港 元(截至二零二三年十二月三十一日止九個月: 約335,000港元)。

銷售及分銷開支

截至二零二四年十二月三十一日止年度,本集 團的銷售及分銷開支約為635,736,000港元(截 至二零二三年十二月三十一日止九個月:約 422,722,000港元)。相較去年同期,截至二零 二四年十二月三十一日止年度本集團的銷售及 分銷開支從截至二零二三年十二月三十一日止 年度未經審核的銷售及分銷開支約556,971,000 港元增加約14.1%,其主要由於零售店舖網絡 擴張導致租金開支及其他店舖營運開支增加, 建同僱用更多前線及倉務人員以支援規模增長 以及員工成本增加。截至二零二四年十二月三 十一日止年度,銷售及分銷開支佔總收入約 22.7%(截至二零二三年十二月三十一日止年 度:約21.5%(未經審核))。

Administrative and Other Expenses

For the year ended 31 December 2024, administrative and other expenses of the Group amounted to approximately HK\$83,456,000 (nine months ended 31 December 2023: approximately HK\$62,568,000). Compared with the same period last year, administrative and other expenses of the Group for the year ended 31 December 2024 increased by approximately 2.5% from approximately HK\$81,418,000 for the unaudited administrative and other expenses for the year ended 31 December 2023, which was mainly attributable to rising staff cost.

Finance Costs

Finance costs of the Group for the year ended 31 December 2024 amounted to approximately HK\$18,060,000 (nine months ended 31 December 2023: approximately HK\$10,930,000). Compared with the same period last year, finance costs of the Group for the year ended 31 December 2024 increased by approximately 30.7% from approximately HK\$13,821,000 for the unaudited finance costs for the year ended 31 December 2023. Effective interest rate for bank borrowings of the Group was approximately 3.2% for the year ended 31 December 2024, representing an increase of 0.2 percentage point from the unaudited effective interest rate for the year ended 31 December 2023 of approximately 3.0%, primarily due to an adjustment to the interest margin for the Financial Year under Review.

Financial Position, Liquidity and Financial Resources

As at 31 December 2024, the Group's total cash and bank balances (including cash and cash equivalents) were approximately HK\$159,510,000 (31 December 2023: approximately HK\$130,712,000), representing a increase of approximately HK\$28,798,000 which was mainly generated from operating activities.

As at 31 December 2024, the Group has total bank borrowings of approximately HK\$73,246,000, representing a decrease of approximately 4.6% as compared to approximately HK\$76,756,000 as at 31 December 2023. The total unutilised banking facility extended by commercial banks as at 31 December 2024 amounted to approximately HK\$239,821,000 (31 December 2023: approximately HK\$240,630,000). The carrying amounts of the Group's borrowings are denominated in Hong Kong dollars, secured and approximate to their fair value.

行政及其他開支

截至二零二四年十二月三十一日止年度,本集 團的行政及其他開支約為83,456,000港元(截 至二零二三年十二月三十一日止九個月:約 62,568,000港元)。相較去年同期,截至二零二 四年十二月三十一日止年度本集團的行政及其 他開支從截至二零二三年十二月三十一日止年 度未經審核的行政及其他開支約81,418,000港 元增加約2.5%,其主要由於員工成本增加。

融資成本

本集團截至二零二四年十二月三十一日止年度 的融資成本約為18,060,000港元(截至二零二三 年十二月三十一日止九個月:約10,930,000港 元)。相較去年同期,本集團截至二零二四年十 二月三十一日止年度的融資成本從截至二零二 三年十二月三十一日止年度未經審核的融資成 本約13,821,000港元增加約30.7%。截至二零 二四年十二月三十一日止年度的本集團銀行借 款實際利率約為3.2%,較截至二零二三年十二 月三十一日止年度未經審核的實際利率約3.0% 增長0.2個百分點,乃由於回顧財政年度利率調 整。

財務狀況、流動資金及財務資源

於二零二四年十二月三十一日,本集團的現金 及銀行結餘總額(包括現金及現金等值項目)約為 159,510,000港元(二零二三年十二月三十一日: 約130,712,000港元),增加約28,798,000港元, 主要來自經營業務。

於二零二四年十二月三十一日,本集團的銀 行借款總額約為73,246,000港元,較於二零二 三年十二月三十一日約76,756,000港元減少約 4.6%。本集團於二零二四年十二月三十一日 獲商業銀行提供的未使用銀行融資額合共約為 239,821,000港元(二零二三年十二月三十一日: 約240,630,000港元)。本集團的借款為有抵押, 其賬面值以港元計值,並與其公平值相若。

As at 31 December 2024, the Group had a gross gearing ratio (i.e., gross debt divided by total equity) of approximately 13.7% (31 December 2023: approximately 16.8%). For this purpose, gross debt is defined as total interest-bearing borrowings excluding lease liabilities.

The Group financed its liquidity and working capital requirements through a combination of various sources, including but not limited to cash generated from the Group's operations, bank borrowings, and other external equity and debt financings as and when appropriate.

The Group continued to maintain a strong financial position with cash and bank balances of approximately HK\$159,510,000 and the Group's working capital amounted to approximately HK\$148,631,000 as at 31 December 2024. Based on the Group's steady cash inflow from operations, coupled with sufficient cash and bank balances and readily available banking facilities, the Group has adequate liquidity and financial resources to meet its working capital requirements in the next twelve months from the balance sheet date. During the Financial Year under Review, the majority of the Group's cash and bank balances were in Hong Kong dollar and Macau Pataca were deposited in reputable financial institutions.

Capital Structure

The shares of the Company (the "**Shares**") were successfully listed on the main board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") on 11 January 2019 by way of share offer. Since then, there has been no change in the capital structure of the Company. The capital structure of the Company comprises issued share capital and reserves. As at 31 December 2024, the Company had 1,000,000,000 Shares in issue.

The capital structure of the Group as at 31 December 2024 in terms of debt profile is mainly bank borrowings and as at 31 December 2024, the Group has outstanding bank borrowings repayable within one year or contain a repayment on demand clause of approximately HK\$73,246,000 (31 December 2023: approximately HK\$76,756,000). Bank borrowings bear interest at floating interest rates. The effective interest rate of the Group's bank borrowings is 3.2% per annum for the year ended 31 December 2024.

於二零二四年十二月三十一日,本集團的總 資本負債比率(即債務總額除以權益總額)約 為13.7%(二零二三年十二月三十一日:約 16.8%)。就此而言,債務總額界定為計息借款 總額(不含租賃負債)。

本集團透過不同資金來源(包括但不限於本集團 經營所得現金、銀行借款,以及於適當時候取 得的其他外部股本及債務融資),為其流動資金 及營運資金需求提供資金。

本集團繼續保持良好的財務狀況,其於二零二 四年十二月三十一日的現金及銀行結餘約為 159,510,000港元,而本集團的營運資金約為 148,631,000港元。由於本集團擁有穩定的經 營現金流入,加上充足的現金及銀行結餘以及 隨時可用的銀行融資,本集團具備足夠流動資 金及財務資源以滿足其自資產負債表日期起未 來十二個月的營運資金需求。於回顧財政年度 內,本集團大部分現金及銀行結餘乃以港元及 澳門元計值,並存放於信譽良好的金融機構。

資本架構

本公司股份(「股份」)已於二零一九年一月十一日 成功以股份發售方式在香港聯合交易所有限公 司(「聯交所」)主板上市。自此之後,本公司的 資本架構並無任何變動。本公司的資本架構由 已發行股本及儲備組成。於二零二四年十二月 三十一日,本公司有1,000,000,000股已發行股 份。

本集團於二零二四年十二月三十一日的資本架 構在債務方面主要為銀行借款,而於二零二四 年十二月三十一日,本集團有未償還銀行借款 約73,246,000港元(二零二三年十二月三十一 日:約76,756,000港元)為須於一年內償還或 具有按要求即時償還條款。銀行借款按浮動利 率計息。截至二零二四年十二月三十一日止年 度,本集團銀行借款的實際年利率為3.2%。

Capital Commitments

Details of capital commitments are set out in note 26 to the financial statements.

Charge on Group Assets

As at 31 December 2024, the bank borrowings and other banking facilities of the Group are secured by:

- a corporate guarantee provided by the Company and a subsidiary; and
- property, plant and equipment of office premises of the Group with carrying amount of approximately HK\$157,623,000 (31 December 2023: HK\$162,615,000).

Foreign Currency Risk

The Group mainly operates in Hong Kong and is exposed to foreign exchange risk from (i) the purchase of products from various overseas suppliers, which are primarily settled in foreign currencies, mainly USD, JPY, EUR, GBP, AUD, SGD and RMB; and (ii) the revenue generated from the operation in Macau. Nevertheless, taking into account the retail industry practice, the Group's current operation, the stable exchange rate of Macau Pataca historically is considered to be not material, the Directors do not consider that the Group is subject to material foreign exchange risk. The Group will take proactive measures and monitor closely its exposure to such currencies movement.

Treasury Policies

The Group adopts prudent treasury management policies and does not engage in any highly leveraged or speculative derivative products. Cash balances are mostly placed in Hong Kong dollars bank deposit with appropriate maturity period for meeting future funding requirements.

外幣風險

本集團主要於香港經營業務,並因(i)向不同海外 供應商採購產品,且有關採購主要以外幣(主要 為美元、日圓、歐元、英鎊、澳元、坡元及人 民幣)結算;及(ii)澳門營運所得收入,而面對外 幣風險。儘管如此,考慮到零售業慣例、本集 團目前營運狀況、澳門元滙率一直穩定被視為 並不重大,董事認為本集團面對的外幣風險並 不重大。本集團將就有關貨幣變化所帶來的風 險,而採取主動措施以及作出嚴密監察。

庫務政策

本集團採取審慎的庫務管理政策,不投購任何 高槓桿或投機性衍生產品。現金結餘一般存於 設定適當到期日的港元銀行存款賬戶,以滿足 未來資金需要。

EMPLOYEES REMUNERATION POLICY

The remuneration policy of the Group is to reward the employees based on their performance, gualifications, experience and competence. Remuneration package typically comprises salary, contribution to pension schemes, discretionary annual bonus, performance-related bonus, sales target bonus and miscellaneous duties-related allowances. The Group conducts annual review on the performance of the employees and make reference to such performance review for assessing discretionary annual bonus, salary adjustments and promotion appraisals. The remuneration packages of the executive Directors and the senior management are determined with reference to those paid by comparable companies. the time commitment and performance of the executive Directors and the senior management, as well as the performance of the Group. A remuneration committee is set up to review the Group's emolument policy and structure of all remuneration of the Directors and senior management of the Group with reference to their experience, responsibilities, workload and time devoted to the Group and performance of the Group.

The Group has joined the Mandatory Provident Fund Scheme under the Mandatory Provident Fund Scheme Ordinance (Cap. 485 of the Laws of Hong Kong) (the "**MPF Scheme**") for all employees in Hong Kong. The contributions to the MPF Scheme are based on minimum statutory contribution requirement of the lower of 5% of eligible employees' relevant aggregate income and HK\$1,500 per month. The funds of the MPF Scheme are held separately from those of the Group.

The Group makes contributions to the social security fund for our eligible employees in Macau based on, *inter alia*, whether they are long term employees or fixed term employees. As stipulated by the labour regulations of PRC, the Group participates in various defined contribution retirement plans organised by municipal and provincial governments for its PRC employees. The Group is required to make contributions to the retirement plans at rates ranging from 14% to 15% of the eligible employees' salaries for the year ended 31 December 2024 (nine months ended 31 December 2023: 14% to 15%).

僱員薪酬政策

本集團為香港所有僱員參加香港法例第485章強制性公積金計劃條例項下的強制性公積金計劃 (「強積金計劃」)。強積金計劃的供款乃基於每月 合資格僱員相關總收入的5%及1,500港元的較 低者的最低法定供款規定計算。強積金計劃的 資金與本集團的資金分開持有。

CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining a high standard of corporate governance in accordance with the principles of good corporate governance, to formulate good corporate governance practice for improvement of accountability and transparency in operations, and to strengthen the internal control system from time to time so as to ensure we meet the expectations of the Shareholders.

During the Financial Year under Review, the Company has adopted and complied with all applicable code provisions in the Corporate Governance Code (the "**CG Code**") as set out in Appendix C1 to the Rules Governing the Listing of Securities on the Stock Exchange (the "**Listing Rules**").

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of the Chairman and the Chief Executive Officer are separate and performed by different individuals to ensure a balance of power and authority, so that power is not concentrated in any one individual. Mr. Li Guanpeng, the chairman of the Company and an executive Director, is responsible for formulating the Group's strategic planning and the overall business development and overseeing overall management and operation of the Group, while Mr. Hui Chi Kwan, the chief executive officer of the Group and an executive Director, is responsible for overseeing day-today management of the Group and reporting to and executing decisions from the Board. There is a clear division of responsibilities between the chairman and the chief executive officer.

SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "**Model Code**") as set out in Appendix C3 to the Listing Rules as its own code of conduct governing the securities transactions by the Directors. Following a specific enquiry made by the Company on the Directors, all Directors have confirmed that they had complied with the required standard set out in the Model Code during the Financial Year under Review.

主席及行政總裁的角色乃分開並由不同人士擔 當,以確保權力及授權分佈均衡,使任何單一 人士不能包攬全部權力。本公司主席兼執行董 事李關鵬先生負責本集團的戰略規劃及整體業 務發展,以及監督本集團的戰體管理及營運, 而本集團行政總裁兼執行董事許志群先生則負 責監督本集團日常管理以及向董事會報告及執 行董事會所定決策。主席與行政總裁各自的職 責已有清楚區分。

董事進行證券交易

本公司已採納上市規則附錄C3所列載的上市 發行人董事進行證券交易的標準守則(「標準守 則))作為其自身規管董事進行證券交易的行為守 則。經本公司向董事作出具體查詢後,全體董 事均已確認,彼等於回顧財政年度內已遵守標 準守則所規定的準則。

BOARD OF DIRECTORS

Responsibilities of the Board

The Board is primarily responsible for overseeing and supervising the overall management of the Group's business. The Board is collectively responsible for promoting the success of the Company by providing effective leadership and direction to its business, formulating group policies and business directions, monitoring internal controls and performances, and ensuring transparency and accountability of its operations. The powers and duties of the Board include convening general meetings and reporting the Board's work at the Shareholders' meetings, determining the business and investment plans, preparing the periodic financial budgets and reports, preparing the financial accounts, overseeing the financial reporting process, formulating proposals for profit distributions and exercising other powers, functions and duties as conferred by the memorandum and articles of association ("Articles of Association") of the Company. The Board has established Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference which are published on the respective websites of the Stock Exchange and the Company.

The Company has established relevant mechanisms to ensure independent views and input are available to the Board and conducted review of such mechanisms on an annual basis. Members of the Audit Committee are independent non-executive Directors who are able to bring independent and objective views to the Board.

The mechanism is disclosed below:

1. The Board ensures the appointment of at least three independent non-executive Directors and at least one-third of its members being independent non-executive Directors (or such higher threshold as may be required by the Listing Rules from time to time), with at least one independent non-executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise. Further, independent non-executive Directors will be appointed to board committees as required under the Listing Rules and as far as practicable to ensure independent views are available.

 董事會應確保委任至少三名獨立非執行董 事,且其成員中至少有三分之一為獨立非 執行董事(或上市規則可能不時規定的更高 門檻),而至少一名獨立非執行董事須具有 合適專業資格或會計或相關財務管理專業 知識。本公司亦會按上市規則所規定及在 可行情況下委任獨立非執行董事加入董事 會委員會,以確保獲取獨立觀點。

- 2. The Nomination Committee strictly adheres to the Nomination Policy with regard to the nomination and appointment of independent non-executive Directors, and is mandated to assess annually the independence of independent nonexecutive Directors to ensure that they can continually exercise independent judgement.
- 3. No equity-based remuneration with performance-related elements will be granted to independent non-executive Directors as this may lead to bias in their decision-making and compromise their objectivity and independence.
- 4. The Board assesses and reviews the time contributed by each independent non-executive Director and their attendance to meetings of the Board and the board committees so as to ensure that every independent non-executive Director has devoted sufficient time to the Board to discharge his/her responsibilities as a Director of the Company.
- 5. The Directors, upon reasonable request, may seek external independent professional advice at the Company's expense, to assist the performance of their duties.
- 6. The chairman meets with the independent non-executive Directors regularly without the presence of the other Directors to discuss matters relating to the Group.

The Directors have full access to information of the Group and are entitled to seek independent professional advice in appropriate circumstances at the Company's expense.

The management of the Company is accountable to the Board and performs the following major duties: reporting to the Board, executing the resolutions of the Board, and completing all the tasks assigned by the Board.

The chairman of the Audit Committee is Ms. Chan Yuen Sau Kelly.

The chairman of the Nomination Committee is Mr. Li Guanpeng.

The Company recognises and embraces the importance and benefit to achieve diversity on the Board to corporate governance and board effectiveness. The Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In deciding the composition of the Board, the Company will consider the Board diversity from various perspectives with reference to the Company's business model and specific needs, including but not limited to gender, age, race, language, cultural background, educational background, industry experience and professional experience.

All appointments of the Board are based on meritocracy, and candidates will be considered against appropriate criteria, having due regard for the benefits of a balance of skills, experience and diversity on the Board. The Nomination Committee has primary responsibility for identifying suitably qualified candidates to become members of the Board and shall give adequate consideration to this policy in selection of board candidates. To ensure changes to the Board composition can be managed without undue disruption, a formal, considered and transparent procedure is in place for the selection, appointment and re-appointment of directors. The Nomination Committee will consider candidates on merit and objective criteria, including his/her ability to dedicate sufficient time and attention to the Company's affairs, contribute to the diversity of the Board as set out in the Board diversity policy as well as effectively support the Board of their responsibilities, in order to determine whether a candidate is qualified before making recommendations to the Board.

As disclosed in said announcements, the Company's external legal advisers (the "**Investigator**") were engaged to conduct an internal investigation (the "**Internal Investigation**") to independently review and assess the relevant information regarding the Incident and report to the Governance Committee and the Board. The Internal Investigation has been completed. Based on the information available to the Investigator, the Investigator considered that, among other things, there was no evidence to suggest that the Incident was related to the Group's business or funds. The Governance Committee and the Board have given due consideration to the findings and adopted the findings accordingly. *(Note 1)*

Note 1: For the avoidance of doubt, nothing contained herein shall be construed as a waiver of legal professional privilege on behalf of the Company.

DIRECTORS' LIABILITIES INSURANCE

During the Financial Year under Review, the Company had arranged for appropriate and adequate insurance cover to protect the Directors from legal action arising from the performance of their duties as a Director. Such insurance coverage is reviewed and renewed by the Board on an annual basis.

- The risk management and internal control systems adopted by the Company are designed to manage rather than to eliminate the risk of failure to achieve business objectives and can only provide reasonable and not absolute assurance against material misstatement or loss.
- The Audit Committee is responsible for reviewing the internal control systems and procedures for compliance with the requirements prescribed by the applicable laws, rules and regulations. The Board is responsible for the risk management and internal control systems of the Company, and through the Audit Committee, conducts an annual review on the effectiveness of the Group's risk management and internal control systems in its financial, operational and compliance controls and risk management functions. If defects are discovered during the review, the Board and the chief executive officer will review such defects and make corresponding plans to resolve them, taking into consideration the available resources.

Furthermore, a compliance team which includes the chief financial officer has been established to organise, review and maintain the internal control system and to provide assistance to the Directors, senior management and employees with respect to the internal control policies. The Company convenes meetings periodically to discuss financial, operational, compliance and risk management control.
- The Directors and senior management keep track of day-today operations and monitor any associated operational risks of the Group and formulate policies and resolutions to mitigate or resolve these risks.
- Trainings are provided to relevant employees in order to enhance their industry knowledge and to encourage encompassing culture of risk management to ensure that the relevant employees are aware of and responsible for risk management.
- During the Financial Year under Review, the Company has engaged external legal advisers to advise the Company on compliance with and provide updates on the changes in the Listing Rules and the applicable Hong Kong laws, rules and regulations from time to time and as required.
- The Company has established procedures and internal controls for the handling and dissemination of inside information, to ensure that inside information and sensitive information in relation to the Company will remain confidential until the disclosure of such information is appropriately approved.

The Board is of the opinion that the Group's risk management and internal control systems were adequate and effective during the Financial Year under Review.

The Company has no fixed dividend policy specifying a dividend payout ratio. The amount of any dividends to be declared will be subject to the decision of the Board and will depend on, among others, the Group's results of operations, available cashflows, financial condition, operating and capital requirements, the Articles of Association, the Companies Laws, applicable laws and regulations and any other factors that the Directors deem relevant. Dividends may only be paid out of the distributable profits of the Company as permitted under the applicable laws and shall not exceed the amount determined by the Board.

SHAREHOLDERS' RIGHTS

Procedures for Putting Forward Proposals at Shareholders' Meetings

There are no provisions allowing Shareholders to make proposals or make a motion at the AGMs under the Articles of Association or the laws of the Cayman Islands. Shareholders who wish to make proposals or motions may, however, convene an extraordinary general meeting of the Company (the "**EGM**") in accordance with the "Procedures for Shareholders to Convene an EGM" set out below.

Procedures for Shareholders to Convene an EGM

In accordance with article 57 of the Articles of Association, an EGM shall be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid up capital of the Company carrying the right of voting at the general meetings of the Company. Such requisition shall be made in writing to the Board or the company secretary for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. Such meeting should be held within two months after the deposit of such requisition.

The requisitionists must state in their requisition(s) the objects of the EGM to be convened, and such requisition must be signed by all the requisitionists. Upon receipt, the Company will verify the requisitionists' particulars and shareholding and if the requisition is in order, the Company will convene the EGM in accordance with the Articles of Association. On the contrary, if the requisition has been verified as not in order, the requisitionists concerned will be advised of the outcome and accordingly, the Board will not convene the EGM and/or include the proposal(s) made or the resolution(s) proposed by the requisitionists at the EGM.

Communications with Shareholders

The Company has adopted a Shareholders' communication policy to ensure effective communication with Shareholders. Under the policy, the Company's information shall be communicated to the Shareholders through general meetings, including AGMs, the Company's corporate communications (including, but not limited to, the annual report, the interim report, notices of meeting, circulars and proxy forms), information and materials on the Company's website and the Stock Exchange's website.

The Board has reviewed the implementation and effectiveness of the Shareholders' communication policy including steps taken at the AGMs and the handling of queries received (if any) which were conducted during the Financial Year under Review and considered the Shareholders' communication policy to be effective and adequate.

The Group connects with external and internal partners including employees, customers, investors, suppliers, business partners, and non-governmental organisations ("**NGOs**") through a wide range of communication channels such as emails, press releases, meetings and site visits, etc. Apart from the AGM, the Group shares its ESG performance with the investors and shareholders and collects their feedback through online meetings, sharing, emails, surveys and press conferences. We ensure stakeholder inclusiveness in our sustainability decision-making and priority concerns.

A. ENVIRONMENTAL

The Group is committed to offering quality products in a manner that ensures a safe and healthy workplace for the Group's employees and minimises the Group's potential impact on the environment. The Group will operate in compliance with all relevant environmental legislation and it strives to use pollution prevention and environmental best practices throughout its operations.

The Group's environmental policy therefore is to:

- Consider environmental concerns and impacts in our decision making and activities;
- Minimise the production of waste and then reuse or recycle as much of it as possible;
- Minimise energy use within our operations and processes in order to conserve supplies and minimize the consumption of natural resources;
- Where possible, purchase products and services that do the least damage to the environment;
- Educate and inform the Group's employees about the environmental issues that may affect their work;
- Promote environmental awareness among the Group's employees and encourage them to work in an environmentally responsible manner; and
- Communicate our environmental commitment to customers and the public and encourage them to support the Group's environmental commitments.

The group is principally engaged in retail business in Hong Kong, Macau and Mainland China and its business operations do not directly generate industrial pollutants that are generally regarded as having a high environmental impact such as hazardous emissions, wastes or pollutants. The Group understands and respects its responsibility to the environment, and endeavours to achieve eco-friendly operations and conservation of resources in pursuit of sustainable development.

A. 環境

本集團致力在確保本集團僱員的工作場所 安全健康,以及盡量減少本集團對環境的 潛在影響下,提供優質產品。本集團將遵 守所有相關環境法例,並努力在其整個營 運過程中,跟從最佳的預防污染及環保常 規。

因此,本集團的環境政策是:

- 在集團決策及活動中顧及環境因素及 影響;
- 盡量減少產生廢物,並盡可能重用或
 回收廢物;
- 在營運過程及程序中盡量減少使用能 源,以節省供應及最大限度地減低天 然資源消耗;
- 盡可能選購對環境損害最小的產品及 服務;
- 教育並告知本集團僱員有哪些環境問題可能影響其工作;
- 提高本集團僱員的環保意識,鼓勵僱 員在工作中實踐環保;及
- 向顧客及公眾傳達本集團的環保承諾,並鼓勵彼等支持本集團履行其環保承諾。

本集團主要在香港、澳門及中國內地從事 零售業務,其業務營運不會直接產生一般 被視為對環境造成高危影響的工業污染 物,例如有害排放物、廢料或污染物。本 集團明白並尊重其對環境的責任,致力實 現對環境友善的經營模式及資源節約,力 求達致可持續發展。 During the Financial Year under Review, the Group had not been involved in any material non-compliance issues in respect of any applicable laws and regulations on environmental protection.

A.1 Emissions

Air emission

The Group does not directly produce air emissions. The major source of air emissions is the transportation of products in Hong Kong, Macau and Mainland China. The Group has engaged several external logistic service companies including a Hong Kong logistic company, and Macau and Mainland China shipping and logistic service companies to collect, distribute and/or deliver goods from the products' arrival shipping terminal, airport and warehouse of the forwarders appointed by the Group's overseas suppliers, to the warehouses and retail stores of the Group. As the logistic services are operated by independent third parties that are not owned by or controlled by the Group, therefore the retrieval of relevant data of such emissions in Hong Kong, Macau and Mainland China are not feasible. Instead, as a major client of our logistic partners, we engage in close collaboration with them to minimize the environmental impact of the transportation fleet through the following methods:

- streamline the logistic routing and maximise the loading capacity of each transportation vehicle;
- arrange delivery services to the retail stores in during non-peak hours;
- encourage our logistics partners to upgrade their fleet to meet the latest emission standards. For example, our Hong Kong logistic partner had upgraded all of its heavy-duty vehicles to the Euro VI emission standard in 2019; and
- ensure our logistics partners are operating in accordance with all prevailing environmental laws and regulations.

A.1 排放物

廢氣排放

本集團不直接產生廢氣。廢氣排放主 要來自香港、澳門及中國內地的產品 運輸過程。本集團委託多間外部物流 服務公司,包括一間香港物流公司、 及澳門及中國內地航運公司及物流服 務公司,負責從產品到貨的航運碼 頭、機場及本集團海外供應商指定的 貨運代理倉庫,收集、配送及/或運 送貨品至本集團的倉庫及零售店舖。 由於物流服務由並非本集團擁有或 控制的獨立第三方處理,故此無法取 得有關方面的香港、澳門及中國內地 排放數據。取而代之,作為上述物流 夥伴的主要客戶,本集團與其共同努 力,透過以下方法減少運輸車隊所造 成的環境影響:

- 精簡物流路線,最大限度地提高 每輛運輸車輛的裝載能力;
- 將送貨至零售店舖的服務編排於 非繁忙時間進行;
- 鼓勵物流夥伴升級其車隊,以符 合最新排放標準。舉例而言,集 團的香港物流夥伴已於二零一九 年全面升級其重型車輛,以符合 歐盟六期排放標準;及
- 確保物流夥伴依照所有現行環境 法律及法規經營其業務。

Greenhouse gases (GHG) emission

The only source of GHG emission is Scope 2 GHG emissions, which were contributed by electricity consumption (for the exact usage, please refer to A.2 Use of resources). Scope 1 GHG emissions typically include fuel usage from company-owned/controlled vehicles or equipment. The data below includes the head office, warehouse and retail stores in Hong Kong, Macau and Mainland China. The Group aims to reduce its GHG emissions in the coming year to levels below those of this year.

The GHG emission data is set out in the table below:

Non-recyclable Waste

Our waste is categorized as non-hazardous municipal waste. Depending on the local regulations and capabilities, we separate the non-recyclable from the recyclable waste. Waste volume is managed and tracked internally. We have a number of programs to raise staff's awareness and introduce best practices on waste management, including that of the office, warehouse and frontline.

The details of the non-recyclable wastes are listed as follows:

We explore various methods for waste treatment, considering community needs and viable solutions tailored to different waste types. Moving forward, we will enhance our waste data collection processes, assess and transparently disclose relevant information, and gradually set appropriate targets on waste reduction.

A.2 Use of resources

The Group is committed to complying with all laws and regulations on managing the use of resources and strives to become a resource-saving and environmentally responsible enterprise through the implementation of various policies and procedures which aims to achieve higher efficiency in resource use and also reduction in the overall use of resources throughout the Group's operations, where possible.

Use of energy

The major source of energy used by the Group is electricity, which is mainly used in the general lighting, air-conditioning and powering of computers, office equipment and other equipment in the retail stores, warehouse and office of the Group. The total energy consumption of the financial year ended 31 December 2024 was 10,253,739 kWh (for the nine months ended 31 December 2023: 7,317,185 kWh) which is 40.1% higher than that of the last reporting period and was due to expansion of the Group's operations and change of the reporting period. The Group has also strived to enhance efficiency through various ways such as cleaning the air conditioners, and will continue to explore ways to improve energy efficiency in its daily operation. 基於社區需求及針對不同廢物類型量 身定製的可行解決方案,我們探索各 種廢物處理方法。展望未來,我們將 優化廢物數據收集流程,評估並透明 地披露相關資料,並逐步制定適當的 減廢目標。

A.2 資源使用

本集團致力遵守有關管理資源使用的 所有法律及法規,並通過落實不同政 策及程序,以盡可能提高資源使用效 率及減少本集團整體營運中使用的資 源為目標,從而成為一間節約資源、 對環境負責的企業。

能源使用

本集團使用的主要能源為電力,其主 要用於本集團辦公室、零售店舖及倉 庫的一般照明、空調以及電腦、辦 室設備及其他設備的供電。截至二零 二四年十二月三十一日止財政年度的 能源消耗總量為10,253,739千瓦時(截 至二零二三年十二月三十一日止九個月 至二零二三年十二月三十一日止九個月 高40.1%,此乃由於本集團亦致力 過不同方法提高效益,例如清潔空改 善能源效益的方法。

- Note 1: The increase in consumption of electricity and the generation of carbon dioxide emissions for the Financial Year under Review as compared to that of last reporting period was mainly due to the increase in the number of retail stores of the Group in the Financial Year under Review and change of the reporting period. In addition, the Group increased the product categories to selling frozen foods, therefore more refrigerators are needed for storage which increased the energy consumption.
- Note 2: The revenues of the Financial Year under Review and the last reporting period are approximately HKD2,805,146,000 and HKD1,930,831,000, respectively.

Water consumption

Water usage in the Group's business operation is minimal as the Group's operation does not consume water. Water is mainly used by employees for drinking and personal hygiene purpose in the office, retail stores and warehouses of the Group and the usage was relatively insignificant. There was no issue in sourcing water that is fit for purpose.

A.3 Impacts on natural resources and management actions

The Group believes that corporate development should not come at the expense of the environment. The Group's material impact on the environment and natural resources are in the form of electricity and material consumption, as well as waste generation. Other environmental impact such as noise pollution or impact to biodiversity is not material given the nature of our business activities. The following summarises our efforts in reducing our negative environmental impacts.

The Group has adopted the following measures for energy and resources saving during the Financial Year under Review:

- switch-off lighting, air-conditioning and computer monitors when leaving the office areas and workplaces to reduce electricity consumption;
- automatically switch off non-essential lighting in office areas and workspaces after office hours;
- install block-out curtains to keep out sunlight and heat during daytime and maintain a relatively lower room temperature;
- switch off all non-essential air-conditioning in retail stores when the retail stores are closed after operation hours;
- maintain air-conditioning temperature to avoid power wastage (in office generally at 24–26°C, in retail stores generally at around 24–25°C in autumn and winter seasons and at not lower than 19°C in summer season); and
- login with staff card when photocopying to encourage paper saving.

A.3 對天然資源的影響及管理行動

本集團相信,企業發展不應以犧牲環 境為代價。本集團對環境及天然資源 所帶來的重大影響體現在電力及材料 消耗以及廢物產生兩方面。鑑於集團 的業務活動的性質,噪音污染或生物 多樣性影響等其他環境影響並不顯 著。下文總結了集團在減少不利及負 面的環境影響方面所作的努力。

本集團已於本回顧財政年度採取以下 節約能源及資源措施:

- 離開辦公區域及工作場所時,關 掉照明、空調及電腦屏幕,以減 低電力消耗;
- 辦公時間後自動關上於辦公室範 圍及工作空間的非必要照明;
- 安裝遮擋窗簾,在白天遮擋陽光
 及熱力,保持相對較低的室溫;
- 零售店舖在營業時間後關門時, 關掉店內所有非必要的空調;
- 保持空調溫度以避免浪費電力(辦公室一般為攝氏24至26度,零售店舖於秋冬季節一般為攝氏24至25度左右、於夏季為不低於攝氏19度);及
- 複印文件時必須使用職員證登入,以鼓勵節約用紙。

For resources used in daily operation, the following measures have been adopted:

- paperless office is encouraged by using electronic POS, WMS and M18 and electronic note-taking. If that is not possible, paper used by the Group is sourced from suppliers which are certified to be in compliance with Forest Stewardship Council (FSC) Chain-of-Custody certification and promote double sided printing, where possible;
- collection boxes for one-sided paper are placed next to printers in office to encourage paper recycling;
- very thin thermal paper rolls used by cash registers of retail stores have been tested to be free from bisphenol A;
- tissue paper and towel paper used by the Group have been tested to be in compliance with GB standard 20810–2006 Bathroom Tissue (including bathroom tissue base paper);
- electronic salary statements have been adopted to exempt paper usage;
- time attendance system and leave application system of employees have been computerized to minimize paper usage;
- ink boxes and toner cartridges used by the Group are sourced from manufacturers which are certified to be in compliance with ISO 9001:2016;
- choosing vendors using water-based latex ink instead of traditional latex ink to print advertising materials;
- garbage classification has been implemented in the office and warehouse of the Group for the ease of waste recycling;

- 零售店舖的收銀機使用的特薄熱 敏紙卷經測試為不含雙酚A;
- 本集團使用的衛生紙及抹手紙經 測試為符合中國國家標準20810-2006《衛生紙(含衛生紙原紙)》;
- 採用電子糧單,以免除使用紙
 張;
- 僱員考勤系統及請假系統均已電 腦化,以減少使用紙張;
- 本集團使用的墨水匣及碳粉盒均 採購自符合ISO 9001:2016認證 的製造商;
- 選擇使用水基乳膠油墨而不是傳統乳膠油墨的供應商來印刷廣告 材料;
- 本集團的辦公室及倉庫已實行垃 圾分類,方便回收垃圾;

- all circulars and notices to retail stores are sent in electronic format to exempt paper usage;
- reduced the use of the undegradable plastic wrap by increasing the use of reusable ropes and nylon ties in replacement of the one-time packaging plastic wrap for bounding products and the use of pallet cage carts to secure products on the transition from warehouses to retail stores;
- reduced the use of disposable cutlery by increasing the use of washable cutlery and lunch boxes;
- reduced the use of single-use batteries by increasing the use of rechargeable electronic products; and
- encouraged effective internal lighting by daylighting if possible.

In addition, the Group promotes the quantitative reduction of wastage at source by:

- reducing food wastage by offering slow-moving and expiring products at clearance prices to customers;
- no festival gift wrapping in order to reduce the usage of wrapping paper; and
- strictly complying with the Product Eco-responsibility (Amendment) Ordinance 2014 and the plastic shopping bag levy in Hong Kong.

Looking ahead, aiming at growing the business without depleting the environment and natural resources, the Group will continue to review its operation and explore other possibilities to further diminish pollutants and waste, optimize energy consumption and improve energy efficiency.

此外,本集團推動源頭減廢,例如:

- 以清倉價向顧客出售滯銷及快將 過期的產品,以減少浪費食物;
- 不設節日禮品包裝,以減少使用
 包裝紙;及
- 嚴格遵守香港的《2014年產品環 保責任(修訂)條例》及塑膠購物袋 徵費規定。

展望將來,在尋求業務成長,但不竭 盡環境及天然資源的宗旨下,本集團 將繼續檢討其營運,不斷探索其他機 遇,以進一步減少污染及廢物、優化 能源消耗及改善能源效益。

A.4 Climate Change

Climate change is an issue that the Group is fully aware of and understands as being one that will inevitably affect all of the Group's business operations and its stakeholders. The Board is responsible for ensuring the Group is prepared to tackle both physical and transition climate risks, and the Group's vulnerability to these risks. The Group identifies the physical and transitional risks and related financial and operational impact. It has implemented a number of mitigation plans and measures in order to protect its assets against extreme weather and reduce the carbon footprint from its managed properties. Climate-related risks have been classified by the Group into physical and transition risks, which are as follows:

Physical Risk

Physical climate risks come in the form of extreme weather conditions in greater frequency and intensity, as well as rise in sea level. The operations of the Group are located in Hong Kong and Macau. Extreme weather conditions such as typhoons and heavy rains are expected to become more frequent with climate change. The Group has prepared contingency plans to cope with these threats. For example, the Group maintains comprehensive insurance to cover damage to the Group's assets arising from flooding and typhoons.

Transition Risk

Transition climate risks are the evolution of the regulatory, technological and market landscape due to climate change action. It is believed that environmental-related policies and regulations, such as waste reduction requirements, will be tightened in the future. The Group will promote and encourage employees to reduce waste in their daily business activities, and will also provide relevant information and resources to enhance responsiveness. The Group will monitor updates on climate change-related regulations on a periodic basis.

A.4 氣候變化

實體風險

實體氣候風險肇因於極端天氣情況發 生的頻率及強度加劇,以及海平面上 升。本集團的營運業務位於香港及澳 門。隨著氣候變化,預計颱風及暴雨 等極端天氣情況將變得更加頻繁。本 集團已擬備應變計劃,以應對此等威 脅。舉例而言,本集團投購承保範圍 較全面的保險,以保障本集團資產因 洪水及颱風而造成的損失。

過渡風險

過渡氣候風險為基於氣候變化行動而 帶來的監管、技術及市場格局的變革 所造成的風險。未來,相信將會收緊 各項環保相關政策及法規,如減廢要 求等。本集團將推動及鼓勵僱員於日 常業務活動中減少浪費,並將提供相 關資料及資源,以提高應對能力。本 集團將定期監察氣候變化相關法規的 最新動態。

B. SOCIAL

As a responsible business and employer, the Group seeks to maximize positive impacts on its staff and community, as well as its business partners. The Group is committed to consistently looking for ways to meet corporate social responsibilities.

B.1 Employment and labour practices

Human resources is a critical foundation of the Group's operations and is fundamental to achieving the continued development of the Group. The Group treats its employees as one of its valuable assets. The Group generally recruits employees from the open market. The recruitment process is conducted thoroughly and monitored by the human resources department to ensure fairness, factors such as their experience in the retail industry would be reviewed. The Group is an equal opportunities employer and is committed to providing equal opportunities in recruitment and promotion, regardless of age, gender, race, color, religion, nationality, marital status or disability.

The Group conducts performance reviews for its employees periodically and would assess salary adjustments and promotion appraisals based on their performance. The Group offers discretionary annual bonus to all of the employees and, for the front-line staff, performance-related bonus, sales target bonus and miscellaneous duties-related allowances. The Group also offers various benefit plans to the employees, including staff shopping discounts, top-up leave entitlement and medical insurance. The Group would regularly review its remuneration policy to ensure packages offered by the Group are appealing to employees, which could persistently increase the loyalty and incentives of employees.

B.2 Employee health and safety

The Group strives to promote safety awareness, improve occupational environment and reduce occupational risks and commits to providing a healthy and safe working environment for its employees. The Group complies with the Occupational Safety and Health Ordinance in all relevant requirements. The business operations do not involve high-risk or safety-sensitive types of work. To ensure that the business is operated in a safe environment and staff has the necessary knowledge on work safety, the Group has adopted and implemented work place safety guidelines for all our staff in the retail stores which set out the Group's work safety policies and promote safety in work sites. The Group has also conducted training sessions for employees to increase their knowledge of correct practices for health and safety in work place.

Accidents that occur in the work place will be reported to and handled by the human resources department to ensure injuries that occurred in the work place will be properly recorded, and that insurance claims and treatments are effectively pursued to protect the employees and the Group. The Group has not reported any fatalities in relation to its work during the reporting period of the past three years. During the Financial Year under Review, the number of working days lost due to work-related injury was 838 days.

B.2 僱員健康與安全

During the Financial Year under Review, the Group had no non-compliance case regarding violation of relevant laws and regulations on occupational health and safety.

B.3 Development and training

Enabling the Group's employees achieve to their full potential will ultimately benefit the Group in its future development plans. The Group provides various types of training to enhance the competency of our staff. For the newly recruited employees, orientation trainings for understanding the company background, code of conduct, workplace health and safety, customer service and grooming standard were provided. The Group also provided operations technical trainings, supervisory skills trainings and anti-corruption trainings to all staff to educate the them on the duties to comply with statutory obligations. The Group also supports employees' personal development through attending external trainings. The Group would provide sponsorship for the employees' personal development. Various types of relevant seminars or training courses are recommended to employees via email and they can choose to register either in person or through the Company.

B.4 Labour standards

The Group ensures equal opportunities for all employees and job applicants, particularly in recruitment, internal transfer, and promotion. Discrimination based on gender, age, religious belief, race, or any physical disability is strictly prohibited. Applicants' identities would be verified during the recruitment process. The Group strictly prohibits the use of child labour and forced or compulsory labour at all of its business units, and highly values and strictly abides by all applicable labour laws and regulations on employment in Hong Kong. If child or forced labour is discovered, the Group will terminate the employment contract immediately and assist the child to resume education and contact social workers to follow up. During the Financial Year under Review, the Group did not identify any non-compliance cases regarding violation of relevant child labour and forced labour laws.

B.5 Supply Chain Management

To maintain a quality, trendy and broadly appealing product mix in the retail stores with competitive prices, the selection of suppliers is crucial in decision-making. The Group generally maintains stable collaborative business relationships with the existing suppliers to regularly review new brands and products available in the markets around the world to keep abreast of information on new products available in the international market. 本集團亦支持僱員為自身個人發展參 加外部培訓。本集團會為僱員的個人 發展提供資助。各類相關研討會或培 訓課程乃透過電子郵件推薦予僱員, 彼等可選擇親自或透過本公司報名。

The Group has maintained a list of suppliers and typically works with trustworthy suppliers possessing a reliable corporate background, trading history and reputation. All of the potential suppliers would be screened by standardised criteria for evaluating the qualifications. Documents such as manufacturing and analysis certificates, health certificates, certificates of origin and/ or attestations, and certificates in relation to food or products safety and/or quality manufacturing process of the products, may need to be provided by the potential supplier for the screening process.

During the Financial Year under Review, the Group has engaged a total of 494 suppliers, of which 100% have undergone the supplier screening process. Choose the Right Partners Referencing to International Standards

We encourage our suppliers to adopt responsible and sustainable practices with respect to a range of environmental and social issues when engaging with new suppliers. This process gives preference to suppliers which integrate considerations for environmental conservation, protection of endangered species, protection of labour rights and welfare, equal opportunities, non-participation in animal testing, and responsible sourcing into their own operations. When selecting logistics partners for the distribution of goods from our central warehouse to our stores, environmental protection is one of our selection criteria.

During the Financial Year under Review, the Group implemented an ESG supplier assessment policy (the "**ESG Supplier Assessment**") that makes it mandatory to assess its major suppliers regarding its ESG practices during the tender process. In this way, the Group endeavours to achieve a balance of sourcing from suppliers that offer competitive pricing and quality goods and to excluding suppliers that have not complied with the Group's requirements on environmental protection, employee health and rights, information security requirements and ethics. The ESG Supplier Assessment also gives preference to those that offer products that have positive environmental and/or social characteristics, such as products with recycled packaging or manufactured by small local businesses.

The Group would review approved suppliers periodically in terms of product quality, services standard and reputation to ensure product quality and services are maintained at a satisfactory level. The Group would assess the appropriateness of packaging of products provided by individual approved suppliers on their arrival, the consistency of guality between sample products and products ordered and delivered, any quality issue(s) on products provided by individual approved suppliers and its/their nature and materiality of such issue(s) and the overall satisfactory level on the quality of products provided by individual approved suppliers based on customers' feedback. Recommendations would be provided to suppliers which are unable to meet the guiding standards for periodical review, and the suppliers will be removed from the list of suppliers until appropriate remedial measures are taken to the Group's satisfaction.

B.6 Product responsibility

The Group puts great efforts into maintaining product quality and safety, which includes establishing procedures to ensure that the products procured are in full compliance with the food safety, food labelling and consumer goods safety-related laws and regulations in Hong Kong. The Group has set up a quality control team and they are responsible for monitoring and assessing the compliance of products to be procured with the relevant Hong Kong laws and regulations before placing purchase orders. Relevant documents or certificates that could warrant the accuracy and completeness of products should be provided by the suppliers. The Group's logistic team performs designated quality check procedures and checks the inclusion of printed label information on product packages or the status of affixation of applicable product labels on such products at the warehouse. The products are checked regularly in store by the front-line sales to maintain the safety and quality of the in-store inventory and to ensure relevant product labels are duly affixed.

B.6 產品責任

本集團在維持產品品質及安全上作出 了極大努力,包括建立多項程序以確 保所採購的產品完全符合香港的食品 安全、食品標籤及消費品安全的相關 法律及法規。本集團已成立品質控制 **團隊,負責在下達採購訂單前監控及** 評估擬採購的產品是否符合相關香港 法律及法規。供應商應提供文件或證 明,以保證相關產品的準確性及完整 性。本集團的物流團隊會於倉庫內執 行指定的品質檢查程序,檢查產品包 裝上是否已印有標籤資料或是否已貼 上適用的產品標籤。前線銷售人員定 期於店舖內檢查產品,以維持店內存 貨的安全及品質,並確保產品已妥為 貼上相關標籤。

During the Financial Year under Review, an independent food testing laboratory had been engaged to conduct laboratory tests that are necessary for private label products to safeguard and ensure the compliance of relevant laws and regulations for such original equipment manufacturer products, such as product labels requirements and to uplift food safety standard.

The Group is committed to complying with relevant laws and regulations on customer data protection and privacy. The personal information of customers collected by the Group through the membership scheme are kept in strict confidence and is only used for specific intended purposes. The Group has established internal guidelines to ensure compliance with the Personal Data (Privacy) Ordinance of Hong Kong.

The Group implements a complaint handling procedure. When the Group receives customer complaints, the information of the customers and corresponding stores is recorded. The record is kept for three years in the customer service department. Each complaint is investigated and recommendations of solutions, responses and/or decisions is provided post-investigation. Exchange or refund is offered if the complaint is valid and is about unsatisfactory product quality. During the Financial Year under Review, the Group has received 292 complaints about products and services and no products were required to be recalled. In the event of any recall, whether announced by the government, notified by media, requested by suppliers or identified during product monitoring process, we will arrange the goods to be removed from shelves and notify the staff on the suspension of sales of these products. All relevant departments will be informed for following up the incident. Media and PR agencies will be notified after our investigation when appropriate. The Group will also share the information with the government departments upon request.

本集團訂有一套投訴處理程序。本集 團於收到客戶投訴時,會記錄客戶及 相應店舗的資料。有關紀錄於客戶服 務部保存三年。每項投訴均會展開調 查,並於調查後提供建議,包括解決 方案、回應及/或決定。倘發現投訴 屬實,而有關投訴涉及產品品質,本 集團將會提供換貨或退款。於回顧財 政年度,本集團共收到292宗關於產 品及服務的投訴,並無產品需要被召 回。倘基於政府宣佈、媒體報導、供 應商要求或在產品檢測過程中發現而 須召回任何產品,本集團會安排有關 貨品下架,通知員工暫停出售有關貨 品,並通知各相關部門對事件進行跟 進。本集團於調查結束後,將適時通 知媒體及公關機構。本集團亦會應要 求向政府部門分享有關資料。

The Group is committed to complying with relevant laws and regulations such as Colouring Matter in Food Regulations (Cap.132H), Sweeteners in Food Regulations (Cap.132U), Food Adulteration (Metallic Contamination) Regulations (Cap.132V), Consumer Goods Safety Ordinance (Cap. 456), Trade Descriptions Ordinance (Cap. 362), Food Safety Ordinance (Cap. 612), etc. that constitute a significant impact on the Group in relation to health and safety, labelling and privacy matters. The Group's OA department would perform the random checking of the goods including packaging and food labels regularly, the goods department would need to reprint the correct label and the packaging department would re-packed the goods if the label is wrong or the packaging quality is not up to standard. The Group would accept the punishment for any violations of laws and regulations. The Group did not have any material product non-compliance during the Financial Year under Review.

Intellectual Property Rights

The Group respects intellectual property rights and is committed to observe and comply with the relevant laws including the Copyright Ordinance (Cap. 528 of the Laws of Hong Kong) and the Trade Marks Ordinance (Cap. 559 of the Laws of Hong Kong). The Group regularly consults its legal advisor on any potential issues relating to infringement of intellectual property rights of third parties. In addition, in an effort to protect the Group's intellectual property rights and interests, the Group's trademarks have been duly registered and the Group will take prompt action to respond to any violation of its intellectual property rights upon detection, including but not limited to obtaining legal advice from its legal advisor on any course of legal action available. During the Financial Year under Review, the Group was not aware of any material non-compliance with the relevant laws and regulations concerning the intellectual property and privacy of its products and services that may have a significant impact on the Group.

B.7 Anti-corruption

The Group is strongly against bribery, extortion, fraud and money laundering and is committed to the highest possible standards of openness, probity and accountability. We have implemented various policies and procedures, including but not limited to the Conflict of Interest Policy, Whistleblowing Policy, and Code of Conduct for Suppliers and Contractors, which outline the required standards of conduct. These policies and procedures are periodically reviewed and updated as needed. They are accessible via our Company's intranet, with certain policies also publicly available on our website. All employees must fully comply with the relevant laws and regulations as well as the Group's corruption prevention policies.

During the Financial Year under Review, anti-corruption trainings were conducted for executive Directors and staffs to enhance their understanding of the anti-corruption laws as well as to enhance ethical management and staff integrity. The breakdown of training participation is shown as follows:

To maintain a high standard of corporate governance, the Group acknowledges the importance of enhancing its transparency to the community. The Group actively participates in various community involvement programs or charity events to support the development of healthy life, to cater the needs of local community, to enhance fraternal cooperation in the community and to create a better community.

The Group has actively participated in environmental protection activities and has been accredited the Certificate of Merit of "Hong Kong Awards for Environmental Excellence" by Hong Kong Productivity Council.

The Group consistently adheres to the principle of "Taking from Society, Giving Back to Society", actively caring for disadvantaged groups and participating in social affairs by organizing volunteer teams to engage in community activities, addressing the needs of society.

To express gratitude for the contributions of the elderly to society, we hold Senior Citizen Discount Day every Tuesday in stores. In addition, the Group donated a total of 1,000 gift bags to the elders in February and April 2024, with a total value of over HKD200,000, aiming to alleviate the burden on grassroots elders and let them feel the care of society. At the same time, a Poon Choi Feast with 44 tables was held in the community, inviting over 500 elders to attend and share the festive blessings of the Lunar New Year. Before the Poon Choi Feast, the volunteer team of Best Mart 360° visited several elderly residents living in public housing estates in person to understand their daily needs.

The first event, "Best Mart 360° Mental Health Martial Arts Exercise", was held in February 2024, where all students performed martial arts exercises together during the morning assembly. This allowed students to experience Chinese culture in person and understand the benefits of exercising more, enhancing their physical strength, alleviating emotions and stress. The Group also sponsored the entire sixth grade of the school to participate in a Guangxi Guilin exchange tour during the Easter holiday, and provided various healthy snacks to participants during the trip. In addition, the Care Project launched a three-week walking activity "One More Step to Health, Best Mart Can Do It" at the end of April, encouraging students from third grade to fifth grade to walk at least 8,000 steps daily to enhance stress resilience and face life with a positive attitude.

On 7 January 2024, the Group participated in the Community Chest 55th Anniversary Walk for Millions, walking 6 kilometers on the Hong Kong-Zhuhai-Macau Bridge. The Company collectively supported this charitable event, raising funds for 24 social welfare organisations under the Community Chest that provide "Family and Child Welfare Services", assisting families in need, preventing and addressing individual or family issues, and offering support services.

The Group organised the "Caring Rice Dumpling" event on 1 June 2024, dispatching a volunteer team to collaborate with 15 families in making alkaline rice dumplings to celebrate the festival, jointly experience the traditional festive atmosphere, and distributed a total of 700 gift bags to grassroots families in the community, delivering care and warmth. 針對香港學童情緒健康問題,本集團 連續第二年與鳳溪第一小學合作,舉 行關愛活動「關注健康•動喜來」,推出 一系列活動以鼓勵學生多走動並放眼 世界,追求身心健康,提升正能量。 首項活動在二零二四年二月份舉行, 「優品360°精神健康武藝操」, 全體學 牛在早會上一同耍武藝操,讓同學親 身體驗中國文化外,從而了解多做運 動的好處,增強體魄,紓緩情緒及壓 力;本集團亦在復活節假期贊助該校 全級小六學生參與廣西桂林交流團, 包括於旅程中提供各款健康零食予參 加者。此外,關愛項目在四月底展開 為期三周的健步活動「健康多一步・優 品做得到」,鼓勵三至五年級學生同學 每天步行至少8,000步,從而增強抗壓 力,以正面態度面對生活。

二零二四年一月七日,本集團參與公益金五十五周年百萬行,並步行全長6 公里的港珠澳大橋,本公司上下共襄 善舉,為公益金旗下24間提供「家庭及 兒童福利服務」的社會福利機構籌得善 款,協助有需要家庭,預防及處理個 人或家庭問題,提供輔助服務。

本集團在二零二四年六月一日舉辦「愛 心包糭」活動,派出義工隊與15組家庭 合力製作鹼水糭應節,一同感受傳統 節日氣氛,並向地區基層家庭送贈共 700個福袋,送上關懷及溫暖。

In October 2024, the Group collaborated for the first time with the community public service brand "China Merchants Happy Community" under China Merchants Group, and distributed "China Merchants Happy Community Best Mart 360° Heartwarming Vouchers" to needy elderly and low-income families in multiple districts through 15 community members on the eve of the National Day, benefiting approximately 75,000 individuals. PRINCIPAL ACTIVITIES

The Company is an investment holding company and the Group is principally engaged in the retail sale of prepackaged leisure foods and other grocery products, which can be broadly categorised into (i) chocolates and confectioneries; (ii) packaged bakery products and snacks; (iii) nuts and dried fruits; (iv) grain and other miscellaneous food products; (v) beverages and wine; (vi) personal care products; and (vii) other products. The principal activities of the subsidiaries are set out in note 28 to the consolidated financial statements.

BUSINESS REVIEW

業務回顧

Risks related to the global and local economic environment

The global economy continues to face considerable challenges, with the International Monetary Fund (IMF) projecting economic growth of 3.3% for both 2025 and 2026, below the historical (2000–19) average of 3.7%. Medium-term risks remain tilted to the downside, driven by elevated policy uncertainty, restrictive monetary policies, geopolitical tensions, and diverging fiscal policies. These factors may disrupt the disinflation process, delay the implementation of monetary easing policy, and exacerbate economic disparities.

Uncertainties in the global economy and business environment may lead to fluctuating exchange rates. As the Group adheres to its global procurement policy by sourcing products worldwide, part of the Group's purchase cost, which are settled in foreign currencies, may increase, thus negatively impacting profitability.

In Hong Kong, the local economy continues to face headwinds stemming from global economic uncertainties, geopolitical risks, and underperformance in the equity and real estate markets. The persistent strength of the Hong Kong Dollar has adversely impacted local competitiveness. Trade protectionist policies implemented by the United States have disrupted global trade flows, weakened Hong Kong's goods exports, and contributed to prolonged currency strength, further diminishing export and retail competitiveness.

The retail sector has experienced significant pressures due to changing consumption patterns, reduced local demand driven by outbound travel, and increased cross-border shopping. High operational costs, particularly elevated rents and staff costs, continue to weigh heavily on retail businesses.

全球經濟仍然面臨相當大的挑戰,國際貨幣基 金組織(IMF)預測二零二五年及二零二六的經 濟增長率均為3.3%,低於3.7%的歷史(二零 零零年至二零一九年)平均值。在政策不確定 提高、限制性貨幣政策、地緣政治緊張以及財 政政策分化的驅動下,中期風險仍然傾向於下 行趨勢。該等因素可能會破壞通貨膨脹的消退 過程、延遲貨幣寬鬆政策的實施及激化經濟差 距。

全球經濟及商業環境的不確定性可能導致匯率 波動。由於本集團堅持全球採購政策,在世界 各地採購產品,部分本集團的採購成本(以外幣 結算)可能會增加,因此,對盈利能力產生負面 影響。

在香港,本地經濟仍然面對來自全球經濟不明 朗、地緣政治風險以及股票和房地產市場表現 不佳等方面的逆風。港元持續強勢對本地競爭 力造成不利影響。美國實施貿易保護主義政策 破壞全球貿易流動,削弱香港貨物出口,並導 致持續的貨幣強勢,進一步削弱出口及零售競 爭力。

由於消費模式轉變、外遊引致本地需求減少以 及跨境購物增加,零售業承受龐大壓力。運營 成本高昂,特別是租金和員工成本上漲,繼續 嚴重拖累零售業務。

The economic landscape presents several risks, including global and local economic uncertainties, fluctuating exchange rates, high operational costs, and evolving consumer behaviour. These factors are expected to pose challenges to profitability and business performance in 2025.

During the Financial Year under Review, there was no material and significant dispute between the Group and its employees, customers and suppliers.

- (viii) any other group or classes of participants who have contributed or may contribute by way of joint venture, business alliance or other business arrangement to the development and growth of the Group,

and, for the purposes of the Share Option Scheme, the options may be granted to any company wholly owned by one or more Eligible Participants.

The Share Option Scheme will remain in force for a period of 10 years commenced on the adoption date, i.e. 18 December 2018. The remaining life of the Share Option Scheme is around 4 years.

(f) Time of acceptance and exercise of option

An option may be accepted by a participant within 21 days from the date of the offer of grant of the option.

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by the Directors to each grantee, which period may commence on the date on which the offer for the grant of option is made but shall end in any event not later than 10 years from the date on which the offer for the grant of option is made subject to the provisions for early termination thereof. Unless otherwise determined by the Directors and stated in the offer of the grant of options to a grantee, there is no minimum period required under the Share Option Scheme for the holding of an option before it can be exercised.

(g) Subscription price for Shares and consideration for the option

The subscription price per Share under the Share Option Scheme shall be determined at the absolute discretion of the Directors, provided that it shall not be less than the highest of (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date on which the offer for the grant of option is made, which must be a business day; (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations for the five business days immediately preceding the date on which the offer for the grant of option is made; and (iii) the nominal value of the Shares.

A nominal consideration of HK\$1.00 is payable on acceptance of the grant of an option.

DIRECTORS' AND SUBSTANTIAL SHAREHOLDERS' INTEREST IN COMPETING BUSINESS

As at 31 December 2024, save for Mr. Lin Tsz Fung who is also the chairman and chief executive officer of other retail stores in Hong Kong principally engaged in the sales of footwear and lifestyle products as disclosed in the prospectus of the Company dated 28 December 2018, none of the Directors and substantial shareholders of the Company and its subsidiaries, or their respective close associate, had interests in businesses which compete or are likely to compete, either directly or indirectly, with the businesses of the Company and its subsidiaries as required to be disclosed pursuant to the Listing Rules. Given the overall nature of such retail products of Mr. Lin's other business is substantially different from the principal products of the Company i.e. prepackaged leisure food, the Directors are of the view that the competition between such retail businesses of Mr. Lin and the Group is relatively minimal and remote.

During the Financial Year under Review and up to date of this report, the Company has in force indemnity provisions for the benefit of the Directors. CONNECTED TRANSACTIONS AND CONTINUING CONNECTED TRANSACTIONS

During the Financial Year under Review, the Group entered into the following transactions, which constituted connected transactions and continuing connected transactions under the Listing Rules, and are required to be disclosed in accordance with Chapter 14A of the Listing Rules:

(a) Connected and continuing connected transactions in relation to On Yam Estate Tenancy Agreement and Shek Wai Kok Estate Tenancy Agreement

Reference is made to the announcement of the Company dated 14 September 2023 (the "**14 September Announcement**"). On 14 September 2023, CIAO International Limited ("**CIAO International**") (a whollyowned subsidiary of the Company) entered into (i) a tenancy agreement with Glorious Supreme Limited (as landlord) for a term of three years for the lease of the On Yam Estate Property (as defined in the 14 September Announcement) (the "**On Yam Estate Tenancy Agreement**"); and (ii) a tenancy agreement with King Worldwide Holdings Limited (as landlord) for a term of three years for the lease of the Shek Wai Kok Estate Property (as defined in the 14 September Announcement) (the "**Shek Wai Kok Estate Tenancy Agreement**"), respectively.

The monthly rental of the On Yam Estate Property comprises of (i) monthly base rent of HK\$50,000 ("**On Yam Property Fixed Base Rent**"); and (ii) a turnover rent of 5% monthly gross receipts exceeding the On Yan Property Fixed Base Rent, exclusive of government rates, management charge air-conditioning charge and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$178,047 in respect of the On Yam Estate Property.

The monthly rental of the Shek Wai Kok Estate Property comprises of (i) monthly base rent of HK\$50,000 ("**Shek Wai Kok Property Fixed Base Rent**"); and (ii) a turnover rent of 5% monthly gross receipts exceeding the Shek Wai Kok Property Fixed Base Rent, exclusive of government rates, management charge air-conditioning charge and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$189,099 in respect of the Shek Wai Kok Estate Property.

安蔭邨物業的月租包括:(i)每月基本租金 50,000港元(「安蔭邨物業固定基本租金」); 及(ii)按每月總收入5%計算超出安蔭邨物業 固定基本租金的營業額租金,不包括政府 差餉、管理費、空調費及其他支出,但包 括政府地租。彩鷗國際亦須就安蔭邨物業 繳付按金178,047港元。

石圍角邨物業的月租包括:(i)每月基本租 金50,000港元(「石圍角邨物業固定基本租 金」);及(ii)按每月總收入5%計算超出石圍 角邨物業固定基本租金的營業額租金,不 包括政府差餉、管理費、空調費及其他支 出,但包括政府地租。彩鷗國際亦須就石 圍角邨物業繳付按金189,099港元。 The Group's lease of the On Yam Estate Property and the Shek Wai Kok Estate Property to operate the "Best Mart 360°" brand retail stores shall optimize the Group's retail store-location strategy and enhance the Group's overall performance.

As detailed in the 14 September Announcement, based on the then present value of the aggregated fixed rental payments for the entire terms of the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement as discounted using a discount rate which is equivalent to the Company's incremental borrowing rate, the aggregated value of right-of-use assets of the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement recognised by the Company in accordance with HKFRS 16 amounted to approximately HK\$3,078,000.

The variable turnover rents under the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement will be recognized as expenses of the Group over the term of the respective tenancy agreement. Both Glorious Supreme Limited and King Worldwide Holdings Limited are wholly-owned by Mr. Lin Tsz Fung, a substantial Shareholder and an executive Director. Accordingly, each of Glorious Supreme Limited and King Worldwide Holdings Limited is a connected person of the Company under the Listing Rules. As such, the payment of fixed base rents under the tenancy agreements will be regarded as one-off connected transactions, whereas the payment of variable turnover rents constitutes continuing connected transactions pursuant to the Listing Rules.

(b) Continuing connected transactions in relation to CMHT Sales and Procurement Framework Agreement

Reference is made to the announcement of the Company dated 26 January 2024. On 26 January 2024, the Company (for itself and on behalf of its subsidiaries) and CMHT (for itself and on behalf of its subsidiaries other than the Group) entered into a sales and procurement framework agreement (the "**CMHT Sales and Procurement Framework Agreement**") for the term of one year from 1 January 2024 to 31 December 2024. As CMHT is a substantial Shareholder, the entering into the CMHT Sales and Procurement Framework Agreement between the Company and CMHT and the transactions contemplated thereunder constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules. 誠如九月十四日公告所詳述,由於安蔭邨 租約及石圍角邨租約項下可變動營業額租 金年度上限總額的所有適用百分比率低 於5%,且有關年度上限低於3,000,000港 元,故根據上市規則第14A章,該等持續 關連交易可豁免遵守申報、年度審閲、公 告及獨立股東批准的規定。

On 12 April 2024, (i) CIAO International (a wholly-owned subsidiary of the Company) and China Merchants Bonded Logistics Co., Limited ("CMBL"), a company held by China Merchants Port Holdings Company Limited ("CMPH") as to 60% and China Merchants Port Group Co., Ltd as to 40%, which is a substantial shareholder of CMPH, entered into a logistics services framework agreement (the "CMBL Logistics Services Framework Agreement") for a term from 12 April 2024 to 31 December 2026; and (ii) CIAO International and China Merchants Qian Hai Wan (Shenzhen) Supply Chain Management Co., Ltd. ("CMQHW"), a company indirectly held by CMPH as to 60% and China Merchants Port Group Co., Ltd. as to 40%, entered into a transportation framework agreement (the "CMQHW Transportation Framework Agreement") for a term from 12 April 2024 to 31 December 2026.

As CMHT, a substantial shareholder of the Company, and both CMBL and CMQHW are indirect subsidiaries of China Merchants Group Limited, each of CMBL and CMQHW is considered as an associate of CMHT, and therefore a connected person of the Company as defined under the Listing Rules. As such, the entering into of (i) the CMBL Logistics Services Framework Agreement between CIAO International and CMBL and (ii) the CMQHW Transportation Framework Agreement between CIAO International and CMQHW, and the respective transactions contemplated thereunder constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

Pursuant to the CMBL Logistics Services Framework Agreement, CIAO International and CMBL agree that (i) CMBL shall provide customs clearance, warehousing and related logistics services to CIAO International for its goods, and (ii) CIAO International shall appoint CMBL as its sole customs clearance service provider in Shenzhen Qianhai Comprehensive Bonded Zone (深圳前海綜合保税 匾) (the "CMBL Transactions"). Pursuant to the CMQHW Transportation Framework Agreement, CIAO International and CMQHW agree that CMQHW shall provide land transportation services of goods between Shenzhen and Hong Kong and other supporting services to CIAO International (the "CMQHW Transactions").

(c) 有關招商保税物流服務框架協議及招商前 海灣運輸框架協議的持續關連交易

Given that CMPH is a leading provider of bonded logistics in the PRC in particular in Shenzhen, the Group can leverage on the cooperation with CMPH and CMPH's bonded logistics services to manage the logistics and transportation of the Group's products more efficiently. This collaboration grants the Group access to reliable and cost-effective supply chain solutions in Mainland China, especially when the Group is tackling the current labour shortage while simultaneously expanding its retail operations in Hong Kong. 截至二零二四年十二月三十一日止年度, 招商保税交易及招商前海灣交易金額分別 約為6,902,000港元及3,117,000港元。

(d) Connected transaction and continuing connected transactions in relation to Stanley New Street Tenancy Agreement

Reference is made to the announcement of the Company dated 12 April 2024. On 12 April 2024, CIAO International (as tenant) and Mr. Lin Hiu San Burton (as landlord) entered into a tenancy agreement (the "Stanley New Street Tenancy Agreement") for a term of three years from 22 April 2024 to 21 April 2027 (both days inclusive) for the lease of the Stanley New Street Property (as defined in the announcement of the Company dated 12 April 2024). Pursuant to the Stanley New Street Tenancy Agreement, CIAO International shall pay Mr. Lin Hiu San Burton (i) a monthly base rent of HK\$110,000 ("Fixed Base Rents") and (ii) a turnover rent of 8% monthly gross receipts exceeding the Fixed Base Rents ("Variable Turnover Rents"), exclusive of government rates, management charges and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$344,100 in respect of the Stanley New Street Property.

Mr. Lin Hiu San Burton is the son of Mr. Lin Tsz Fung, a substantial Shareholder and an executive Director. Accordingly, Mr. Lin Hiu San Burton is a connected person of the Company under the Listing Rules. Hence, the payment of the Fixed Base Rents under the Stanley New Street Tenancy Agreement will be regarded as a one-off connected transaction, whereas the payment of the Variable Turnover Rents under the Stanley New Street Tenancy Agreement will be regarded as continuing connected transactions under Rule 14A.31 of the Listing Rules.

As detailed in the announcement of the Company dated 12 April 2024, based on the then present value of the aggregated Fixed Base Rents for the entire terms of the Stanley New Street Tenancy Agreement as discounted using a discount rate which is equivalent to the Company's incremental borrowing rate, the value of right-of-use assets of the Stanley New Street Tenancy Agreement recognized by the Company in accordance with HKFRS 16 amounted to approximately HK\$3,587,737.

(d) 有關赤柱新街租約的關連交易及持續關連 交易

The payment of variable turnover rents for the year ended 31 December 2024 under the Stanley New Street Tenancy Agreement is nil.

The Group's lease of the Stanley New Street Property to operate the "Best Mart 360°" brand retail store is conducted after comprehensive market research and assessment. The Group considers that the location of the Stanley New Street Property is suitable for the opening of a new "Best Mart 360°" shop, which optimizes the Group's retail store-location strategy and enhances the Group's overall performance.

As detailed in the announcement of the Company dated 12 April 2024, as all the applicable percentage ratios in respect of the aggregated annual caps for the payment of variable turnover rents under the Stanley New Street Tenancy Agreement are less than 5% and less than HK\$3,000,000, such continuing connected transactions are exempted from the reporting, annual review, announcement and the independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

On 27 December 2024, as the CMHT Sales and Procurement Framework Agreement was due to expire on 31 December 2024, the Board announced that, on 27 December 2024 (after trading hours), the Company (for itself and on behalf of its subsidiaries) and CMHT (for itself and on behalf of its subsidiaries other than the Group) entered into a new sales and procurement framework agreement (the "New CMHT Sales and Procurement Framework Agreement") in order to regulate the CMHT Procurement Transactions and CMHT Sales Transactions for the term of three years from 1 January 2025 to 31 December 2027. As CMHT is a substantial Shareholder, the entering into the New CMHT Sales and Procurement Framework Agreement between the Company and CMHT and the transactions contemplated thereunder constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

Pursuant to the New CMHT Sales and Procurement Framework Agreement, the parties may, from time to time during the term of the New CMHT Sales and Procurement Framework Agreement, enter into specific procurement and sales order(s) in respect of (i) the CMHT Sales Transactions; and (ii) the CMHT Procurement Transactions, which will specify, among others, the type, price, quantity, delivery date of the products to be sold or procured, and other ancillary clauses (if appropriate), which shall be subject to the terms of the New CMHT Sales and Procurement Framework Agreement.

For those related party transactions that constituted connected transactions or continuing connected transactions (as the case may be) (other than those described in the section above headed "Connected transactions and continuing connected transactions") under the Listing Rules, such transactions were fully exempt from Shareholders' approval, annual review and all disclosure requirements under Chapter 14A of the Listing Rules.

DONATIONS

The Group had made charitable or other donations of approximately HK\$553,000 during the Financial Year under Review.

Valuation of inventories

Refer to Note 5 "Key Sources of Estimation Uncertainty" and Note 17 "Inventories" to the consolidated financial statements.

The key audit matters

The Group held significant inventories as at 31 December 2024, which comprised finished goods in respect of food and beverage, household and personal care products. Inventories are stated at the lower of cost and net realisable value.

Management assessed the level of write-downs of inventories required at the reporting date after considering inventory ageing and other relevant factors. Such assessment involves significant management judgement and estimation in determining the value of inventories which will not be recoverable at the reporting date.

We identified the valuation of inventories as a key audit matter because inventories are significant to the consolidated financial statements and because of the significant degree of management judgement involved in determining the write-down of inventories.

How the matter was addressed in our audit

- obtaining an understanding of and assessing the application of the Group's key internal controls over the inventory writedown assessment process;
- comparing the cost of goods with third party supplier invoices, on a sample basis;
- selecting inventory items, on a sample basis, at the reporting date and comparing their carrying value with their subsequent selling prices as indicated in sales invoices subsequent to the reporting date; and
- assessing the historical accuracy of management's calculation of write-downs of inventories at the end of the previous financial year during the current financial year.

1. GENERAL

Best Mart 360 Holdings Limited (the "**Company**") was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 24 January 2018. The address of the Company's registered office is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands and its principal place of business in Hong Kong is 11th Floor, C-Bons International Centre, No. 108 Wai Yip Street, Kowloon, Hong Kong.

The Company is an investment holding company and its subsidiaries (collectively referred to as the "**Group**") are principally engaged in retailing of food and beverage, household and personal care products under the "Best Mart 360° (優品360°)" and "FoodVille" brand stores in the Hong Kong Special Administrative Region ("**Hong Kong**"), the Macau Special Administrative Region ("**Macau**") and the Mainland of People Republic of China ("**PRC**") and wholesaling in Hong Kong.

The directors consider the ultimate controlling party of the Group to be China Merchants Group Limited, which was established in the PRC.

The consolidated financial statements are presented in Hong Kong Dollars ("**HK\$**"), which is also the functional currency of the Company and its subsidiaries and all values are rounded to the nearest thousand except when otherwise indicated.

The consolidated financial statements for the year ended 31 December 2024 were approved and authorised for issue by the board of directors of the Company on 25 March 2025.

1. 一般事項

Application of amendments to HKFRSs (Cont'd)

Expect as described below, the application of the new and amendments to HKFRSs in the current period has had no material effect on the Group's financial performance and positions for the current and prior periods and/or on the disclosures set out in these consolidated financial statements.

Impact on application of Amendment to HKAS 1 Classification of Liabilities as Current or Non-current and the related amendments to Hong Kong Interpretation 5 (the "2020 Amendment"); and Amendment to HKAS 1 – Non-current Liabilities with Covenants (the "2022 Amendments")

The 2020 Amendments clarify the requirement for classifying liabilities as current or non-current, including what is meant by a right to deferred settlement and that a right to defer must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement. The amendments also clarify that a liability can be settled in its own equity instruments, and that only is a conversion option in a convertible liability is itself accounted for as an equity instrument would the terms of a liability not impact its classification. The 2022 Amendments further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date effect the classification of that liability as current or non-current. Additional disclosures are required for non-current liabilities that are subject to the entity complying with future covenants with 12 months after the reporting period.

The amendments add subsequent measurement requirements for sale and leaseback transactions that satisfy the requirements of HKFRS 15 Revenue from Contracts with Customers to be accounted for as a sale. The amendments require a seller-lessee to determine "lease payment" or "revised lease payments" such that the seller-lessee would not recognized a gain or loss that related to the right of use retained by the seller-lessee.

The application of the amendments had no material impact on the consolidated financial statements of the Group.

Impact on application of Amendments to HKAS 7 and HKFRS 7 Supplier Finance Arrangements

The amendments clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. 4. MATERIAL ACCOUNTING POLICY INFORMATION

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis at the end of each reporting period.

Historical cost is generally based on the fair value of the consideration given in exchange for goods.

The material accounting policies are set out as below.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Group.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns.

The Company reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of these elements of control stated above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Basis of consolidation (Cont'd)

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to owners of the Company and to the non-controlling interest. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

Revenue from contracts with customers

Revenue is recognised to depict the transfer of promised goods to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods. Specifically, the Group uses a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation.

The Group recognised revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods underlying the particular performance obligation is transferred to customers.

A performance obligation represents a good or service (or a bundle of goods) that is distinct or a series of distinct goods that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- The Group's performance creates and enhances an asset that the customer controls as the asset is created and enhanced; or
- The Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct goods or service.

Revenue is measured based on the consideration to which the Group expects to be entitled in a contract with a customer, excludes amounts collected on behalf of third parties, discounts and sales related taxes.

Contract liabilities

A contract liability represents the Group's obligation to transfer goods to a customer for which the Group has received consideration from the customer.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

The Group recognised revenue from the following major sources:

- Sale of goods retail
- Sale of goods wholesale
- Customer loyalty programme

Sale of goods - retail

The Group sells goods directly to retail customers within retail stores. Revenue recognised from sale of goods to retail customers is recognised at a point in time when the product is transferred to the customers upon sale. Payment of the transaction price is due immediately when the customers purchase the good. The payment is usually settled in cash or using credit cards, octopus card, Alipay, WeChat pay and other electronic payment platform.

Sale of goods - wholesale

Sales are recognised at a point in time when control of the products has been transferred, being when the products are delivered to the wholesaler, the wholesaler has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that affects the wholesaler's acceptance of the products.

Discount, coupons and other cash incentives to retail customers and discount to wholesale customers are accounted for as reduction of the transaction prices.

Customer loyalty programme

The Group operates a loyalty programme where retail customers accumulate points for purchases made which entitle them to redeem award points for discounts in future purchases. The transaction price is allocated to the product and the award points on a relative stand-alone selling price basis. Revenue from the award points is recognised when the award points are redeemed. Contract liabilities are recognised until the award points are redeemed. Contract liabilities in relation to customer loyalty programme were included in "Accruals and other payables".

Leasing

Definition of a lease

A contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration.

The Group as lessee

The Group assesses whether a contract is or contains a lease, at inception of the contract or modification date or acquisition date, as appropriate. The Group recognises a right-of-use asset and a corresponding lease liability with respect to all lease arrangements in which it is the lessee, except for short-term leases (defined as leases with a lease term of 12 months or less from the commencement date and do not contain a purchase option) and leases of low value assets. For these leases, the Group recognises the lease payments as an operating expense on a straight-line basis over the term of the lease unless another systematic basis is more representative of the time pattern in which economic benefits from the leased assets are consumed.

顧客忠誠計劃

本集團設有忠誠計劃,零售顧客可藉購物 累積積分,並兑換獎賞積分作為未來購物 折扣之用。交易價格基於相對獨立售價分 配至產品與獎賞積分。獎賞積分所帶來的 收益於獎賞積分獲兑換時確認;合約負債 則一直確認,直至獎賞積分獲兑換為止。 涉及顧客忠誠計劃的合約負債乃計入「應計 費用及其他應付款項」。

租賃

租賃的定義

如果合約賦予客戶在一段時期內控制特定 資產的使用的權利以換取代價,則該合約 屬租賃或包含租賃。

本集團作為承租人

本集團在合同開始時或修改日或收購日(如 適用)評估合約是否為或包含租賃。本集團 就其為承租人的所有租賃安排,確認一項 使用權資產和相應的租賃負債,但短期租 賃(定義為自開始日期始租期不超過12個月 的租賃且不包含購買選擇權)和低價值資產 租賃除外。就該等租賃而言,本集團於有 關租賃期內以直線法將與該等相關之租賃 付款確認為營運費用,除非另一系統化基 準更能體現耗用租賃資產所產生的經濟利 益的時間模式則除外。

Lease liabilities

At the commencement date, the Group measures lease liability at the present value of the lease payments that are not paid at that date. The lease payments are discounted by using the interest rate implicit in the lease. If this rate cannot be readily determined, the Group uses its incremental borrowing rate.

Lease payments included in the measurement of the lease liability comprise fixed lease payments (including in-substance fixed payments).

The lease liability is presented as a separate line in the consolidated statement of financial position.

The lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability (using the effective interest method) and by reducing the carrying amount to reflect the lease payments made.

Lease liability is remeasured (and with a corresponding adjustment to the related right-of-use asset) whenever:

- the lease term has changed or there is a significant event or change in circumstances resulting in a change in the assessment of exercise of a purchase option, in which case the lease liability is remeasured by discounting the revised lease payments using revised discount rate.
- the lease payments change due to changes in an . index or rate or a change in expected payment under a guaranteed residual value, in which cases the lease liability is remeasured by discounting the revised lease payments using the initial discount rate (unless the lease payments change is due to a change in a floating interest rate, in which case a revised discount rate is used).

 A lease contract is modified and the lease modification is not accounted for as a separate lease, in which case the lease liability is remeasured based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

Right-of-use assets

The right-of-use assets comprise the initial measurement of the corresponding lease liability, lease payments made at or before the commencement date and any initial direct costs, less lease incentives received. Whenever the Group incurs an obligation for costs to dismantle and remove a leased asset, restore the site on which it is located or restore the underlying asset to the condition required by the terms and conditions of the lease, a provision is recognised and measured under HKAS 37 "Provision, Contingent Liabilities and Contingent Assets". The costs are included in the related right-of-use asset.

Right-of-use assets are subsequently measured at cost less accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities, if any. They are depreciated over the shorter period of the lease term and useful life of the underlying asset. The depreciation starts at the commencement date of the lease.

Right-of-use assets is presented as "properties" under property, plant and equipment.

The Group applies HKAS 36 Impairment of Assets to determine whether a right-of-use assets is impaired and accounts for any identified impairment loss.

Variable rents that do not depend on an index or rate are not included in the measurement of the lease liability and the right-of-use asset. Lease modification

The Group accounts for a lease modification as a separate lease if:

- the modification increases the scope of the lease by adding the right to use one or more underlying assets; and
- the consideration for the lease increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

For a lease modification that is not accounted for a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

Exchange differences arising on the retranslation of nonmonetary items carried at fair value are included in profit or loss for the period.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year/period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributed to non-controlling interest as appropriate).

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Retirement benefits costs

Payments to the Mandatory Provident Fund Scheme (the "**MPF Scheme**") are recognised as an expense when employees have rendered service entitling them to the contributions.

Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries and annual leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "loss before tax" as reported in the consolidated statement of profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of their assets and liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the lease liabilities, and the related assets separately. The Group recognises a deferred tax asset related to lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they related to income taxes levied by the same taxation authority and the Group intends to settle current tax liabilities and assets on a net basis.

Property, plant and equipment, including right-of-use assets, are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Ownership interests in leasehold land and buildings

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment, less their residual values over their estimated useful lives, using the straightline method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. The estimated useful lives are as follows:

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the first-in, first-out method. Net realisable value represents the estimated selling price in the ordinary course of business less all estimated costs of completion and costs necessary to make the sale.

Cash and cash equivalents

In the consolidated statement of financial position, cash and bank balances comprise cash (i.e. cash on hand and shortterm bank deposits) and cash equivalents. Cash equivalents are short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather for investment or other purposes.

Investments in subsidiaries

Investments in subsidiaries are stated in the statement of financial position of the Company at cost less accumulated impairment loss, if any.

Financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value, except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15 Revenue from Contracts with Customers. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial asset at fair value through profit or loss, "**FVTPL**") are added to or deducted from the fair values of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial asset at FVTPL are recognised immediately in profit or loss.

Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets. Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and FVTPL.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them.

Financial assets at amortised cost (debt instruments)

The Group measures financial assets subsequently at amortised cost if both of the following conditions are met:

- the financial asset is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment.

For purchased or originated credit impaired financial assets, a credit adjusted effective interest rate is calculated by discounting the estimated future cash flows, including expected credit losses, to the amortised cost of the debt instrument on initial recognition.

The amortised cost of a financial asset is the amount at which the financial asset is measured at initial recognition minus the principal repayments, plus the cumulative amortisation using the effective interest method of any difference between that initial amount and the maturity amount, adjusted for any loss allowance. The gross carrying amount of a financial asset is the amortised cost of a financial asset before adjusting for any loss allowance.

Interest income is recognised using the effective interest method for debt instruments measured subsequently at amortised cost. For financial assets other than purchased or originated credit-impaired financial assets, interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit impaired (see below). The Group recognises a loss allowance for ECL on trade receivables and all other financial assets measured at amortised cost. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables. The ECL on these financial assets are estimated individually for customer with significant balances or creditimpaired and/or collectively using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, including other receivables and cash and cash equivalents, the Group measures the loss allowance equal to 12-month ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if (i) the financial instrument has a low risk of default; (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term; and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when the asset has external credit rating of 'investment grade' in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of 'performing'. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable:

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

The recoverable amount of property, plant and equipment, right-of-use assets and interest in subsidiaries are estimated individually. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating unit, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

5. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in Note 4, the directors of the Company are required to make judgements, estimates and assumptions about the amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Useful lives and residual values of property, plant and equipment

In determining the useful life and residual value of an item of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvement in production, or from a change in the market demand for the products or service output of the asset, expected usage of the asset, expected physical wear and tear, the care and maintenance of the asset, and legal or similar limits on the use of the asset. The carrying amount of property, plant and equipment excluding properties as at 31 December 2024 is approximately HK\$193,557,000 (31 December 2023: HK\$209,987,000). The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in similar way. The Group will revise the depreciation charge where useful lives are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

Allowance for slow-moving inventories

Allowance for slow-moving inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/writeback in the period in which such estimate has been changed. The carrying amount of inventories as at 31 December 2024 is approximately HK\$339,513,000 (31 December 2023: HK\$276,691,000).

Impairment loss for non-financial assets

The Group assesses at the end of each reporting period whether non-financial assets suffered any impairment in accordance with accounting policy stated in Note 4. The nonfinancial assets are reviewed for the impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds their recoverable amounts. The determination of recoverable amount requires an estimation of future cash flows and the selection of appropriate discount rates. Changes in these estimates could have a significant impact on the carrying value of the assets and could result in additional impairment charge or reversal of impairment in future periods, where applicable. No impairment loss on nonfinancial assets was recognised by the Group in both periods.

Income taxes

The Group is subject to income taxes in Hong Kong and Macau. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which ultimate tax determination is uncertain during the ordinary course of business. The Group recognised liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will affect the income tax and deferred tax provision in the period in which such determination is made.

Provision of reinstatement costs of retail stores and offices

Most of the Group's retail stores are leased under operating lease and are subject to reinstatement obligation as stipulated in the lease agreements. Management assesses the amount of provision made for each store and offices based on various factors, including the size of the store and offices, the complexity of refurbishment and specific requirements from landlords. The Group's management assesses the adequacy of such provision at the end of each reporting period. As at 31 December 2024, the carrying amount of such provision was approximately HK\$6,200,000 (31 December 2023: HK\$4,916,000).

Leases - Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

31. FINANCIAL RISK MANAGEMENT

The main risks arising from the Group's financial instruments in the normal course of the Group's business are credit risk, foreign currency risk, liquidity risk and interest rate risk.

These risks are limited by the Group's financial management policies and practices described below.

(a) Credit risk

The Group's maximum exposure to credit risk is the carrying amounts of cash and bank balances, and trade and other receivable. The Group has no concentration of credit risk from third party debtors.

All of the Group's trade receivables and other receivables have no collateral. The Group assessed the credit quality of the counterparties by taking into account their financial position, credit history and other factors. Management also regularly reviews the recoverability of these receivables and follow up the disputes or amounts overdue, if any. The Directors are of the opinion that the risk of default by counterparties is low.

The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk, the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportable forwarding-looking information.

(i) Trade receivables

The Group applies the simplified approach to providing for ECL prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for all trade receivables. The Group always measures the loss allowance for trade receivables. at an amount equal to lifetime ECL. The ECL on trade receivables is estimated by reference to past default experience of the debtor and current market condition in relation to each debtor's exposure. The ECL also incorporates forward-looking information with reference to general macroeconomic conditions that may affect the ability of the debtors to settle receivables. To measure the ECL, the trade receivables have been grouped based on share credit risk characteristics and the days past due according to the ageing as disclosed in Note 18. Expected loss rate of current trade receivables are assessed to be 0.1% as the trade receivables mainly represent amounts due from Octopus Cards Limited and credit card companies with high credit rating and no history of default. For the past due trade receivables, since the balances were immaterial, the management of the Group considered the loss allowance provision for these balances were immaterial. There is no change in the ECL rate for trade receivables during the period/year mainly due to no significant change in the historical default rates of trade receivables based on which the ECL rate is determined. The management of the Group considered the loss allowance provision for trade receivables was immaterial during the year ended 31 December 2024 (for the period ended 31 December 2023: immaterial).

As at 31 December 2024, the management of the Group takes into account the historical default experience and forward-looking information, as appropriate, for example the Group considers the consistently low historical default rates of counterparties, and concludes that credit risk inherent in the Group's outstanding other receivables is insignificant. The management of the Group has assessed that other receivables do not have a significant increase in credit risk since initial recognition and risk of default is insignificant, therefore the ECL for these receivables were immaterial under the 12 months expected loss method and no loss allowance was recognised during the year ended 31 December 2024 (for the period ended 31 December 2023: Nil).

(b) Liquidity risk

The Group's policy is to regularly monitor its liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and long term. The management of the Company is satisfied that the Group will be able to meet in full its financial obligations as and when they fall due in the foreseeable future in the normal course of business. The following table details the remaining contractual maturities at the end of each reporting period of the Group's financial liabilities, which are based on contractual undiscounted cash flows (including interest payment computed using contractual rates or, if floating, based on the current rates at the reporting date) and the earliest date the Group may be required to pay.

(d) Interest rate risk

The Group's exposure to interest rate risk relates principally to its bank deposits and interest-bearing bank borrowing. Borrowing issued at variable rates expose the Group to cash flow interest-rate risk. The Group has not entered into any financial derivative instruments to hedge its exposure to interest rate risk. The Group's policy is to manage its interest rate risk, working within an agreed framework, to ensure that there are no unduly exposures to significant interest rate movements.

Sensitivity analysis

At the respective end of each reporting period, it is estimated that a general increase/decrease of 100 basis points in interest rates, with all other variables held constant, would increase/decrease the Group's profit for the year ended 31 December 2024 by approximately HK\$330,000 (for the period ended 31 December 2023: HK\$56,000).

The sensitivity analysis above has been determined to assume that the change in interest rates had occurred at the end of each reporting period and had been applied to the exposure to interest rate risk for the bank deposits and borrowing in existence at that date. The 100 basis point increase or decrease represents management's assessment of a reasonably possible change in interest rates over the next twelve months period.

The interest rate risk policies have been followed by the Group consistently throughout the year/period.

32. CAPITAL MANAGEMENT

The Group's primary objective when managing capital is to safeguard the Group's ability to continue as a going concern and maximising the return to stakeholders. The Group's capital structure is regularly reviewed and managed by the directors of the Company. The Group is not subject to externally imposed capital requirements. To maintain or adjust capital structure, the Group may adjust dividend payment to shareholders or issue new shares. Adjustments will be made to the capital structure in light of changes in economic conditions affecting the Company or its subsidiaries, and the risk characteristics of the Group's underlying assets.

The capital structure of the Group consists of debts, which includes the bank borrowing, lease liabilities, cash and bank balance and equity attributable to owners of the Company, comprising share capital and reserves. The Group's risk management reviews the capital structure on a semi-annual basis. As part of this review, the management considers the cost of capital and the risks associated with each class of capital.

The net debt to equity ratio as at the reporting dates is as follows:

34. ACCOUNTING IMPLICATIONS OF THE ABOLITION OF THE MPF-LSP OFFSETTING MECHANISM IN HONG KONG

In June 2022, the Hong Kong Government gazetted the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the "Amendment Ordinance"), which will eventually abolish the statutory right of an employer to reduce its long service payment ("LSP") and severance payment payable to a Hong Kong employee by drawing on its mandatory contributions to the mandatory provident fund ("MPF") scheme (also known as the offsetting mechanism). The HKSAR Government has subsequently announced that the Amendment Ordinance will come into effect from 1 May 2025 (the "Transition Date"). Separately, the Hong Kong Government is also expected to introduce a subsidy scheme to assist employers after the abolition.

Among other things, once the abolition of the offsetting mechanism takes effect, an employer can no longer use any of the accrued benefits derived from its MPF contributions (irrespective of the contributions made before, on or after the Transition Date) to reduce the LSP in respect of an employee's service from the Transition Date. However, where an employee's employment commenced before the Transition Date, the employer can continue to use the above accrued benefits to reduce the LSP in respect of the employee's service up to that date; in addition, the LSP in respect of the service before the Transition Date will be calculated based on the employee's monthly salary immediately before the Transition Date and the years of service up to that date.

34. 香港取消強積金與長期服務金對沖 機制的會計影響

二零二二年六月,香港政府就《二零二二年 僱傭及退休計劃法例(抵銷安排)(修訂)條 例》(「修訂條例」)刊憲,落實取消僱主使用 其向強制性公積金(「強積金」)計劃作出的強 制性供款來扣減應付予其香港僱員的長期 服務金(「長期服務金」)及遣散費的法定權利 (又稱對沖機制)。香港特別行政區政府其 後宣佈修訂條例將於二零二五年五月一日 (「過渡日」)起生效。另外,預計香港政府還 將推出一項補貼計劃,在取消對沖機制後 為僱主提供協助。

一旦取消對沖機制生效,僱主不可再使用 其強積金強制性供款(不論在過渡日之前、 當日或之後作出的供款)所產生的累算權 益,來扣減僱主就員工於過渡日後的服務 所應付的長期服務金。然而,如僱員在過 渡日前開始受僱,僱主可繼續以上述累算 權益扣減就該僱員截至該日止的服務所應 付的長期服務金;此外,就過渡日之前的 服務所應付的長期服務金,將根據過渡日 之前僱員的最後月薪及截至該日的服務年 期計算。

34. ACCOUNTING IMPLICATIONS OF THE ABOLITION OF THE MPF-LSP OFFSETTING MECHANISM IN HONG KONG (Cont'd)

In July 2023, the HKICPA published accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong that provides guidance on the accounting considerations relating to the offsetting mechanism and the abolition of the mechanism. In particular, the guidance indicates that entities may account for the accrued benefits derived from its mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed contributions by that employee towards the LSP; however, upon the enactment of the Amendment Ordinance in June 2022, entities can no longer apply the practical expedient in paragraph 93(b) of HKAS 19, Employee Benefits, to recognise such deemed contributions as reduction of current service cost in the period the related service is rendered, and any impact from ceasing to apply the practical expedient is recognised as a catch-up adjustment in profit or loss with a corresponding adjustment to the LSP liability in the financial statements.

In this financial report and in prior periods, consistent with the HKICPA guidance the Group has been accounting for the accrued benefits derived from its mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed employee contributions towards the LSP. The Group has been applying the abovementioned practical expedient.

The Group has assessed the implications of this new guidance on the above accounting policies and has decided to change those accounting policies to conform with the HKICPA guidance. The management has commenced the processes on implementing the change including additional data collection and impact assessment. However, the impact of the change is not reasonably estimable at the time of these consolidated financial statements are authorised for issuance, as the Group has yet to fully complete its assessment of the impact of the HKICPA guidance.

34. 香港取消強積金與長期服務金對沖 機制的會計影響(續)

二零二三年七月,香港會計師公會發出《香 港取消強積金與長期服務金對沖機制的會 計影響》,為對沖機制及取消對沖機制的 相關會計考慮提供指引。具體而言,該指 引指出,實體可以將其預計用以扣減應付 僱員的長期服務金的強積金強制供款累約 權益,以視作僱員對長期服務金的供款累入 賬後,實員福利第93(b)段中的可行權宜之 法的任何影響均路認為提供相關服 可 行權宜之法的任何影響均確認為損益中的 追加調整,在財務報表中對長期服務金負 債進行相應調整。

於本財務報告及過往會計期中,本集團均 依照香港會計師公會的指引,將其預計用 以扣減應付予僱員的長期服務金的強積金 強制供款累算權益,視作僱員對公司的供 款入賬。本集團一直應用上述可行權宜之 法。

本集團已評估此項新指引對上述會計政策 的影響,並決定為符合香港會計師公會指 引而改變該等會計政策。管理層已經開始 實施變動的程序,包括收集額外資料及進 行影響評估。然而,在該等綜合財務報表 獲授權發佈時,由於本集團尚未完全完 成對香港會計師公會指引的影響作出的評 估,因此未能對該變動的影響作出合理的 估計。
