For and on behalf of the board (the **"Board**") of directors (the **"Directors**", each a **"Director**") of Zhong Ao Home Group Limited (the **"Company**", together with its subsidiaries, the **"Group**"), I am pleased to present the annual report of the Company for the year ended 31 December 2024.

#### **FINANCIAL REVIEW**

In summary, the key financial performance of the Group over the last year ended 31 December 2024 included (i) increase in property management business revenue from approximately RMB1,285.5 million for the year ended 31 December 2023 to approximately RMB1,331.4 million for the year ended 31December 2024, representing an increase of approximately RMB45.9 million or 3.6%; (ii) increase in revenue generated from cleaning and greening business of approximately RMB22.6 million; and (iii) increase in revenue generated from other businesses of approximately RMB0.92 million. Overall, the Group's 2024 profit attributable to owners of the parent amounted to RMB88.9 million (2023: RMB80.1 million), representing an increase of 11.0% as compared to 2023.

#### DIVIDEND

The Board has resolved to recommend the payment of a final dividend of HKD2.50 cents per share for the year ended 31 December 2024 (2023: HKD2.50 cents) to the shareholders whose names appear on the register of members of the Company on 12 June 2025, making the total dividend payment of approximately HKD21.4 million.

#### **OPERATION REVIEW**

The Group is a leading independent property management company in China. In 2024, the Group received the following recognition and awards.

#### 財務回顧

綜上所述,本集團截至2024年12月31日止上一 年度的主要財務表現包括(i)物業管理業務收益由 截至2023年12月31日止年度的約人民幣1,285.5 百萬元至截至2024年12月31日止年度的約人民 幣1,331.4百萬元,增加約人民幣45.9百萬元或 3.6%:(ii)清潔及緣化業務所得收益增加約人民幣 22.6百萬元;及(iii)其他業務所得收益增加約人民幣 22.6百萬元;及(iii)其他業務所得收益增加約人民 幣0.92百萬元。總體而言,本集團2024年母公司 擁有人應佔利潤為人民幣88.9百萬元(2023年: 人民幣80.1百萬元),較2023年增加11.0%。

## 股息

董事會議決建議就截至2024年12月31日止年度 派付末期股息每股2.50港仙(2023年:2.50港仙) 予2025年6月12日名列本公司股東名冊內的股 東,總派息金額約21.4百萬港元。

As of 31 December 2024, the Group had maintained its presence in 45 cities in China where it was delivered contracted to manage a total of 555 residential and non -residential properties such as commercial or government buildings with an aggregate delivered contracted GFA of approximately 60 million sq.m. This represents a decrease of approximately 3% compared to the delivered contracted GFA of approximately 62 million sq.m as at 31 December 2023.

#### PROSPECTS

Looking forward, the Group will continue to maintain its own advantage as an independent property management company, competing with counterparts in the market by its high quality service and operation efficiency, actively establishing stable partnership with leading property developers in all regions, exploring potential new development projects and pursuing properties which have established owners' associations. When right opportunities arise, the Group will accelerate its expansion of business scope and coverage in China through acquisition of property management companies and other value adding service companies which provide services related to communities.

In addition, we will closely persist in the philosophy of stable development by gradually expanding the upstream and downstream industry chain, as well as strategically realigning our industry foothold. On the other hand, we expect to penetrate into the downstream sector of the industry chain by acquiring firms specialized in living value adding services. In the next few years, we will gradually ride on our strength to extend our reach along the upstream and downstream of the industry chain with a focus on property management. In doing so, the Group will ultimately evolve into an integrated operator offering the whole-industry community services. 於2024年12月31日,本集團維持其於中國45個 城市的地位,已交付訂約管理合共555項住宅物 業及非住宅物業(如商用或政府樓宇),總合約建 築面積為約60百萬平方米。有關2023年12月31 日已交付合約建築面積約62百萬平方米,減少約 3%。

## 前景

展望未來,本集團將繼續維持身為獨立物業管理 公司的優勢,以高質素服務及營運效率與市場對 手競爭,積極與各地區的領先物業發展商建立穩 定合作關係,以及探索潛在的新發展項目並尋求 已成立業主委員會之物業。當有適當機會時,本 集團將透過收購物業管理公司及其他提供社區相 關服務的增值服務公司以加快其於中國的業務規 模擴展及覆蓋。

此外,我們緊守穩健發展的理念,逐步拓展上下 游產業鏈,重新調整產業佈局。另一方面期望將 產業鏈往下游推進一步,陸續併購生活增值式服 務等專業公司。未來幾年將逐步發力,以物業管 理為核心,向上向下做產業鏈的延伸,最終使本 集團發展成一家全產業鏈小區綜合服務營運商。

The Group's main business line is property management business. Under the property management business line, the Group is engaged in the provision of property management services, provision of cleaning and greening services, and other services.

## 業務回顧

本集團的主要業務線為物業管理業務。根據物業 管理業務線,本集團從事提供物業管理服務、提 供清潔及綠化以及其他服務。



#### **PROPERTY MANAGEMENT SERVICES**

The Group primarily provides property developers and property owners with a broad range of property management services to mainly residential properties, commercial and government buildings. Services provided by the Group include standard property management services and also ancillary services such as cleaning, gardening, property facilities repair and maintenance and butler services. Through its butler services, the Group provides personalised and premium property management services to residents with its trained butlers onsite. While its primary and longterm business focus is on the residential property market, the Group also provides services to non-residential properties, including both standalone non-residential properties and properties associated with residential properties, such as schools and commercial buildings.

The Group believes that service quality is fundamental to establish a solid foundation to support the growth of the Group's business. The Group holds various qualifications and licenses in respect of property management services, namely CMS31950, IEC27001, ISO50001, ISO 9001, ISO 14001, OHSAS 18001.

As of 31 December 2024, the Group had maintained its presence in 45 cities in China where it was delivered contracted to manage a total of 555 residential and non -residential properties such as commercial or government buildings with an aggregate delivered contracted GFA of approximately 60 million sq.m. This represents a decrease of approximately 3% compared to the delivered contracted GFA of approximately 62 million sq.m as at 31 December 2023.

The Group strives to develop new business relationships from its existing customer base and network in order to provide strong organic growth to the Group. In addition to organic growth, the Group continues to identify appropriate acquisition targets to strengthen its portfolio and increase geographic presence across China.

#### **GEOGRAPHIC PRESENCE**

The Group will continue to strategically select markets to enter into, focus on those with more developed economies and comparatively high per capita GDP. Once the Group has established presence in a new city, it will seek to expand its business within the same city or neighboring cities with a view to maximising its economies of scale.

### 物業管理服務

本集團主要向物業發展商及業主提供廣泛的物業 管理服務,當中大部份為住宅物業、商用及政府 樓宇。本集團提供的服務包括標準物業管理服務 及配套服務,例如清潔、園藝、物業設施維修及 保養以及管家服務等。透過管家服務,本集團訓 練有素的駐場管家會為住戶提供切合個人需要之 優質物業管理服務。本集團的主要及長期業務重 點為住宅物業市場,亦會向非住宅物業提供服務 (包括單幢非住宅物業及住宅物業附屬物業),如 學校及商業大樓。

本集團相信,服務質素乃為奠定穩實基礎以支持 本集團業務增長之基本要素。本集團就物業管理 服務持有多項資格及牌照,分別為CMS31950、 IEC27001、ISO50001、ISO 9001、ISO 14001、OHSAS 18001。

於2024年12月31日,本集團維持其於中國45個 城市的地位,已交付訂約管理合共555項住宅物 業及非住宅物業(如商用或政府樓宇),總合約建 築面積為約60百萬平方米。有關2023年12月31 日已交付合約建築面積約62百萬平方米,減少約 3%。

本集團致力透過現有客戶基礎及網絡發展新業務 關係,從而為本集團提供強勁內部增長。除內部 增長外,本集團繼續物色合適的收購目標,以強 化其組合及增加於中國之地理據點。

#### 地理分佈

本集團將繼續策略性地選擇有意進軍的市場,專 注於經濟較發達且人均國內生產總值較高的市場。 本集團在新城市立足後,會力圖拓展同一城市或 鄰近城市內的業務,以發揮最大的規模經濟效益。

#### **CLEANING AND GREENING BUSINESS**

The Group provides property developers and property owners with a series of indoor and outdoor environmental cleaning, greening and maintenance services. This business division also provides services to the property developers and property owners of the property management business division. Accordingly, segment results of the cleaning and greening division is evaluated by the Group's management on services as subcontracted from the property management business division. The Group holds various qualifications and licenses in respect of cleaning services, namely  $\boxtimes \overline{x} -$ 級環衛清潔服務企業資質 (National Level One Environmental Hygiene Cleaning Service Qualification\*), E315甲級高空外牆清洗服務企業 (E315 A Grade High-altitude Exterior Wall Cleaning Services Enterprise\*), ISO 14001, ISO 9001 and ISO 45001.

#### 清潔及綠化業務

本集團為物業發展商及業主提供一系列室內及室 外環境清潔、綠化及維護業務。該業務部門亦為 物業管理業務部門的房地產開發商及物業業主提 供服務。因此,清潔及綠化分部的分部業績由本 集團的管理層按物業管理業務部門所分包的服務 進行評估。本集團就清潔服務持有多項資格及牌 照,即國家一級環衛清潔服務企業資質、E315甲 級高空外牆清洗服務企業、ISO 14001、ISO 9001 及 ISO 45001。

#### **OTHER BUSINESSES**

Other businesses comprise shuttle bus, security guard and maintenance services in the PRC, engineering services related to elevators, engineering services, the sale of engineering spare parts, canteen operations as well as catering services, providing sales assistance services and consulting and agency services to property developers and property owners.

#### **PROSPECTS AND FUTURE PLANS**

The Group will continue to maintain its own advantage as an independent property management company and compete with counterparts in the market by its high quality service and operational efficiency. The Group will actively establish stable partnerships with leading property developers and/or property management service providers in all regions and explore potential projects under development. The Group will strive to develop new business relationships from its existing customers base and own network in order to provide strong organic growth to the Group. The Group also targets to expand its portfolio of customers by pursuing properties with established owners' association. Furthermore, when right opportunities arise, the Group will accelerate its expansion by expanding its business scope and coverage in China by means of acquisitions and cooperation.

Reference is made to the announcements of the Company dated 1 August 2022 and 17 April 2023. Guangdong Zhong Ao had demanded 梁錫偉 (Liang Xiwei\*) ("**Mr. Liang**") from time to time to (i) pay the remaining balance of the Option Price; and (ii) complete the registration procedures for mortgaging the remaining 183 Tianyu Garden Car Parking Spaces. As Mr. Liang has not settled and completed the registration procedures for mortgaging, this constituted a breach of the Second Supplemental Agreement.

## 其他業務

## 前景及未來計劃

本集團將繼續維持身為獨立物業管理公司的優勢, 以高質素服務及營運效率與市場對手競爭。本集 團將積極與各地區的領先物業發展商及/或物業 管理服務提供商建立穩定合作關係,以及探索潛 在發展中的項目。本集團將致力以現有客戶基礎 及自身網絡發展新業務關係,為本集團帶來強勁 內部增長。本集團並藉尋求已成立業主委員會之 物業,以擴展其客戶組合。此外,當有適當機會 時,本集團將透過收購及合作以加快其於中國的 業務規模擴展及覆蓋。

兹提述本公司日期為2022年8月1日及2023年4月 17日的公告。廣東中奧要求梁錫偉(「**梁先生**」)不 時(i)支付期權價格餘額:及(ii)完成抵押餘下183 個天譽花園停車位的登記手續。由於梁先生未有 結付及完成抵押登記手續,此舉構成對第二份補 充協議的違約。



Guangdong Zhong Ao has commenced civil lawsuit and submitted a claim (the "Claim") against Mr. Liang to the People's Court of Qingxiu District, Nanning City, the PRC for, among others, (i) the remaining balance of the Option Price of RMB20 million and all accrued interest; (ii) penalties for breach of contract; and (iii) an order that Guangdong Zhong Ao shall have the right to be compensated in priority by the proceeds from the auction or sale of the mortgaged properties (including a house and 227 Tianyu Garden Car Parking Spaces). On 14 April 2023, Guangdong Zhong Ao has received from the Court an acceptance notice in relation to the Claim. The Company has received the judgment from the Court dated 17 April 2024 (the "Judgment") and it was ordered by the Court that (i) Mr. Liang to pay the outstanding Option Price adjudged by the Court in the amount of RMB30,565,479.45 and the relevant interest amount (to be calculated based on the Option Price in the amount of RMB20 million with interest rate of 10% per annum accruing from 1 April 2023 up to the date of full payment) within 10 days after the effective date of the Judgment; (ii) Mr. Liang to pay the penalty (to be calculated based on the method determined by the Court) within 10 days after the effective date of the Judgment; and (iii) Guangdong Zhong Ao shall have the right to be compensated in priority by the proceeds from the auction or sale of the mortgaged properties (including a house and 227 Tianvu Garden Car Parking Spaces). On 31 May 2024, the Company received a written appeal dated 13 May 2024 by Mr. Liang as the appellant against the Judgment. The appeal against the Judgment by Mr. Liang was heard by the Intermediate People's Court of Nanning Municipality, Guangxi Zhuang Autonomous Region (廣西壯族 自治區南寧市中級人民法院) and on 30 October 2024, the Company received the judgment dated 24 October 2024 from the Appeal Court and it was ruled by the Appeal Court, among others, that (i) the appeal be dismissed and the original Judgment be upheld; and (ii) the relevant costs for the appeal be borne by Mr. Liang. After the dismissal of the appeal, the Company has applied to the court to mandatorily enforce the Judgment against Mr. Liang (the "Enforcement Application"). On 3 April 2025, the Company was informed by the People's Court of Liangging District, Nanning City, Guangxi Zhuang Autonomous Region that the Enforcement Application was accepted and the Company will proceed with the enforcement of the Judgement against the First Vendor accordingly. For further details, please refer to the announcements of the Company dated 18 August 2021, 22 October 2021, 31 January 2022, 1 August 2022, 17 April 2023, 29 April 2024, 3 June 2024, 30 October 2024 and 7 April 2025.

#### FINANCIAL PERFORMANCE REVIEW

#### Revenue

During the year ended 31 December 2024, the Group recorded revenue of approximately RMB1,779.0 million, representing an increase of 4.1% over the year 2023.

Increase in the Group's revenue was primarily attributable to the increase in property management business revenue from approximately RMB1,285.5 million for the year ended 31 December 2023 to approximately RMB1,331.4 million for the year ended 31 December 2024 and represented approximately 3.6% increase over the corresponding year. In addition, the Group's revenue generated from cleaning and greening business has increased by approximately RMB2.6 million or 8.6% and from other businesses has increased by approximately RMB0.9 million or 0.6%.

## **財務表現回顧** 收益

截至2024年12月31日止年度,本集團錄得收益 約人民幣1,779.0百萬元,較2023年增加4.1%。

本集團收益增加主要由於物業管理業務收益由截 至2023年12月31日止年度約人民幣1,285.5百萬 元增加至截至2024年12月31日止年度約人民幣 1,331.4百萬元,較去年同期增加約3.6%。此外, 本集團清潔及緣化業務的收益增加約人民幣22.6 百萬元或8.6%,其他業務的收益增加約人民幣0.9 百萬元或0.6%。

#### **PROPERTY MANAGEMENT BUSINESS**

The Group's property management business includes the provision of property management services, cleaning and greening services and other services. Details of analysis of each service are as follows:

#### **Property management services**

Revenue from property management services increased by approximately RMB45.9 million or 3.6% over 2023 primarily due to increase in weighted average price of property management services during 2024.

#### **Cleaning and greening business**

Revenue from cleaning and greening business for the year ended 31 December 2024 was approximately RMB286.0 million, comparing to RMB263.4 million for the year ended 31 December 2023, representing an increase of approximately RMB22.6 million or 8.6%. The increase was primarily due to development in new projects.

#### **Other businesses**

Revenue from other businesses increased from approximately RMB160.7 million for the year ended 31 December 2023 to approximately RMB161.6 million for the year ended 31 December 2024. The increase of approximately RMB0.9 million or 0.6% over the year was mainly due to development in security guard services.

#### **COST OF SALES AND SERVICES**

The Group's cost of sales and services primarily comprises (i) subcontracting costs, representing the expenses paid to sub-contractors for various services under the property management services and sales assistance services; (ii) staff costs; (iii) depreciation expenses associated with equipment and property used in providing services; (iv) costs of other services and sale of goods such as salaries cost of the technicians in the provision of elevator engineering services and weak-current engineering services; costs of the spare parts sold and operating costs in running the catering services and (v) costs of cleaning and greening products and utensils as well as commission paid for the real estate and property agency services.

Cost of sales and services increased by 3.9% from approximately RMB1,359.1 million for the year ended 31 December 2023 to approximately RMB1,412.2 million for the year ended 31 December 2024. Increase in cost of sales and services was due primarily to the growth of the corresponding revenue.

#### 物業管理業務

本集團物業管理業務包括提供物業管理服務、清 潔及綠化業務以及其他服務。各項服務之分析詳 情如下:

#### 物業管理服務

物業管理服務所得收益較2023年增加約人民幣 45.9百萬元或3.6%,主要由於2024年物業管理服 務加權平均價格增加。

#### 清潔及綠化業務

截至2024年12月31日止年度,清潔及綠化業務 收益約為人民幣286.0百萬元,較截至2023年12 月31日止年度的人民幣263.4百萬元增加約人民 幣22.6百萬元或8.6%。增加主要由於新項目發展 所致。

#### 其他業務

其他業務收益由截至2023年12月31日止年度約 人民幣160.7百萬元增加至截至2024年12月31日 止年度約人民幣161.6百萬元。年內增加約人民 幣0.9百萬元或0.6%,主要由於發展保安服務所致。

#### 銷售及服務成本

本集團的銷售及服務成本主要包括(i)分包成本, 指付予分包商以取得物業管理服務及協銷服務等 多項服務的開支;(ii)員工成本;(iii)與提供服務時 使用的設備及物業有關的折舊開支;(iv)其他服 務及銷售貨品成本,例如提供升降機工程服務及 弱電工程服務的技術人員薪資成本;銷售零部件 成本及營運餐飲服務的經營成本及(v)清潔綠化 產品及器具成本以及房地產及物業代理服務佣金。

銷售及服務成本由截至2023年12月31日止年度 約人民幣1,359.1百萬元增加3.9%至截至2024年12 月31日止年度的約人民幣1,412.2百萬元。銷售及 服務成本增加主要是由於相應收入增長。

The Group's gross profit for the year ended 31 December 2024 was approximately RMB366.8 million, comparing to approximately RMB350.6 million in 2023, representing an increase of approximately RMB16.3 million, or 4.6%. The Group's gross profit margin increased slightly from 20.5% for the year ended 31 December 2023 to 20.6% in 2024.

#### **OTHER INCOME AND GAIN**

The Group's other income and gain for the year ended 31 December 2024 was approximately RMB41.5 million, comparing to approximately RMB49.3 million for the year ended 31 December 2023, representing a decrease of approximately RMB7.8 million or 15.8%. The decrease was primarily due to decrease in government grants and rental income.

#### SELLING AND DISTRIBUTION EXPENSES

The Group's selling and distribution expenses for the year ended 31 December 2024 were approximately RMB7.3 million, comparing to approximately RMB6.5 million for the year ended 31 December 2023, which represented an increase of approximately RMB0.8 million. The increase was primarily due to increase in marketing expenses for development in new projects.

截至2024年12月31日止年度,本集團毛利約為 人民幣366.8百萬元,較2023年的約人民幣350.6 百萬元增加約人民幣16.3百萬元或4.6%。本集團 毛利率由截至2023年12月31日止年度的20.5%略 增至2024年的20.6%。

## 其他收入及收益

截至2024年12月31日止年度,本集團的其他收入及收益為約人民幣41.5百萬元,而截至2023年 12月31日止年度則為約人民幣49.3百萬元,減少約人民幣7.8百萬元或15.8%。減少主要原因是政府補貼及租金收入減少所致。

#### 銷售及分銷開支

截至2024年12月31日止年度,本集團的銷售及 分銷開支為約人民幣7.3百萬元,較截至2023年 12月31日止年度的約人民幣6.5百萬元增加約人 民幣0.8百萬元。增加主要是由於用於開發新項 目的市場推廣開支增加。



#### **ADMINISTRATIVE EXPENSES**

The Group's administrative expenses for the year ended 31 December 2024 was approximately RMB206.5 million, comparing to approximately RMB192.3 million for the year ended 31 December 2023, represented an increase of approximately RMB14.1 million or 7.3% which was mainly due to the increase in administrative expenses brought by the growth in business revenue. For long term control issue, the Group will continue to strengthen the streamlining of organisation and control of administrative costs for controlling better administrative expenses.

## NET IMPAIRMENT LOSSES RECOGNISED ON FINANCIAL ASSETS

The Group's net impairment losses on financial assets were approximately RMB41.1 million for the year ended 31 December 2024, comparing to net impairment losses on financial assets of approximately RMB58.7 million for the year ended 31 December 2023, representing a decrease of approximately RMB17.6 million which was primarily due to decrement in trade receivables and other receivables.

#### **FINANCE COSTS**

The Group's net finance costs amounted to approximately RMB2.4 million for the year ended 31 December 2024 comparing to net finance costs for the year ended 31 December 2023 of approximately RMB3.4 million, representing a decrease of approximately RMB1.0 million or 29.9%. The decrement was primarily due to decrease in bank borrowings.

#### **INVESTMENT PROPERTIES**

Certain investment properties are leased to third parties under operating leases.

These operating lease do not have "significant impact" as defined under Rule 14.04(1) (d) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**") and hence is exempt from the requirements under chapter 14 of the Listing Rules.

## 行政開支

本集團截至2024年12月31日止年度的行政開支 為約人民幣206.5百萬元,較截至2023年12月31 日止年度的約人民幣192.3百萬元增加約人民幣 14.1百萬元或7.3%,主要是業務規模增長帶來的 管理費用增加。就長期控制問題而言,本集團將 持續加強組織機構的精簡和行政管理費用的控制, 以更好地控制行政管理費用。

#### 就金融資產確認的減值虧損淨額

本集團截至2024年12月31日止年度的金融資產 減值虧損淨額為約人民幣41.1百萬元,而截至 2023年12月31日止年度的金融資產減值虧損淨 額為約人民幣58.7百萬元,減少約人民幣17.6百 萬元,乃主要由於貿易應收款項及其他應收款項 減少。

#### 財務成本

本集團截至2024年12月31日止年度的淨財務成 本為約人民幣2.4百萬元,而截至2023年12月31 日止年度的淨財務開支約為人民幣3.4百萬元, 減少約人民幣1.0百萬元或29.9%。減少主要是由 於銀行借款減少所致。

## 投資物業

若干投資物業已根據經營租約租予第三方。

該等經營租賃並未具有香港聯合交易所有限公司 證券上市規則(「上市規則」)第14.04(1)(d)條所定 義之「重大影響」,故獲豁免遵守上市規則第14 章之規定。

#### **TRADE RECEIVABLES**

As at 31 December 2024, total trade receivables of the Group amounted to approximately RMB505.9 million, representing decrease of approximately RMB32.4 million or 6% compared to approximately RMB538.3 million as at 31 December 2023. The decrease was primarily due to strengthen on the assessment, management and control of repayment to improve the rate of repayment.

#### PREPAYMENTS AND OTHER RECEIVABLES

Prepayments and other receivables mainly represent payment on behalf of customers for expenditure on communities' facilities, performance bonds, bidding deposit for contracts, business-related prepayments and advance to other independent third parties. As at 31 December 2024, the Group's prepayments and other receivables amounted to approximately RMB248.8 million, representing a decrease of approximately RMB68.2 million or 21.5% compared to approximately RMB317.0 million as at 31 December 2023. The decrease was primarily due to less prepayment made for and on behalf of customers to utility suppliers and less deposits paid to utility suppliers.

Other receivables included RMB14.1 million (31 December 2023: RMB14.2 million) advanced to three independent third parties for business purpose. The loans were unsecured, and interest-free (except for one secured loan bearing interest at 7% per annum). Impairment provision of RMB4.4 million is required for these loans as at 31 December 2024 (31 December 2023: RMB0.8 million).

#### **OTHER PAYABLES AND ACCRUALS**

Other payables and accruals primarily comprise receipts on behalf of community residents for utilities, receipts in advances, accruals, deposits received and other payables. Other payables and accruals decreased from approximately RMB702.7 million at 31 December 2023 to approximately RMB539.7 million as at 31 December 2024. The decrease in the amount of approximately RMB163 million was due to ameliorate of high-risk contract liabilities.

## 貿易應收款項

於2024年12月31日,本集團的貿易應收款項總 額為約人民幣505.9百萬元,較2023年12月31日 的約人民幣538.3百萬元減少約人民幣32.4百萬元 或6%。減少主要是由於加強還款考核管控,提 高還款率。

### 預付款項及其他應收款項

預付款項及其他應收款項主要為代客戶支付社區 設施支出、履約保證金、合同投標保證金、業務 相關預付款項及向其他獨立第三方預付。於2024 年12月31日,本集團的預付款項及其他應收款 項約為人民幣248.8百萬元,較2023年12月31日 的約人民幣317.0百萬元減少約人民幣68.2百萬元 或21.5%。減少的主要原因是代表客戶向公用事 業供應商付款以及向公用事業供應商支付的押金 減少。

其他應收款項包括因商業目的預付給三個獨立第 三方人民幣14.1百萬元(2023年12月31日:人民 幣14.2百萬元)。貸款無抵押且免息(除一筆年利 率為7%的抵押貸款)。於2024年12月31日,該等 貸款需要計提人民幣4.4百萬元的減值撥備(2023 年12月31日:人民幣80萬元)。

#### 其他應付款項及應計費用

其他應付款項及應計費用主要包括就公用事業 向社區住戶代收款、預收款項、應計費用、已收 按金及其他應付款項。其他應付款項及應計費用 由2023年12月31日約人民幣702.7百萬元減少至 2024年12月31日約人民幣539.7百萬元。減少金 額約人民幣163百萬元,是由於高風險合約負債 減少所致。



#### LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL 流動資金、財務資源及資本架構 STRUCTURE

The Group maintains a strong and healthy financial position. The Group's principal sources of funds to finance the working capital, capital expenditure and other capital requirements were internally generated by cash flows and bank loans. As at 31 December 2024, net working capital (calculated as current assets less current liabilities) was approximately RMB505.9 million, representing an increase of RMB107.2 million from RMB398.7 million as at 31 December 2023. The current ratio (calculated as current liabilities) was 1.6 times as at 31 December 2024 (2023: 1.4 times).

As at 31 December 2024 and 31 December 2023, the Group's borrowings were denominated in RMB. The bank borrowing balances of the Group bore interest at fixed rates at 31 December 2024 and 31 December 2023. The carrying amounts of the interest-bearing bank and other borrowings at fixed rates approximate to their fair values.

The Group principally focused on the operation in the PRC. Except for the cash, bank deposits and bank borrowings denominated in foreign currencies, the Group was not subject to any other material risk directly relating to the foreign exchange fluctuation. For the year ended 31 December 2024, despite the depreciation of RMB against USD and HKD, the Directors expected that fluctuations of the RMB exchange rate would not materially and adversely affect the operations of the Group. The management will continue to monitor foreign currency exchange exposure and will take prudent measures to minimise the currency translation risk.

#### **GEARING RATIO**

The gearing ratio is defined as total borrowings add amounts due to noncontrolling equity holders of a subsidiary and net of bank balances and cash divided by total equity. As at 31 December 2024, the Group was in a strong financial position with a net cash position amounting to RMB496.2 million (2023: RMB479.2 million). Accordingly, no gearing ratio is presented. 本集團的財務狀況保持穩健。本集團為營運資金、 資本開支及其他資本要求提供的資金的主要來源 是由現金流及銀行貸款內部產生的。於2024年12 月31日,營運資金淨額(按流動資產減流動負債 計算)約為人民幣505.9百萬元,較2023年12月31 日的人民幣398.7百萬元增加人民幣107.2百萬元。 於2024年12月31日,流動比率(按流動資產/流 動負債計算)為1.6倍(2023年:1.4倍)。

於2024年12月31日及2023年12月31日,本集 團借款均以人民幣計值。於2024年12月31日及 2023年12月31日,本集團的銀行借款結餘按固 定利率計息。按固定利率計息的銀行及其他借款 的賬面值與其公平值相若。

本集團主要集中在中國進行營運。除以外幣計值 的現金、銀行存款及銀行借款外,本集團並無面 臨任何直接與外匯波動有關的其他重大風險。截 至2024年12月31日止年度,儘管人民幣兑美元 及港元貶值,董事預期,人民幣匯率波動不會對 本集團營運造成重大不利影響。管理層將繼續監 察外匯風險,並採取審慎措施,以最大程度減低 匯兑風險。

#### 資產負債比率

資產負債比率定義為借款總額加應付一家附屬公 司非控股權益持有人的款項(扣除銀行結餘及現 金)再除以權益總額。於2024年12月31日,本集 團財務狀況良好,淨現金狀況達人民幣496.2百 萬元(2023年:人民幣479.2百萬元)。因此,並無 呈列資產負債比率。

#### **PLEDGE OF ASSETS**

At 31 December 2024, investment properties and property and equipment of RMB95.0 million (2023: RMB99.0 million) were pledged to secure certain banking facilities granted to the Group.

#### **CONTINGENT LIABILITIES**

The Group had no material contingent liabilities as at 31 December 2024 (2023: Nil).

#### **PROFIT GUARANTEE**

The Board has reviewed the audited consolidated financial statements of Guangdong Huaui Environmental Engineering Company Limited for the financial year ended 31 December 2024 and is pleased to confirm that profit guarantee of consolidated net profit after tax not less than RMB13 million was met.

#### **EMPLOYEES AND REMUNERATION POLICIES**

As at 31 December 2024, the Group had approximately 9,351(2023: 8,521) employees. In order to enhance the morale and productivity of employees, employees are remunerated based on their performance, experience and prevailing industry practices. Compensation policies and packages of management staff and functional heads are being reviewed on a yearly basis. In addition to basic salary, performance related salary may also be awarded to employees based on internal performance evaluation. Moreover, the Company has adopted a share award scheme in June 2017 in order to retain elite personnel to stay with the Group and to provide incentives for their contribution to the Group.

The Group also invests in continuing education and training programmes for management staff and other employees with a view to upgrade their skills and knowledge. These training courses comprise internal courses run by the management of the Group and external courses provided by professional trainers and range from technical training for butlers to financial and administrative trainings for management staff.

#### **SHARE AWARD SCHEME**

Reference is made to the announcements of the Company in respect of grant of awarded shares between 6 July 2017 and 15 January 2019 and in respect of adoption of share award scheme (the "**Share Award Scheme**") dated 20 June 2017.

The purposes and objectives of the Share Award Scheme are to recognise the contributions by certain employees of the Group and to provide them with incentives in order to retain them for the continual operation and development of the Group and to attract suitable personnel for further development of the Group.

The Board may select any Eligible Person (other than Excluded Person) for participation in the Share Award Scheme and determine the number of the Awarded Shares to be awarded to the Selected Persons. The Board is entitled to impose any conditions (including a period of continued service within the Group after the Reference Date), as it deems appropriate with respect to the entitlement of the Selected Person to the Awarded Shares.

The maximum number of Shares which may be awarded to a Selected Person under the Share Award Scheme shall not exceed 1% of the issued share capital of the Company as at the Adoption Date. Based on the 794,172,000 Shares in issue as at the Adoption Date, the maximum entitlement of each Selected Person under the Share Award Scheme would be 7,941,720 Shares at nominal value. No amount is payable on the acceptable of an award.

Any Awarded Shares and the related income thereof held in the Account or by the Trustee and which are referable to a Selected Person shall vest in that Selected Person in accordance with the timetable and conditions as imposed by the Board at its absolute discretion, provided that the Selected Person remains at all times after the Reference Date and on the relevant Vesting Date(s) an Eligible Person of the Group.

No Awarded Shares were granted by the Company during the year ended 31 December 2024. As 1 January 2024, 31 December 2024 and the date of this annual report, 375,160 Shares were available for issue under the Share Award Scheme, representing approximately 0.04% of the issued Shares.

Subject to any early termination as may be terminated by the Board, the Share Award Scheme shall be valid and effective for a term of ten (10) years commencing on the Adoption Date and shall expire on 19 June 2027.

On 28 March 2025, the Directors resolved to recommend the payment of a final dividend of HKD2.5 cents per share for the year ended 31 December 2024 (2023: HKD2.5 cents) to the shareholders whose names appear on the register of members of the Company on 12 June 2025. Subject to the approval by the shareholders of the Company at the forthcoming annual general meeting of the Company (the "**AGM**"), the final dividend is expected to be payable on or about 10 July 2025. The aggregate amount shall be paid out of the Company's share premium account if the payment of the dividend is approved by the shareholders at the AGM.

# CORPORATE GOVERNANCE REPORT 企業管治報告

The board ("**Board**") of directors ("**Directors**") of the Company is pleased to present this corporate governance report for the year ended 31 December 2024.

#### **CORPORATE GOVERNANCE PRACTICES**

The Board is committed to maintaining and upholding high standards of corporate governance of the Company to ensure that formal and transparent procedures are in place to protect and maximise the interests of the shareholders of the Company (**"Shareholders**").

The Company has adopted the code provisions set out in the Corporate Governance Code ("**CG Code**") contained in Appendix C1 to the Rules Governing the Listing of the Securities ("**Listing Rules**") on The Stock Exchange of Hong Kong Limited ("**Stock Exchange**") as its code of corporate governance.

For the year ended 31 December 2024, the Board is of the view that the Company has complied with all code provisions set out in the CG Code in force during the reporting period save and except for the following code provisions:

Code Provision C.2.1 of Part 2 – Principle of good corporate governance code provisions and recommended best practices of the CG Code requires that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. The Company has appointed Mr. Liu Jian as both the chairman and the chief executive officer of the Company. The Board believes that vesting the roles of the chairman and chief executive officer in the same individual would enable the Company to achieve higher responsiveness, efficiency and effectiveness when formulating business strategies and executing business plans. The Board believes that the balance of power and authority is sufficiently maintained by the operation of the senior management and Board, which comprises four executive directors (including Mr. Liu Jian), two non-executive directors and three independent non-executive directors and therefore has a fairly strong independence element in its composition.

企業管治守則第二部分一良好企業管治的原則、 守則條文及建議最佳常規的守則條文C.2.1規定, 主席與行政總裁的角色應有區分,不應由一人同 時兼任。本公司已委任劉建先生為本公司主席兼 行政總裁。董事會認為,賦予一人同時兼任主席 與行政總裁可提升本公司制定業務策略及執行業 務計劃時的應對能力、效率及成效。董事會相信, 可透過經驗豐富及高質素的高級管理層及董事會 運作,充分保持權責均衡。董事會現時由四名執 行董事(包括劉建先生)、兩名非執行董事及三名 獨立非執行董事組成,故其組成具相當獨立性。

#### DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "**Model Code**") as set out in Appendix C3 to the Listing Rules as its code of conduct for Directors in their dealings in the Company's securities. Having made specific enquiry to all the Directors, all the Directors confirmed that they had complied with the required standard of dealings as set out in the Model Code for the year ended 31 December 2024.

#### **BOARD OF DIRECTORS**

The Board is responsible for the leadership and control of the Group and oversees the Group's businesses.

The Board is also responsible for performing the corporate governance duties as set out below:

- To develop and review the Company's policies and practices on corporate governance;
- To review and monitor the training and continuous professional development of Directors and senior management;
- To review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- To develop, review and monitor the code of conduct applicable to Directors and employees; and
- To review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

#### (i) Board composition

The Board currently comprises a combination of four executive Directors, two non-executive Directors and three independent nonexecutive Directors. There is a strong independent element on the Board, to ensure the independence and objectivity of the Board's decision making process as well as the thoroughness and impartiality of the Board's oversight of the management.

#### (iii) Responsibilities of the Board and management

The executive Directors, with the assistance from the senior management, form the core management team of the Company. The executive Directors have the overall responsibility for formulating the business strategies and development plan of the Company and its subsidiaries (collectively the "**Group**") and the senior management personnel are responsible for supervising and executing the plans of the Group.

#### (iv) Independence of independent non-executive Directors

In compliance with Rule 3.10(1), 3.10(2) and 3.10A of the Listing Rules, the Company has appointed three independent nonexecutive Directors. The Board considers that all independent nonexecutive Directors have appropriate and sufficient diversity, industry or finance experience and qualifications to carry out their duties so as to protect the interests of the Shareholders. One of the independent non-executive Directors, Mr. Chan Wai Cheung, Admiral is a member of the Hong Kong Institute of Certified Public Accountants.

Prior to their respective appointment, each of the independent non-executive Directors has submitted a written statement to the Stock Exchange confirming their independence and has undertaken to inform the Stock Exchange as soon as practicable if there is any subsequent change of circumstances which may affect their independence. In addition, the Company has also received a written confirmation from each of the independent non-executive Directors in respect of their independence. Based on such confirmations, the Board considers that all independent non-executive Directors are independent.

# (v) Induction for Director and continuous professional development

Each newly appointed Director is provided with necessary induction and information to ensure that he or she has a proper understanding of the Company's operations and businesses as well as his or her responsibilities under relevant status, laws, rules and regulations. The Company also provides Directors with regular updates on latest development and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. The Directors are also provided with regular updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties.

#### (iii) 董事會及管理層的責任

During the year ended 31 December 2024, each Director, namely Mr. Liu Jian, Ms. Chen Zhuo, Mr. Liang Bing, Mr. Long Weimin, Ms. Jin Keli, Ms. Xu Yaping, Mr. Chan Wai Cheung, Admiral, Mr. Chan Ka Leung, Kevin and Mr. Yin Weizhong, has participated in continuous professional development by reading relevant materials on regulatory requirements and/or attending training sessions or seminars organised by the Company or externally.

#### **CHAIRMAN AND CHIEF EXECUTIVE OFFICER**

Chairman and chief executive officer are two key aspects of the management of a company. Chairman is responsible for providing leadership for the board and management of the board while chief executive officer is responsible for day-to-day management of business. Clear division of these responsibilities should be in place to ensure a balance power and authority. The code provision C.2.1 of CG Code which provides that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual.

During the year, Mr. Liu Jian ("**Mr. Liu**") is the chairman and chief executive officer of the Company. This constitutes a deviation from the code provision C.2.1 of CG Code.

The Company considers that having Mr. Liu acting as both the chairman and chief executive officer will provide a strong and consistent leadership to the Group and allow for more effective strategic planning and management of the Group. Further, in view of Mr. Liu's experience in the industry, personal profile and role in the Group and historical development of the Group, the Group considers it is to the benefit of the Group in the business prospects that Mr. Liu continues to act as both the chairman and chief executive officer after the Listing. Therefore, the Company currently has no intention to separate the functions of chairman and chief executive officer. 本公司亦鼓勵董事參加持續專業發展,發 展及更新其知識技能。本公司的公司秘書 不時就董事的職位、職能及責任更新及提 供書面培訓材料。

截至2024年12月31日止年度,各董事(即 劉建先生、陳卓女士、梁兵先生、龍為民 先生、金科麗女士、徐亞萍女士、陳偉璋 先生、陳家良先生及尹衛忠先生)透過閱讀 有關監管規定的相關資料及/或參加由本 公司或外部舉辦的培訓課程或研討會,參 與持續專業發展。

#### 主席及行政總裁

主席及行政總裁為管理一家公司的兩個主要範疇。主席負責領導及管理董事會,而行政總裁負 責業務的日常管理。該等職責應清晰區分,以確 保權責平衡。企業管治守則的守則條文第C2.1條 規定,主席及行政總裁的職務須予區分,不應由 同一人士擔任。

年內,劉建先生(「**劉先生**」)為本公司的主席兼行 政總裁,此構成偏離企業管治守則的守則條文第 C.2.1條。

本公司認為,由劉先生同時擔任主席及行政總裁 將為本集團提供強大及貫徹的領導,使本集團的 策略計劃及管理更為有效。此外,鑒於劉先生的 行業經驗、個人履歷及於本集團擔任的職務,以 及本集團的歷史發展,本集團認為於上市後由劉 先生繼續同時擔任主席及行政總裁符合本集團的 業務前景利益。因此,本公司目前無意區分主席 及行政總裁的職能。

#### **BOARD COMMITTEES**

#### Audit committee

The Company has established an audit committee on 5 November 2015 with written terms of reference in compliance with Rule 3.21 of the Listing Rule and the Corporate Governance Code and Corporate Governance Report as set out in Appendix 14 to the Listing Rules. The audit committee consists of three members, namely Mr. Chan Wai Cheung, Admiral, Mr. Chan Ka Leung, Kevin and Mr. Yin Weizhong, all being independent non-executive Directors. Mr. Chan Wai Cheung, Admiral is the chairman of the audit committee with the appropriate professional qualifications. The primary duties of the audit committee are to review and supervise the financial reporting process and internal control system of the Group, oversee the audit process and perform other duties and responsibilities as assigned by the Board.

During the year ended 31 December 2024, four audit committee meetings were held and the individual attendance of each Director is set out in the section "Directors' Attendance Records At Meetings".

At the meetings, the members of audit committee principally reviewed and discussed with the external auditor of the Company about the Group's annual results and audited consolidated financial statements for the year ended 31 December 2023, the interim review scope and process for the Group's result for the six months ended 30 June 2024, the interim results for the six months ended 30 June 2024 and audit scope and process for the Group's annual results for the year ended 31 December 2024 and reviewed the effectiveness of the risk management and assessment, financial reporting process and internal control system, respectively.

#### **REMUNERATION COMMITTEE**

The remuneration committee meets to determine the policy for the remuneration of Directors and assess the performance of executive Directors and approving the terms of executive Directors' service contracts. In determining the remuneration for Directors, the remuneration committee takes into consideration factors such as salaries paid by comparable companies, time commitment and responsibilities of the Directors and the desirability of performance-based remuneration.

During the year ended 31 December 2024, one remuneration committee meetings were held and the individual attendance of each Director is set out in the section "Directors' Attendance Records At Meetings".

#### NOMINATION COMMITTEE

#### **NOMINATION POLICY**

#### I. Objective

1.1 The nomination policy sets out the approach and procedures the Board adopts for the nomination and selection of Directors, including the appointment of additional Directors, replacement of Directors, and re-election of Directors.

#### II. Policy Statement

- 2.1 The Company recognises the importance of having a qualified and competent Board to achieve the Group corporate strategy as well as promote shareholder value.
- 2.2 The Company believes that a Board that possesses a balance of skill set, experience, expertise and diversity of perspectives enhances decision-making capability and the overall effectiveness of the Board. The Board is committed to ensuring that proper nomination and election processes are in place for the selection and nomination of Directors.

#### III. Selection Criteria

- 3.1 In the determination of the suitability of a candidate, the nomination committee shall consider the potential contributions a candidate can bring to the Board in terms of qualifications, skills, experience, independence, age, culture, ethnicity and gender diversity. The nomination committee shall consider the following selection criteria and such other factors that it may consider appropriate for a position on the Board:
  - (i) Attributes Complementary to the Board: The candidate should possess attributes that complement and expand the skill set, experience and expertise of the Board as a whole, having regard to the current structure, size, diversity profile and skills matrix of the Board and the needs of the Board.
  - (ii) Business Experience & Board Expertise and Skills: The candidate should have the ability to exercise sound business judgment and also possess proven achievement and experience in directorship including effective oversight of and guidance to management.

#### 提名政策

- I. 目標
  - 1.1 提名政策載列董事會所採納以提名及 甄選董事的方法及程序,包括委任額 外董事、更換董事及重選董事。

#### Ⅱ. 政策聲明

- 2.1 本公司認識到擁有合資格及精幹的董 事會對於實現本集團企業戰略及提升 股東價值的重要性。
- 2.2 本公司認為,董事會擁有不同的技能、 經驗、專長及多元化角度,提高董事 會的決策能力及整體效率。董事會致 力確保設立適當的提名及選擇程序, 用於甄選及提名董事。

#### Ⅲ. 甄選標準

- 3.1 於釐定候選人是否合適時,提名委員 會應考慮候選人在資格、技能、經驗、 獨立性、年齡、文化、種族及性別多 樣性方面可為董事會帶來的潛在貢獻。 提名委員會應考慮以下甄選標準及其 認為適合董事會職位的有關其他因素:
  - (i) 與董事會相輔相成:考慮到董 事會現有架構、規模、多元化及 技能矩陣以及董事會需求,候 選人應可補充及擴展董事會整 體技能、經驗及專長。
  - (ii) 業務經驗及董事會專長與技能: 候選人應有能力作出正確的商業判斷,並於董事職務方面擁 有備受認可的成就及經驗,包 括對管理層的有效監督及指引。



- (iii) Availability: The candidate should have sufficient time for the proper discharge of the duties of a Director, including devoting adequate time for the preparation and participation in meetings, training and other Board or Company associated activities.
- (iv) **Motivation:** The candidate should be self-motivated and have a strong interest in the Company's businesses.
- Integrity: The candidate should be a person of integrity, honesty, good repute and high professional standing.
- (vi) Independence: Independent non-executive Director candidates must satisfy the independence requirements under the Listing Rules. The candidate shall be independent in character and judgement and be able to represent and act in the best interests of all Shareholders.

The above criteria are for reference only and are not meant to be exhaustive or decisive. The Board shall take into consideration the benefits of a diversified Board when selecting Board candidates.

#### **IV.** Nomination Procedures

- 4.1 Appointment of New and Replacement Directors
  - (i) If the Board determines that an additional or replacement Director is required, it will deploy multiple channels for identifying suitable director candidates, including referral from Directors, shareholders, management, advisors of the Company and external executive search firms.
  - (ii) Upon compilation and interview of the list of potential candidates, the nomination committee will shortlist candidates for consideration by the Board based on the selection criteria and such other factors that it considers appropriate. The Board has the final authority on determining suitable director candidate for appointment.

- (iii) 時間充裕:候選人應有充足的時間適當履行董事職責,包括投入足夠的時間籌備及參加會議、培訓及其他董事會或本公司相關活動。
- (iv) 積極性:候選人應積極主動,對 於本公司業務有濃厚興趣。
- (v) **誠信**:候選人應誠信、誠實、聲 譽良好及高度專業。
- (vi) 獨立性:獨立非執行董事候選人 應符合上市規則的獨立性規定。 候選人應具備獨立性及判斷力, 並能代表全體股東的最佳利益 行事。

以上標準僅供參考,並非詳盡無遺或 具有決定性意義。於甄選董事會候選 人時,董事會應考慮多元化董事會的 裨益。

#### Ⅳ. 提名程序

- 4.1 委任新董事及更換董事
  - (i) 倘董事會決定須委任額外董事 或更換董事,其將透過多種渠 道物色合適的董事候選人,包 括本公司董事、股東、管理層、 顧問及外部獵頭公司轉介。
  - (ii) 於編製及面試潛在候選人名單後,提名委員會根據甄選標準及其認為適當的有關其他因素,將候選人列入最終候選人名單供董事會考慮。董事會擁有確定委任合適董事候選人的最終權利。



- 4.2 Re-election of Directors and Nomination from Shareholders
  - (i) Where a retiring Director, being eligible, offers himself for re-election, the Board shall consider and, if consider appropriate, recommend such retiring Director to stand for re-election at a general meeting. A circular containing the requisite information on such retiring Director will be sent to shareholders prior to a general meeting in accordance with the Listing Rules.
  - (ii) Shareholder(s) may nominate a candidate to stand for election as a Director at a general meeting in accordance with the "Procedures for shareholders to propose a person for election as a director of the Company" published by the Company from time to time.

#### V. Review and Monitoring

5.1 The Board will from time to time review this Policy and monitor its implementation to ensure its continued effectiveness and compliance with regulatory requirements and good corporate governance practice.

#### **BOARD DIVERSITY**

The Company recognises and embraces the benefits of having a diverse Board, and sees increasing diversity at Board level as an essential element in maintaining an effective Board to enhance the quality of its performance. The Board has adopted the Board Diversity Policy with an aim to promote broad experience and diversity on the Board.

In designing the Board composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

The Board has reviewed, through the nomination committee, the structure, size, composition and diversity of the Board as well as the nomination and appointment procedure of Directors during the year.

#### A. Risk Management and Internal Control Review

During the financial year ended 31 December 2024, the Board has conducted an annual review on the effectiveness of the Group's risk management and internal control systems. The following is the summary of the Internal Control and Risk Management Report.

This report summarises our assessment and procedures for the Company's risk management, and its internal control is considered to be sufficient and at low risk. This report also aims to assist the Company to recognise its internal control weakness in relevant financial procedures, systems and internal controls area.

Our assessment commencing from assessing the over compliance system and risk management control, the financial reporting and disclosure control, and the operating controls of the Company. Approaches include interviews with management, reviewing on relevant documents, walkthroughs of processes, tests on selected operating samples, and a follow-up assessment after implementation of recommendation on internal control issues.

We have performed annual enquiries, reviewed of company's documents, and on-site inspection to identify and understand the extent of the risks. The Board of Directors has full responsibility to set up a strategy when designing a system of internal controls that eliminate risk and achieve business objectives. In our findings, an Internal Control and Risk Management basic framework is established and it consists of effectiveness and efficiency of operation; reliability of financial reporting; and compliance with applicable laws and regulations. An Operation Manual is also imposed for employees to comply with applicable laws and all in-house procedures and practices.

On an annual basis, the department heads review and update their risk registers; discussion sessions are then led by the Chief Executive. Control activities are built on top-level reviews, segregation of duties and physical controls by documenting all control process in policies and procedures to limit delegation of authority, identifying the material risks, planning the action items, and finalizing the budget and business objectives through variance analyses. The company secretary and legal advisor are also responsible to review adherence to the laws, while the Board is responsible to delegate roles and authorities to the Board members and senior management and ensure they understand them.

For employee risk management, the Code of Conduct and Business Ethics are set out; training sessions are regularly held to reiterate the Company's zero tolerance approach to bribery and proper business ethics.

#### A. 風險管理及內部監控檢討

截至2024年12月31日止財政年度內,董事 會對本集團風險管理及內部監控系統的有 效性進行了年度檢討。以下為該風險管理 及內部監控檢討的概要。

本報告概括了我們對本公司風險管理的評 估及程序,而其內部監控被視為足夠且低 風險。本報告亦旨在協助本公司確認其在 相關財務程序、系統及內部監控範疇的內 部監控弱點。

我們的評估工作從評估本公司守規系統及 風險管理控制、財務報告和披露控制及經 營控制入手。評估手法包括與管理層面談, 審閱相關文件,走查程序,對選定經營樣 板作測試,以及對實施針對內部監控問題 的推薦建議後作跟進評估。

我們進行了年度查詢、公司文件審視及實 地視察,以便識別並了解風險程度。董事 會有全面責任制定策略以設計出一個可消 除風險並能達致業務目標的內部監控系統。 在我們的查詢結果中,內部監控及風險管 理基本框架已經確立,其中包含營運有效 性及效率;財務報告可靠性;以及遵守 用法律法規的合規性。亦有製發營運手册 供僱員使用,以便僱員遵守適用法律法規 及所有內部程序和常規。

部門主管會每年檢討並更新其風險登記冊, 然後在行政總裁領導下開會討論。控制活 動建基於高層檢討、職責分工及實質控制 (以文件記錄所有政策和程序上的控制流程, 從而限制權力下放,識別重大風險、規劃 行動項目及通過方差分析敲定預算及業務 目標。公司秘書和法律顧問亦負責審視有 否守法,而董事會則負責分配角色及授權 予董事會成員及高級管理層,確保各人明白。

僱員的風險管理方面,本公司已制定操守 守則及商業道德準則,並定期舉行集訓, 重申公司對賄賂零容忍及宣揚正當商業道 德的立場。

#### **B.** Internal Audit Function

During the financial year ended 31 December 2024, the Company has an internal audit department which consists of 2 employees to monitor the daily operations of the Group. Besides, the Company also appointed an internal control advisor (the "**IC Advisor**") to perform internal audit for the Group during the financial year ended 31 December 2024. The IC Advisor reported to the audit committee and to the Company's management. The IC Advisor conducted its internal audit review activities according to the endorsed internal audit plan during the financial year ended 31 December 2024. The IC Advisor reported the internal audit findings and recommendations to both the audit committee and the management of the Group. The management of the Group agreed on the internal audit findings and adopted the recommendations by the IC Advisor accordingly.

#### C. Management's confirmation on risk management

Based on the risk management mechanism and internal audit review activities mentioned in the aforementioned paragraphs, the management of the Group had provided a confirmation to the Board that the Group had maintained an effective risk management mechanism and internal control system during the financial year ended 31 December 2024.

No significant areas of concern that may affect the financial, operational, compliance controls, internal audit, risk management and internal controls functions of the Group were identified. There is no material weakness in the internal control of the Company identified.

The Board and the audit committee, continue to evaluate the adequacy of resources, qualifications and experience of staff in the Group's accounting and financial reporting and internal audit functions, as well as that function's training programs and budget. Based on its annual review, the Board and the audit committee are not aware of any material deficiencies in the effectiveness of risk management and internal control for the year ended 31 December 2024 and consider them effective and adequate.

#### B. 內部審核職能

#### **SHAREHOLDER RIGHTS**

# Convening an extraordinary general meeting ("EGM") and putting forward proposals at EGM

Pursuant to Article 58 of the Articles of Association of the Company, any one or more shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If within 21 days of the requisition the Board fail to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

# Procedures for directing shareholders' enquiries to the Board

The annual report and the Company's website provide the contact details of the Company. Shareholders may at any time send their enquiries and concerns to the Board in writing. Shareholders may also make enquiries with the Board at the general meetings of the Company.

# Procedures for putting forward proposals at general meetings by shareholders

There are no provisions allowing shareholders to put forward proposals at the general meeting under the Cayman Islands Company Laws or the articles of association of the Company. The above mentioned conditions must be satisfied at the same time. If any of the company.

The arrangement of the Performance Bonus is due to the reallocation and assignment of additional duties and responsibilities to Mr. Liu Jian, Ms. Chen Zhuo, Mr. Liang Bing and Mr. Long Weimin to manage the businesses of the Group including Zhejiang Yongcheng and Jinan Kuaiqin immediately after the retirement of a personnel (the "**Retired Personnel**") who was responsible for management of the businesses operation of the Group including Zhejiang Yongcheng and Jinan Kuaiqin. With the above reallocation and assignment of additional duties and responsibilities, it is to aim for growth and improvement of the overall performance of the Group including Zhejiang Yongcheng and Jinan Kuaiqin.

Taking into account that Mr. Liu Jian, Ms. Chen Zhuo, Mr. Liang Bing and Mr. Long Weimin are able to take up additional duties and responsibilities that left over by the Retired Personnel immediately (which save the cost and time in searching for suitable candidate for replacement); Mr. Liu Jian, Ms. Chen Zhuo, Mr. Liang Bing and Mr. Long Weimin are well experienced and familiar with the operations of the Group; and both of the Performance Indicators represent a growth as compare to the year ended 31 December 2024, the Company considers that the arrangement of the Performance Bonus is in the best interests of the Company and its shareholders as a whole.

#### PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The principal activity of the Company is investment holding. Its subsidiaries are primarily engaged in the provision of property management services, sales assistance services, provision of cleaning and greening services and provision of real estate agency services in the PRC. Further discussion and analysis of these activities as required by Schedule 5 to the Hong Kong Companies Ordinance, including a fair review of the business and a discussion of the principal risks and uncertainties facing the Group, particulars of important events affecting the Group that have occurred since the end of the financial year 2024, and an indication of likely future development in the Group's business, can be found in the "Chairman's Statement", "Management Discussion and Analysis" and "Corporate Governance Report" sections of this annual report. The above sections form part of this report.

During the year, the Company has complied with all the relevant laws and regulations that have a significant impact on the operations of the Group.

#### **ENVIRONMENTAL POLICIES AND PERFORMANCE**

The Group is committed to reducing emissions and minimizing negative environmental impacts through the implementation of the environmental management system ("**EMS**") across our properties. The Group's EMS is certified to the international standard ISO14001. Apart from complying with all relevant international and local regulations, the Group regularly identify potential environmental risks and strive for continuous improvement. The key environmental concerns from the Group's operations relate to resource use and waste management. The Group have implemented relevant initiatives, such as implementation of metering systems to monitor the energy and water consumption, installation of LED lighting and energy efficient water pumps. The Group also promote environmental protection awareness to its employees and property owners through posting reminders and providing recycle bins.

The Group obtain the certification from OHSAS18001 occupational health and safety management system. The Group prides itself on providing a safe, effective and congenial work environment and it values the health and well-being of its staff. Adequate arrangements, training and guidelines have been implemented to ensure its working environment is healthy and safe.

The Company's Environmental, Social and Governance Report, regarding the same year covered in this annual report, will be posted on the websites of the Stock Exchange and the Company with the publication of this annual report.

The aggregate amount shall be paid out of the Company's share premium account if the payment of the dividend is approved by the shareholders at the AGM.

  - any other factors that the Board deems relevant.
- 2.3 The declaration and payment of dividends by the Company is subject to any restrictions under the Companies Law of the Cayman Islands, the Company's memorandum and articles of association, the Listing Rules and any other applicable laws and regulations.

As at 31 December 2024, the balance of trade receivables amounted to RMB659,920,000 and the related provision for impairment amounted to RMB154,056,000. In addition, the balance of other receivables amounted to RMB307,685,000 and the related provision for impairment amounted to RMB114,400,000. For the trade receivables, management recognised an impairment provision based on the expected credit loss (ECL) model under Hong Kong Financial Reporting Standards ("HKFRS") 9 Financial Instruments. The measurement of ECLs requires the application of management's significant judgement and estimation, such as the existence of disputes, historical payment record, forward-looking factors and any other available information. Meanwhile, for the other receivables, management recognised an impairment provision based on the general approach. The measurement requires management to assess whether there is any significant increase in credit risk. Therefore, we identified it as a key audit matter.

The valuation of the investment properties involves significant estimates and key assumptions on items such as the selection of comparable properties and market price.

In the absence of current prices in an active market for appropriate similar properties, the Group considers information from a variety of sources, including current prices in an active market for properties of a different nature, condition or location, less active market transactions and discounted cash flows of rental income.

- Checking the property related information and involving our valuation specialists to assist us in reviewing and assessing the underlying assumptions adopted by the valuers in their valuation, such as the selection of comparable properties and market price. 檢查物業相關信息並加入我們的估值專家協助我 們審視及評估估值師在其估值中採納的相關假設, 如選取可資比較物業及市場價格。

We found that the valuation of investment properties was supported by available evidence. 本所發現投資物業估值得到證據支持。

#### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with HKFRS Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties and financial assets at fair value through profit or loss ("**FVTPL**") which have been measured at fair value. These financial statements are presented in Renminbi ("**RMB**") and all values are rounded to the nearest thousand except when otherwise indicated.

#### **Basis of consolidation**

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "**Group**") for the year ended 31 December 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

### 2.1 編製基準

#### Basis of consolidation (Continued)

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the noncontrolling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The 2020 Amendments clarify the requirements for classifying (b) liabilities as current or non-current, including what is meant by a right to defer settlement and that a right to defer must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement. The amendments also clarify that a liability can be settled in its own equity instruments, and that only if a conversion option in a convertible liability is itself accounted for as an equity instrument would the terms of a liability not impact its classification. The 2022 Amendments further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. Additional disclosures are required for non-current liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period.

The Group has reassessed the terms and conditions of its liabilities as at 1 January 2023 and 2024 and concluded that the classification of its liabilities as current or noncurrent remained unchanged upon initial application of the amendments. Accordingly, the amendments did not have any impact on the financial position or performance of the Group.

(c) Amendments to HKAS 7 and HKFRS 7 clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. The disclosure requirements in the amendments are intended to assist users of financial statements in understanding the effects of supplier finance arrangements on an entity's liabilities, cash flows and exposure to liquidity risk. As the Group does not have supplier finance arrangements, the amendments did not have any impact on the Group's financial statements.

Further information about those HKFRSs that are expected to be applicable to the Group is described below.

HKFRS 18 replaces HKAS 1 Presentation of Financial Statements. While a number of sections have been brought forward from HKAS 1 with limited changes, HKFRS 18 introduces new requirements for presentation within the statement of profit or loss, including specified totals and subtotals. Entities are required to classify all income and expenses within the statement of profit or loss into one of the five categories: operating, investing, financing, income taxes, and discontinued operations and to present two new defined subtotals. It also requires disclosures about management-defined performance measures in a single note and introduces enhanced requirements on the grouping (aggregation and disaggregation) and the location of information in both the primary financial statements and the notes. Some requirements previously included in HKAS 1 are moved to HKAS 8 Accounting Policies, Changes in Accounting Estimates and Errors, which is renamed as HKAS 8 Basis of Preparation of Financial Statements. As a consequence of the issuance of HKFRS 18, limited but widely applicable amendments are made to HKAS 7 Statement of Cash Flows, HKAS 33 Earnings per Share, and HKAS 34 Interim Financial Reporting. In addition, there are minor consequential amendments to other HKFRSs. HKFRS 18 and the consequential amendments to other HKFRSs are effective for annual periods beginning on or after 1 January 2027, with earlier application permitted. Retrospective application is required. The Group is currently analysing the new requirements and assessing the impact of HKFRS 18 on the presentation and disclosure of the Group's financial statements.

HKFRS 19 allows eligible entities to elect to apply reduced disclosure requirements while still applying the recognition, measurement, and presentation requirements in other HKFRSs. To be eligible, at the end of the reporting period, an entity must be a subsidiary as defined in HKFRS 10 *Consolidated Financial Statements*, cannot have public accountability, and must have a parent (ultimate or intermediate) that prepares consolidated financial statements available for public use which comply with HKFRSs. Earlier application is permitted. As the Company is a listed company, it is not eligible to elect to apply HKFRS 19. Some of the Company's subsidiaries are considering the application of HKFRS 19 in their specified financial statements.

香港財務報告準則第18號取代香港會計準 則第1號—財務報表的呈列。雖然若干章 節從香港會計準則第1號轉移且變動有限, 但香港財務報告準則第18號引入了損益表 中呈列的新規定,包括指定的總額和小計 數目。實體需要將損益表中的所有收入和 支出分類為五個類別之一:經營、投資、融 資、所得税及已終止業務,並呈列兩個新的 定義小計。其亦要求在單一附註中披露管 理層定義的績效指標, 並引入對主要財務 報表及附註中資料分類(合計及分解)和位 置資料的進一步要求。香港會計準則第1號 過往包含的若干規定已轉移至香港會計準 則第8號會計政策、會計估計變動及錯誤, 並重新命名為香港會計準則第8號財務報表 編製基礎。由於頒佈香港財務報告準則第 18號,故此對香港會計準則第7號現金流量 表、香港會計準則第33號每股盈利及香港 會計準則第34號中期財務報告進行了有限 但廣泛適用的修訂。此外,其他香港財務報 告準則亦已作出輕微後續修訂。香港財務 報告準則第18號及對其他香港財務報告準 則的後續修訂將於2027年1月1日或之後開 始的年度期間生效,並允許提前應用,亦需 要作出追溯應用。本集團目前正在分析新 規定,並評估香港財務報告準則第18號對 本集團財務報表的呈列及披露的影響。

香港財務報告準則第19號允許符合資格的 實體選擇應用減少的披露規定,同時仍然 應用其他香港財務報告準則中的確認、計 量及呈報規定。於報告期末,為符合資格, 實體必須是香港財務報告準則第10號綜合 財務報表所界定附屬公司,不得具有公眾 問責性,並且必須有一家母公司(最終或問 接)編制符合香港財務報告準則的綜合財務 報表供公眾使用。準則允許提前應用。由 於本公司為上市公司,故不符合資格選擇 應用香港財務報告準則第19號。本公司若 下附屬公司正在考慮在其特定財務報表中 應用香港財務報告準則第19號。

Amendments to HKFRS 9 and HKFRS 7 clarify the date on which a financial asset or financial liability is derecognised and introduce an accounting policy option to derecognise a financial liability that is settled through an electronic payment system before the settlement date if specified criteria are met. The amendments clarify how to assess the contractual cash flow characteristics of financial assets with environmental, social and governance and other similar contingent features. Moreover, the amendments clarify the requirements for classifying financial assets with non-recourse features and contractually linked instruments. The amendments also include additional disclosures for investments in equity instruments designated at fair value through other comprehensive income and financial instruments with contingent features. The amendments shall be applied retrospectively with an adjustment to opening retained profits (or other component of equity) at the initial application date. Prior periods are not required to be restated and can only be restated without the use of hindsight. Earlier application of either all the amendments at the same time or only the amendments related to the classification of financial assets is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKFRS 10 and HKAS 28 address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 was removed by the HKICPA. However, the amendments are available for adoption now.

Amendments to HKAS 21 specify how an entity shall assess whether a currency is exchangeable into another currency and how it shall estimate a spot exchange rate at a measurement date when exchangeability is lacking. The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. Earlier application is permitted. When applying the amendments, an entity cannot restate comparative information. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening balance of retained profits or to the cumulative amount of translation differences accumulated in a separate component of equity, where appropriate, at the date of initial application. The amendments are not expected to have any significant impact on the Group's financial statements.

Annual Improvements to HKFRS Accounting Standards — Volume 11 set out amendments to HKFRS 1, HKFRS 7 (and the accompanying Guidance on implementing HKFRS 7), HKFRS 9, HKFRS 10, and HKAS 7. Details of the amendments that are expected to be applicable to the Group are as follows:

#### Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with HKFRS 5 *Noncurrent Assets Held for Sale and Discontinued Operations*.

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss or other comprehensive income, as appropriate.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

由收購方轉讓的任何或有代價於收購日期 按公平值確認。分類為資產或負債的或有 代價按公平值計量,公平值變動於損益確 認。分類為權益的或有代價毋須重新計量, 其後結算於權益入賬。

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cashgenerating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

#### Fair value measurement

The Group measures its investment properties, derivative financial instruments and equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the asset or liability, assuming that market participants act in their economic best interest.

#### 公平值計量

An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cashgenerating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cashgenerating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of comprehensive income or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of comprehensive income in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

#### Property and equipment and depreciation

Property, and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of comprehensive income in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property and equipment to its residual value. The principal annual rates used for this purpose are as follows:

Where parts of an item of property and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of comprehensive income in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Investment properties are interests in land and buildings held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of comprehensive income in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of comprehensive income in the year of the retirement or disposal.

#### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

#### Software and trademark

Purchased software and trademark are stated at cost less any impairment losses and are amortised on the straight-line basis over their estimated useful lives of 3 to 10 years.

#### Acquired property management contracts

Acquired property management contracts are stated at cost less any impairment losses and are amortised on the sum of the years digits basis over their estimated useful lives of 5 to 15 years.

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-ofuse asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

#### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are included in interest-bearing bank borrowings.

#### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease term. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

#### Investments and other financial assets

#### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

**Initial recognition and measurement** (Continued)

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("**SPPI**") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

#### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

#### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of comprehensive income when the asset is derecognised, modified or impaired.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of comprehensive income.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on the equity investments are also recognised as other income in the statement of comprehensive income when the right of payment has been established.

#### **Derecognition of financial assets**

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third-party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("**ECLs**") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### **General approach**

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

預期信貸虧損分兩個階段進行確認。就自 初始確認起未有顯著增加的信貸風險而言, 預期信貸虧損就由未來12個月內可能發生 違約事件而導致的信貸虧損計提撥備(12個 月預期信貸虧損)。就自初始確認起經已顯 著增加的信貸風險而言,不論何時發生違 約,於餘下風險年期內的預期信貸虧損均 須計提虧損撥備(全期預期信貸虧損)。

於各報告日期,本集團評估金融工具的信 貸風險自初始確認起有否顯著增加。作出 評估時,本集團將截至報告日期金融工具 發生違約的風險與初始確認日期金融工具 發生違約的風險進行比較,並考慮在無須 付出不必要的額外成本或努力即可獲得合 理且有依據的資料,包括歷史及前瞻性資 料。本集團認為合約付款逾期超過30天時 信貸風險大幅增加。

本集團會在合約付款逾期90日時考慮金融 資產違約。然而,在若干情況下,倘內部 或外部資料反映,在沒有計及本集團任何 現有信貸提升措施前,本集團不大可能悉 數收到未償還合約款項,則本集團亦可認 為金融資產將會違約。

當並無合理預期收回合約現金流量時,會 撇銷金融資產。

- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

#### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

#### **Financial liabilities**

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings or payables as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, lease liabilities and interest-bearing bank borrowings.

#### Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

#### Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities at amortised cost (trade and other payables, and borrowings)

After initial recognition, trade and other payables, and interestbearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of comprehensive income when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of comprehensive income.

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of comprehensive income.

#### **Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of comprehensive income.

#### **Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

#### 撥備

當本公司現時因過往事件而須承擔法定或 推定責任,而履行責任可能導致日後資源 流出,且有關責任金額能可靠估算時,則 確認撥備。

當折現影響重大時,所確認的撥備金額為 預期日後履行責任所需的開支於呈報期結 算日的現值。隨時間推移而增加的折現現 值,在全面收益表內計入財務成本。

#### 所得税

所得税包括即期及遞延税項。有關於損益 外確認之項目的所得税於損益外確認,或 於其他全面收入確認或直接於權益確認。

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associates and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

#### **Government grants**

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### (a) Provision of property management services

Revenue from the provision of property management services is recognised over the scheduled period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

#### (b) Provision of cleaning and greening services

Revenue from cleaning and greening services is recognised when the relevant services are rendered and the customer simultaneously receives and consumes the benefits provided by the Group.

#### (c) Sales of goods

Revenue from the sales of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

#### (d) Other services

Revenue from other services is recognised when the relevant services are rendered and the customer simultaneously receives and consumes the benefits provided by the Group.

#### Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

#### **Contract liabilities**

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

股息收入於確立股東收取付款的權利時確 認,股息涉及的經濟利益可能流入本集團, 且股息數額能可靠地計量。

### 合約負債

#### Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "**MPF Scheme**") under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of comprehensive income as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute 14% to 20% of its payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### **Borrowing costs**

All borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

### 退休金計劃

根據強制性公積金計劃條例,本集團為其 全體僱員設有定額供款強制性公積金退休 福利計劃(「強積金計劃」)。供款乃根據僱 員基本薪金的某個百分比計算,並按照強 積金計劃的規則於繳付供款時於全面收益 表內扣除。強積金計劃的資產與本集團的 資產分開,由獨立管理的基金持有。本集 團繳付的僱主供款於存入強積金計劃後即 全數歸屬於僱員。

本集團在中國內地營運的附屬公司所聘僱 員,須參與由當地市政府籌辦的中央退休 金計劃。該等附屬公司須將彼等薪金成本 的14%至20%作為中央退休金計劃供款。供 款根據中央退休金計劃的規則成為應付時 於損益扣除。

### 借款成本

所有借款成本於產生期間支銷。借款成本 包括實體就借款所產生的利息及其他成本。

If the Group receives information after the reporting period, but prior to the date of authorisation for issue, about conditions that existed at the end of the reporting period, it will assess whether the information affects the amounts that it recognises in its financial statements. The Group will adjust the amounts recognised in its financial statements to reflect any adjusting events after the reporting period and update the disclosures that relate to those conditions in light of the new information. For non-adjusting events after the reporting period, the Group will not change the amounts recognised in its financial statements, but will disclose the nature of the non-adjusting events and an estimate of their financial effects, or a statement that such an estimate cannot be made, if applicable.

#### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

### **Foreign currencies**

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of comprehensive income.

#### Foreign currencies (Continued)

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of overseas subsidiaries are currencies other than RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of comprehensive income are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of comprehensive income.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

### 3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### Revenue from contracts with customers

The Group applied the following judgements that significantly affect the determination of the amount and timing of revenue from contracts with customers:

#### *(i) Identifying performance obligations in multiple underlying activities of property management services*

The Group provides property management services which comprised multiple underlying activities to the customers (i.e., security, maintenance, cleaning, landscaping, administrative and support services).

While each of these activities are individually capable of being distinct, the Group determined that they are not distinct within the context of the contract because the ultimate objective of the management services is to perform any activities that are necessary to ensure that the properties are operating as intended. In addition, the Group determined that the management services represent a series of services that are substantially the same and have the same pattern of transfer to the customers over the term of the contract. Each distinct service represents a performance obligation that would be satisfied over time (i.e., over the length of the contract, not at a point in time) and has the same measure of progress (e.g., time elapsed). Consequently, the Group determined the multiple underlying activities of property management services to be accounted for as a single performance obligation.

### (ii) Determining the method to estimate variable consideration and assessing the constraint for property management services

The Group gives discount to the customers as a strategy to improve the cash collection of property management fees, which give rise to variable consideration. The Group determined that the expected value method is the appropriate method to use in estimating the variable consideration for reductions in property management services, given that there is a wide range of possible outcomes which are subject to specific cases and negotiations with customers.

Before including any amount of variable consideration in the transaction price, the Group considers whether the amount of variable consideration is constrained. The Group determined that the estimates of variable consideration are not constrained based on its historical experience, current negotiations with customers and the current economic conditions. In addition, the uncertainty on the variable consideration will be resolved within a short time frame.

#### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Significant judgements and estimates are involved in the identification of cashgenerating units, operating profit forecasts, perpetuity growth rates and discount rates. Changes in these assumptions can result in material differences in impairment charges or available headroom. Further details are given in note 16.

#### Provision for expected credit losses on trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

#### 商譽減值

管理層至少每年釐定商譽有否減值。此要 求估計獲分配商譽現金產生單位的使用價 值。現金產生單位識別、經營溢利預測、 永久增長率及折現率涉及重大判斷及估計。 該等假設的變動可導致減值費用或可用淨 額重大不同。進一步詳情載於附註16。

貿易應收款項的預期信貸虧損準備

本集團使用撥備矩陣計算貿易應收款項的 預期信貸虧損。撥備率根據具有類似損失 模式(即客戶類別)的各個客戶群的分組的 逾期天數計算。

撥備矩陣最初基於本集團的歷史觀察違約 率。本集團將通過調整矩陣以調整歷史信 用損失經驗與前瞻性資訊。於各報告日期, 歷史觀察到的違約率均被更新,並分析前 瞻性估計的變化。

Provision for expected credit losses on trade receivables (Continued)

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 23 to the financial statements.

#### Estimation of fair value of investment properties

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources for estimation of fair value of investment properties, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences; and
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

Further details, including the key assumptions used for fair value measurements, are set out in note 14 to the financial statements.

估算投資物業的公平值

在欠缺相類物業的活躍市場的現行價格情況下,本集團考慮來自多個不同源頭的資料來估計投資物業的公平值,包括:

- (a) 不同性質、狀況或地點的物業在活躍 市場上的現行價格,並作出調整以反 映上述差異;及
- (b) 類似物業於活躍程度稍遜的市場的最近期價格,並作出調整以反映自交易按有關價格進行之日期起出現之任何經濟狀況變動;及根據對未來現金流量所作的可靠估計而得出的折現現金流量預測,以任何現有租約及其他合約之條款及(在可能情況下)外在證據(例如地點及狀況相同的類似物業的現行市場租金)作為支持理據,並採用足以反映當時市場對現金流量的金額及時機的不確定因素所作評估之折現率。

For management purposes, the chief operating decision maker (the "**CODM**") reviews the operating results of the Group as a whole to make decision about resources allocation. The CODM organised into business units based on different lines of services rendered in the PRC as follows:

- (a) The Group primarily provides property developers and property owners with a broad range of property management services for mainly residential properties, and commercial and government buildings. Services provided by the Group include standard property management services and ancillary services;
- (b) The Group provides property developers and property owners with a series of indoor and outdoor environmental cleaning, greening and maintenance services. This business division also provides services to the property developers and property owners of the property management business division. Accordingly, segment results of cleaning and greening division are evaluated by the Group's management on services as subcontracted from the property management business division; and
- (c) Other businesses comprise sales of elevators and installation services, provision of security services, real estate consulting and agency services, sales assistance services, engineering services, catering services and the sale of engineering spare parts.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment revenue and profit (which is a measure of adjusted profit before tax). The adjusted profit before tax is measured consistently with the Group's profit before tax except that bank interest income, other interest income from financial assets at fair value through profit or loss, changes in fair value of investment properties, fair value adjustment of contingent consideration, net foreign exchange loss, share of profits of joint ventures, share of profits of associates, net foreign exchange gains, non-lease-related finance income/costs as well as head corporate expenses are excluded from such measurement.

Segment assets exclude deferred tax assets, cash and cash equivalents, financial assets at fair value through profit or loss and other unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude interest-bearing bank and other borrowings (other than lease liabilities), tax payable, deferred tax liabilities and other unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

Intersegment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

According to the relevant PRC tax regulations, High-New Technology Enterprise (the "**HNTE**") operating within a High and New Technology Development Zone an entitled to a reduced EIT rate of 15%. A subsidiary is recognised as HNTE during the year and accordingly, is subject to EIT 15%. The recognition as a HNTE is subject to review on every three years by relevant government bodies.

The Group's investment properties were revalued on 31 December 2024 based on valuations performed by Jones Lang LaSalle Corporate Appraisal and Advisory Limited, an independent firm of professionally gualified valuers, using the market approach, as at 31 December 2024. Each year, the Group's property manager and the directors decide, after approval from the audit committee, to appoint which external valuer to be responsible for the external valuations of the Group's properties. Selection criteria include market knowledge, reputation, independence and whether professional standards are maintained. The Group's property manager and the directors have discussions with the valuer on the valuation assumptions and valuation results twice a year when the valuation is performed for interim and annual financial reporting.

The Group's investment properties with a carrying value of RMB95,365,000 (2023: RMB98,981,000) were pledged to secure general banking facilities granted to the Group as at 31 December 2024 (note 29).

At the end of the reporting period, the cash and cash equivalents of the Group denominated in RMB amounted to RMB538,145,000 (2023: RMB517,913,000). The RMB is not freely convertible into other currencies, however, under Mainland China's Foreign Exchange Control Regulations and Administration of Settlement, Sale and Payment of Foreign Exchange Regulations, the Group is permitted to exchange RMB for other currencies through banks authorised to conduct foreign exchange business.

The Group collects deposits from certain community residents to establish daily repair and maintenance funds in accordance with the relevant rules and regulations in the PRC.

All of the deposits collected are required to be kept in designated bank accounts under the name of the relevant subsidiaries of the Group though the deposits collected and the related interest income belong to the community residents. Pursuant to the property management agreements between the Group and the community residents, the withdrawal and use of the funds are subject to approval by the community residents. As the monies maintained for daily repair and maintenance funds are not controlled by the Group, they are not recorded as bank balances by the Group. As at 31 December 2024, RMB23,760,000 (2023: RMB21,766,000) was kept in the daily repair and maintenance funds on behalf of the community residents.

Cash at banks earns interest at floating rates based on daily bank deposit rates. #### **31. RESERVES**

The amounts of the Group's reserves and the movements therein for the current and prior years are presented in the consolidated statement of changes in equity to the financial statements.

#### (a) Statutory reserves

In accordance with the PRC Company Law and the PRC subsidiaries' articles of association, each subsidiary registered in the PRC as a domestic company is required to appropriate 10% of its annual statutory net profit as determined under generally accepted accounting principles of The People's Republic of China (the "**PRC GAAP**") after offsetting any prior years' losses to the statutory surplus reserve. When the balance of this reserve fund reaches 50% of the entity's capital, any further appropriation is optional. The statutory reserve can be utilised to offset prior years' losses or to increase capital. However, the balance of the statutory surplus reserve must be maintained at a minimum of 25% of the capital after these usages.

#### (b) Other reserve

The amount represented the contribution from Mr. Liu Jian, the controlling shareholder and director of the Company, through transferring his 40% equity interest in Guangdong Zhong Ao, a subsidiary of the Company, to Mr. Long Weimin and Mr. Liang Bing, both being directors of the Company and employees of Guangdong Zhong Ao in 2011.

#### (c) Special reserve

The special reserve mainly arises from (i) deemed contributions by the shareholders in previous years' Group reorganisation and non-controlling equity holders to the Group; (ii) difference between the consideration paid by the Group and the additional share of net assets in subsidiaries acquired from non-controlling equityholders; (iii) divestment of interests in subsidiaries; (iv) capital contribution from non-controlling equity holders.

The special reserve arised in the current year mainly represents (i) the divestment of interest in a subsidiary; and (ii) the difference between the consideration paid by the Group and the additional share of net assets in subsidiaries acquired from non-controlling equityholders.

The fair values of non-current portion of interest-bearing bank and other borrowings have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The changes in fair value as a result of the Group's own non-performance risk for interest-bearing bank and other borrowings as at 31 December 2024 was assessed to be insignificant.

The fair values of financial assets at fair value through profit or loss have been calculated using Monte Carlo simulation with rates currently available for instruments with similar terms, credit risk and remaining maturities.

Management has assessed that the fair values of the interestbearing bank borrowings with fixed rates which approximate to their carrying amounts largely due to the fact that these borrowings are made between the Group and independent third-party financial institutions based on prevailing market interest rates.

Management has also assessed that the fair values of the Group's other financial instruments approximate to their carrying amounts largely due to the short term maturities of these instruments.

Below is a summary of the significant unobservable input to the valuation of financial instruments together with a quantitative sensitivity analysis as at 31 December 2024 and 2023:

#### 39. FINANCIAL RISK MANAGEMENT OBJECTIVES 39. AND POLICIES

The Group's financial instruments include financial assets at fair value through profit or loss, cash and cash equivalents, other payables and interest-bearing bank borrowings. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as financial assets included in prepayment and other receivables, trade and bills receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

#### Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's interest-bearing bank borrowings.

No sensitivity analysis of interest-bearing bank and other borrowings is presented as a reasonably possible change in interest rate would not have significant impact on profit or loss of the Group.

#### Foreign currency risk

The Group has minimal exposures to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in RMB except for those owed and incurred by the Company and subsidiaries which are dominated in United States dollars and Hong Kong dollars. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

#### **Credit risk**

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

#### Maximum exposure and year-end staging

The table below shows the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 31 December 2024 and 31 December 2023. The amounts presented are gross carrying amounts for financial assets and the exposure to credit risk for the financial guarantee contracts.

#### **Capital management**

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group is not subject to any externally imposed capital requirements. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2024 and 31 December 2023.

The Group monitors capital using a gearing ratio, which is net debt divided by the adjusted capital plus net debt. Net debt includes interest-bearing bank and other borrowings less cash and cash equivalents. Capital includes equity attributable to owners of the parent. The gearing ratios as at the end of the reporting periods were as follows:
