CHAIRMAN'S STATEMENT 主席報告

On behalf of the Board, I am pleased to present to you the annual results of China Shuifa Singyes New Materials Holdings Limited (the "Company") and its subsidiaries (the "Group") for the year ended 31 December 2024.

For the year ended 31 December 2024, the revenue of the Group was approximately RMB109.3 million, representing a year-on-year increase of 28.0%.

BUSINESS DEVELOPMENT

Upholding leading strategic role In 2024, the revenue of Smart PDLC products of the Group was approximately 79.6 million, which enabled this principal business to maintain a leading position in terms of market share in the PRC.

Upholding cost reduction and efficiency improvement The Group had effectively reduce production cost by changing the operation model, developing new products, introducing competitive products and improving production techniques throughout all areas of operations from research and development, procurement to production.

Upholding product market expansion In 2024, the production of motor vehicle films of the Group had been continue to enlarge, which continue to tapping into the motor vehicle sector. Through efforts in recent years, relying on ITO development advantages and years of accumulation and reputation in the industry, the Group has officially joined the supplier system of well-known automotive glass manufacturers, consolidating its position in the industry and laying a good foundation and development prospects.

截至二零二四年十二月三十一日止,本集 團收入為約人民幣109.3百萬元,同比增加 28.0%。

業務發展

堅持首位度引領戰略於二零二四年,本集團智能調光產品收入為約人民幣79.6百萬元,主 營業務在國內市場佔有率居於領先地位。

堅持降本增效本集團從研發、採購到生產各個 環節,通過改變模式、導入新品、引入競品、 技改提升等多種措施手段,有效降低生產成 本。

堅持擴大產品市場於二零二四年,本集團繼續 擴大汽車膜的生產,繼續全面進軍汽車行業; 通過近年努力,憑藉ITO開發優勢及在行業中 多年的積累和口碑,本集團正式加入知名汽車 玻璃製造商供應商體系,鞏固行業地位,奠定 良好基礎和發展前景。

CHAIRMAN'S STATEMENT 主席報告

TECHNOLOGY RESEARCH AND DEVELOPMENT

In 2024, the Group was actively dedicated to research and development and obtained 8 authorized patents during the year, including 3 invention parents and utility models. The Group held more than 100 valid patents. The Group participated in the compilation of two national standards "Intelligent Photochromic Glass for Automobiles - Part 2: Polymer Dispersed Liquid Crystal Light-adjusting Glass" and "Intelligent Photochromic Glass for Automobiles - Part 1: Organic Electrochromic Glass". The Group led the formulation of the group standard of "Polymer Dispersed Liquid Crystal Light-adjusting Film for Automobiles", which has been implemented in July 2024. In addition, the Group led the formulation of the group stand of "Polymer Dispersed Liquid Crystal (PDLC) Light-adjusting Thin Film for Construction", which was released for public consultation in November 2024. The technological innovation and standard formulation have laid a solid foundation for the development of the Group. During the year, the Group was recognized as a national-level specialized, refined, differential and innovative "Little Giants" enterprise, which is the most prestigious honourary title awarded since its establishment. Meanwhile, the Group won the title of "Guangdong Green Factory" by virtue of its green development strategy. The certification of Guangdong Liquid Crystal Functional Materials Engineering Technology Research Center undertaken by the Group successfully passed the 2023 annual evaluation.

技術研發

二零二四年,本集團積極投入研發工作,年內 獲得8項專利授權,包含3項發明專利和5項 **實**用新型,現持有有效專利突破100項。參編 國家標準《汽車用智能變色玻璃 – 第2部分: 聚合物分散液晶調光玻璃》和《汽車用智能變色 玻璃 - 第1部分: 有機電致變色玻璃》兩項。 奉頭制定的《汽車用聚合物分散液晶調光膜》團 體標準已於二零二四年七月實施。牽頭制定的 《建築用聚合物分散液晶(PDLC) 調光薄膜技術 要求》團體標準已於二零二四年十一月公開徵 求意見。技術創新和標準制定工作為本集團發 展奠定了堅實的基礎。年內,本集團獲評國家 級專精特新「小巨人」企業,是本集團自成立 以來獲評獎項含金量最高的榮譽稱號。同時, 本集團憑借綠色發展策略,榮獲「廣東省綠色 工廠」稱號。本集團承擔的廣東省液晶功能性 材料工程技術研究中心資質順利通過二零二三 年度評估。

Adhering to our new development vision of "prioritizing quality and efficiency", the Group has always upheld technology research, development and innovation as its strategic support for business operation. BUSINESS REVIEW

The Group carries out research and development on, and manufactures and sells ITO film, Smart Polymer-Dispersed Liquid Crystals ("PDLC") products, LED Display and Projection System. The Group uses ITO film as one of the main materials for the development of downstream products, namely: (i) PDLC film (i.e. Smart Light-adjusting Film); and (ii) electronically switchable glass (i.e. Smart Light-adjusting Glass). The Group is one of the few integrated manufacturers in the PRC which produces and sells ITO film as well as a range of related downstream products.

For the year ended 31 December 2024, The domestic market has begun to recover slightly, but the pace is still slow. We recorded an increase in both revenue and gross profit margin as compared to the same period 2023.

ITO film can be applied for use in a variety of products including smart phones, GPS systems and other touch-screen devices and equipment such as automated teller machines. Our ITO film customers are primarily domestic touch-screen device manufacturers. Revenue from sales of ITO film was approximately RMB23.0 million for the year ended 31 December 2024, which represented a decrease of approximately RMB3.9 million or approximately 14.5%, from approximately RMB26.9 million for the same period in 2023.

Smart PDLC products include Smart Light-adjusting Film and Smart Lightadjusting Glass. Smart Light-adjusting Film can be switched from a milky, cloudy, translucent and opaque state into a colourless and transparent state when electricity is applied to it, and may be applied to windows and glass to control the passing-through of light. Smart Light-adjusting Glass permits a user to control the permeability of light through the glass by adjusting the voltage of electricity voltage applied to the Smart Light-adjusting Film fixed therein. Our Smart PDLC products customers are primarily construction companies and contractors of developers. Revenue from sales of Smart PDLC products was approximately RMB79.6 million for the year ended 31 December 2024, which represented an increase of approximately RMB30.7 million or approximately 62.8%, from approximately RMB48.9 million for the same period in 2023.

業務回顧

本集團從事ITO導電膜、智能聚合物分散液晶 (「智能調光」)產品、LED顯示屏及投影系統的 研發、生產及銷售。本集團使用ITO導電膜作 為主要材料之一來開發下游產品,即(i)聚合 物分散液晶膜(即智能調光膜);及(ii)電控調 光玻璃(即智能調光玻璃)。本集團是中國為 數不多的生產及銷售ITO導電膜以及一系列相 關下游產品的綜合製造商。

於截至二零二四年十二月三十一日止年度,國 內市場開始稍為復甦,但速度仍然緩慢。與二 零二三年同期相比,我們的銷售額及毛利率均 有所上升。

ITO 導電膜可以應用於多種產品(包括智能手機、GPS系統及自動櫃員機等其他觸摸屏裝置及設備)。我們的ITO導電膜客戶主要為國內 觸摸屏設備製造商。截至二零二四年十二月 三十一日止年度的ITO導電膜銷售收入為約人 民幣23.0百萬元,較二零二三年同期的約人 民幣26.9百萬元減少約人民幣3.9百萬元或約 14.5%。

智能調光產品包括智能調光膜及智能調光玻 璃。通電後,智能調光膜可由乳白色、朦朧、 半透明及不透明狀調節成無色及透明狀,可用 於窗戶及玻璃,以控制光線穿透。智能調光玻 璃允許用戶透過調節應用於智能調光玻璃內部 的智能調光膜的電壓控制透光性。智能調光產 品客戶主要為建築公司及開發商的承包商。截 至二零二四年十二月三十一日止年度的智能調 光產品銷售收入為約人民幣79.6百萬元,較 二零二三年同期的約人民幣48.9百萬元增加 約人民幣30.7百萬元或約62.8%。

Others include sales of other materials and products. The revenue from other products was approximately RMB6.7 million for the year ended 31 December 2024, which represented an decrease of approximately RMB2.5 million, from approximately RMB9.2 million for the same period in 2023.

Our Group strives to manufacture and supply high quality products to our customers, and our Directors believe that our Group is a reputable supplier of ITO film and related downstream products in the PRC. Our key operating subsidiary was ranked as the leading manufacturer of Smart Light-adjusting Products in the PRC in terms of market share by revenue. During the year ended 31 December 2024, our revenue has increased by approximately 28.0% as compared to the same period in 2023. We recorded a profit attributable to owners of the Company of approximately RMB11.4 million for the year ended 31 December 2024, as compared with the loss attributable to owners of the Company of approximately RMB39.8 million for same period in 2023. The profit for the year was mainly resulted from the increase in sales of PDLC products.

其他包括其他材料及產品銷售。截至二零二四 年十二月三十一日止年度來自其他產品的收入 為約人民幣6.7百萬元,較二零二三年同期的 約人民幣9.2百萬元減少約人民幣2.5百萬元。

本集團致力於製造及向客戶供應優質產品,董 事相信本集團是中國ITO導電膜及相關下游產 品的知名供應商。按收入所佔市場份額計算, 我們的主要營運附屬公司在中國智能調光產品 製造商中名列前茅。截至二零二四年十二月 三十一日止年度,我們的收入較二零二三年同 期錄得約28.0%上升。截至二零二四年十二 月三十一日止年度,我們錄得本公司擁有人 應佔溢利約人民幣11.4百萬元,而二零二三 年同期則錄得本公司擁有人應佔虧損約人民幣 39.8百萬元。本年度溢利是主要由於智能減 光產品銷售的增加引致。

OUTLOOK AND PROSPECTS

Our Directors believe that, as a market participant which is active in the technology sector, it is crucial for the business of our Group to devote substantial resources towards research and development (including identifying new materials and applications) which will advance or sustain its competitiveness in light of evolving market trends and customer preferences and needs. Further, our Directors believe that our Group's current market leading positions in the PRC by market share relating to its ITO film and Smart PDLC products is testimonial of sufficient market demand for its products. In response to the rapidly changing market conditions of the Smart PDLC products, our Group has been diversifying our product range.

Looking into the future, we believe that the competition remains keen in the domestic market. While we are diversifying our business in response to the challenges, our Group will remain cautious in expanding our production lines and carrying out research and development projects to cater the expected demand in the future. In the meantime, our Directors will closely monitor the economic change, maintain a prudent and stable strategy and react proactively to the challenges and opportunities ahead.

FINANCIAL REVIEW

Revenue

Our revenue was approximately RMB109.3 million for the year ended 31 December 2024, which represented an increase of approximately RMB23.9 million, or approximately 28.0% from approximately RMB85.4 million for the same period in 2023. The increase was mainly attributable to the increase of sales volume of smart PDLC products.

前景及展望

我們董事認為,作為活躍於技術行業的市場參 與者之一,將大量資源投入到研發(包括識別 新材料及應用)對本集團的業務至關重要,有 鑒於不斷變化的市場趨勢以及客戶偏好及需 求,此舉將提升或保持本集團的競爭力。此 外,我們董事相信,按與本集團ITO導電膜及 智能調光產品有關的市場份額計,本集團目前 於中國的市場領導地位佐證了其產品的充足市 場需求。為應對智能調光產品急速變化的市場 環境,本集團已將產品組合多元化發展。

展望將來,我們認為國內市場仍競爭激烈。在 多元化發展業務以應對挑戰的同時,本集團在 擴張生產線及開展研發項目方面將保持謹慎, 以滿足未來的預期需求。與此同時,董事將密 切注視經濟變化,維持審慎穩健的策略,積極 應對前方的挑戰與機遇。

財務回顧

收入

截至二零二四年十二月三十一日止年度的收入 為約人民幣109.3百萬元,較二零二三年同期 的約人民幣85.4百萬元增加約人民幣23.9百 萬元或約28.0%。增加主要是由於智能減光產 品的銷售量增加。

Cost of sales and gross profit

Our cost of sales was approximately RMB66.7 million for the year ended 31 December 2024, which represented a increase of approximately RMB3.8 million or approximately 6.0%, from approximately RMB62.9 million for the same period in 2023. The increase in cost of sales mainly reflected the increase in the production capacity during the year.

Our gross profit increased by approximately RMB20.1 million or approximately 89.3%, from approximately RMB22.5 million for the year ended 31 December 2023 to approximately RMB42.6 million for the year ended 31 December 2024. Our gross profit margin increased from approximately 26.3% for the year ended 31 December 2023 to approximately 38.9% for the same period in 2024. The increase was mainly due to the increase in production capacity utilization of various products, the shared costs decreased year-on-year, resulting in an increase in gross profit margin.

Selling and distribution expenses

Our selling and distribution expenses were approximately RMB3.9 million for the year ended 31 December 2024. These expenses mainly included remuneration for sales and marketing employees based on sales performances and expenses relating to the marketing efforts in business promotion and participation in exhibitions. The selling and distribution expenses was approximately 3.6% of the revenue for the year ended 31 December 2024, as compared to approximately 5.7% for the same period in 2023.

Administrative expenses

Our administration expenses were approximately RMB24.6 million for the year ended 31 December 2024, which represented a increase of approximately RMB3.3 million or approximately 15.5%, from approximately RMB21.3 million for the same period in 2023. These expenses mainly included employee wages and salaries, depreciation and research costs. The administrative expenses was approximately 22.5% of the revenue for the year ended 31 December 2024, as compared to approximately 24.9% for the same period in 2023.

銷售成本及毛利

截至二零二四年十二月三十一日止年度的銷售 成本為約人民幣66.7百萬元,較二零二三年 同期的約人民幣62.9百萬元增加約人民幣3.8 百萬元或約6.0%。銷售成本增加主要反映本 年產能有所提升。

毛利由截至二零二三年十二月三十一日止年 度的約人民幣22.5百萬元增加約人民幣20.1 百萬元或約89.3%至截至二零二四年十二月 三十一日止年度的約人民幣42.6百萬元。 毛利率由截至二零二三年十二月三十一日止 年度的約26.3%上升至二零二四年同期的約 38.9%。該上升乃主要由於各項產品在產能利 用率提升下,分攤成本同此下降,使得毛利率 有所提升。

銷售及分銷開支

截至二零二四年十二月三十一日止年度銷售及 分銷開支為約人民幣3.9百萬元。該等開支主 要包括根據銷售業績而釐定的銷售及營銷員工 的薪酬,以及與我們業務推廣及參與展覽相 關的營銷工作開支。截至二零二四年十二月 三十一日止年度銷售及分銷開支佔收入的約 3.6%,而二零二三年同期則為約5.7%。

行政開支

截至二零二四年十二月三十一日止年度行政開 支為約人民幣24.6百萬元,較二零二三年同 期的約人民幣21.3百萬元增加約人民幣3.3百 萬元或約15.5%。此等開支主要包括僱員工資 及薪金、折舊及研究成本。截至二零二四年 十二月三十一日止年度行政開支佔收入的約 22.5%,而二零二三年同期則為約24.9%。

Liquidity, financial resources and capital structure

Our primary use of cash is to satisfy our working capital and capital expenditure needs. Historically, our Group's use of cash has mainly been financed through a combination of cash received from the sales of our products and financial support from our Group's related parties.

As at 31 December 2024, our Group had short term borrowings of RMB30.0 million and no long term borrowings. Going forward, we believe our liquidity requirements will be satisfied using a combination of cash generated from operating activities, bank borrowings and proceeds from the Listing. Our Directors believe that in the long term, our Group's operation will be funded by internally generated cash flows and, if necessary, additional equity and/or debt financing.

Capital expenditure

For the year ended 31 December 2024, our capital expenditure amounted to approximately RMB4.9 million (2023: approximately RMB8.0 million) and mainly arose from expenditures for purchase of production machinery.

Gearing ratio

Gearing ratio is calculated by dividing the total liabilities by total equity attributable to owners of the Company at the end of the reporting period. As at 31 December 2024, our gearing ratio remained stable at approximately 49.2% (31 December 2023: approximately 54.9%).

Future plans for material investments or capital assets

Apart from those disclosed in this annual report, there was no plan authorised by the Board for other material investments or additions of capital assets at the date of this annual report.

Significant investments, acquisitions and disposals

The Group did not make any material acquisition or disposal of subsidiaries, associated companies and joint ventures as well as any significant investments.

流動資金、財務資源及資本架構

我們的現金主要用於滿足我們的營運資金及資 本開支需要。以往,本集團的現金使用主要透 過綜合從銷售產品及本集團關連方財務支持所 獲得的現金予以撥付。

於二零二四年十二月三十一日,本集團有人民 幣30.0百萬短期借款及並無長期借款。展望 未來,我們相信,綜合使用營運活動所得現 金、銀行借貸及上市之所得款項,我們的流動 資金需求將會得到滿足。董事相信,長遠而 論,本集團之營運將透過內部所得現金流以及 (如必要)額外股本及/或債務融資撥付。

資本開支

截至二零二四年十二月三十一日止年度,我們 的資本開支金額為約人民幣4.9百萬元(二零 二三年:約人民幣8.0百萬元),主要產生自 購買生產機器的開支。

資產負債比率

資產負債比率乃按報告期末總負債除以本公司 擁有人應佔總權益計算。於二零二四年十二月 三十一日,我們的資產負債比率保持穩定, 為約49.2%(二零二三年十二月三十一日:約 54.9%)。

重大投資或資本資產的未來計劃

除本年報所披露者外,於本年報日期,概無董 事會授權的其他重大投資或資本資產添置。

重大投資、收購及出售

本集團並無進行任何重大收購或出售附屬公 司、聯營公司及合營公司或任何重大投資。

Capital commitments

As at 31 December 2024, the Group had capital commitments amounting to approximately RMB4.5 million (2023: approximately RMB4.5 million) in respect of equity investments.

Contingent liabilities

As at 31 December 2024, the Group had no significant contingent liabilities (2023: Nil).

Pledge of assets

As at 31 December 2024, the Group had restricted cash of approximately RMB6.1 million (2023: approximately RMB28,000).

IMPAIRMENT LOSS ON TRADE RECEIVABLES

The Group has recognised approximately RMB2.5 million as impairment losses charged on overdue trade receivables during the year ended 31 December 2024, where most of the outstanding balances have an ageing of over three years. Management of the Group (the "Management") carry out a valuation of the recoverable amount of trade receivables as at 31 December 2024 ("Valuation Date").

Circumstances leading to the recognition of the impairment loss

The Group understands that its customers and their repayment ability have been affected by the adverse business environment and the slow recovery of the economy. The customers of these trade receivables consist of various customers with long aging. The Group has been following up the status to understand the latest development of such customers. As at the date of this announcement, the Group had no subsequent cash settlements of the trade receivables with ageing of over three years, the most of which the management of the Group considered unlikely to be recoverable and provided impairment loss.

截至二零二四年十二月三十一日止年度,本 集團確認應收貿易款項之減值虧損約人民幣 約2.5百萬元,當中大部分為超過3年賬齡的 未清餘額。集團管理層(「管理層」)對於二零 二四年十二月三十一日(「估值日期」)之應收 貿易款項之可收回金額進行估值。

導致確認減值虧損的情況

集團理解其客戶及其償還能力受到不利的商業 環境和經濟復蘇緩慢的影響。應收賬款的客戶 包括各種長期未償還的客戶。集團一直在跟進 這些客戶的狀況,以了解最新的發展情況。 截至本公告日期,本集團逾三年未償還的應收 貿易款項並無後續現金結算,集團管理層認為 其中大部份不太可能收回及已為其計提減值虧 損。

Value of inputs used or key assumptions adopted in the impairment valuation

With reference to the valuation, the Group carried out an assessment on the recoverable amount of trade receivables and estimated the amount of the expected credit loss (the "ECL") of trade receivables.

The valuation of trade receivables considered ECL method, in which the ECL is based on the assessments considering exposure at default, probability of default, and expected recovery rates from default, adjusted with forward-looking factor.

The Management is of the opinion that the recoverable amount of overdue trade receivables of the Group with ageing of over 3 years as at the Valuation Date is nil, except for certain balances assessed individually. The ECL was provided with reference to the valuation results conducted by the Management. The Group believed that the above-mentioned valuation basis, value of inputs used and key assumptions applied by the Management were consistent with the current market trends and conditions. Accordingly, allowance for expected credit losses for trade receivables has been made to the Group's audited consolidated financial statement for the year ended 31 December 2024.

Valuation Method and Reason for its Adoption

The Group's impairment assessment policy on trade receivables was set out in note 4 to the consolidated financial statements of the Company as included in the 2024 Annual Report.

The Group always recognises lifetime ECL for trade receivables and has applied the simplified approach in IFRS 9 to measure the loss allowance at lifetime ECL. Except for debtors with significant outstanding balances or credit-impaired, the Group determines the ECLs on these items by using a provision matrix, grouped by past due status.

In completing the valuation, reference was made to generally accepted approaches to the valuation of trade receivables, as well as IFIRS 9 in relation to the disclosure and presentation, recognition and measurement of financial instruments.

Management of the Group is of opinion that the adopted expected loss method for the assessment of ECL which is commonly used in measuring the ECL of trade receivables. The Management estimated the ECL as the product of three factors: (i) exposure at default; (ii) forecasted probability of default; and (iii) loss given default, if applicable. Recoverable amount of trade receivables is estimated as its exposure of default less the ECL.

With reference to the valuation results, allowance for credit losses for trade receivables of approximately RMB2.5 million was recognised during the year ended 31 December 2024.

估值方法及其採納之理由

本集團一直就應收貿易款項確認存續期預期 信貸虧損,並於國際財務報告準則第9號中應 用簡化方法計量存續期預期信貸虧損之虧損撥 備。除有大量未償還結餘或信貸減值之債務人 外,本集團均採用按逾期狀況分組之撥備矩陣 釐定該等項目之預期信貸虧損。

在完成估值時,已參考就應收貿易款項之公認 估值方法,及有關金融工具之披露及呈列、確 認及計量之國際財務報告準則第9號。

管理層採用預期虧損法就預期信貸虧損進行估 值,該方法一般用於計量應收貿易款項之預期 信貸虧損。管理層將預期信貸虧損估計為三個 因素之乘積:(i)違約時風險敞口;(ii)預計違 約概率;及(iii)違約損失。應收貿易款項之可 收回金額按其違約風險敞口減預期信貸虧損而 進行估計。

參考評估結果,截至二零二四年十二月三十一 日止年度,確認應收貿易款項信貸虧損撥備約 人民幣2.5百萬元。

Having considered the above, the Directors are of the view that such provisions of impairment were fair and reasonable, and were in line with the prevailing accounting standards.

Actions to recover the trade receivables

While each case may have unique circumstances, the Company generally follows a series of steps to recover outstanding payments. Set out below are the usual actions undertaken by the Company:

- 1. Analysis and Communication
- 2. Reminder Notices
- 3. Payment Negotiation
- 4. Legal Actions
- 5. Debt Recovery Agencies

It is important to note that the specific actions taken may vary depending on the nature of the debt, the debtor's financial condition, legal considerations and also cost implications in recovering the debts. The Group's priority is to maintain open lines of communication, explore mutually beneficial solutions, and ensure fair treatment of all parties involved.

By following these usual actions, the Group aims to maximise the chances of recovering trade receivables while preserving relationships with our valued clients. Our dedicated team remains committed to resolving outstanding balances promptly and efficiently.

USE OF PROCEEDS FROM THE LISTING

The Shares of the Company were listed on GEM on 21 July 2017 (the "Listing Date") with net proceeds received by the Company from the Share Offer in the amount of HK\$93,500,000 after deducting underwriting commission and all related listing expenses.

The business strategies as set out in the Prospectus were based on the best estimation of the future market conditions made by the Group at the time of preparing the Prospectus. The use of proceeds was applied in accordance with the actual development of the market.

As at 31 December 2024, approximately HK\$79.5 million out of the net proceeds from the Share Offer had been used. The unused net proceeds have been deposited in licensed banks.

The Company intends to apply the net proceeds in the manner consistent with that set out in the Prospectus. However, the actual use of proceeds was lower than planned use of proceeds because of the delay in automation and installation of production lines. Moreover, while the domestic market has begun to recover, the pace remains to be slow. It is the priority of the Group to maintain a healthy financial position and conduct its operations in a prudent and stable manner so as to maintain viability and sustainability. It is therefore the business strategy of the Group to slow down the Group's business plans so as to mitigate short term risks and fluctuations faced by the Group. In response to the rapidly changing business environment, it has also taken more time than expected to look for suitable machinery and equipment producers which could meet our production requirements. Hence, the timeline for utilizing net proceeds allocated for installation of production lines has been postponed accordingly. The Directors will constantly evaluate the Group's business strategies and may change or modify plans against the changing market condition to attain sustainable business growth of the Group.

DIVIDEND

The Directors did not recommend a final dividend (2023: Nil). The actual dividend payout ratio in each year will depend on the actual performance of the Group, the general industry and economic environment.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of Chairman and Chief Executive Officer are held by Mr. Du Peng and Mr. Zhang Chao, respectively. The Chairman of the Board is responsible for leading the Board, and facilitating the business of the Board. The Chairman is also required to ensure that the principles of good corporate governance and processes of Board meetings are maintained. The Chief Executive Officer is responsible to lead executive management of the Group within the limits of delegated authorities. The Chief Executive Officer commits to take overall responsibilities for the supervision and the conducts of the Company's business and its ordinary operation, in accordance with the policies, strategies and objectives established by the Group. The Company is in compliance with Code Provision C.2.1 of the Code as the roles of chairman and Chief Executive Officer are separated and not performed by the same individual.

主席及行政總裁

杜鵬先生及張超先生分別擔任主席及行政總 裁。董事會主席負責領導董事會並促進董事會 事務。主席亦須確保維持良好的公司管治原則 及董事會會議流程。行政總裁負責在授權範圍 內領導本集團的行政管理工作。行政總裁承諾 根據本集團制定的政策、策略及目標全面負責 監督本公司的業務及其日常營運。由於主席與 行政總裁的角色已分開且並非由同一人兼任, 本公司已遵守守則的第C.2.1條。

APPOINTMENT AND RE-ELECTION OF DIRECTORS

The current Bye-laws provide that at each annual general meeting, one-third of the directors for the time being shall retire from office by rotation and that every director shall be subject to retirement by rotation at least once every three years. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting after his/her appointment and be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting and shall then be eligible for re-election.

All of the non-executive Director and independent non-executive Directors are appointed for a specific term but they are subject to retirement by rotation and re-election at the annual general meeting in accordance with the Byelaws. The term of appointment of each Independent Non-Executive Director has been set out in the section headed "Directors' Service Contracts" of this report. Each independent non-executive Director is required to inform the Company as soon as practicable if there is any change that may affect his independence and must provide an annual confirmation of his independence to the Company. Up to the date of this report, no independent non-executive Director has served the Company more than 9 years.

委任及重選董事

現行細則訂明,於每屆股東週年大會上,當時 至少三分之一的董事須輪值告退,且每名董 事須至少每3年輪值告退一次。任何獲董事會 委任填補臨時空缺的董事任期將直至彼獲委任 後首次股東大會為止,並可於該大會上重選連 任,而任何獲董事會委任作為現有董事會增補 成員的董事的任期僅直至下屆股東週年大會為 止,屆時將合資格重選連任。

全體非執行董事及獨立非執行董事以特定任期 獲委任,惟彼等須根據細則於股東週年大會上 輪席退任及重選。各獨立非執行董事的任期載 列於本報告「董事服務合約」一節。倘出現任 何可能影響獨立非執行董事獨立性的變動,各 獨立非執行董事均須盡快在切實可行的情況下 通知本公司,並須向本公司提供有關其獨立性 的年度確認書。截至本報告日期止,尚無獨立 非執行董事服務本公司超過9年。

DIVISION OF RESPONSIBILITIES BETWEEN THE BOARD AND MANAGEMENT

While the Board is responsible for directing and approving the Group's overall strategies, the Group also has formed management teams in its business areas, comprising both the executive Directors and senior officers of the Group, with authority and responsibility for developing and exercising both operational and non-operational duties. The management team members of the Group have a wide range of skills, knowledge and experience necessary to govern the Group's operations. All management team members are required to report directly to the Chairman on a regular basis to report business performance and operational and functional issues of the Group.

This will allow the Group's management to allocate resources more efficiently for its decision-making and facilitate its daily operations. The Board and the Group's management fully appreciate their respective roles and are committed to corporate governance. The Board is responsible for overseeing the processes by which the management identifies business opportunities and risks. The Board's role is not to manage the day-to-day business operations of the Group and the responsibility of which remains vested in the management.

The Board has set up formal procedures for the Board's decisions. Matters which the Board considers suitable for delegation to its committees are contained in the specific terms of reference of its committees. The terms of reference clearly define the powers and responsibilities of the Board Committees. In addition, the Board will receive reports and/or recommendations from time to time from the Board Committees on any matter significant to the Group.

AUDIT COMMITTEE

The Company has established the Audit Committee on 21 July 2017 in compliance with Rule 5.28 of the GEM Listing Rules. Among other things, the primary duties of the Audit Committee are to review and supervise the Company's financial reporting process, internal control system and risk management system and to provide advice and recommendations to the Board on the appointment, reappointment and removal of external auditors.

董事會及管理層的責任分工

雖然董事會負責指導及批准本集團的整體策略,本集團亦已在其商業範疇上組成管理隊 伍,當中包括本集團執行董事及高級管理人 員,並擁有發展及行駛營運及非營運職務的權 力及責任。管理隊伍成員具備的廣泛技能、知 識及經驗以管理本集團的營運。所有管理隊伍 成員必須定期直接向主席匯報本集團的業務表 現、營運及職務上的事項,因此可令本集團管 理層更有效地分配資源以制定決策及促進日常 營運。

董事會及本集團管理層充分認知彼等各自的角 色,並忠於良好企業管治。董事會負責監督管 理層識別商機及風險的過程。董事會的角色並 非管理本集團日常業務,此責任仍然歸屬於管 理層。

董事會已為董事會的決策訂立正式程序。董事 會認為適合向其委員會授權的事項已載於其委 員會的特定職權範圍內。職權範圍明確界定董 事會委員會的權力及責任。此外,董事會不時 從董事會委員會收到有關對本集團而言屬重大 的任何事項的報告及/或建議。

審核委員會

本公司已遵照GEM上市規則第5.28條於二零 一七年七月二十一日成立審核委員會。其中, 審核委員會的主要職責為檢討及監督本公司的 財務申報過程、內部監控制度及風險管理系統,並就外部核數師的委任、續聘及罷免向董 事會提供意見及建議。

The Audit Committee consists of three independent non-executive Directors, namely Ms. Pan Jianli, Mr. Zhang Yumo and Dr. Li Ling. Ms. Pan Jianli is the chairperson of the Audit Committee.

During the year ended 31 December 2024, four meetings of the Audit Committee were held to review the Group's quarterly, interim and annual financial results. One of the meetings were attended by the Company's external auditor so that the members of the Audit Committee could exchange their views and concerns on the financial reporting process of the Group with the auditor. 審核委員會成員包括三名獨立非執行董事潘 建麗女士、張宇模先生及李玲博士。潘建麗 女士為審核委員會主席。

The Audit Committee has also reviewed the effectiveness of internal controls and risk management for the year ended 31 December 2024. Such review covered financial, operational and compliance controls and risk assessment of the Group. REMUNERATION COMMITTEE

The Company has established the Remuneration Committee on 21 July 2017 with written terms of reference in compliance with Rules 5.34 and 5.35 of the GEM Listing Rules. The primary duties of the Remuneration Committee are, among other things, to make recommendations to the Board on the overall remuneration policy and structure relating to all Directors and senior management of our Group; review and approve the management's remuneration proposals and benefits; and to ensure none of our Directors will be regularly monitored by our remuneration committee to ensure that the level of remuneration and compensation is appropriate.

The Remuneration Committee consists of three independent non-executive Directors, namely, Mr. Zhang Yamo, Ms. Pan Jianli and Dr. Li Ling. Mr. Zhang Yumo Jianguo is the chairman of the Remuneration Committee.

During the year ended 31 December 2024, the Remuneration Committee held a meeting to approve the remuneration packages and performance bonuses for the Directors and senior management of the Company for recommendation to the Board after reviewing of the remuneration policy and structure of the Directors and senior management of the Group and assessment of individual performance of each.

The Remuneration Committee is tasked to review and/or approve matters relating to share schemes under Chapter 23 of the GEM Listing Rules. The Remuneration Committee has reviewed the remuneration policy and package of the Group, including an assessment of individual performance, attractiveness of the rewards offered by the Company, talent retention and incentivization, the financial condition and performance of the Group. No share awards and share options were recommended to be awarded by the Remuneration Committee during the year.

NOMINATION COMMITTEE

The Company has established the Nomination Committee on 21 July 2017 with written terms of reference in compliance with Rule 5.36A of the GEM Listing Rules. The primary function of the nomination committee is to make recommendations to the Board and senior management regarding appointment of Directors and candidates to fill vacancies on the Board and senior management team review the structure, size and composition of the Board and succession planning for directors to complement the Company's corporate strategy and refreshment of the composition of the Board.

Board Diversity Policy

The Board has adopted the board diversity policy which sets out the approach to achieve diversity on the Board. Accordingly, selection of candidates to the Board is based on a range of measurable objectives, including but not limited to gender, age, cultural and educational background, professional experience and qualifications, skills, knowledge and length of service, having due regard to the Company's own business model and specific needs from time to time. With the existing Board members coming from a variety of business and professional background, the Company considers that the Board possesses a balance of skills, experience, expertise and diversity of perspectives appropriate to the requirements of the Company's business.

Nomination procedures include identification and acknowledgment of qualified individuals by the Nomination Committee and review and approval of such nomination by the Board. The selection criteria for Directors are that the candidates must have substantial experience in business relevant to the Company, or in corporate management, or in relevant profession and must be able to contribute effectively to the objectives of the Company. In identifying suitable candidates for appointment to the Board, the Nomination Committee will consider candidates on merit against objective criteria (such as professional expertise, relevant experience, personal ethics etc.) and with due regard for the benefits of diversity on the Board. Any committee member may propose suitable candidates for directorship for discussion and approval by the Nomination Committee, after which the Board will consider and, if proper, approve such nomination.

董事會多元化政策

提名程序包括由提名委員會物色及確認合資格 人員並由董事會審批有關提名。董事的甄選標 準為,候選人須於與本公司相關業務或企業管 理或相關專業方面擁有充分經驗,且能夠為達 成本公司目標作出有效貢獻。物色合適董事會 成員候選人時,提名委員會將根據客觀標準擇 優而錄(如專業知識、相關經驗、個人道德等) 並充分考慮對董事會多元化的惠益。任何委員 會成員可提名合適董事人選以供提名委員會討 論及審批,其後董事將考慮並酌情通過有關提 名。

As at 31 December 2024, there were 5 male Directors and 2 female Directors on the Board. The Board had not set any measurable objective for implementing the diversity policy during the year, as it considered that the Board is sufficiently diverse in terms of gender and other aspect. The male to female ratio in the workforce (including senior management) of the Group was approximately 64%:36%, which is consistent with the gender composition in the industry in which the Group operates. The Board has not set any numerical targets, plans and timelines set for achieving gender diversity on its Board and in the workforce. The Board is mindful of the objectives for the factors as set out in the diversity policy for assessing the candidacy of the Board members and will ensure that any successors to the Board shall follow the diversity policy. Similar considerations will also be in place to assess the candidacy of the senior management team from time to time. The Group is determined to maintain gender diversity and equality in terms of the whole workforce, and to procure the senior management team to achieve gender equality in terms of the gender ratio. The Nomination Committee will discuss periodically and when necessary, agree on further measurable objectives and plans for achieving diversity, including gender diversity, on the Board and recommend them to the Board for adoption.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board is responsible for the Group's risk management and internal control system and reviewing its effectiveness on a periodic basis, at least annually. The review covers all material controls, including but not limited to financial, operational, and compliance controls. During the year ended 31 December 2024, the Board assessed and reviewed the risk management policies and measures and internal control procedures of the Group. The Group has also engaged external independent professionals to review its risk management and internal control systems. Our Directors considered them effective and adequate, and further enhance the Group's risk management and internal control systems as appropriate.

There is currently no internal audit function within the Group. The Board has reviewed the need for an internal audit function and is of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost effective to appoint external independent professionals to perform internal audit functions for the Group as the need arises. Nevertheless, the Board will continue to review the need for an internal audit function annually.

AUDITOR'S REMUNERATION

During the year ended 31 December 2024, the fees paid/payable for the services provided by the Company's auditor are set out as follows:

SHAREHOLDERS' RIGHTS

Communication with Shareholders

The Board recognises the importance of effective and on-going communications with Shareholders and continues to act in the best interests of the Company and its shareholders. The Company keeps Shareholders and investors informed of its business performance and strategies by adopting a transparent and timely disclosure policy which complies with the GEM Listing Rules and provides all Shareholders equal access to such information. The Company also publishes all documents on the Company's website.

The annual general meeting of the Company (the "AGM") also provides a forum for the Board to dialogue and interact with the Shareholders directly. The Directors and the committee members are available to answer questions during the AGM. Notice of AGM, annual report, financial statements and related papers were posted to Shareholders for their consideration at least 20 clear business days prior to the AGM.

At each general meeting, the chairman of the meeting proposes individual resolutions in respect of each substantially separate matter. All matters at the Company's general meetings are resolved by poll and the procedures for conducting a poll will be explained at the meeting. Independent scrutineer will be engaged to ensure all votes at general meeting are properly counted. Poll vote results will be posted on the websites of the Company and HKEx in a timely manner.

AGM proceedings and policies regarding Shareholders' communication of the Company are continually reviewed in the light of corporate governance best practices.

Set out below is a summary of certain rights of the shareholders of the Company.

(a) Convening of general meeting on requisition by shareholders

Members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Company's registered office in Bermuda at Clarendon House, 2 Church Street, Hamilton, HM11, Bermuda and its principal office in Hong Kong at Unit 3108, 31/F, China Merchants Tower, Shun Tak Centre, 168-200 Connaught Road Central, Hong Kong for the attention of the Board or the Secretary of the Company, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within three (3) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionists themselves may do so in accordance with the provisions of Section 74(3) of the Companies Act 1981 of Bermuda.

(b) Procedures for putting forward proposals at a Shareholders' meeting

Pursuant to the Companies Act 1981 of Bermuda, either any number of the shareholders holding not less than one-twentieth (5%) of the total voting rights of all the shareholders of the Company, or not less than one hundred of such shareholders, can request the Company in writing to (a) give to shareholders entitled to receive notice of the next general meeting notice of any resolution which may properly be moved and is intended to be moved at that meeting; and (b) circulate to shareholders entitled to have notice of any general meeting any statement of not more than one thousand words with respect to the matter referred to in any proposed resolution or the business to be dealt with at that meeting. PRINCIPAL PLACE OF BUSINESS

The Company was incorporated in Bermuda under the Companies Act as an exempted company with limited liability on 14 November 2014. The registered office of the Company is Clarendon House, 2 Church Street, Hamilton HM11, Bermuda. The Company has established a place of business in Hong Kong at Unit 3108, 31/F China Merchants Tower, Shun Tak Centre, 168-200 Connaught Road, Central, Hong Kong. The Company was registered under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) on 18 April 2016. Each of Mr. Du Peng and Mr. Chan Koon Leung, Alexander has been appointed as the authorised representative of the Company for the acceptance of service of process and notices on behalf of our Company in Hong Kong. The address for service of process on the Company in Hong Kong is the same as its principal place of business in Hong Kong set out above.

As the Company is incorporated in Bermuda, it operates subject to the Companies Act and to its constitution, which comprises the Memorandum of Association and the Bye-laws.

PRINCIPAL ACTIVITIES

The Company acts as an investment holding company. The Group carries out research and development on, and manufactures and sells ITO film, Smart PDLC products, LED Display and Projection System. The Group is one of the few integrated manufacturers in the PRC which produces and sells ITO film as well as a range of related downstream products. The Group principally operated in Mainland China.

Details of the principal activities of the principal subsidiaries are set out in note 38 to the financial statements. There were no significant changes in the nature of the Group's principal activities during the year ended 31 December 2024.

For the year ended 31 December 2024, sales to the Group's top five customers and its largest customer accounted for approximately 63% and 43% of total revenue, respectively.

The Group procures a majority of the raw materials from third party suppliers based in the PRC who are agents of overseas manufacturers, and procure certain raw materials (including ITO target, protective film, PDLC and projectors) from PRC manufacturers. For the year ended 31 December 2024, purchases from the Group's top five suppliers and its largest supplier accounted for approximately 48% and 13% of total purchases, respectively.

During the year ended 31 December 2024, none of the Directors, their close associates (as defined in the GEM Listing Rules), or any of the shareholders of the Company (which, to the best knowledge of the Directors, own more than 5% of the Company's issued share capital) had any interest in any of the Group's five largest customers or suppliers.

SHARE OPTION SCHEME

On 17 October 2017, the Company adopted a share option scheme (the "Share Option Scheme"). Under the Share Option Scheme, the Board may, at its absolute discretion and on such terms as it may think fit, grant Share Options to the any Eligible Person (who is (i)(a) any director or proposed director (whether executive or non-executive, including any independent non-executive director), employee or proposed employee (whether full time or part time) of, or (b) any individual for the time being seconded to work for, any member of the Group or any substantial shareholder or any company controlled by a substantial shareholder (a "Category A Eligible Person"); or (ii) any person or entity that provides research, development or other technological support or any advisory, consultancy, professional or other services to any member of the Group (a "Category B Eligible Person") and, for the purposes of the Share Option Scheme, shall include any company controlled by one or more persons belonging to any of the above classes of participants, collectively the "Eligible Person") to subscribe at a price calculated in accordance with the Share Option Scheme for such number of Shares as it may determine in accordance with the terms of the Share Option Scheme.

Purpose of the Share Option Scheme

The purpose of the Share Option Scheme is to enable the Company to grant Share Options to the selected Eligible Persons as incentives or rewards for their contribution or potential contribution to the growth and development of the Group.

1. GENERAL INFORMATION

China Shuifa Singyes New Materials Holdings Limited (formerly known as "China Singyes New Materials Holdings Limited") (the "Company") is a limited liability company incorporated in Bermuda. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda. The principal place of business of the Company is located at Unit 3108, 31st Floor, China Merchants Tower, Shun Tak Centre, 168-200 Connaught Road Central, Sheung Wan, Hong Kong.

The Company and its subsidiaries (collectively referred to as the "Group") were principally engaged in the sale and installation of Indium Tin Oxide ("ITO") film, and the research and development, production, sale and installation of Smart Polymer-Dispersed Liquid Crystals ("Smart PDLC") products, Light Emitting Diode ("LED") Display and Projection System in the People's Republic of China (the "PRC"). There were no significant changes in the nature of the Group's principal activities during the year.

In the opinion of the directors of the Company (the "Directors"), the immediate holding company and the ultimate holding company are China Shuifa Singyes Energy Holdings Limited ("Shuifa Singyes") and Shuifa Group Co., Ltd. ("Shuifa Group"), respectively. Shuifa Singyes was incorporated in Bermuda and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Shuifa Group was an state-owned enterprise incorporated in the PRC.

1. 一般資料

2. BASIS OF PREPARATION

The consolidated financial statements have been prepared in accordance with IFRS Accounting Standards ("IFRS"), which include all International Financial Reporting Standards, International Accounting Standards ("IAS") and Interpretations, issued by the International Accounting Standards Board ("IASB"). In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the GEM of the Stock Exchange of the Hong Kong Limited and by the Hong Kong Companies Ordinance.

Going concern assessment

The directors of the Company have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

These financial statements have been prepared under the historical cost basis. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of preparation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2024.

The preparation of financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 5.

Basis of consolidation

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (e.g., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the equity shareholders of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation. Unrealised losses resulting from intra-group transactions are eliminated in the same way as recognised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and noncontrolling interests within consolidated equity to reflect the change in relative interest, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of noncontrolling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for noncontrolling interests; and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset or the cash-generating unit to which it belongs, exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

終止確認金融資產

the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "passthrough" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the assets. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months after the reporting date (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

金融資產減值

本集團就並非按公平值計入損益持有的 所有債務工具確認預期信用損失(「預期 信用損失」)撥備。預期信用損失乃基於 根據合約到期的合約現金流量與本集團 預期收取的所有現金流量之間的差額而 釐定,並以原實際利率的近似值貼現。 預期現金流量將包括出售所持抵押的現 金流量或組成合約條款的其他信貸提升 措施。

一般方法

預期信用損失分兩個階段進行確認。就 自初步確認起信貸風險並無大幅增加的 信貸敞口而言,會就報告日期後未來12 個月內可能發生違約事件而導致的信貸 虧損(12個月預期信用損失)計提預期 信用損失。就自初步確認起信貸風險大 幅增加的該等信貸敞口而言,不論何時 發生違約,於敞口的餘下年期內的預期 信用損失均須計提虧損撥備(全期預期 信用損失)。

於各報告日期,本集團評估金融工具信 貸風險是否自初步確認起大幅增加。本 集團於進行評估時比較金融工具於報告 日期發生違約的風險與金融工具於初步 確認日期發生違約的風險,並考慮合理 及有理據而無需付出不必要之成本或努 力即可獲得之資料(包括過往及前瞻性 資料)。

General approach (Continued)

The Group considers a financial asset in default when contractual payments are 180 days past due. The Group has rebutted the 90 days past due presumption of default on reasonable and supportable information, including the Group's credit risks control practices and the historical recovery rate of financial assets over 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not creditimpaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

一般方法(續)

倘合約付款已逾期180天,則本集團認 為金融資產違約。本集團已根據合理且 有依據的資料(包括本集團信用風險控 制措施以及逾期90天以上金融資產的 歷史回收率),拒絕逾期90天的違約推 定。然而,在若干情況下,倘內部或外 部資料反映,在計及本集團持有的任何 信貸提升措施前,本集團不大可能悉數 收到未償還合約款項,則本集團亦可認 為金融資產違約。倘無法合理預期收回 合約現金流量,則撇銷金融資產。

按公平值透過其他全面收益計量的債務 投資與按攤銷成本計量的金融資產須根 據一般法減值,且按以下階段分類以計 量預期信用損失,而採用下文所詳述簡 化法的貿易應收款項及合約資產除外。

- 第一階段 自初步確認起信貸風險並 無大幅增加,且虧損撥備 按等於12個月預期信用損 失的數額計量的金融工具

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forwardlooking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings, and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, borrowings and lease liabilities.

簡化法

就並不包含顯著融資組成部份或本集團 已就此應用實務中權宜處理方法不調整 顯著融資組成部份的影響之貿易應收款 項而言,本集團採用簡化法計算預期信 用損失。根據簡化法,本集團並無追蹤 信貸風險的變化,反而於各報告日期根 據全期預期信用損失確認虧損撥備。本 集團已根據其歷史信貸虧損經驗建立撥 備矩陣,並就債務人特定的前瞻性因素 及經濟環境作出調整。

就包含顯著融資組成部份的貿易應收款 項而言,本集團選擇上文所述之政策作 為其會計處理政策,採納簡化法計算預 期信用損失。

金融負債

初始確認及計量

金融負債於初始確認時分類為按公平值 計入損益之金融負債、貸款及借貸、應 付款項,或被指定為有效對沖內對沖工 具之衍生工具(如適當)。

所有金融負債初始按公平值確認,如屬 貸款及借貸、及應付款項,則扣除直接 應佔交易成本。

本集團的金融負債包括貿易及其他應付 賬款、借貸及租賃負債。

Subsequent measurement

The subsequent measurement of the Group's financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (trade and other payables, and borrowings)

After initial recognition, the Group's financial liabilities are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

後續計量

本集團金融負債的後續計量取決於其分 類如下:

按攤銷成本入賬的金融負債(貿易及其 他應付款項以及借款)

經初始確認後,本集團的金融負債其後 以攤銷成本計量,除非折現影響並不重 大,否則採用實際利率法,反之,則按 成本入賬。負債終止確認時,或通過實 際利率攤銷時,收益及虧損於損益中確 認。

攤銷成本將任何收購折價或溢價和構成 實際利率不可或缺的費用或成本計算 在內。實際利率攤銷計入損益之融資成 本。

終止確認金融負債

當負債項下的義務被解除、取消或期 滿,則終止確認金融負債。

如一項現有金融負債被來自同一貸款方 且大部分條款均有差別的另一項金融負 債所取代,或現有負債的條款被大幅修 改,此種置換或修改視作終止確認原有 負債並確認新負債處理,而兩者的賬面 值差額於損益中確認。

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank over drafts which are repayable on demand and form an integral part of the Group's cash management.

抵銷金融工具

倘於現時存在可強制執行的合法權利以 抵銷已確認款額及有意向按淨額基準進 行結算,或同時變現資產及結算負債, 則金融資產及金融負債會予以抵銷,而 淨額會於財務狀況表中記錄。

存貨

存貨按成本或可變現淨值兩者較低者列 賬。成本以加權平均基準釐定,就在製 品和製成品而言,成本包括直接材料、 直接勞工及適當分攤的經常性費用。可 變現淨值按估計售價減任何尚需投入的 完成生產及出售的估計成本計算。

現金及現金等價物

就綜合現金流量表而言,現金及現金等 價物包括手頭現金、活期存款,以及期 限短、流動性強、易於轉換為已知金額 現金、價值變動風險小且一般於收購後 三個月內的較短期限到期的投資。

就綜合財務狀況表而言,現金及現金等 價物包括手頭現金和銀行存款,以及上 文定義的短期存款,減按要求償還並構 成本集團現金管理組成部分的銀行透 支。

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

The Group provides for warranties in relation to the sale of certain products for general repairs of defects occurring during the warranty period. Provisions for these assurance-type warranties granted by the Group are recognised based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the jurisdictions in which the Group operates.

撥備

如因過往事件產生現時債務(法定或推 定)及未來可能需要有資源流出以償還 債務,而該債務金額能可靠估計,則確 認撥備。

如貼現的影響重大,則就撥備確認的金 額為償還債務預期所需未來支出於報告 期末的現值。貼現現值因時間流逝而產 生的增幅計入損益之融資成本。

本集團就銷售若干產品用作質保期內所 發生缺陷的一般修理提供保證。本集團 授出之該等保證類別質保之撥備基於銷 量以及維修程度及退貨之過往經驗,貼 現至彼等之現值(如適當)確認。

所得税

所得税包括當期和遞延税項。有關損益 外確認項目的所得税於損益外確認,於 其他全面收益確認或直接在權益確認。

當期税項資產和負債按預期自税務局退 回或支付予税務局的金額計算,基於報 告期末已訂立或大致訂立的税率(及税 法),並計及本集團經營所在司法權區 現行之詮釋及慣例。

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition
 of goodwill or of an asset or liability in a transaction that is not
 a business combination and, at the time of the transaction,
 affects neither the accounting profit nor taxable profit or loss and
 does not give rise to equal taxable and deductible temporary
 differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

遞延税項資產和負債以資產被變現或負 債被清償的期間預期適用的税率衡量, 並根據於報告期末已制訂或實際上已制 訂的税率(及税法)計算。

僅當本集團有可合法執行權利可將當期 税項資產與當期税項負債抵銷,且遞延 税項資產與遞延税項負債與同一税務機 關對同一應税實體或於各未來期間預期 有大額遞延税項負債或資產需要結算或 清償時,擬按淨額基準結算當期税務負 債及資產或同時變現資產及結算負債的 不同税務實體徵收的所得税相關,則遞 延税項資產與遞延税項負債可予抵銷。

政府補助

倘有合理保證可獲取政府補助,而所有 附帶條件均可予以遵從,則按公平值確 認政府補助。倘補助與支出項目有關, 則以有系統基準於該項補助所補貼成本 列支之期間確認為收入。

倘補助涉及一項資產,則其公平值記入 遞延收益賬目及於相關資產的預期可使 用年限期間按等同年度金額撥回至損益 表,或從資產賬面值中扣減並以經扣減 折舊開支調撥至損益表。

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

(a) Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

Under the Group's standard contract terms, customers have a right to return/exchange for dissimilar goods within a period from 6 months to 2 years. The Group uses its accumulated historical experience to estimate the number of exchange on a portfolio level using the expected value method. Revenue is recognised for sales which are considered highly probable that a significant reversal in the cumulative revenue recognised will not occur. A refund liability is recognised for refund for the returned goods. The Group's right to recover the goods when customers exercise their right is recognised as a right to returned goods asset and a corresponding adjustment to cost of sales.

收入確認

來自客戶合約的收益

來自客戶合約的收益於商品或服務的控 制權轉移至客戶時,按反映本集團預期 就交換該等商品或服務而有權獲得的代 價金額予以確認。

當合約中的代價包含可變金額時,代價 金額按本集團向客戶提供商品或服務而 有權收取的金額作出估計。可變代價於 合約開始時作出估計並受到限制,直至 與可變代價相關的不確定因素其後獲得 解決,已確認的累計收益金額很可能不 會出現重大收益轉回為止。

(a) 銷售商品

銷售商品的收益於資產控制權轉 讓予客戶之時間點(一般為交付商 品時)確認。

根據本集團的標準合約條款,客 戶有權於6個月至2年期間內退還 /交換不同商品。本集團使用其 累積過往經驗按預期價值法估計 組合層面之交換數量。對於被認 為不大可能出現已確認累計收益 大幅撥回之銷售,則會確認為求 負債。本集團於客戶行使權利時 對收回產品之權利確認為退還商 品資產擁有權,並對銷售成本作 相應調整。

(b) Installation contracts

When the outcome of a installation contract can be estimated reliably, revenue from a fixed price contract is recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to the estimated total contract costs for the contracts.

When the outcome of a installation contract cannot be estimated reliably, revenue is recognised only to the extent of contract costs incurred that it is probable will be recoverable.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

For disclosure purpose, contract liabilities are included in accruals and other payables in the consolidated statement of financial position.

Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of sharebased payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 29 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be nonvesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or nonvesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

(a) Pension scheme

The employees of the Group's subsidiaries in Mainland China are required to participate in a central pension scheme operated by the local government. These subsidiaries and their employees are required to make monthly contributions calculated as a percentage of the employees' wages and salaries, subject to certain ceilings and local practices set by the relevant local governments, to the central pension scheme. Other than the central pension scheme, the Group's subsidiaries in Mainland China have no legal obligation for retirement benefits beyond the contributions made. Contributions to these plans are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme. The employer contributions vest fully once made.

(b) Housing fund

Contributions to a defined contribution housing fund administered by the Public Accumulation Funds Administration Centre in Mainland China are charged to profit or loss as incurred. 4. 重大會計政策資料(續)

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the Directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared. In the event that the interim dividends are paid out of the share premium account, shareholders' approval at an extraordinary general meeting is needed. When these interim dividends have been approved by the shareholders and declared, they are recognised as a liability.

Foreign currencies

These financial statements are presented in RMB. The functional currency of the Company is HK\$. The Group's presentation currency is RMB because the Group's principal operations are carried out in Mainland China. Each entity in the Group determines its own functional currency and items included in these financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration. 4. 重大會計政策資料(續)

The functional currencies of certain overseas subsidiaries are currencies other than RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statement of profits or losses are translated into RMB at the weighted average exchange rates for the year.

The resulting transaction exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

In the application of the Group's accounting policies, which are described in note 4, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2024 was RMB6,448,000 (2023: RMB6,448,000). Details of the impairment of goodwill are disclosed in note 17 to the consolidated financial statements.

Provision for ECLs on trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on ageing for groupings of various customer segments that have similar loss patterns (i.e., by customer type and profile).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecasted economic conditions (i.e., gross domestic products) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecasted economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecasted economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. Details of provision for ECLs on trade receivable are disclosed in note 19 to the consolidated financial statements.

貿易應收款項的預期信用損失撥備

本集團使用撥備矩陣計算貿易應收款項 的預期信用損失。撥備率乃基於具有類 似虧損模式的多個客戶分類組別(即按 客戶類型及評級劃分)的賬齡釐定。

撥備矩陣初步基於本集團的歷史觀察違 約率。本集團將通過校正矩陣以調整歷 史信用損失經驗及前瞻性資料。例如, 若預測經濟狀況(如國內生產總值)於未 來一年內惡化,從而導致製造行業的違 約數量增加,歷史違約率將得到調整。 於各報告日期,歷史觀察違約率將會予 以更新,並分析前瞻性估計的變化。

對歷史觀察違約率、預測經濟狀況及預 期信用損失之間的相關性評估乃一項重 要的估計。預期信用損失的金額對環境 及預測經濟狀況敏感。本集團的歷史信 用損失經驗及對經濟狀況的預測亦可能 無法表示客戶於日後的實際違約情況。 有關貿易應收款項的預期信用損失撥備 的詳情於綜合財務報表附註19披露。

Leases - estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

The weighted average IBR applied to lease liabilities range from 3.78% to 4.75% for the year ended 31 December 2024 (2023: from 3.78% to 4.75%).

租賃 – 估算增量借款利率

本集團無法輕易釐定租賃內所隱含的利 率,因此,使用增量借款利率(「增量借 款利率」)計量租賃負債。增量借款利率 為本集團於類似經濟環境中為取得與使 用權資產價值相近之資產,而以類似抵 押品與類似期間借入所需資金應支付之 利率。因此,增量借款利率反映了本集 團 [應支付] 的利率,當無可觀察的利 率(如就並無訂立融資交易之附屬公司) 或當須對利率進行調整以反映租賃之條 款及條件時(如當租賃並非以附屬公司 之功能貨幣訂立時),則須作出利率估 計。當可觀察輸入數據可用時,本集團 使用可觀察輸入數據(如市場利率)估算 增量借款利率並須作出若干實體特定的 估計(如附屬公司之獨立信貸評級)。

Corporate income tax ("CIT")

The Group's subsidiaries operating in Mainland China are subject to PRC CIT. As a result of the fact that certain matters relating to PRC CIT have not been confirmed by the relevant local tax authorities, objective estimates based on currently enacted tax laws, regulations and other related policies are required in determining the provision for PRC CIT to be made. Where the final tax outcome of these matters is different from the amounts originally recorded, the differences will impact the income tax and tax provision in the period in which the final outcome is determined. The carrying amount of PRC CIT payable at 31 December 2024 was RMB1,636,000 (2023: RMB1,951,000).

Useful lives and residual values of property, plant and equipment

In determining the useful lives and residual values of items of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvements in production, or from a change in the market demand for the product or service output of the asset, expected usage of the asset, expected physical wear and tear, the care and maintenance of the asset, and legal or similar limits on the use of the asset. The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in a similar way. The depreciation amount will be adjusted if the estimated useful lives and/or the residual values of items of property, plant and equipment are different from the previous estimation. Useful lives and residual values are reviewed at each financial year end date taking into account changes in circumstances. The carrying amount of property, plant and equipment at 31 December 2024 was RMB61,622,000 (2023: RMB66,904,000).

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs to be incurred to completion and disposal. These estimates are based on the current market condition and the historical experience of selling products of a similar nature. It could change significantly as a result of changes in customers' interests or competitor actions. Management reassesses these estimates at the end of each reporting period. The impairment provision for inventories as at 31 December 2024 was RMB1,106,000 (2023: Nil). Details of impairment provision for inventories are disclosed in note 18 to the consolidated financial statements.

Deferred tax assets

Deferred tax assets should be recognised when it is probable that taxable profits will be available against which the deferred tax assets can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. The net carrying amount of deferred tax assets at 31 December 2024 was RMB15,879,000 (2023: RMB16,739,000). Deferred taxation has not been provided for in the consolidated statement of financial position in respect of temporary differences attributable to the accumulated profits of the PRC subsidiaries at the end of the reporting period, as the Group is able to control the timing of the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future. The aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totaled approximately RMB26,411,000 as at 31 December 2024 (2023: RMB12,381,000).

The values assigned to the key assumptions on market development of the cash-generating unit and the discount rate are consistent with external information sources.

The directors of the Company estimated the reasonably possible changes in the above factors and acknowledged that, even if the most unfavourable possible values were assigned to those factors, the recoverable amount then calculated, after incorporating any sequential effects of such assignments on the other variables used to measure the recoverable amount of Shenzhen Kangsheng CGU, would still exceeds its carrying amount.

Pursuant to the Companies Act 1981 of Bermuda (as amended), contributed surplus of the Company is also available for distribution to shareholders. However, the Company cannot declare or pay a dividend, or make a distribution out of contributed surplus, if (a) it is, or would after the payment be, unable to pay its liabilities as they become due; or (b) the realisable value of its assets would thereby be less than the aggregate of its liabilities and its issued share capital and share premium accounts.

(b) Statutory reserve fund

Pursuant to the relevant laws and regulations in the PRC, a portion of profits as determined in accordance of the Generally Accepted Accounting Principles of the PRC of subsidiaries established in the PRC has been transferred to reserve funds. Such reserve funds are non-distributable except in the event of liquidation and subject to certain restrictions set out in the relevant PRC regulations. They can be used to offset accumulated losses or capitalised as paid-up capital.

(c) Share option reserve

The share option reserve comprises the fair value of share options granted which are yet to be exercised, as further explained in the accounting policy for share-based payments in note 4 to the financial statements. The amount will either be transferred to the share premium account when the related options are exercised, or be transferred to accumulated loss should the related options expire or be forfeited.

(d) Capital reserves

Capital reserves consist of (i) the deemed contribution from the Company's parent company, Shuifa Singyes with respect to share options granted by Shuifa Singyes; and (ii) the advance received from Top Access in 2015 amounting to RMB55,161,000, which was waived by Top Access during the same year.

40. FAIR VALUE MEASUREMENTS

Management has assessed that the fair values of cash and cash equivalents, restricted cash, trade and bills receivables, financial assets included in prepayments, deposits and other receivables, trade payables, financial liabilities included in accruals and other payables, borrowings and lease liability approximate to their carrying amounts largely due to the short-term maturities of these instruments.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale.

41. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise trade and bills receivables, prepayments, deposits and other receivables, restricted cash, cash and cash equivalents, trade payables, other payables, borrowings and lease liabilities. The main purpose of these financial instruments is to raise finance for the Group's operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group does not have any significant exposure to the risk of changes in market interest rates as the Group does not have any significant long-term receivables and loans which are subject to floating interest rate.

本集團金融工具所產生之主要風險為利 率風險、外幣風險、信貸風險及流動資 金風險。董事會復核及商議管理各類風 險的政策,有關政策概述如下。

利率風險

本集團並無面臨市場利率的任何重大變 動風險,因本集團並無受浮息利率規限 的任何重大長期應收款項及貸款。

Foreign currency risk

The Group's principal businesses are located in the Mainland China and most of the transactions are conducted in RMB. Most of the Group's assets and liabilities are denominated in RMB, except for those of the overseas subsidiaries in Hong Kong and the Company whose functional currency is HK\$. Foreign currency exposure mainly arises from intra-company balance denominated in HK\$ as recorded by Zhuhai New Materials. At 31 December 2024, Zhuhai New Materials recorded an amount due to the Company of RMB68,284,000 (2023: RMB40,326,000) denominated in HK\$. If RMB strengthens/ weakens against HK\$ as a reasonable possible change of 5%, the profit for the year of the Group will decrease/increase by approximately RMB2,902,000 (2023: loss for the year of the Group will increase/ decrease by approximately RMB1,714,000), correspondingly.

Credit risk

Trade receivables

The Group has established a credit risk management policy under which individual credit evaluations are performed on all customers requiring credit. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. In addition, trade receivable balances are monitored on an ongoing basis. Any credit sales exceeding the initial approved limits require approval from the board of directors. Debtors with balances that are more than 3 years past due are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral from customers.

外幣風險

本集團的主要業務位於中國大陸,大部 分交易以人民幣進行。本集團大部分資 產及負債以人民幣計值,惟於香港的海 外附屬公司及本公司的功能貨幣為港 元。外幣風險主要產生自珠海新材料錄 得之以港元計值之集團內公司間結餘。 於二零二四年十二月三十一日,珠海新 材料錄得以港元計值之應付本公司款項 人民幣68,284,000元(二零二三年:人 民幣40,326,000元)。倘按可能合理變 動人民幣兑港元走強/走弱5%,則本 集團之本年度溢利將相應減少/增加約 人民幣2,902,000元(二零二三年:本集 團之本年度虧損將增加/減少約人民幣 1,714,000元)。

信貸風險

貿易應收款項

本集團已制定信貸風險管理政策,據 此,會對所有需要信貸的客戶進行個別 信貸評估。此等評估集中於客戶過往支 付到期款項的記錄及現時付款的能力, 並考慮客戶特定的資料以及關於客戶經 營所在經濟環境的資料。此外,貿易應 收款項結餘乃持續監察。任何超出初始 獲批限額的信貸銷售需要獲得董事會的 批准。結餘逾期超過三年的債務人須於 獲授進一步信貸前清償所有未付結餘。 一般而言,本集團並無自客戶取得任何 抵押品。

Credit risk (Continued)

Bill receivables

The Group considered that there is no significant increase in the credit risk arising from bills receivables after taking into account payment history and forward-looking information. The Group only accepts bills issued or guaranteed by reputable PRC banks if trade receivables are settled by bills and therefore the management of the Group considers the credit risk arising from the endorsed or discounted bills is insignificant. In this regard, the management considers that the Group's credit risk is significantly reduced.

Cash and cash equivalents/restricted cash

Credit risk on cash and cash equivalents/restricted cash is limited because the counterparties are reputable banks with high credit ratings assigned by international credit agencies. The Group assessed 12m ECL for cash and cash equivalents/restricted cash by reference to information relating to probability of default and loss given default of the respective credit rating grades published by external credit rating agencies. Based on the average loss rates, the 12m ECL on cash and cash equivalents/restricted cash is considered to be insignificant and therefore no loss allowance was recognised/to specify the amount of impairment made.

應收票據

本集團認為,經考慮過往付款記錄及前 瞻性資料,來自應收票據的信貸風險並 無顯著增加。倘貿易應收款項以票據結 算,則本集團僅接受中國知名銀行發出 或擔保之票據,因此,本集團管理層認 為,背書或貼現票據產生的信貸風險並 不重大。就此而言,管理層認為本集團 的信貸風險顯著下降。

現金及現金等價物/受限制現金

現金及現金等價物/受限制現金的信貸 風險有限,原因為交易對手方為國際信 用評級機構指定的具較高信用評級且信 譽良好的銀行。本集團參考外部評級機 構發佈的相應信用評級等級的違約概率 及違約損失率相關的資料,評估現金及 現金等價物/受限制現金的12個月預期 信用損失。根據平均損失率,現金及現 金等價物/受限制現金的12個月預期信 用損失被視為並不重大,因此,並無確 認虧損撥備/列明計提的減值金額的虧 損撥備。

Deposits and other receivables

For deposits and other receivables, the management makes periodic individual assessment on the recoverability of deposits and other receivables based on historical settlement records, past experience, and also quantitative and qualitative information that is reasonable and supportive forward-looking information. The management believes that there are no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. For the years ended 31 December 2024 and 2023, the Group assessed the ECL for deposits and other receivables are insignificant and thus no loss allowance is recognised/to specify the assessment of ECL and the amount of impairment made.

The Group's management reviews the liquidity position of the Group on an ongoing basis, including review of the expected cash inflows and outflows in order to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements.

The liquidity of the Group is primarily dependent on its ability to maintain a balance between continuity of funding and flexibility through the settlements from customers and the payments to vendors.

Capital management

The Group's objectives of its capital management are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for the shareholders and benefits for other stakeholders, and to provide an adequate return to shareholders by pricing services and products commensurately with the level of risk.

The Group sets the amount of capital in proportion to risk. The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debts.

The Group monitors capital using a gearing ratio, which is net debt divided by total equity plus net debt. Net debt comprises trade payables, borrowings, lease liabilities, accruals and other payables, and tax payable, less cash and cash equivalents and restricted cash. Capital represents equity attributable to equity shareholders of the Company.
