On June 10, 2025, Shareholders of Dada Nexus Limited (DADA) will vote concerning the proposed merger with JD Sunflower Merger Sub Limited, a wholly owned subsidiary of JD Sunflower Investment Limited. If the merger is approved and consummated, each existing DADA American Depositary Share will be converted into the right to receive \$2.00 cash, less fees (including a \$0.05 ADS cancellation fee) and withholdings, if any.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur prior to or within the third quarter of 2025.

**New Deliverable  
Per Contract:** \$200.00 Cash (\$2.00 x 100), less fees and withholdings, if any

Settlement in DADA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
