On June 18, 2025, Concentra Merger Sub IV, Inc., a wholly owned subsidiary of Concentra Biosciences, LLC, completed its tender offer for Kronos Bio, Inc. The merger was subsequently consummated before the open on June 20, 2025. As a result, each existing KRON Common Share will be converted into the right to receive \$0.57 cash plus one non-transferable Contingent Value Right ("CVR").

Note: The CVR represents a non-transferable contractual right to receive additional payments. The adjusted KRON option deliverable will not include the non-transferable CVRs.

Contract Adjustment

Date: June 20, 2025

New Deliverable

Per Contract: \$57.00 Cash (\$0.57 x 100)

Settlement in KRON options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Kronos Bio, Inc. options whose expiration dates are after 07-18-2025 will have their expiration dates advanced to 07-18-2025. Expiration dates occurring before 07-18-2025 (e.g., Flex options) will remain unchanged.

All Kronos Bio, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 07-18-2025

Existing American-style Kronos Bio, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
