On June 24, 2025, Redwood Merger Sub Inc., a wholly owned subsidiary of Novartis AG, completed its tender offer for Regulus Therapeutics Inc. The merger was subsequently consummated before the open on June 25, 2025. As a result, each existing RGLS Common Share will be converted into the right to receive \$7.00 cash plus one non-transferable Contingent Value Right ("CVR").

Note: The CVR represents a non-transferable contractual right to receive additional payments. The adjusted RGLS option deliverable will not include the non-transferable CVRs.

Contract Adjustment

**New Deliverable
Per Contract:** \$700.00 Cash (\$7.00 x 100)

Settlement in RGLS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Regulus Therapeutics Inc. options whose expiration dates are after 07-18-2025 will have their expiration dates advanced to 07-18-2025. Expiration dates occurring before 07-18-2025 (e.g., Flex options) will remain unchanged.

All Regulus Therapeutics Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Regulus Therapeutics Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
