**Subject:** ChampionX Corporation – Cash In Lieu Settlement  
Adjusted Option Symbol: SLB1

ChampionX Corporation options were adjusted on July 16, 2025 (See OCC Information Memo #56878). The new deliverable became 1) 73 Schlumberger Limited (SLB) Common Shares and 2) Cash in lieu of 0.5 fractional SLB shares. Only settlement of the cash portion of SLB1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$34.94 per whole SLB share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$34.94 = \$17.47 \text{ per SLB1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 16, 2025 through July 22, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the SLB1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 73 Schlumberger Limited (SLB) Common Shares  
2) \$17.47 Cash

**Strike Prices:** Unchanged

**CUSIP:** SLB: 806857108

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The SLB component of SLB1 exercise/assignment activity from July 16, 2025 through July 21, 2025, has settled through National Security Clearing Corporation (NSCC). The \$17.47 cash amount will be settled by OCC.

## **Pricing**

The underlying price for SLB1 will be determined as follows:

$$\text{SLB1} = 0.73 (\text{SLB}) + 0.1747$$

For example, if SLB closes at 33.54, the SLB1 price would be calculated as follows:

$$\text{SLB1} = 0.73 (33.54) + 0.1747 = 24.66$$
