Subject: Adjusted Global X AgTech & Food Innovation ETF – Cash In Lieu Settlement
Adjusted Option Symbol: KROP1

Adjusted Global X AgTech & Food Innovation ETF options were adjusted on September 2, 2025 (See OCC Information Memo #57168). The new deliverable became 1) 33 Global X AgTech & Food Innovation ETF (KROP) Shares and 2) Cash in lieu of approximately 0.3333 fractional KROP Shares. Only settlement of the cash portion of KROP1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$32.19 per whole KROP share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$32.19 = \$10.73 \text{ per KROP1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 2, 2025 through September 12, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the KROP1 options are as follows:

New Deliverable Per Contract: 1) 33 Global X AgTech & Food Innovation ETF (KROP) Shares
2) \$10.73 Cash

Strike Prices: Unchanged

CUSIP: KROP: 37960A198

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The KROP component of KROP1 exercise/assignment activity from September 2, 2025 through September 11, 2025, has settled through National Security Clearing Corporation (NSCC). The \$10.73 cash amount will be settled by OCC.

Pricing

The underlying price for KROP1 will be determined as follows:

$$\text{KROP1} = 0.33 (\text{KROP}) + 0.1073$$

For example, if KROP closes at 32.08, the KROP1 price would be calculated as follows:

$$\text{KROP1} = 0.33 (32.08) + 0.1073 = 10.69$$
