- Reference is made to the announcement of Beijing Enterprises Water Group Limited (the “Company”) dated 27 August 2025, with respect to (a) the payment of interim dividend of HK7.35 cents per share for the six months ended 30 June 2025 (“2025 Interim Dividend”); and (b) the option given to the shareholders to elect to receive all (but not part, save in the case of HKSCC Nominees Limited, which may elect to receive part of its entitlement in Renminbi (“RMB”)) of 2025 Interim Dividend in RMB at the exchange rate of HK\$1.0: RMB0.912492.

If no Form is received by the branch share registrar of the Company in Hong Kong by the Closing Time, you will receive your 2025 Interim Dividend in HONG KONG DOLLARS. The Closing Time will be adjusted, as the case may be, in accordance with (a) or (b) below if a Typhoon Warning Signal No. 8 or above is hoisted, a Black Rainstorm Warning is in force in Hong Kong or “extreme conditions” resulting from a typhoon or a rainstorm are announced by the Government of the Hong Kong Special Administrative Region of the People’s Republic of China:
(a) at any local time before 12:00 noon on Monday, 6 October 2025. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or
(b) at any local time between 12:00 noon and 4:30 p.m. on Monday, 6 October 2025. In such case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m.
