Please revise to identify your current Authorized Participants that have Authorized Participant Agreements that allow for only cash, only in-kind and both cash and in-kind creations and redemptions. In addition, please revise to identify your Ether Trading Counterparties and disclose the material terms of the agreements with the Ether Trading Counterparties.
