We believe the adjusted measures provide valuable insight into our ongoing operational performance and assist in comparisons to our competitors. These measures also assist management with the establishment of operational budgets and forecasts. The most directly comparable U.S. GAAP measures are operating revenues (and by calculation, gross revenue yield on AUM), operating expenses, operating income, operating margin, net income attributable to Invesco Ltd., and diluted EPS.

A reconciliation of U.S. GAAP results to non-GAAP results may be found in the Appendix. The information in this presentation is meant to supplement the information contained in the earnings release and includes a more detailed reconciliation format of the income statement from U.S. GAAP to a non-GAAP presentation. We believe that this presentation is useful, as it aggregates the various non-GAAP adjustments to illustrate adjusted revenue and expense categories and allows more transparency into the calculation of the non-GAAP financial measures.

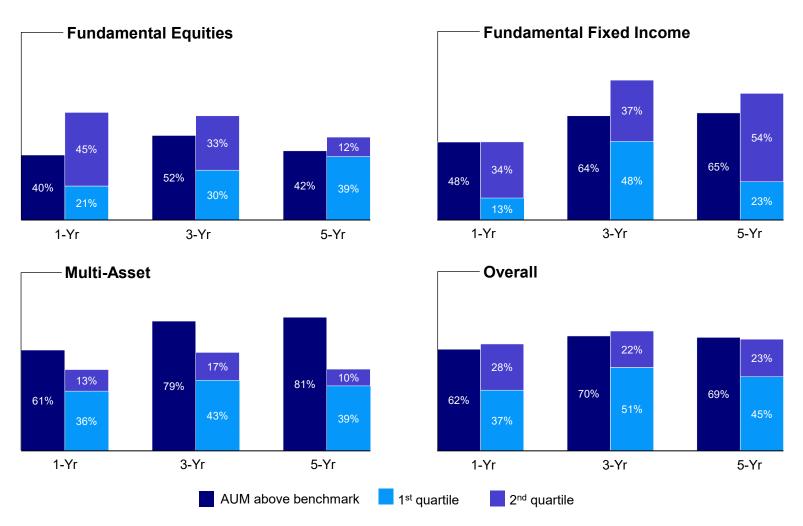

#### **Investment Performance**

### **Financial Highlights**

- Net Long-Term inflows of \$28.9 billion or 7.9% annualized organic growth in the third quarter of 2025
  - Record Ending AUM of \$2.1 trillion
  - Ending Long-Term AUM grew 16% over the third quarter of 2024
- Net revenues increased 7.4% and expenses remained well-managed with a 3.3% increase from the third quarter of last year
  - Net revenues increased 7.4% and expenses increased 2.6% from the second quarter of 2025
- Generated positive operating leverage of 410 basis points from the third quarter of 2024; drove 260 basis points of operating margin improvement
  - Generated positive operating leverage of over 480 basis points from the second quarter of 2025; drove 300 basis points of operating margin improvement
- Continued strengthening of the balance sheet with no draw on the credit facility and leverage ratio improvement (inclusive of preferred stock)
  - Repaid \$260 million of bank term loans during the quarter
  - Executed share buybacks of \$25 million or 1.2 million shares

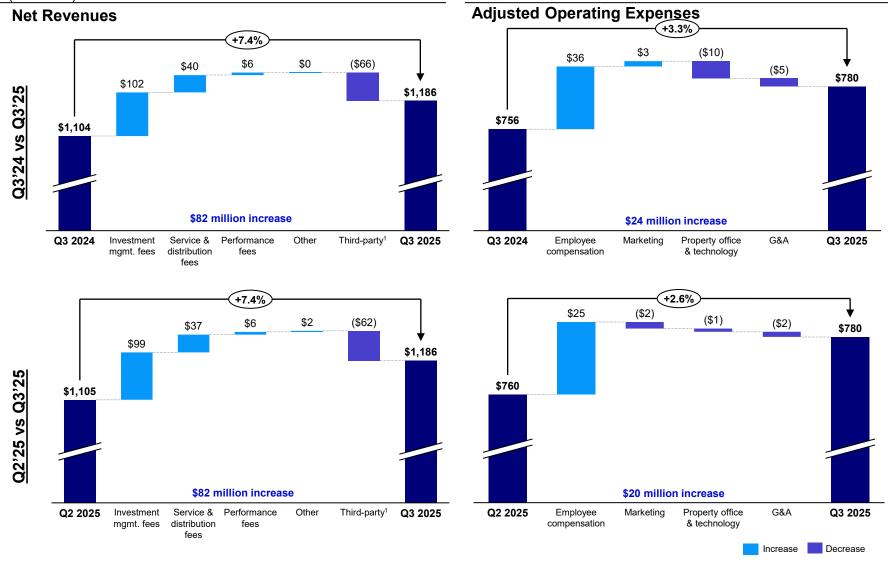

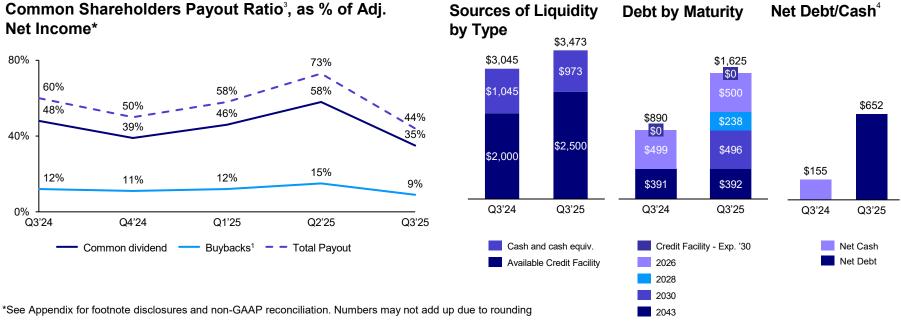

Common Shareholders Payout Ratio<sup>3</sup>, as % of Adj.







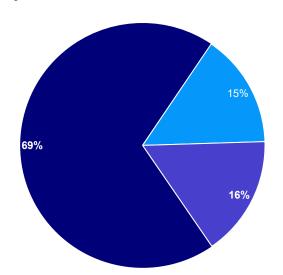

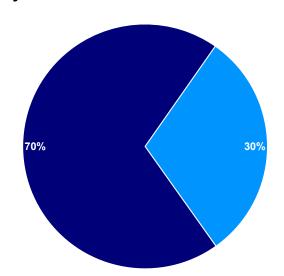

### **By Client Domicile**



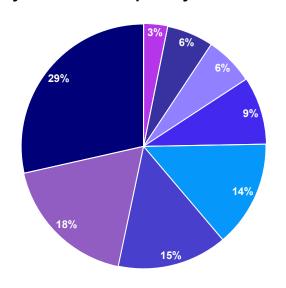

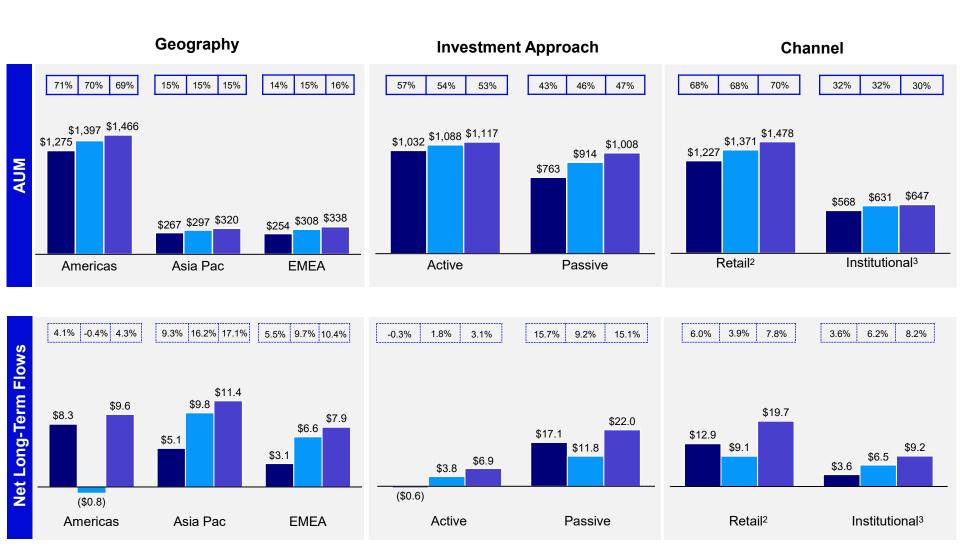

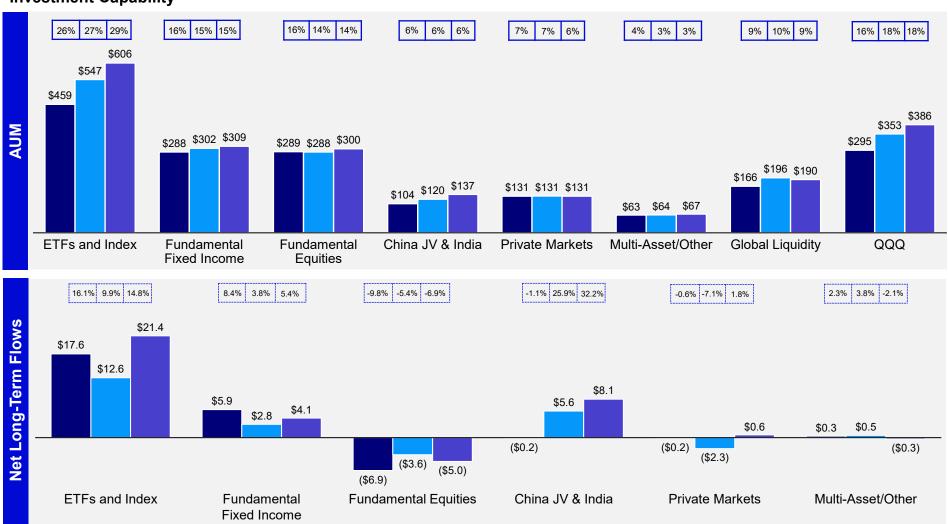

The calculation of adjusted debt is defined in our credit facility and equals debt plus letters of credit less excess unrestricted cash (cash and cash equivalents less the minimum regulatory capital requirement), not to exceed \$600 million. For Q3 2025, adjusted debt of \$1,028.2 million is calculated as debt of \$1,624.6 million plus \$3.6 million in letters of credit less \$600.0 million of excess unrestricted cash.
