- Reference is made to the announcement of Sun Art Retail Group Limited (the “Company”) dated 11 November 2025, with respect to the payment of interim dividend of Hong Kong dollars (“HKD”) \$0.085 per share for the six months ended 30 September 2025 (“FY26 Interim Dividend”) and the option given to the shareholders to elect to receive all or part of their dividend in Renminbi (“RMB”), or in United States dollars (“USD”), both at the exchange rate to be quoted by The Hong Kong Association of Banks at 3 March 2026, or a combination of HKD, RMB and USD.
茲提述高鑫零售有限公司「本公司」於二零二五年十一月十一日刊發的公告，內容有關派付截至二零二五年九月三十日止的六個月中期股息每股港幣0.085元（「26財年中期股息」）及給予股東以人民幣（「人民幣」）收取全部或部分股息的選擇權，以美元（「美元」）收取全部或部分股息的選擇權，均將以二零二六年三月三日香港銀行公會所報匯率計算；或港幣、人民幣和美元的組合。
