- References are made to the announcements of the Bank dated 29 August 2025, 12 December 2025 and 30 December 2025 with respect to (a) the payment of 2025 Interim Dividend of RMB1.563 per 10 shares (tax-inclusive); (b) the H shareholders have the right to choose to receive the 2025 Interim Dividend in RMB or HKD in whole (HKSCC Nominees Limited may choose to receive the dividends in whole or in part); and (c) the relevant exchange rate shall be determined based on the average of the reference rates of RMB against HKD published daily at 11:00 a.m. by China Money (www.chinamoney.com.cn) for the five working days prior to the commencement date for the shareholders' currency election (excluding the commencement date).
