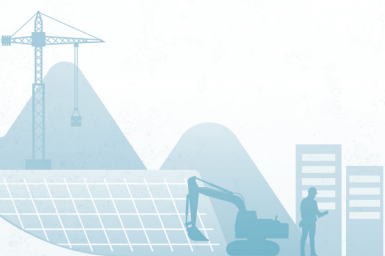

Financial Highlights

財務摘要

- Revenue amounted to approximately HK\$75.40 million for the six months ended 31 October 2025 (the "Reporting Period") (2024: approximately HK\$161.44 million), representing a decrease of approximately 53.30% as compared with the corresponding period of last year.
- Loss attributable to owners of the Company for the Reporting Period amounted to approximately of HK\$2.26 million (2024: HK\$0.046 million).
- Basic loss per share amounted to approximately of HK0.143 cents for the Reporting Period (2024: HK0.003 cents).
- The Board does not recommend the payment of interim dividend for the Reporting Period (2024: Nil).

BUSINESS REVIEW AND OUTLOOK

The Group is a contractor principally engaged in under taking slope works, foundation works and other general building works in Hong Kong. Slope works generally refer to landslip preventive and remedial works for improving or maintaining the stability of slopes and/or retaining walls. Foundation works are generally concerned with the construction of foundations. General building works mainly include the general construction of buildings. Fraser Construction Company Limited, our principal operating subsidiary, is an approved specialist contractor included in the List of Approved Specialist Contractors for Public Works maintained by the Development Bureau of the Government of the Hong Kong Special Administrative Region (the "Hong Kong Government") under the categories of "Landslip Preventive/Remedial Works to Slopes/Retaining Walls" with a confirmed status and "Land Piling (Group II)". Being on such list is a prerequisite for tendering for public sector projects in the relevant works categories. In addition, Fraser Construction Company Limited is registered under the Buildings Ordinance (Chapter 123 of the Laws of Hong Kong) as a (i) Registered Specialist Contractor under the sub-register of "Site Formation Works" and "Foundation Works" categories; and (ii) Registered General Building Contractor.

The Group experienced a decrease in revenue and decrease in gross profit margin, recorded an increase in net loss for the six months ended 31 October 2025 compared to the net loss for the six months ended 31 October 2024. Hong Kong construction companies are still facing tougher competitive condition. The Group has also been facing challenging operating environment resulting from increasing costs of operation including, in particular, higher subcontracting rate and higher general operation costs. As such, the Directors consider that competition in the market has remained intense.

Nevertheless, we believe that the Hong Kong Government's continuing increase in major construction and infrastructure projects in Hong Kong will increase the demand for slope works that are directly related to public safety. The Hong Kong Government still maintain its stand to launch a rolling Landslip Prevention and Mitigation Programme to systematically deal with the landslide risk associated with both man-made slopes and natural hillsides. The stand enable steady flow of slopes construction works load to the construction industry. All in all, the Directors remain cautiously optimistic about the slope works industry in Hong Kong.

業務回顧及展望

本集團為一名主要在香港承建斜坡工程、地基工程及其他一般建築工程的承建商。斜坡工程一般指改善或保持斜坡及／或擋土牆穩定性的防止山泥傾瀉及修補工程。地基工程一般指地基建造成。一般建築工程主要包括一般建築施工。我們的主要營運附屬公司科正建築有限公司為一名香港特別行政區政府（「香港政府」）發展局備存的「斜坡／擋土牆的防止山泥傾瀉／修補工程」（已取得核准資格）及「土地打樁（第II組）」類別下的認可公共工程專門承建商名冊上的認可專門承建商。名列該名冊是投標有關工程類別中的公營項目的必備條件。此外，科正建築有限公司已根據建築物條例（香港法例第123章）登記註冊為(i)「地盤平整工程」及「地基工程」類別分冊下的註冊專門承建商；及(ii)註冊一般建築承建商。

與截至二零二四年十月三十一日止六個月錄得虧損淨額相比，本集團於截至二零二五年十月三十一日止六個月的收益減少及毛利率下降，錄得虧損淨額增加。香港的建築公司仍面臨更嚴峻的競爭環境。本集團亦面臨更具挑戰性的經營環境，此乃由於經營成本不斷上升，包括（尤其是）分包費用及整體經營成本升高。因此，董事認為市場競爭依然激烈。

然而，我們相信，香港政府於香港持續增加主要建設及基建項目將增加斜坡工程之需求，而斜坡工程與公共安全息息相關。香港政府仍持續展開長遠防治山泥傾瀉計劃，以有系統地處理人造斜坡和天然山坡涉及的山泥傾瀉風險，為建造業帶來穩定斜坡建造工程。總而言之，董事對香港斜坡工程行業仍持審慎樂觀態度。

Looking forward, the Group anticipates that the Hong Kong construction market will remain challenging with rising trend in subcontracting costs and intensive competition, which is expected to continue to place repeated pressure on our profit margin.

FINANCIAL REVIEW

Revenue

The Group's overall revenue decreased by approximately HK\$86.04 million or approximately 53.30% from approximately HK\$161.44 million for the six months ended 31 October 2024 to approximately HK\$75.40 million for the six months ended 31 October 2025. The decrease in revenue was mainly due to the decrease in revenue derived from undertaking slope works as further discussed below.

Slope works: Undertaking landslip preventive and remedial works for improving or maintaining the stability of slopes and/or retaining walls. Revenue from undertaking slope works decreased from approximately HK\$161.15 million for the six months ended 31 October 2024 to approximately HK\$64.46 million for the six months ended 31 October 2025, representing a decrease of approximately 60.00%. The decrease in revenue was primarily attributable to the decrease in the number of slopes works projects.

Foundation works: Undertaking works in relation to the construction of foundations for general building construction. Revenue from undertaking foundation works increased from approximately HK\$0.29 million for the six months ended 31 October 2024 to approximately HK\$10.95 million for the six months ended 31 October 2025, representing an increase of approximately 3,675.86%. The increase in revenue was primarily attributable to the increase in the number of foundation works projects.

Gross Profit and Gross Profit Margin

The Group's gross profit decreased by approximately HK\$2.41 million from approximately HK\$3.51 million for the six months ended 31 October 2024 to approximately HK\$1.10 million for the six months ended 31 October 2025 and the Group's gross profit margin decreased from approximately 2.2% for the six months ended 31 October 2024 to approximately 1.5% for the six months ended 31 October 2025. The decrease in gross profit margin was mainly due to decrease in revenue.

展望未來，本集團預期香港建築市場仍充滿挑戰，預期分包費用的上升趨勢及激烈競爭將持續，這預計會對溢利率構成沉重壓力。

財務回顧

收益

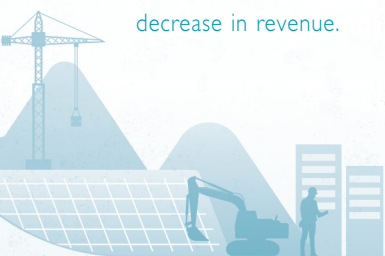
本集團總體收益由截至二零二四年十月三十一日止六個月之約161.44百萬港元減少約86.04百萬港元或約53.30%至截至二零二五年十月三十一日止六個月之約75.40百萬港元。收益減少主要是由於承建斜坡工程所產生的收益減少（於下文作進一步論述）。

斜坡工程：承建改善或保持斜坡及／或擋土牆穩定性的防止山泥傾瀉及修補工程。來自承建斜坡工程的收益由截至二零二四年十月三十一日止六個月之約161.15百萬港元減少至截至二零二五年十月三十一日止六個月之約64.46百萬港元，降幅約60.00%。收益減少乃主要由於斜坡工程項目數量減少所致。

地基工程：承建與一般樓宇建設的地基建造有關的工程。來自承建地基工程的收益由截至二零二四年十月三十一日止六個月之約0.29百萬港元增加至截至二零二五年十月三十一日止六個月之約10.95百萬港元，增幅約3,675.86%。收益增加主要歸因於地基工程項目的數目增加。

毛利及毛利率

本集團的毛利由截至二零二四年十月三十一日止六個月的約3.51百萬港元減少約2.41百萬港元至截至二零二五年十月三十一日止六個月的約1.10百萬港元，而本集團的毛利率由截至二零二四年十月三十一日止六個月的約2.2%減少至截至二零二五年十月三十一日止六個月的約1.5%。毛利率減少主要由於收入減少所致。

The Group's direct costs decreased by approximately HK\$83.63 million or approximately 52.95% from approximately HK\$157.93 million for the six months ended 31 October 2024 to approximately HK\$74.30 million for the six months ended 31 October 2025. Such decrease was mainly attributable to the decrease in the number of slopes works projects.

Other Income and other net loss

The Group's other income and other net loss decreased from HK\$1.00 million for the six months ended 31 October 2024 to approximately HK\$0.94 million for the six months ended 31 October 2025. Such decrease was mainly attributable to the decrease in sundry income.

Administrative Expenses

The Group's administrative expenses increased slightly by approximately HK\$0.06 million or approximately 1.77% from approximately HK\$3.39 million for the six months ended 31 October 2024 to approximately HK\$3.45 million for the six months ended 31 October 2025.

Finance costs

For the six months ended 31 October 2025, the Group has incurred an expense of approximately HK\$0.85 million (2024: HK\$0.78 million). An increase in finance costs is due to a loan amount was increased.

Loss attributable to owners of the Company

As a result of the foregoing combined effects of the above, the loss attributable to owners of the Company for the six months ended 31 October 2025 was approximately HK\$2.26 million as compared to loss attributable to owners of the Company approximately HK\$0.046 million for the six months ended 31 October 2024.

本集團直接成本由截至二零二四年十月三十一日止六個月的約157.93百萬港元減少約83.63百萬港元或約52.95%至截至二零二五年十月三十一日止六個月的約74.30百萬港元。有關減少乃主要由於斜坡工程項目數量減少所致。

其他收入及其他虧損淨額

本集團的其他收入及其他虧損淨額由截至二零二四年十月三十一日止六個月的1.00百萬港元減少至截至二零二五年十月三十一日止六個月的約0.94百萬港元。有關減少乃主要由於雜項收入減少。

行政開支

本集團的行政開支由截至二零二四年十月三十一日止六個月的約3.39百萬港元輕微增加約0.06百萬港元或約1.77%至截至二零二五年十月三十一日止六個月的約3.45百萬港元。

融資成本

截至二零二五年十月三十一日止六個月，本集團產生的開支約為0.85百萬港元（二零二四年：0.78百萬港元）。融資成本增加乃由於貸款金額增加。

本公司擁有人應佔虧損

由於上述各項的綜合影響，故截至二零二五年十月三十一日止六個月本公司擁有人應佔虧損約為2.26百萬港元，而截至二零二四年十月三十一日止六個月本公司擁有人應佔虧損則約為0.046百萬港元。

LIQUIDITY, FINANCIAL AND CAPITAL RESOURCES

Capital structure

As at 31 October 2025, the issued share capital of the Company was 1,577,200,000 ordinary shares of HK\$0.01 each.

As at 31 October 2025, the equity attributable to owners of the Company amounted to approximately negative HK\$23.89 million (as at 30 April 2025: approximately negative HK\$21.63 million).

Cash position

As at 31 October 2025, the cash at banks and in hand of the Group amounted to approximately HK\$19.89 million (as at 30 April 2025: approximately HK\$36.04 million), representing a decrease of approximately HK\$16.15 million as compared to that as at 30 April 2025.

Charges over Assets of the Group

As at 31 October 2025, the Group did not have any charges over assets of the Group (as at 30 April 2025: Nil).

Gearing ratio

As at 31 October 2025, the gearing ratio of the Group was negative approximately 151.90% (as at 30 April 2025: negative approximately 257.37%). The gearing ratio is calculated as total debts divided by the equity attributable to owners of the Company as the respective reporting date. Total debts includes borrowings, due to former directors and director of a subsidiary.

The Group's gearing ratio was negative as the Group's equity was deficit position as at 31 October 2025 and 30 April 2025.

Capital Commitments

The Group had no material capital commitment as at 31 October 2025 and 30 April 2025.

資本架構

於二零二五年十月三十一日，本公司擁有人應佔權益達約負23.89百萬港元(於二零二五年四月三十日：約負21.63百萬港元)。

現金狀況

於二零二五年十月三十一日，本集團的銀行及手頭現金約為19.89百萬港元(於二零二五年四月三十日：約36.04百萬港元)，較二零二五年四月三十日減少約16.15百萬港元。

本集團的資產抵押

於二零二五年十月三十一日，本集團並無將任何本集團資產抵押(於二零二五年四月三十日：無)。

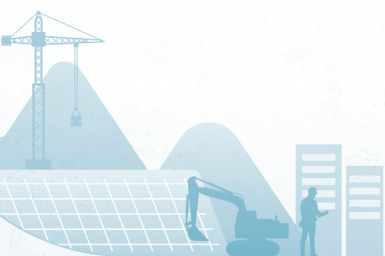
資產負債比率

於二零二五年十月三十一日，本集團的資產負債比率約為負151.90%(於二零二五年四月三十日：約負257.37%)。資產負債比率乃按於各報告日期的債務總額除以本公司擁有人應佔權益計算。債務總額包括借貸、應付前董事及一間附屬公司之董事款項。

本集團的資產負債比率為負值，原因是於二零二五年十月三十一日及二零二五年四月三十日本集團的權益處於虧絀狀態。

The Group had total staffs cost HK\$1.82 million for the Period. Remuneration is determined with reference to market terms and the performance, qualifications and experience of the individual employee. I. CORPORATE INFORMATION

Zhejiang United Investment Holdings Group Limited (the “Company”) was incorporated in the Cayman Islands on 20 May 2015 as an exempted company with limited liability and its shares have been listed on the GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 2 November 2015. The directors of the Company consider that the immediate holding company of the Company during the period ended 31 October 2025 is Emperor Securities Limited, a company incorporated in Hong Kong and indirectly wholly-owned subsidiary of Emperor Capital Group Limited, the intermediate holding company of the Company is Emperor Capital Group Limited, a company incorporated in Bermuda and the shares of which are listed on the Main Board of the Stock Exchange with stock code 717 while the Company’s ultimate holding company is, in the opinion of the directors of the Company, Albert Yeung Capital Holdings Limited, a limited liability company incorporated in the BVI. The entire issued share capital of Albert Yeung Capital Holdings Limited is in turn held by CDM Trust & Board Services AG, being the trustee of Albert Yeung Capital Discretionary Trust, a discretionary trust set up by Dr. Yeung Sau Shing, Albert.

The address of the registered office of the Company is Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the principal place of business of the Company is Unit A6-A, 12th floor, Block A, Hong Kong Industrial Centre, 489-491 Castle Peak Road, Lai Chi Kok, Kowloon, Hong Kong. The Company is an investment holding company and its subsidiaries (collectively, the “Group”) are principally engaged in undertaking slope works, foundation works and other general building works in Hong Kong. The consolidated financial statements are presented in Hong Kong dollar (“HK\$”), which is the functional currency of the Company and its subsidiaries, and all values are rounded to the nearest thousands (“HK\$’000”), except when otherwise indicated.

I. 公司資料

浙江聯合投資控股集團有限公司(「本公司」)於二零一五年五月二十日在開曼群島註冊成立為一間獲豁免有限公司，以及其股份已於二零一五年十一月二日在香港聯合交易所有限公司(「聯交所」) GEM上市。本公司董事認為本公司於截至二零二五年十月三十一日止期間之直接控股公司為英皇證券有限公司(一間於香港註冊成立之公司及為英皇資本集團有限公司之間接全資附屬公司)，本公司之中間控股公司為英皇資本集團有限公司(一間於百慕達註冊成立之公司，其股份於聯交所主板上市，股份代號：717)，而本公司董事認為，本公司之最終控股公司為Albert Yeung Capital Holdings Limited(一間於英屬處女群島註冊成立之有限公司)。Albert Yeung Capital Holdings Limited的全部已發行股本由CDM Trust & Board Services AG(即由楊受成博士設立的酌情信託Albert Yeung Capital Discretionary Trust之受託人)持有。

本公司註冊辦事處的地址為Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands。本公司的主要營業地點的地址為香港九龍荔枝角青山道489-491號香港工業中心A座12樓A6-A室。本公司為一間投資控股公司，本公司及其附屬公司(統稱「本集團」)主要在香港承建斜坡工程、地基工程及其他一般建築工程。綜合財務報表以港元(「港元」)呈列，港元為本公司及其附屬公司之功能貨幣，而除另有指明外，所有金額均約整至最接近的千位(「千港元」)。

2. BASIS OF PREPARATION

The unaudited condensed consolidated interim financial statements (the "Interim Financial Information") of the Group for the six months ended 31 October 2025 have been prepared in accordance with Hong Kong Accounting Standard ("HKAS") 34 Interim Financial Reporting issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the applicable disclosure requirements of the GEM Listing Rules on the Stock Exchange.

The Interim Financial Information have been prepared in accordance with the same accounting policies applied in the 2025 annual financial statements for the year ended 30 April 2025, except for additional accounting policies resulting from application of new and revised Hong Kong Financial Reporting Standards ("HKFRSs") and application of certain accounting policies which became relevant to the Group for the six months ended 31 October 2025 as set out in note 3 to the Interim Financial Information.

The preparation of the Interim Financial Information in conformity with HKAS 34 requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

The Interim Financial Information contains condensed consolidated financial statements and selected explanatory notes. The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and financial performance of the Group since 2025 annual financial statements for the year ended 30 April 2025. The Interim Financial Information and notes thereon do not include all of the information required for a full set of financial statements prepared in accordance with HKFRSs and should be read in conjunction with the 2025 annual financial statements for the year ended 30 April 2025.

The Interim Financial Information have been prepared on the historical cost basis.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

2. 編製基準

The Group incurred a net loss of approximately HK\$2,255,000 for the six months ended 31 October 2025, the Group had net current liabilities and net liabilities of approximately HK\$24,171,000 and HK\$23,888,000 as at 31 October 2025. However, the Group generated a net operating cash inflow of approximately HK\$4,081,000 for the six months ended 31 October 2025. The Directors adopted the going concern basis in the preparation of the Interim Financial Information and implemented some measures in order to improve the working capital and liquidity and cash flow position of the Group. More information is set out in the Company's annual report for the year ended 30 April 2025.
