On February 2, 2026, AT2B, Inc., an indirect wholly owned subsidiary of Cycle Group Holdings Limited, completed its tender offer for Applied Therapeutics, Inc. The merger was subsequently consummated before the open on February 3, 2026. As a result, each existing APLT Common Share will be converted into the right to receive \$0.088 cash plus one non-transferable Contingent Value Right ("CVR").

Note: The CVR represents a non-transferable contractual right to receive up to four contingent cash payments of up to an aggregate of \$0.40 per CVR upon achievement of certain specified milestones plus the pro rata portion of any closing cash payment. The adjusted APLT options deliverable will not include the non-transferable CVRs.

Contract Adjustment

**New Deliverable
Per Contract:** \$8.80 Cash (\$0.088 x 100)

Settlement in APLT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Applied Therapeutics, Inc. options whose expiration dates are after 02-20-2026 will have their expiration dates advanced to 02-20-2026. Expiration dates occurring before 02-20-2026 (e.g., Flex options) will remain unchanged.

All Applied Therapeutics, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Applied Therapeutics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
