From 10:30 a.m. on Friday, 26 June 2026 (i.e. approximately 30 minutes prior to the commencement of the AGM), you can log in to the Online Platform for the AGM by visiting [http://meetings.computershare.com/StarPlusLegend\\_AGM2026](http://meetings.computershare.com/StarPlusLegend_AGM2026).

In order to attend the AGM online, you need to (i) contact your Intermediaries to appoint you as a proxy and (ii) provide your e-mail address to your Intermediaries, before the deadline required by your Intermediaries. Details regarding the AGM arrangements including the login details to access the AGM online platform will be sent by the Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited to the e-mail address provided by you.
