**Reminder letter regarding the Arrangement of Electronic Dissemination of Corporate Communications** (Note 1)

With reference to the notification letter dated March 12, 2024 titled "Arrangement of Electronic Dissemination of Corporate Communications", Ganfeng Lithium Group Co., Ltd.
