FINANCIAL HIGHLIGHTS 財務摘要

Total operating revenues for the period amounted to RMB1,738.5 million, representing a decrease of 11.4% as compared to RMB1,962.8 million for the corresponding period of last year.

期內經營收益總額為人民幣1,738.5百萬元，較去年同期的人民幣1,962.8百萬元下降11.4%。

Same store sales ("SSS") for the period decreased by 13.5%.

期內同店銷售（「同店銷售」）下降13.5%。

Total gross sales proceeds ("GSP") inclusive of value-added tax for the period were RMB3,532.4 million, representing a year-on-year decrease of 15.0%.

Profit from operations for the period was RMB235.4 million, representing a decrease of 8.6% as compared to RMB257.6 million for the corresponding period of last year.

Profit attributable to owners of the Company for the period was RMB23.0 million, representing an increase of 2.2% as compared to RMB22.5 million for the corresponding period of last year.

INTRODUCTION

We have reviewed the interim condensed consolidated financial information of Parkson Retail Group Limited (the "Company") and its subsidiaries (together, the "Group") set out on pages 8 to 48, which comprises the interim condensed consolidated statement of financial position as at 30 June 2026, and the related interim condensed consolidated statement of profit or loss, the interim condensed consolidated statement of comprehensive income, the interim condensed consolidated statement of changes in equity and the interim condensed consolidated statement of cash flows for the six months period then ended, and notes to the interim condensed consolidated financial information, including material accounting policy information. The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited require the preparation of an interim financial information to be in compliance with the relevant provisions thereof and International Accounting Standard 34 "Interim Financial Reporting" ("IAS 34") as issued by the International Accounting Standards Board. The directors of the Company are responsible for the preparation and presentation of this interim condensed consolidated financial information in accordance with IAS 34. Our responsibility is to express a conclusion on this interim condensed consolidated financial information based on our review, and to report our conclusion solely to you, as a body, in accordance with our agreed terms of engagement, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report.

引言

SCOPE OF REVIEW

We conducted our review in accordance with Hong Kong Standard on Review Engagements 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" as issued by the Hong Kong Institute of Certified Public Accountants. A review of interim condensed consolidated financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

CONCLUSION

Based on our review, nothing has come to our attention that causes us to believe that the interim condensed consolidated financial information are not prepared, in all material respects, in accordance with IAS 34.

1. CORPORATE INFORMATION

Parkson Retail Group Limited (the "Company") is a limited liability company incorporated in the Cayman Islands on 3 August 2005. The Company has established a principal place of business in Hong Kong in Room 1010, 10th Floor, Harcourt House, 39 Gloucester Road, Wanchai, Hong Kong.

The Company acts as an investment holding company. The principal activities of the Company and its subsidiaries (the "Group") are the operation and management of a network of department stores, shopping malls, outlets and supermarkets mainly in the People's Republic of China (the "PRC"), and the provision of credit services in Malaysia.

In the opinion of the directors, the ultimate holding company of the Company is Parkson Holdings Berhad ("PHB"), which is incorporated in Malaysia and listed on Bursa Malaysia Securities Berhad.

2.1 BASIS OF PREPARATION

The interim condensed consolidated financial information for the six months ended 30 June 2026 has been prepared in accordance with International Accounting Standard ("IAS") 34 "Interim Financial Reporting" as issued by the International Accounting Standards Board. The interim condensed consolidated financial information does not include all the information and disclosures required in the annual consolidated financial statements, and should be read in conjunction with the Group's annual consolidated financial statements for the year ended 31 December 2025.

百盛商業集團有限公司（「本公司」）於二零零五年八月三日在開曼群島註冊成立為有限公司。本公司於香港的主要營業地點為香港灣仔告士打道39號夏慤大廈10樓1010室。

本公司為投資控股公司。本公司及其附屬公司（「本集團」）的主要業務為在中華人民共和國（「中國」）經營及管理百貨店、購物中心、奧特萊斯及超市網絡，以及於馬來西亞提供信貸服務。

董事認為，本公司的最終控股公司為Parkson Holdings Berhad（「PHB」），一家於馬來西亞註冊成立的公司，並於馬來西亞證券交易所上市。

Going concern basis

The Group reported net current liabilities of RMB1,735,823,000 as at 30 June 2026. The unrestricted cash and cash equivalents amounting to RMB1,309,885,000 as at 30 June 2026. As at 30 June 2026, the Group's capital commitment in respect of the capital expenditure for its construction in progress and leasehold improvement to be incurred in the coming twelve months was RMB3,204,000. These circumstances may cast significant doubt on the Group's ability to continue as a going concern.

Management has prepared a cash flow forecast of the Group for the next twelve months from reporting date based on the existing situation, the future events and commitments of the Group. Management considered that the Group will have adequate working capital to meet its obligations, and therefore the consolidated financial statements of the Group have been prepared on a going concern basis. Measures and estimations have been taken into consideration by management, including and not limited to:

- (a) The Group's syndicated loans of RMB2,270,000,000 are secured by mortgages over the Group's properties with a total carrying amount of RMB2,038,080,000. After considered the fair values of these pledged assets and the annual rental income from investment properties, management believes that the pledged assets are sufficient to cover the outstanding balance of the loans in full.

- (b) The Group has been actively negotiating with banks to obtain additional loans to replace the existing RMB2,270,000,000 secured syndicated bank loans and to supplement its operating cash flows. Based on the communication between the Group and the banks, among others, up to the date of approval of the interim condensed consolidated financial information, the Group expects to obtain additional loans amounting to approximately RMB2,300,000,000. Nevertheless, the confirmation of the loans is subject to the final contract between the Group and the banks.
- (c) The Group continues to focus on the improvement of its retail business operation, including opening new stores with competitive advantages, closing under-performing stores, formulating customised renovation and upgrade plan for the stores, and advancing its integrated "online + offline" sales model.

Management considered that the Group will have sufficient working capital to fulfil its financial obligations and commitments as and when they fall due in the coming twelve months from 30 June 2026. Accordingly, management is satisfied that it is appropriate to prepare the interim condensed consolidated financial information on a going concern basis.

6. INCOME TAX EXPENSE

The Group is subject to income tax on an entity basis on the assessable profit arising in or derived from the tax jurisdictions in which members of the Group are domiciled and operate.

Pursuant to the rules and regulations of the Cayman Islands and the British Virgin Islands, the Group is not subject to any income tax in the Cayman Islands and the British Virgin Islands.

Under the relevant PRC income tax regulations, except for a certain preferential treatment available to certain PRC subsidiaries of the Group, the PRC companies of the Group are subject to corporate income tax at a rate of 25% (30 June 2025: 25%) on their respective taxable income. During the six months ended 30 June 2026, three (30 June 2025: three) PRC entities of the Group obtained approval from the relevant PRC tax authorities and were entitled to a preferential corporate income tax rate of 15%.

Malaysia profits tax has been provided at the rate of 24% (30 June 2025: 24%) on its taxable income.

No provision for Hong Kong, Singapore and Laos profits has been made for the six months ended 30 June 2026 and 2025, as the Group had no assessable profits arising in Hong Kong, Singapore and Laos for each of the periods.

The Group's finance department headed by a director is responsible for determining the policies and procedures for the fair value measurement of financial instruments. The director reports directly to the audit committee. At each reporting date, the finance manager analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the director. The valuation process and results are discussed with the audit committee twice a year for interim and annual financial reporting.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale.

The Group invests in unlisted investments, which represent wealth management products issued by banks in the PRC. The Group has estimated the fair value of these unlisted investments by using a discounted cash flow valuation model based on the market interest rates of instruments with similar terms and risks.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

The Board would like to present the interim results of the Group for the six months ended 30 June 2026 (the "Review Period").

During the Review Period, amid rising uncertainties in the global economic environment, the economy of the People's Republic of China (the "PRC") demonstrated remarkable resilience. According to the latest data released by the National Bureau of Statistics of China, in the first half of 2026, the PRC's GDP reached RMB69.57 trillion, representing a year-on-year increase of 4.7%, while total retail sales of consumer goods grew by 1.3% year-on-year. The overall economy maintained a steady recovery trajectory despite operating in a complex environment.

FINANCIAL RESULTS

During the Review Period, the Group recorded gross sales proceeds of RMB3,532.4 million (inclusive of value-added tax), representing a decrease of 15.0% compared to the same period last year. This change was primarily attributable to the structural shifts in consumer spending content and patterns, coupled with the ongoing transition of certain stores from traditional department store formats to shopping mall formats, which resulted in a corresponding decrease in concessionaire sales and direct sales. SSS decreased by 13.5% during the Review Period. The Group recorded operating profit of RMB235.4 million during the Review Period, compared to RMB257.6 million in the same period last year, representing a decrease of 8.6%.

As of 30 June 2026, the Group and its associates operated and managed 38 Parkson stores (including department stores, shopping malls, outlets, Parkson Beauty concept stores, and supermarkets) across 23 cities in the PRC and Laos, as well as 2 Parkson Newcore City Malls.

於回顧期內，全球經濟環境不確定性因素增多，中華人民共和國（「中國」）經濟展現出強大的韌性。根據中國國家統計局公佈的最新數據，二零二六年上半年，中國國內生產總值為人民幣69.57萬億元，同比增長4.7%，消費品零售總額同比增長1.3%。儘管面臨複雜的環境，整體經濟仍保持了穩步復甦的態勢。

財務業績

於回顧期內，本集團錄得銷售所得款項總額人民幣3,532.4百萬元（含增值稅），較去年同期減少15.0%。這一變化主要源於消費者在支出內容及方式上正經歷結構性轉變，加之部分門店正逐步從傳統百貨店業態向購物廣場業態轉型，導致特許專櫃銷售及直接銷售相應減少。同店銷售於回顧期內減少了13.5%。於回顧期內，本集團錄得經營利潤人民幣235.4百萬元，較去年同期人民幣257.6百萬元減少8.6%。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

OPERATIONAL REVIEW

Over the years, consumer spending behavior in the PRC has continued to evolve, ushering the consumer market into a new phase of demand reconstruction rather than a mere downgrade in consumption. Today's shoppers have shifted beyond material satisfaction to a multidimensional fulfillment of value, experience, and emotional resonance. Consumption patterns have also evolved from standardised product purchases to more personalised, diversified, and scenario-driven consumption, reflecting the changing preference of emerging consumer segments. As a result, new economic trends such as the silver economy, self-indulgence economy, and experience economy are gaining momentum.

In response to these trends, the Group is actively redefining its positioning by placing customers at the center of our strategy, transforming physical spaces from "transactional markets" to "lifestyle innovation destinations". The year 2025 marked a pivotal turning point in the Group's renovation and transformation efforts. The Group formulated customised renovation and upgrade plans for our stores to restructure business formats and gradually phase out traditional ones. The Group has driven the transformation of key stores, such as our Harbin Store, Nanning Store, Hefei Store, and Shenyang Store. Although this transition inevitably required a period of adjustment, resulting in a decline in concessionaire and direct sales, it has gradually increased foot traffic to our stores.

Transformation and renovation are a gradual process, hence the Group has designated 2026 as our "Year of Transformation Breakthrough". The Group will continue to deepen and comprehensively roll out the renovation of key transforming stores, with the aim of elevating customer experience and improving operational efficiency. At the same time, we are increasing our support for the Group's high-potential stores in their growth stage by refining targeted, sustainable enhancement plans for these stores. Our focus is on building resilient, scalable profitability across our portfolio.

運營回顧

近年來，中國消費者的支出行為持續變化，消費市場進入需求重構的全新階段，而非簡單的消費降級。當代購物者已經不再僅僅滿足於物質層面的需求，而是轉向追求價值、體驗和情感共鳴的多維滿足。消費模式亦隨之演變，從購買標準化的產品，轉變為更加個性化、多樣化以及由場景為導向的消費，這反映了新興消費群體偏好的轉變。因此，銀髮經濟、悅己經濟、體驗經濟等新興經濟趨勢正展現出強勁的發展勢頭。

面對這一趨勢，本集團在積極重塑自身定位的同時，以顧客為中心，將實體空間從「交易型市場」轉變為「生活方式創新目的地」。二零二五年為本集團的調改轉型轉折年。本集團針對門店制定了量身定制的調改升級計劃，重構業態，並逐步淘汰傳統業態。本集團推動重點門店的轉型調改，以哈爾濱店、南寧店、合肥店、瀋陽店為例。雖然這次轉型不可避免地需要一段適應期，並導致特許專櫃銷售及直接銷售下滑，但逐步帶動了門店的客流量。

轉型調改為一個循序漸進的過程，故本集團視二零二六年為本集團的「調改攻堅年」。本集團將持續深化並全面推進重點轉型門店的改造工作，旨在提升顧客體驗與運營效率。與此同時，我們正加大對本集團處在成長階段的高潛力門店的扶持力度，並完善具針對性且可持續發展的提升計劃。我們的核心目標是在資產組合中構建具備高韌性且可規模化的盈利能力。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

During the Review Period, the Group renewed the tenancy for Mianyang Parkson Fulin Store and Shanghai Parkson Newcore City Mall. Mianyang Parkson Fulin Store is positioned as a mid-to-high-end department store, which together with Mianyang Parkson Sanjiang Supermarket, Mianyang Parkson Guanhua Supermarket, Mianyang Parkson Metropolitan Store, and Mianyang Parkson Shangma Shopping Mall (which opened in October 2025), form a multi-store layout with differentiated market positioning within one city.

Meanwhile, Shanghai Parkson Newcore City Mall embraces a unique "City Outlets" concept and integrates a vibrant Korean-wave theme to create an immersive shopping landscape. Shanghai Parkson Newcore City Mall is located in the prime area of Changning District, Shanghai and is operated by our associate, Parkson Newcore.

The Group has also conducted a comprehensive review of its portfolio. During the Review Period, the Group closed Chengdu Fashion Parkson Store and Shanghai Xinzhuang Parkson Store due to strategic operational adjustments. The Group aims to provide consumers with a more comfortable, modern, and premium shopping environment and service experience.

OUTLOOK AND FUTURE PLANS

Looking ahead, the PRC's retail industry has entered a deep adjustment period characterised by increasing competition for existing market share and structural divergence. To navigate this landscape, our transformation strategy retains its customer-centric focus with clear priorities: deepen customer engagement, accelerate business format innovation, and optimise our portfolio. We firmly believe that this is a crucial step in meeting the expectations of today's discerning shoppers.

Amidst the current macroeconomic uncertainties, we will adopt a prudent approach to expansion while continuing to fine-tune our operations and maintain steady progress in our established core markets. We are confident in our ability to not only adapt to changes but also to seize the opportunities they represent.

於回顧期內，本集團重續了綿陽百盛富臨店及上海百盛優客城市廣場的租賃。綿陽百盛富臨店定位於中高端百貨店，連同綿陽百盛三江超市、綿陽百盛觀花超市、綿陽百盛大都會店及於二零二五年十月開業的綿陽百盛上馬購物廣場形成了一市多店及市場定位差異化的佈局。

而上海百盛優客城市廣場採用獨特的「城市奧特萊斯」概念，融入鮮明的韓流主題，營造出沉浸式的購物場景。上海百盛優客城市廣場位於上海長寧區的黃金地段，並通過我們的聯營公司百盛紐可爾運營。

本集團亦全面審視資產組合。於回顧期內，本集團因經營戰略調整，關閉了成都時尚百盛店及上海莘莊百盛店。本集團旨在為消費者提供更為舒適、現代且高水準的購物環境及服務體驗。

前景及未來計劃

展望未來，中國的零售業已步入了存量博弈與結構分化的深度調整期。為順應這一市場格局，我們的轉型戰略將秉持以顧客為中心的理念，並明確優先事項：深化客戶互動、加速業態創新、優化資產組合。我們堅信，這是滿足當今眼光日趨敏銳的購物者預期的關鍵舉措。

在當前宏觀經濟的不確定性背景下，我們將採取審慎擴張的態度，同時持續優化運營，並在現有的核心市場中保持穩健發展。我們有信心不僅能夠適應變革，更能把握蘊含的機遇。

GSP AND TOTAL OPERATING REVENUES

The Group recorded total GSP (inclusive of value-added tax) of RMB3,532.4 million or RMB3,206.8 million (net of value-added tax) in 1H2026, representing a decrease of 15.0% as compared to the same period of last year. The decline in GSP was primarily due to structural shifts in consumer spending content and patterns, coupled with the ongoing transition of certain stores from traditional department store formats to shopping mall formats. SSS decreased by 13.5% in 1H2026 as compared to the same period of last year.

TOTAL MERCHANDISE SALES

The following table sets out a breakdown of our total merchandise sales through different channels for the periods indicated:

銷售所得款項總額及經營收益總額

二零二六年上半年，本集團的銷售所得款項總額為人民幣3,532.4百萬元（含增值稅）或人民幣3,206.8百萬元（不含增值稅），與去年同期相比下降15.0%。銷售所得款項總額下降主要由於消費者在支出內容及方式上正經歷結構性轉變，加之部分門店正逐步從傳統百貨店業態向購物廣場業態轉型。於二零二六年上半年與去年同期相比，同店銷售下降13.5%。

Concessionaire sales which constituted 68.5% of the Group's total merchandise sales in 1H2026, decreased by 18.2% as compared to the same period of last year; while direct sales decreased by 10.9% as compared to the same period of last year. The Group's sales in 1H2026 decreased across both concessionaire sales and direct sales as compared to 1H2025.

MERCHANDISE GROSS MARGIN

The Group's merchandise gross margin, a combination of concessionaire commission rate and the direct sales margin, increased from 13.6% in 1H2025 to 13.9% in 1H2026.

TOTAL OPERATING REVENUES

Total operating revenues of the Group decreased by 11.4% to RMB1,738.5 million in 1H2026 as compared to RMB1,962.8 million in 1H2025. The decrease in total operating revenues was mainly due to overall decrease in direct sales, commissions from concessionaire sales, rental income and other income and offset by the increase in revenue from credit services.

The revenue from contracts with customers which constituted 59.7% of our total operating revenues in 1H2026, decreased by RMB142.7 million or 12.1% as compared to the same period of last year. The revenue from contracts with customers consists of sale of goods from direct sales, commissions from concessionaire sales and consultancy and management service fees.

OPERATING EXPENSES

Purchases of goods and changes in inventories

Purchases of goods and changes in inventories represent the cost of sales for direct sales. Cost of sales decreased by RMB84.8 million or 11.0% from RMB773.5 million in 1H2025 to RMB688.7 million in 1H2026. The decrease in purchases of goods and changes in inventories is consistent with the decrease in sale of goods from direct sales.

商品銷售毛利率

本集團的商品銷售毛利率，即綜合特許專櫃銷售佣金率及直接銷售的毛利率，由二零二五年上半年的13.6%上升至二零二六年上半年的13.9%。

經營收益總額

本集團的經營收益總額相較二零二五年上半年的人民幣1,962.8百萬元下降11.4%至二零二六年上半年的人民幣1,738.5百萬元。經營收益總額的減少主要由於直接銷售、特許專櫃銷售佣金、租金收入及其他收入整體減少，但被信貸服務收益的增長所抵銷。

來自客戶合約的收益佔本集團於二零二六年上半年經營收益總額的59.7%，較去年同期減少人民幣142.7百萬元或12.1%。來自客戶合約的收益包括自營銷售額、特許專櫃銷售佣金以及諮詢及管理服務費。

經營開支

購買貨物及存貨變動

購買貨物及存貨變動指直接銷售的銷售成本。銷售成本由二零二五年上半年的人民幣773.5百萬元減少人民幣84.8百萬元或11.0%至二零二六年上半年的人民幣688.7百萬元。購買貨物及存貨變動的減少與自營銷售額的減少相符。

Staff costs

Staff costs decreased by RMB39.1 million or 15.5% from RMB252.8 million in 1H2025 to RMB213.7 million in 1H2026. The decrease was mainly due to closure of underperforming stores in year 2025 and cost controlling in 1H2026. On a same store basis, staff costs decreased by 7.5% in 1H2026.

Staff costs as a percentage of GSP remain consistent as 6.7% in 1H2025 and 1H2026.

Depreciation and amortisation

Depreciation and amortisation decreased by 10.8% from RMB241.1 million in 1H2025 to RMB215.0 million in 1H2026. The decrease was mainly due to decrease in depreciation expenses on right-of-use assets of the property as a result of closure of underperforming stores in year 2025. In 1H2026, depreciation expenses on right-of-use assets for property of RMB131.7 million was recognised as compared to RMB151.7 million in 1H2025. On a same store basis, depreciation and amortisation decreased by 0.5% in 1H2026.

Depreciation and amortisation as a percentage of GSP increased from 6.4% in 1H2025 to 6.7% in 1H2026.

Rental expenses

Rental expenses decreased by RMB1.6 million or 4.3% from RMB37.5 million in 1H2025 to RMB35.9 million in 1H2026. The decrease was mainly due to closure of underperforming stores. On a same store basis, rental expenses increased by 2.3% in 1H2026.

Rental expenses as a percentage of GSP increased from 1.0% in 1H2025 to 1.1% in 1H2026.

員工成本

員工成本由二零二五年上半年的人民幣252.8百萬元減少人民幣39.1百萬元或15.5%至二零二六年上半年的人民幣213.7百萬元。該減少主要由於二零二五年關閉了業績不佳的門店及二零二六年上半年的成本控制。於二零二六年上半年，同店員工成本下降7.5%。

員工成本佔銷售所得款項總額的百分比於二零二五年上半年及二零二六年上半年保持一致為6.7%。

折舊及攤銷

折舊及攤銷由二零二五年上半年的人民幣241.1百萬元下降10.8%至二零二六年上半年的人民幣215.0百萬元。該減少主要由於二零二五年關閉業績不佳的門店使得物業使用權資產的折舊開支減少。於二零二六年上半年，確認物業使用權資產的折舊開支人民幣131.7百萬元，而二零二五年上半年為人民幣151.7百萬元。於二零二六年上半年，同店折舊及攤銷下降0.5%。

折舊及攤銷佔銷售所得款項總額的百分比由二零二五年上半年的6.4%上升至二零二六年上半年的6.7%。

租金開支

租金開支由二零二五年上半年的人民幣37.5百萬元減少人民幣1.6百萬元或4.3%至二零二六年上半年的人民幣35.9百萬元。該減少主要由於關閉業績不佳的門店。於二零二六年上半年，同店租金開支上升2.3%。

租金開支佔銷售所得款項總額的百分比由二零二五年上半年的1.0%上升至二零二六年上半年的1.1%。

Other operating expenses

Other operating expenses which consist primarily of (a) utilities cost; (b) marketing, promotional and selling expenses; (c) property management expenses; (d) general administrative expenses; and (e) city development and educational surcharge, decreased by 12.6% from RMB400.3 million in 1H2025 to RMB349.9 million in 1H2026. The decrease in other operating expenses was mainly due to closure of underperforming stores in year 2025. In addition, impairment allowance of RMB67.2 million was provided in 1H2026 where RMB81.5 million was provided in 1H2025. On a same store basis, other operating expenses decreased by 13.7% in 1H2026.

Other operating expenses as a percentage of GSP increased from 10.6% in 1H2025 to 10.9% in 1H2026.

PROFIT FROM OPERATIONS

The Group generated profit from operations of RMB235.4 million in 1H2026, a decrease of RMB22.2 million or 8.6% as compared to RMB257.6 million recorded in 1H2025.

Profit from operations as a percentage of GSP increased from 6.8% in 1H2025 to 7.3% in 1H2026.

FINANCE INCOME/(COSTS)

The Group incurred net finance costs of RMB194.5 million in 1H2026 which represented a decrease of RMB12.4 million or 6.0% compared to RMB206.9 million 1H2025. The decrease in finance costs mainly resulted from the decrease in interest expense on lease liabilities due to closure of underperforming stores in year 2025.

For interest expense on the lease liabilities, RMB134.9 million was recognised in finance cost in 1H2026 as compared to RMB147.5 million in 1H2025. For interest income on the net investments in subleases, RMB2.2 million was recognised in finance income in 1H2026 as compared to RMB5.4 million in 1H2025.

其他經營開支主要包括(a)水電費；(b)市場營銷、宣傳及銷售費用；(c)物業管理開支；(d)一般行政開支；及(e)城市建設及教育附加費，由二零二五年上半年的人民幣400.3百萬元下降12.6%至二零二六年上半年的人民幣349.9百萬元。其他經營開支的減少主要由於二零二五年關閉業績不佳的門店。此外，於二零二六年上半年計提了減值撥備人民幣67.2百萬元，而於二零二五年上半年為人民幣81.5百萬元。於二零二六年上半年，同店其他經營開支下降13.7%。

其他經營開支佔銷售所得款項總額的百分比由二零二五年上半年的10.6%上升至二零二六年上半年的10.9%。

經營利潤

於二零二六年上半年，本集團的經營利潤為人民幣235.4百萬元，較二零二五年上半年的人民幣257.6百萬元減少人民幣22.2百萬元或8.6%。

經營利潤佔銷售所得款項總額的百分比由二零二五年上半年的6.8%上升至二零二六年上半年的7.3%。

融資收入／(成本)

於二零二六年上半年，本集團的淨融資成本為人民幣194.5百萬元，較二零二五年上半年的人民幣206.9百萬元減少人民幣12.4百萬元或6.0%。融資成本的減少主要由於二零二五年關閉業績不佳的門店使得租賃負債的利息開支減少。

就租賃負債的利息開支而言，於二零二六年上半年，確認融資成本人民幣134.9百萬元，而二零二五年上半年則為人民幣147.5百萬元。就轉租賃投資淨額的利息收入而言，於二零二六年上半年確認融資收入人民幣2.2百萬元，而二零二五年上半年則為人民幣5.4百萬元。

Profit before tax is RMB51.0 million in 1H2026 and RMB60.2 million in 1H2025.

Profit before tax as a percentage of GSP remained consistent as 1.6% in 1H2025 and 1H2026.

INCOME TAX EXPENSE

Income tax expense decreased by RMB11.4 million or 29.1% from RMB39.2 million in 1H2025 to RMB27.8 million in 1H2026.

PROFIT FOR THE PERIOD

The Group recorded profit for the period of RMB23.2 million in 1H2026 and RMB20.9 million in 1H2025.

PROFIT ATTRIBUTABLE TO OWNERS OF THE COMPANY

The Group recorded profit attributable to owners of the Company amounted to RMB23.0 million in 1H2026 and RMB22.5 million recorded in 1H2025.

LIQUIDITY AND FINANCIAL RESOURCES

As at 30 June 2026, the Group had cash and bank balances of RMB1,309.9 million (31 December 2025: RMB1,457.2 million), time deposits of RMB71.3 million (31 December 2025: RMB46.6 million), financial assets at fair value through profit or loss of RMB65.0 million (31 December 2025: RMB77.2 million) and restricted cash of RMB59.1 million (31 December 2025: RMB60.7 million).

The Group's cash and cash equivalents are mainly denominated in Renminbi with the remaining denominated in United States dollars, Hong Kong dollars, Ringgit Malaysia and others.

Total debt to total assets ratio of the Group was 26.0% as at 30 June 2026 (31 December 2025: 26.4%).

CURRENT ASSETS AND NET ASSETS

The Group's current assets as at 30 June 2026 were RMB2,665.7 million. Net assets of the Group as at 30 June 2026 were RMB2,885.4 million.

INFORMATION ON THE FINANCIAL PRODUCTS

Financial assets at fair value through profit or loss refer to the non-principal preservation type wealth management products subscribed by the Group from licensed banks operate in the PRC. As at 30 June 2026, the fair value of these products was RMB65.0 million, accounting for approximately 0.6% of the total assets of the Group.

PLEDGE OF ASSETS

As at 30 June 2026, the Group has pledged trade receivables of RMB638.1 million, pledged buildings, investment properties and leasehold land with a net carrying amount of approximately RMB1,259.5 million, RMB492.2 million and RMB286.4 million, respectively, to secure the general bank loans. The Group has pledged unrealised receivables of RMB153.8 million which will be due within 48 months to secure the general interest-bearing bank loans. In addition, the Group has pledged deposits of RMB26.7 million held in designated bank accounts for performance guarantee.

Other than the aforesaid, no other assets are pledged to any bank or lender.

Pursuant to the Facility Agreement, Tan Sri Cheng Heng Jem (together with his wife, Puan Sri Chan Chau Ha alias Chan Chow Har, who is deemed to be interested in Tan Sri Cheng Heng Jem's interests in the Company) shall remain to be the single largest ultimate beneficial owner of the Company. In the event that Tan Sri Cheng Heng Jem (together with his wife, Puan Sri Chan Chau Ha alias Chan Chow Har) ceases to be the single largest ultimate beneficial owner of the Company, the facility available will be cancelled and the Company shall be obliged to pay all outstanding amounts immediately.
