Notes to the Unaudited Interim Financial Report

未經審核中期財務報告附註

1. Basis of presentation and accounting policies

This Interim Financial Report has been prepared in accordance with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, including compliance with Hong Kong Accounting Standard ("HKAS") 34, "Interim Financial Reporting" issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). The Interim Financial Report was authorised for issuance on 20 August 2026 and should be read in conjunction with the consolidated financial statements for the year ended 31 December 2025.

The Interim Financial Report has been prepared in accordance with the same accounting policies adopted in the consolidated financial statements for the year ended 31 December 2025, except for accounting policy changes that are expected to be reflected in the 2026 annual financial statements. Details of any changes in accounting policies are set out in note 2.

The preparation of the Interim Financial Report in conformity with HKAS 34 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

The Interim Financial Report contains condensed consolidated financial statements and selected explanatory notes. The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the consolidated financial statements for the year ended 31 December 2025. The condensed consolidated interim financial statements and notes thereon do not include all of the information required for a full set of financial statements prepared in accordance with HKFRS Accounting Standards.

The Interim Financial Report is unaudited, but has been reviewed by KPMG in accordance with Hong Kong Standard on Review Engagements 2410, "Review of interim financial information performed by the independent auditor of the entity" issued by the HKICPA. KPMG's independent review report to the Board of Directors is included on pages 31 to 32.

1. 呈列基準及會計政策

本中期財務報告乃根據香港聯合交易所有限公司證券上市規則之適用披露條文而編製，包括符合香港會計師公會（「香港會計師公會」）頒佈之香港會計準則（「香港會計準則」）第34號，「中期財務報告」。中期財務報告已於二零二六年八月二十日獲授權刊發，應與截至二零二五年十二月三十一日止年度之綜合財務報表一併閱讀。

中期財務報告乃根據截至二零二五年十二月三十一日止年度之綜合財務報表採納之相同會計政策編製，惟預期將於二零二六年年末財務報表反映之會計政策變動除外。會計政策之任何變動詳情載於附註2。

編製符合香港會計準則第34號之中期財務報告時，需要管理層作出會影響政策應用以及按本年截至報告日期為止之資產與負債及收入與開支報告數額的判斷、估計及假設。實際結果可能有別於該等估計。

中期財務報告載有簡明綜合財務報表及經選定之解釋附註。該等附註包括自截至二零二五年十二月三十一日止年度之綜合財務報表以來，對了解本集團財務狀況及表現變動之重要事件及交易說明。簡明綜合中期財務報表及其中之附註並未載有根據香港財務報告準則會計準則編製之完整財務報表所需之一切資料。

中期財務報告未經審核，惟已經畢馬威會計師事務所根據香港會計師公會頒佈之香港審閱委聘準則第2410號，「由實體之獨立核數師執行中期財務資料審閱」進行審閱。畢馬威會計師事務所致董事會之獨立審閱報告載於第31至32頁。

1. Basis of presentation and accounting policies (Continued)

The financial information relating to the financial year ended 31 December 2025 that is included in the Interim Financial Report as comparative information does not constitute the Company's statutory annual consolidated financial statements for that financial year but is derived from those financial statements. Statutory annual consolidated financial statements for the year ended 31 December 2025 are available at the Company's Hong Kong registered office. The Company's auditor has reported on these financial statements on 19 March 2026. The auditor's report was unqualified and did not include a reference to any matters to which the auditor drew attention by way of emphasis without qualifying their report.

2. Changes in accounting policies

The HKICPA has issued certain amendments to HKFRS Accounting Standards that are first effective for the current accounting period of the Group. None of the developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented in the Interim Financial Report. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

3. Revenue and segment information

Segment information has been prepared in a manner consistent with the information used by the Group's most senior executive management for the purposes of assessing segment performance and allocating resources between segments. The Group's most senior executive management has been identified as the Board. In this regard, the Group's senior executive management monitors the results attributable to each reportable segment on the following bases:

Revenue and expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those segments.

The measure used for reporting segment profit is the segment results, including items specifically attributed to individual segments, such as directors' and auditors' remuneration and other administration costs within the segment.

中期財務報告所載與截至二零二五年十二月三十一日止財政年度有關及作為比較資料之財務資料並不構成本公司該財政年度之法定年度綜合財務報表，惟乃摘錄自該等財務報表。截至二零二五年十二月三十一日止年度之法定年度綜合財務報表於本公司香港註冊辦事處可供索閱。本公司核數師已於二零二六年三月十九日就該等財務報表作出報告。該核數師報告無保留意見，且並無包括核數師在不對其報告作出保留意見的情況下以強調方式提請須予注意的任何事宜。

2. 會計政策變動

Business and Financial Review

Due to the increasing demand in all segments, particularly in consumer electronics and cloud computing resulting from the AI craze and the proliferation of electronic devices, the Group has recorded a considerable revenue this period. The Group's unaudited consolidated revenue for the six months ended 30 June 2026 amounted to approximately HK\$52,610,461,000 (six months ended 30 June 2025: approximately HK\$45,515,043,000). Revenue from the consumer electronics segment for the six months ended 30 June 2026 amounted to approximately HK\$21,545,348,000 (six months ended 30 June 2025: approximately HK\$17,191,203,000). Revenue from the enterprise systems segment for the six months ended 30 June 2026 was approximately HK\$28,235,242,000 (six months ended 30 June 2025: approximately HK\$25,703,997,000) and revenue from the cloud computing segment for the six months ended 30 June 2026 amounted to approximately HK\$2,829,871,000 (six months ended 30 June 2025: approximately HK\$2,619,843,000).

Gross profit for the six months ended 30 June 2026 amounted to approximately HK\$2,613,707,000 (six months ended 30 June 2025: approximately HK\$2,163,608,000). Gross margin for the six months ended 30 June 2026 was 4.97% (six months ended 30 June 2025: 4.75%). Operating profit for the six months ended 30 June 2026 amounted to approximately HK\$1,270,889,000 (six months ended 30 June 2025: approximately HK\$928,104,000). Unaudited consolidated net profit attributable to equity shareholders for the six months ended 30 June 2026 amounted to approximately HK\$914,906,000 (six months ended 30 June 2025: approximately HK\$610,474,000).

The basic earnings per share for the six months ended 30 June 2026 amounted to approximately HK65.95 cents (six months ended 30 June 2025: approximately HK44.06 cents) per share.

No important events affecting the Group have been occurred since 30 June 2026 and up to the date of the Interim Financial Report.

Prospects

The Group will continue to execute strategies to increase market share as well as the range of products and services offered. This will enable the Group to continue to focus on product range and growth from all business segments. Our extensive portfolio of products and network will enable us to continue to drive growth for the Group.

Liquidity and Financial Resources

As at 30 June 2026, the Group had total cash balances and bank deposits of approximately HK\$4,260,026,000 (31 December 2025: approximately HK\$4,910,098,000). Total borrowings amounted to approximately HK\$13,175,973,000 (31 December 2025: approximately HK\$8,795,163,000). Both the cash balances and bank deposits and borrowings were mainly denominated in Hong Kong dollars, Renminbi, United States dollars, Singapore dollars, Thai baht, Indonesian rupiah and Philippine peso.

As at 30 June 2026, the net debt to total assets ratio, calculated as total borrowings less cash and bank balances divided by total assets, was 0.18 (31 December 2025: 0.09).

As at 30 June 2026, the Group had total current assets of approximately HK\$48,039,865,000 (31 December 2025: approximately HK\$40,553,197,000) and total current liabilities of approximately HK\$38,014,308,000 (31 December 2025: approximately HK\$30,910,570,000). The current ratio of the Group as at 30 June 2026, calculated as total current assets divided by total current liabilities, was approximately 1.26 times (31 December 2025: approximately 1.31 times).

Foreign Exchange Risk Management

The Group is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to United States dollars, Renminbi, Singapore dollars, Thai baht, Indonesian rupiah, Malaysian ringgit and Philippine peso. The Group will enter into foreign currency forward contracts to manage and reduce the risk involved in the net position in each foreign currency, if necessary.

The primary duties of the Remuneration Committee regarding the remuneration of directors and senior management include making recommendations on remuneration policy and structure, reviewing and approving the management’s remuneration proposals, making recommendations on remuneration packages of all directors and senior management, reviewing and approving termination compensation, dismissal or removal compensation arrangements, and ensuring that no Director or any of his associates is involved in deciding his own remuneration, etc.

Nomination Committee

The Company established a Nomination Committee on 22 March 2012 consisting of three Independent Non-executive Directors and the chairman of the board with written terms of reference in compliance with Appendix C1 to the Listing Rules. The primary duties of the Nomination Committee are to review the structure, size and composition of the board annually and make recommendations on any proposed changes to the board to complement the issuer's corporate strategy, identify individuals suitably qualified to become board members, assess the independence of Independent Non-executive Directors, and make recommendations to the board on the appointment or re-appointment of Directors and succession planning for Directors.

Constitutional Documents

On 21 April 2026, the Board approved certain amendments to the Articles of Association of the Company in order to, among other things, (i) expressly allow the Company to hold and resell its shares as treasury shares in accordance with the applicable laws of the Cayman Islands and the Listing Rules; (ii) align with the Listing Rules amendments in relation to the expanded paperless listing regime (including the uncertificated securities market) and the promotion of paperless corporate communications; (iii) reflect certain updates in relation to the Listing Rules and the applicable laws of the Cayman Islands; and (iv) make other consequential and housekeeping improvements. A special resolution for the adoption of the Amended and Restated Memorandum and Articles of Association ("New M&A") was passed by the Shareholders at the annual general meeting of the Company held on 26 May 2026. The New M&A is available on the respective websites of the Stock Exchange and the Company.
