截至二零二六年六月三十日止六個月，本集團的整體收益約為184,400,000港元，較去年同期增加約17.1%。本集團的收益增加主要是由於來自部分現有客戶的銷售訂單增加。

The Group's overall revenue for the six months ended 30 June 2026 was approximately HK\$184.4 million, representing an increase of approximately 17.1% over the last corresponding period. The increase in the Group's revenue was mainly due to an increase in sales orders from part of the existing customers.

截至二零二六年六月三十日止六個月，本集團的整體毛利率下降至6.1%（二零二五年一月至六月：11.3%），截至二零二六年六月三十日止六個月由盈轉虧乃主要由於本集團向一名主要客戶提供大幅度銷售折扣。

The Group's overall gross profit margin decreased to 6.1% for the six months ended 30 June 2026 (January to June 2025: 11.3%) and the turnaround from profit to loss for the six months ended 30 June 2026 were mainly attributable to a substantial sale discount offered to a major customer by the Group.

銷售及營銷開支

銷售及營銷開支主要指截至二零二六年六月三十日止六個月產生的僱員工資及酬酢費用。銷售及營銷開支與去年同期相比維持穩定。

SELLING AND MARKETING EXPENSES

Selling and marketing expenses mainly represented employees' wages and entertainment expenses incurred during the six months ended 30 June 2026. Selling and marketing expenses remained stable when comparing to corresponding period for the last year.

行政開支

行政開支主要指管理、財務及行政人員的僱員福利開支、應酬開支、辦公室物業租賃開支、折舊及出差開支。截至二零二六年六月三十日止六個月，行政開支較二零二五年同期增加約13.3%至約15,200,000港元，主要是由於僱員福利開支、酬酢開支及其他行政開支增加所致。

ADMINISTRATIVE EXPENSES

Administrative expenses mainly represented employee benefit expenses for our management, finance and administrative personnel, entertainment expenses, rental expenses for our office premises, depreciation and travelling expenses. Administrative expenses increased by approximately 13.3% to approximately HK\$15.2 million which was mainly due to an increase in employees benefit expenses, entertainment expenses and other administrative expenses for the six months ended 30 June 2026 compared to the corresponding period in 2025.

MANAGEMENT DISCUSSION AND ANALYSIS

其他收益／（虧損）－淨額

其他收益／（虧損）－淨額主要指外匯虧損。

截至二零二六年六月三十日止六個月，本集團向中國供應商的大多數採購均以人民幣結算。由於人民幣的強勁表現，本集團確認其他收益－淨額約200,000港元（二零二五年一月至六月其他虧損－淨額：約700,000港元）。

財務收入及融資成本

財務收入減少約60.7%至約300,000港元，主要由於截至二零二六年六月三十日止六個月定期存款利率下降。

融資成本減少約87.2%至約100,000港元，主要由於截至二零二六年六月三十日止六個月償還銀行借貸。

所得稅抵免／（開支）

所得稅開支主要指根據香港及中國相關法律及法規按適用稅率計算的已付或應付即期所得稅。截至二零二六年六月三十日止六個月，所得稅抵免為約800,000港元（二零二五年一月至六月：約1,200,000港元）。

存貨

存貨結餘由二零二五年十二月三十一日約93,700,000港元減至二零二六年六月三十日約82,800,000港元，主要由於在二零二五年第四季度發送的若干在途貨品於截至二零二六年六月三十日止六個月期間完成交付。由於本集團對生產及銷售訂單進行有效的存貨管理，存貨週轉日數維持穩定並由截至二零二五年十二月三十一日止年度的95日輕微減少至截至二零二六年六月三十日止六個月的93日。

應收賬款

應收賬款結餘由二零二五年十二月三十一日約56,600,000港元減少至二零二六年六月三十日約32,500,000港元，主要由於本集團持續加大應收款的收款力度，從而令客戶付款速度加快。

OTHER GAINS/(LOSSES) – NET

Other gains/(losses) – net mainly represented the foreign exchange losses.

During the six months ended 30 June 2026, majority of the Group's purchase from suppliers in the PRC were settled in RMB. The Group recognised other gains – net of approximately HK\$0.2 million as a result of the strong performance of RMB (January to June 2025 other losses – net: approximately HK\$0.7 million).

FINANCE INCOME AND COSTS

Finance income decreased by approximately 60.7% to approximately HK\$0.3 million primarily due to the decrease in fixed deposit rate during the six months ended 30 June 2026.

Finance costs decreased by approximately 87.2% to approximately HK\$0.1 million primarily due to the repayment of bank borrowing during the six months ended 30 June 2026.

INCOME TAX CREDIT/(EXPENSES)

Income tax expense mainly represented amounts of current income tax paid or payable at the applicable tax rates in accordance with the relevant laws and regulations in Hong Kong and the PRC. During the six months ended 30 June 2026, income tax credit was approximately HK\$0.8 million (January to June 2025: approximately HK\$1.2 million).

INVENTORIES

Inventories balance decreased from approximately HK\$93.7 million as at 31 December 2025 to approximately HK\$82.8 million as at 30 June 2026 mainly due to the completion of delivery for certain goods in transit that were dispatched in the final quarter of 2025 during the six months ended 30 June 2026. The inventory turnover days remained stable and slightly decreased to 93 days for the six months ended 30 June 2026 from 95 days for the year ended 31 December 2025 as a result of effective inventory management of production and sales order.

TRADE RECEIVABLE

Trade receivable balance decreased from approximately HK\$56.6 million as at 31 December 2025 to approximately HK\$32.5 million as at 30 June 2026 which was primarily attributable to the faster payment from the customers as a result of the Group's continuous and enhanced efforts in receivable collection.

我們一般向服裝供應鏈服務業務客戶提供30至90日的信貸期，彼等一般須透過銀行轉賬或支票向我們清償貿易結餘。截至二零二六年六月三十日止六個月，應收賬款週轉日數減少至44日（二零二五年十二月三十一日：73日）。

應付賬款

應付賬款結餘由二零二五年十二月三十一日約94,000,000港元減少至二零二六年六月三十日約67,700,000港元，主要由於截至二零二六年六月三十日止六個月加快結清若干主要供應商之未結餘額。

我們在清償貨款上一般享有最多90日的信貸期。截至二零二六年六月三十日止六個月，應付賬款的週轉日數減少至83日，主要由於加快向供應商結賬（二零二五年十二月三十一日：105日）。

銀行借貸

本集團於二零二六年六月三十日有銀行借貸合共約15,900,000港元（二零二五年十二月三十一日：4,700,000港元）。所有銀行借貸均由香港銀行提供，按浮動利率計息。於二零二六年六月三十日，約12,100,000港元須於一年內償還，約700,000港元須於一至兩年內償還，約2,100,000港元須於兩至五年內償還，約1,000,000港元須於五年後償還，且所有款項均須遵守按要求償還條款。所有銀行借貸的賬面值以港元計值。於二零二六年六月三十日，本集團並無使用任何財務工具作對沖用途，亦無任何以現有借貸及／或其他對沖工具對沖的外幣淨額投資。

流動資金及財務資源

截至二零二六年六月三十日止六個月，本集團維持健全的流動資金狀況，以內部資源及銀行借貸提供營運資金。於二零二六年六月三十日，現金及現金等價物約為57,300,000港元，其中分別約15,900,000港元以港元計值，約36,000,000港元以人民幣（「人民幣」）計值，另約5,400,000港元以美元（「美元」）計值。於二零二六年六月三十日，本集團的流動比率約為1.8（二零二五年十二月三十一日：1.7）。於二零二六年六月三十日，本集團的現金淨額狀況相對強勁。本集團擁有充足及隨時可用的財務資源用作一般營運資金需要及可見將來的資本開支。

We generally grant customers of our Apparel Supply Chain Servicing Business a credit period of 30 to 90 days and they are generally required to settle their trade balances with us by bank transfer or by cheque. Trade receivable turnover days decreased to 44 days for the six months ended 30 June 2026 (31 December 2025: 73 days).

TRADE PAYABLE

Trade payable balance decreased from approximately HK\$94.0 million as at 31 December 2025 to approximately HK\$67.7 million as at 30 June 2026 primarily because of the accelerated settlement of outstanding balances to certain major suppliers for the six months ended 30 June 2026.

We generally enjoy a credit term of up to 90 days to settle payment. The trade payable turnover days decreased to 83 days for the six months ended 30 June 2026 which was primarily attributable to the faster of settlement to the suppliers (31 December 2025: 105 days).

BANK BORROWINGS

The Group had bank borrowings in the sum of approximately HK\$15.9 million as at 30 June 2026 (31 December 2025: HK\$4.7 million). All bank borrowings were made from banks in Hong Kong at floating interest rates. As at 30 June 2026, approximately HK\$12.1 million was repayable within one year, approximately HK\$0.7 million was repayable between one to two years, approximately HK\$2.1 million was repayable between two to five years, approximately HK\$1.0 million was repayable over five years, and all subject to repayable on demand clauses. All the carrying amounts of bank borrowings were denominated in HK\$. No financial instruments were used for hedging purposes, nor were there any foreign currency net investments hedged by current borrowings and/or other hedging instruments as at 30 June 2026.

LIQUIDITY AND FINANCIAL RESOURCES

During the six months ended 30 June 2026, the Group maintained a healthy liquidity position, with working capital financed by both internal resources and bank borrowings. As at 30 June 2026, cash and cash equivalents amounted to approximately HK\$57.3 million, of which approximately HK\$15.9 million was denominated in HK\$, approximately HK\$36.0 million in Renminbi (“RMB”) and approximately HK\$5.4 million in United States dollar (“USD”). As at 30 June 2026, the current ratio of the Group was approximately 1.8 (31 December 2025: 1.7). The Group was in a relatively strong net cash position as at 30 June 2026. The Group has sufficient and readily available financial resources for general working capital requirement and foreseeable capital expenditure.

MANAGEMENT DISCUSSION AND ANALYSIS

財政政策

本集團在執行財政政策上採取審慎的財務管理策略，因而於整段回顧期間內維持健全的流動資金狀況。本集團不斷評估其客戶的信貸狀況及財務狀況，務求降低信貸風險。為管理流動資金風險，董事會密切監察本集團的流動資金狀況，確保本集團擁有充足財務資源以及及時應付資金需要及承擔。

外匯風險

外匯風險源自海外業務的日後商業交易、已確認資產及負債以及淨額投資。

當日後商業交易或已確認資產或負債以實體功能貨幣以外的貨幣計值時，外匯風險即產生。對於以人民幣或美元作為功能貨幣的集團公司而言，其外匯風險主要來自以外幣計值的金額換算。本集團密切關注匯率變動以控制外匯風險。

本集團在中國有投資，其資產淨值面臨外幣換算風險。本集團在中國投資的資產淨值所產生外幣風險，可以通過在中國境外派付的股息管理。

截至二零二六年六月三十日止六個月，本集團並無利用任何財務工具對沖外幣風險。

資本結構

截至二零二六年六月三十日止六個月，本公司的資本結構並無任何重大變動。本公司的資本包括普通股及其他儲備。

資本承擔

於二零二六年六月三十日，本集團並無任何重大資本承擔（二零二五年十二月三十一日：無）。

TREASURY POLICIES

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the period under review. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the sufficient financial resources are available in order to meet its funding requirements and commitment timely.

FOREIGN EXCHANGE EXPOSURE

Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations.

Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. For group companies with RMB or US dollars as their functional currency, foreign exchange risk arises primarily from translation of amounts denominated in foreign currencies. The Group manages its foreign exchange risk by closely monitoring the movement of the foreign currency rates.

The Group has investments in the PRC, whose net assets are exposed to foreign currency translation risk. Currency exposure arising from the net assets of the Group's investments in the PRC can be managed through dividends paid outside the PRC.

During the six months ended 30 June 2026, the Group did not commit to any financial instruments to hedge its exposure to foreign currency risk.

CAPITAL STRUCTURE

There has been no material change in the capital structure of the Company during the six months ended 30 June 2026. The capital of the Company comprises ordinary shares and other reserves.

CAPITAL COMMITMENTS

As at 30 June 2026, the Group did not have any significant capital commitments (31 December 2025: Nil).

MANAGEMENT DISCUSSION AND ANALYSIS

僱員資料

於二零二六年六月三十日，本集團共有144名僱員，包括執行董事。總員工成本（包括董事酬金）約為15,900,000港元，而去年同期則約為14,600,000港元。酬金乃參考市場常規以及個別僱員的表現、資歷及經驗釐定。

除基本薪金外，亦可視乎本集團的業績以及個人表現獲發花紅。其他員工福利包括香港強制性公積金退休福利計劃供款，以及根據中國及柬埔寨法規及規例以及現行監管規定為本集團聘用的僱員提供退休金、醫療保險、失業保險及其他相關保險。

本集團僱員的薪金及福利均處於具競爭力的水平，僱員的待遇均在本集團就薪酬及花紅設定的整體框架內按表現釐定，而該框架每年進行檢討。本集團亦設有一項由本公司於二零二二年五月二十六日採納的購股權計劃（「**購股權計劃**」），據此，董事及本集團僱員可獲授購股權以認購股份。

購股權計劃

本公司於二零二二年五月二十六日採納購股權計劃。購股權計劃旨在讓本公司向獲選人士授出購股權以激勵或酬謝彼等對本集團目前或日後作出貢獻。

在購股權計劃的條款規限下，董事會可按其全權酌情決定授出或邀請屬於以下任何組別的任何人士接納可認購股份的購股權：

- (a) 本公司或任何附屬公司旗下全職或兼職的任何僱員、供應商／服務提供商、客戶、合作夥伴或合資夥伴，包括本集團不論是否屬執行及獨立與否的任何董事，或
- (b) 任何對本集團已經或可能作出貢獻的人士。

INFORMATION ON EMPLOYEES

As at 30 June 2026, the Group had a total of 144 employees, including the executive Directors. Total staff costs (including Directors' emoluments) were approximately HK\$15.9 million, as compared to approximately HK\$14.6 million for the last corresponding period. Remuneration is determined with reference to market norms as well as individual employees' performance, qualification and experience.

On top of basic salaries, bonuses may be paid by reference to the Group's performance as well as individual's performance. Other staff benefits include contributions to Mandatory Provident Fund retirement benefits scheme in Hong Kong and the provision of pension funds, medical insurance, unemployment insurance and other relevant insurance for employees who are employed by our Group pursuant to the PRC and Cambodia rules and regulations and the prevailing regulatory requirements.

The salaries and benefits of the Group's employees are kept at a competitive level and employees are rewarded on a performance-related basis within the general framework of the Group's salary and bonus system, which is reviewed annually. The Group also operates a share option scheme adopted by the Company on 26 May 2022 ("**Share Option Scheme**") where options to subscribe for shares may be granted to the Directors and employees of the Group.

SHARE OPTION SCHEME

The Company has adopted Share Option Scheme on 26 May 2022. The purpose of the Share Option Scheme is to enable the Company to grant options to selected persons as incentives or rewards for their contribution or future contribution to the Group.

Subject to the terms of the Share Option Scheme, the Board may, at their absolute discretion, grant or invite any person belonging to any of the following classes to take up options to subscribe for shares:

1. 一般資料

2. 編製基準

1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands on 28 September 2011 as an exempted company with limited liability under the Companies Law (2010 Revision) of the Cayman Islands. The address of its registered office is at the office of Vista (Cayman) Limited, P.O. Box 31119 Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands. The immediate and ultimate holding company of the Group is Sky Halo Holdings Limited (“Sky Halo”).

The Group is principally engaged in the apparel supply chain servicing business which includes offering a wide range of woven wear, cut-and-sewn knitwear and sweater knitwear products to a number of owners or agents of global reputable brands (the “Apparel Supply Chain Servicing Business”).

2. BASIS OF PREPARATION

The condensed consolidated interim financial statements for the six months ended 30 June 2026 have been prepared in accordance with Hong Kong Accounting Standard 34 “Interim financial reporting”. The condensed consolidated interim financial statements should be read in conjunction with the annual financial statements for the year ended 31 December 2025, which have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”).

3. ACCOUNTING POLICIES

Except as described below, the accounting policies applied are consistent with those of the annual financial statements for the year ended 31 December 2025, as described in those annual financial statements.
