BUSINESS REVIEW AND PROSPECTS

In the first half of 2026, the global economy achieved a resilient recovery with divergent growth patterns, and supply-demand competition in the international crude oil market intensified. Sustained growth in global crude oil production and adjustments in global demand structure, coupled with rising international geopolitical risks, kept crude oil prices under overall pressure amid ample market supply. During the period, the escalation of US-Iran conflicts and shipping disruptions in the Strait of Hormuz brought substantial geopolitical risk premiums, driving a sharp short-term surge in international crude oil prices and greatly amplifying market volatility. As the situation gradually stabilized, oil prices returned to a reasonable range, and the market achieved orderly recovery amid fluctuations. Faced with a complex and volatile macro market environment, the Group continued to advance digital and intelligent management upgrading, empower efficient oilfield development through technological innovation, further consolidate its cost advantages, and effectively hedge against market fluctuation risks, maintaining a stable and improving overall operating performance.

Our project in the PRC maintained a relatively stable production for the six months ended June 30, 2026. As at June 30, 2026, the Group held a 100% foreign contractors' interest in Daan PSC in the PRC. The Group's total gross production of crude oil for the six months ended June 30, 2026 decreased by 4.9% from approximately 1.52 million barrels for the six months ended June 30, 2025 to approximately 1.45 million barrels. Total net production of crude oil allocated to the Group decreased by 7.8% from approximately 0.73 million barrels for the six months ended June 30, 2025 to approximately 0.67 million barrels. The Group's daily gross production of crude oil for the six months

業務回顧及前景

二零二六年上半年，全球經濟韌性復甦、格局分化，國際原油市場供需博弈加劇。世界原油持續增產、全球需求結構調整，疊加國際地緣風險加劇，油價整體呈寬鬆承壓格局。期間美伊衝突升級、霍爾木茲海峽航運受阻，帶來強力地緣風險溢價，推動國際油價短期大幅飆升，震盪幅度顯著放大，後續隨局勢平復逐步回歸合理區間，市場在波動中有序修復。面對複雜多變的宏觀市場環境，本集團持續推進管理數智化升級，以科技創新賦能油田高效開發，持續夯實成本優勢，有效對沖市場波動風險，整體經營態勢穩中向好。

截至二零二六年六月三十日止六個月，我們位於中國的項目依然保持著相對穩定的產量水平。截至二零二六年六月三十日，本集團在中國持有大安產品分成合同100%的外國合同者權益。截至二零二六年六月三十日止六個月，本集團的原油總產量比截至二零二五年六月三十日止六個月約1.52百萬桶減少4.9%至約1.45百萬桶。歸屬於本集團的原油淨產量份額較之二零二五年六月三十日止六個月約0.73百萬桶減少7.8%至約0.67百萬桶。與截至二零二五年六月三十日止六個月相比，本集團截至二零二六年六月三十日止六個月日

ended June 30, 2026 decreased by 4.9% to 7,997 barrels per day ("BOPD"), and the daily net production of crude oil allocated to the Group decreased by 7.8% to 3,717 BOPD as compared to the six months ended June 30, 2025. The decrease in the net production of crude oil was mainly driven by the decrease in the gross production and the allocation percentage to the Company. The average realized oil price of the Group increased by 16.8% from US\$69.63 per barrel for the six months ended June 30, 2025 to US\$81.34 per barrel for the six months ended June 30, 2026. During the six months ended June 30, 2026, the lifting costs for Daan Oilfield increased by US\$2.81/barrel, or 16.2%, from US\$17.34/barrel for the six months ended June 30, 2025 to US\$20.15/barrel. The Group didn't drill any new well in the Daan Oilfield in the first half of 2026.

The revenue of the Group, which was derived entirely from the PRC, increased by 4.7% to RMB382.8 million compared to the same period for last year. During the six months ended June 30, 2026, net loss for the period was RMB144.5 million, as compared to a net loss of RMB148.0 million for the six months ended June 30, 2025, the net loss decreased by RMB3.5 million and the basic loss per share was RMB0.04 for the six months ended June 30, 2026.

The EBITDA of the Group for the six months ended June 30, 2026 decreased by RMB11.1 million to RMB202.9 million from RMB214.0 million for the six months ended June 30, 2025 and the adjusted EBITDA decreased by RMB11.3 million to RMB201.9 million.

均原油總產量下降4.9%至7,997桶，日均原油淨產量下降7.8%至3,717桶。原油淨產量的減少主要是由總產量及本公司分成比例的下降所致。本集團截至二零二六年六月三十日止六個月平均實現油價比截至二零二五年六月三十日止六個月的69.63美元／桶增加16.8%至81.34美元／桶。大安油田的直接採油成本從截至二零二五年六月三十日止六個月的17.34美元／桶增加2.81美元／桶，或者16.2%至二零二六年六月三十日止六個月20.15美元／桶。本集團二零二六年上半年在大安油田未實施鑽井。

本集團的收入與同期對比增加4.7%至人民幣3.828億元，全部來自於中國。截至二零二六年六月三十日止六個月，本集團共錄得淨虧損人民幣1.445億元，比截至二零二五年六月三十日止六個月淨虧損人民幣1.480億元，淨虧損減少人民幣0.035億元，相關的基本每股虧損為人民幣0.04元。

本集團的EBITDA由截至二零二五年六月三十日止六個月的人民幣2.140億元減少人民幣0.111億元至二零二六年六月三十日止六個月人民幣2.029億元，經調整EBITDA減少人民幣0.113億元至人民幣2.019億元。

In accordance with the supplemental agreement to the PSC relating to the Daan Oilfield (“Supplemental PSC”) signed between the Group and CNPC on June 4, 2020, the Group shall invest in and drill a minimum of 268 wells within three years after the effective date of the Supplemental PSC. By the end of 2022, the Group’s 268 new drilling wells have all been completed. On February 24, 2023, CNPC approval confirmed that the extension of the operating period of Daan PSC to February 29, 2028 became effective.

根據二零二零年六月四日，本集團與中石油集團簽訂的大安石油合同補充協議（「補充協議」），本集團需要在補充協議生效後三年內投資並鑽探至少268口新井。截至二零二二年末，本集團新鑽井268口已全部完成鑽探工作。於二零二三年二月二十四日，中石油集團批准大安產品分成合同的運營期至二零二八年二月二十九日的延期已經生效。

OUTLOOK FOR 2026

Looking ahead to the second half of 2026, despite generally loose market supply-demand conditions and pressured fundamentals, recurrent uncertainties persist in the global geopolitical situation. As domestic policies to support stable economic growth continue to shore up the economy, market operations will be dominated by supply and demand fundamentals, and international crude oil prices are expected to fluctuate within a broad range. The Group will dynamically optimize crude oil capacity deployment and production schedules, effectively mitigate operational risks arising from significant oil price volatility, and ensure stable and orderly production and operations.

二零二六年展望

展望二零二六年下半年，儘管市場供需整體偏寬鬆、基本面承壓，但全球地緣局勢依舊存在反覆變數，國內穩增長政策持續落地托底經濟，市場運行重心回歸供需主導，國際原油價格預計將在寬幅震盪中運行。本集團將動態優化原油產能投放與生產節奏，有效防範化解油價劇烈波動帶來的經營風險，保障整體生產經營平穩有序開展。

REVIEW OF FINANCIAL RESULTS

Revenue

The Group's revenue is generated from sales of oil product and provision of services.

The Group's revenue generated from sales of oil product was contributed entirely by our oilfield in the PRC, which increased by RMB17.1 million, or 4.7%, from RMB365.7 million for the six months ended June 30, 2025 to RMB382.8 million for the six months ended June 30, 2026. The average realized crude oil price of the Group increased by US\$11.71 per barrel, or 16.8% to US\$81.34 per barrel during the six months ended June 30, 2026 from US\$69.63 per barrel for the six months ended June 30, 2025. Net crude oil sales volume decreased by 50 thousand barrels, or 6.8%, from 0.73 million barrels for the six months ended June 30, 2025 to 0.68 million barrels for the six months ended June 30, 2026. The increase of the Group's revenue was primarily due to the increase in oil prices, which was partially offset by a decrease in net sales volume.

Operating expenses

Depreciation, depletion and amortization

The Group's depreciation, depletion and amortization decreased by RMB24.5 million, or 15.4%, from RMB158.8 million for the six months ended June 30, 2025 to RMB134.3 million for the six months ended June 30, 2026. The decrease in depreciation, depletion and amortization was mainly due to: (i) the decrease of net book value at the beginning of the period caused by the recognition of impairment losses on assets in 2025; and (ii) the decrease in net production of crude oil.

經營業績回顧

收入

本集團的收入主要來自於銷售石油產品及提供服務。

本集團石油產品銷售產生的收入全部來自中國油田，由截至二零二五年六月三十日止六個月期間的人民幣3.657億元增加人民幣1,710萬元或4.7%，至截至二零二六年六月三十日止六個月期間的人民幣3.828億元。本集團平均實現油價由截至二零二五年六月三十日止六個月的69.63美元／桶上漲至二零二六年六月三十日止六個月的81.34美元／桶，增加了11.71美元／桶，或16.8%。原油淨銷量由截至二零二五年六月三十日止六個月的73萬桶減少至二零二六年六月三十日止六個月的68萬桶，減少了5萬桶，或6.8%。本集團收入增加主要是由於油價的上漲，但被淨銷量下降所部分抵銷。

經營支出

折舊，折耗及攤銷

本集團的折舊，折耗及攤銷較截至二零二五年六月三十日止六個月期間的人民幣1.588億元減少人民幣2,450萬元或15.4%，至截至二零二六年六月三十日止六個月期間的人民幣1.343億元。折舊，折耗及攤銷的減少主要是由於：(i) 二零二五年確認資產減值損失導致期初資產賬面淨值減少；及(ii) 原油淨產量減少。

Taxes other than income taxes

The Group's taxes other than income taxes increased by RMB21.3 million, or 295.8%, from RMB7.2 million for the six months ended June 30, 2025 to RMB28.5 million for the six months ended June 30, 2026. The following table summarizes the Group's taxes other than income taxes for the six months ended June 30, 2026 and 2025, respectively:

With effect from January 1, 2015, the threshold price for the special oil gain levy was revised from US\$55 per barrel to US\$65 per barrel. Special oil gain levy of RMB27.3 million was incurred due to the crude oil price having exceeded US\$65 per barrel for the six months ended June 30, 2026. During the six months ended June 30, 2025, the special oil gain levy was RMB6.0 million.

自二零一五年一月一日起，石油特別收益金起徵點由55美元／桶調整為65美元／桶。截至二零二六年六月三十日止六個月期間，由於原油價格超過65美元／桶而產生的石油特別收益金為人民幣2,730萬元。截至二零二五年六月三十日止六個月期間，產生的石油特別收益金為人民幣600萬元。

Employee benefit expenses

During the six months ended June 30, 2026 and 2025, the Group's employee benefit expenses were RMB46.3 million in both periods. There has been no change for the employee compensation costs for same period during the two years.

Purchases, services and other direct costs

The Group's purchases, services and other direct costs increased by RMB7.1 million, or 7.1%, from RMB100.6 million for the six months ended June 30, 2025 to RMB107.7 million for the six months ended June 30, 2026. The increase was primarily due to the Group conducting more workover operations in the Daan Oilfield.

Other gains, net

The Group recorded net other gains of RMB2.6 million for the six months ended June 30, 2026, compared to net other gains of RMB2.4 million for the six months ended June 30, 2025. Net other gains for the two corresponding periods remained largely unchanged.

Finance costs

The Group's finance costs increased by RMB6.0 million, or 3.3%, from RMB184.5 million for the six months ended June 30, 2025 to RMB190.5 million for the six months ended June 30, 2026. The increase in finance costs was primarily due to: (i) the amortization amount of loan interest increased by approximately RMB7.3 million; (ii) the finance charges for asset retirement obligations and lease liabilities increased by approximately RMB1.5 million and partially offset by (iii) the increase in exchange gains of approximately RMB2.9 million. All interest expenses are recorded on an accrual basis and no payment is required until the relevant principal has been paid off. Excluding the impact of the accrued interest expenses, the Group would have recorded a net profit amounting to RMB38.3 million for the six months ended June 30, 2026.

員工薪酬成本

截至二零二六年及二零二五年六月三十日止六個月期間，本集團的員工薪酬成本均為人民幣4,630萬元。兩年同期員工薪酬成本持平。

採購、服務及其他直接成本

本集團的採購、服務及其他直接成本增加人民幣710萬元或7.1%，由截至二零二五年六月三十日止六個月期間的人民幣1.006億元增加至截至二零二六年六月三十日止六個月期間的人民幣1.077億元。增加的主要原因為本集團在大安油田的修井作業增加。

其他利得，淨額

截至二零二六年六月三十日止六個月期間，本集團的其他淨利得為人民幣260萬元，截至二零二五年六月三十日止六個月期間則為人民幣240萬元。兩年同期其他淨利得基本持平。

財務費用

本集團的財務費用由截至二零二五年六月三十日止六個月期間的人民幣1.845億元增加人民幣600萬元或3.3%至截至二零二六年六月三十日止六個月期間的人民幣1.905億元。財務費用增加主要是由於：(i) 借款利息攤銷金額增加約人民幣730萬元；(ii) 資產棄置義務及租賃負債相關的財務費用增加約人民幣150萬元；及被(iii)匯兌收益增加約人民幣290萬元所部分抵銷。所有利息費用均按權責發生制記賬，在相關本金被清償之前無需支付。若剔除應計利息費用的影響，截至二零二六年六月三十日止六個月期間，本集團將錄得淨利潤人民幣3,830萬元。

Loss before income tax

The Group's loss before income tax was RMB121.9 million for the six months ended June 30, 2026, compared to a loss before income tax of RMB129.3 million for the six months ended June 30, 2025, representing a decrease of RMB7.4 million. The decrease was primarily due to the increase of approximately RMB17.1 million in revenue as a result of the increase in oil prices, which was partially offset by increases of approximately RMB3.7 million and RMB6.0 million in operating expenses and finance costs, respectively.

Income tax expense

The Group recorded income tax expense of RMB22.6 million for the six months ended June 30, 2026, compared to income tax expense of RMB18.7 million for the six months ended June 30, 2025, representing an increase of RMB3.9 million, or 20.9%.

Loss for the period

The Group's loss for the six months ended June 30, 2026 was RMB144.5 million, compared to the loss of RMB148.0 million for the six months ended June 30, 2025, representing a decrease of RMB3.5 million. This decrease was primarily due to the cumulative effects of the factors mentioned above in this report.

除所得稅前虧損

EBITDA AND ADJUSTED EBITDA

We have provided a reconciliation of EBITDA and adjusted EBITDA to profit/(loss) before income tax, with our most directly comparable financial performance calculated and presented in accordance with IFRS Accounting Standards. EBITDA refers to earnings before income tax, interest income, finance costs and depreciation, depletion and amortization. Adjusted EBITDA refers to EBITDA adjusted to exclude non-cash and non-recurring items such as share-based payment to employees, net impairment losses on financial assets, impairment charges, changes in fair value of financial instruments and any other non-cash or non-recurring income/expenses.

We have included EBITDA and adjusted EBITDA as we believe that EBITDA is a financial measure commonly used in the oil and gas industry. We believe that EBITDA and adjusted EBITDA are used as supplemental financial measures by our management and by investors, research analysts, bankers and others, to assess our operating performance, cash flow and return on capital as compared to those of other companies in our industry, and our ability to take on financing. However, EBITDA and adjusted EBITDA should not be considered in isolation or construed as alternatives to profit from operations or any other measure of performance or as an indicator of our operating performance or profitability. EBITDA and adjusted EBITDA fail to account for tax, interest income, finance costs and other non-operating cash expenses. EBITDA and adjusted EBITDA do not consider any functional or legal requirements of the business that may require us to conserve and allocate funds for any purposes.

The Group's EBITDA decreased by approximately RMB11.1 million, or 5.2%, from approximately RMB214.0 million for the six months ended June 30, 2025 to approximately RMB202.9 million for the six months ended June 30, 2026. The decrease was mainly due to the increase in operating expenses excluding depreciation, depletion and amortization of approximately RMB28.2 million, partially offset by the increase in revenue of approximately RMB17.1 million as a result of higher oil prices.

The decrease was mainly due to the increase in operating expenses excluding depreciation, depletion and amortization of approximately RMB28.2 million, partially offset by the increase in revenue of approximately RMB17.1 million as a result of higher oil prices.

LIQUIDITY AND CAPITAL RESOURCES

Overview

Our primary source of cash during the six months ended June 30, 2026 was cash generated from operating activities. Majority of the Group's cash and cash equivalent as at June 30, 2026 were denominated in RMB, United States Dollars and Hong Kong Dollars.

During the six months ended June 30, 2026, the Group had net cash generated from operating activities of RMB207.1 million, net cash used in investing activities of RMB81.8 million and net cash used in financing activities of RMB80.8 million, a translation loss for foreign currency exchange of RMB2.3 million, resulting in an increase in cash and cash equivalents of RMB42.2 million compared to the cash balance of RMB94.7 million as at December 31, 2025.

Cash generated from operating activities

Net cash generated from operating activities was RMB207.1 million for the six months ended June 30, 2026. During the six months ended June 30, 2026, our net cash generated from operating activities included a loss before income tax of RMB121.9 million adjusted for, among other things, depreciation, depletion and amortization of RMB134.3 million, net interest expenses of RMB194.6 million, net exchange gains of RMB4.2 million, net change in fair value of the derivative components of the secured borrowings and the senior notes of RMB1.0 million. The cash movements from changes in working capital in the six months ended June 30, 2026 included an increase in trade and other receivables of RMB36.5 million; an increase in trade and other payables of RMB57.2 million; a decrease in inventories of RMB3.7 million and income tax paid in the amount of RMB19.2 million.

流動資金及資本資源

Net cash generated from operating activities was RMB165.1 million for the six months ended June 30, 2025. During the six months ended June 30, 2025, our net cash generated from operating activities included a loss before income tax of RMB129.3 million adjusted for, among other things, depreciation, depletion and amortization of RMB158.8 million, net interest expenses of RMB185.8 million, net exchange gains of RMB1.3 million, net change in fair value of the derivative components of the secured borrowings and the senior notes of RMB0.8 million. The cash movements from changes in working capital in the six months ended June 30, 2025 included a decrease in trade and other receivables of RMB7.8 million; a decrease in trade and other payables of RMB12.1 million; an increase in inventories of RMB2.7 million and income tax paid in the amount of RMB41.1 million.

Cash used in investing activities

Net cash used in investing activities for the six months ended June 30, 2026 amounted to RMB81.8 million, mainly as a result of: (i) purchase of property, plant and equipment of RMB28.3 million; (ii) net increase in restricted bank deposits of RMB53.5 million; and (iii) interest received of RMB10 thousand.

Net cash used in investing activities for the six months ended June 30, 2025 amounted to RMB110.4 million, mainly as a result of: (i) purchase of property, plant and equipment of RMB72.3 million; (ii) net increase in restricted bank deposits of RMB38.1 million; and (iii) interest received of RMB20 thousand.

Cash used in financing activities

Net cash used in financing activities for the six months ended June 30, 2026 amounted to RMB80.8 million due to: (i) repayments of secured borrowings of RMB72.8 million and repayments of the senior notes of RMB3.8 million; and (ii) payments of lease liabilities of RMB4.2 million.

Net cash used in financing activities for the six months ended June 30, 2025 amounted to RMB74.5 million due to: (i) repayments of secured borrowings of RMB68.0 million and repayments of the senior notes of RMB3.6 million; and (ii) payments of lease liabilities of RMB2.9 million.

Borrowings

As at June 30, 2026, the Group's borrowings amounting to approximately RMB3,067.4 million, representing an increase of approximately RMB1.2 million as compared to December 31, 2025. Among the Group's borrowings, borrowings repayable within one year amounted to approximately RMB113.0 million, representing a decrease of RMB0.6 million as compared to that of December 31, 2025. All of the Group's borrowings are denominated in United States Dollars and Hong Kong Dollars. The Group's borrowings are all at fixed interest rates. No hedging instruments are used for bank borrowings.

Our gearing ratio, which is defined as total borrowings less cash and cash equivalents ("Net Borrowings") divided by the sum of Net Borrowings and total equity, is 1,114.2% as at December 31, 2025 and 1,639.0% as at June 30, 2026.

Our total borrowings to adjusted EBITDA ratio, which is defined as total borrowings divided by adjusted EBITDA decreased from 8.0 as at December 31, 2025 to 7.6 as at June 30, 2026.

Market risk

Our market risk exposures primarily consist of fluctuations in oil prices and exchange rates.

Oil price risk

Our realized oil prices are determined with reference to oil prices in the international market. Unstable and highly volatile international oil prices may have a significant impact on our revenue and profit.

Currency risk

The majority of the Group's operation sales revenue in the PRC is in US dollars, while production and other expenses in the PRC are incurred in RMB. As RMB is not a freely convertible currency and is regulated by the PRC Government, limitations on foreign exchange transactions imposed by the PRC Government could cause future exchange rates to vary significantly from current or historical exchange rates.

The Group currently does not engage in hedging activities designed or intended to manage foreign exchange rate risk. The Group will continue to monitor foreign exchange changes to best preserve the Group's cash value.

市場風險

本集團於中國經營的大部分銷售以美元計值，而於中國的生產及其他支出則以人民幣入賬。由於人民幣並非為自由轉換貨幣，須受中國政府規管，中國政府對外匯交易所設定的限制可能導致未來匯率與當前或歷史匯率相比出現大幅變動。

本集團現時並未從事旨在或意在管理外匯匯率風險的對沖活動。本集團將繼續監察外匯變動，以儘量保障本集團的現金價值。

SHARE OPTIONS

(i) 2021 Share Option Scheme (“2021 Scheme”)

On June 25, 2021, the Board adopted the 2021 Scheme to enable the Company to grant options to selected participants as incentives or rewards for their contributions to our Group. Participants of the 2021 Scheme include any executive director, non-executive director, full time employee or advisers and consultants of the Group as invited by the Board. The 2021 Scheme shall be valid and effective for a period of 10 years commencing from the approval of the 2021 Scheme. There is no service provider sublimit under the 2021 Scheme and as at June 30, 2026, the remaining life of the 2021 Scheme was 5 years.

The exercise period of any option granted under the 2021 Scheme must not be more than ten years commencing from the date of grant. The acceptance of an offer of the grant of the option must be made within 28 days from the date of grant with a non-refundable payment of RMB1.00 from the grantee. The exercise price determined by the Board will be at the higher of (i) the closing price of the shares as stated in the daily quotations sheet of the Stock Exchange on the date of grant; (ii) the average closing price of the shares as stated in the Stock Exchange’s daily quotations sheet for the five trading days immediately preceding the date of grant and (iii) the nominal value of the shares.

The share options granted under the 2021 Scheme typically vest over three years on the last day of each year starting from the subsequent year of the grant, subject to the participant continuing to be an employee on each vesting date and other performance evaluation results.

1. GENERAL INFORMATION

MIE Holdings Corporation (the “Company”) is a limited liability company incorporated in the Cayman Islands. The address of its registered office is Maples Corporate Services Limited, P.O. Box 309 Ugland House, Grand Cayman KY1-1104, Cayman Islands. The Company and its subsidiaries (together, the “Group”) are principally engaged in the exploration, development, production and sale of crude oil in the People’s Republic of China (the “PRC”) under the production sharing contracts (the “PSC”). During the six months ended June 30, 2026, there is only one PSC in Daan (“Daan PSC”).

On February 24, 2023, the Group obtained approval from China National Petroleum Corporation (the “CNPC”) to extend the expiry date of the Daan PSC from December 31, 2024 to February 29, 2028.

As at June 30, 2026, the Company is indirectly controlled by Far East Energy Limited (“FEEL”), which owns 43.39% of the Company’s shares and is also the ultimate holding company of the Group. FEEL is a limited liability company incorporated in Hong Kong and its ultimate beneficial owners are Mr. Zhang Ruilin, Mr. Zhao Jiangwei and Ms. Zhao Jiangbo (“Mrs. Zhang”, Mr. Zhang Ruilin’s spouse). The controlling shareholder of the ultimate holding company is Mr. Zhang Ruilin.

The Company’s shares have been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) since December 14, 2010.

1. 一般資料

於2023年2月24日，本集團從中國石油天然氣集團有限公司（「中石油集團」）獲得批准，將大安產品分成合同的到期日從2024年12月31日延長至2028年2月29日。

截至2026年6月30日止，本公司受Far East Energy Limited（「FEEL」）間接控制，FEEL擁有本公司股本的43.39%，並且是本集團的最終控股公司。FEEL為一家在香港註冊的有限責任公司，其最終受益方為張瑞霖先生、趙江巍先生及趙江波女士（張瑞霖先生之配偶，以下簡稱「張夫人」）。最終控股公司的控股股東為張瑞霖先生。

本公司的股份自2010年12月14日起於香港聯合交易所有限公司（「聯交所」）主板上市。

This condensed interim consolidated financial information has been reviewed by the Audit Committee of the Company but has not been reviewed or audited by the Company’s auditor.

New standards, interpretations and amendments adopted by the Group

The accounting policies adopted in the preparation of the unaudited condensed interim consolidated financial information are consistent with those followed in the preparation of the Group’s annual consolidated financial statements for the year ended December 31, 2025, except for the adoption of new standards effective as of January 1, 2026. The Group has not early adopted any standard, interpretation or amendment that has been issued but is not yet effective.

3. BASIS OF PREPARATION

This condensed interim consolidated financial information for the six months ended June 30, 2026 has been prepared in accordance with International Accounting Standards (“IASs”) 34 “Interim Financial Reporting”.

The condensed interim consolidated financial information does not include all the notes of the type normally included in an annual financial report. Accordingly, this report is to be read in conjunction with the annual financial report for the year ended December 31, 2025 and any public announcements made by the Company during the interim reporting period.

3.1 Statement of compliance

This condensed interim consolidated financial information for the six months ended June 30, 2026 has been prepared in accordance with all International Financial Reporting Standards and International Accounting Standards as issued by the IASB and Interpretations (hereinafter collectively referred to as the “IFRS Accounting Standards”) and the disclosure requirements of the Hong Kong Companies Ordinance. The condensed interim consolidated financial information also complies with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”).

3. 編製基礎

3.2 Basis of measurement

The condensed interim consolidated financial information has been prepared under the historical cost basis except for certain financial instruments that are measured at fair values as explained in the accounting policies set out below.

The preparation of interim consolidated financial information in accordance with IFRS Accounting Standards requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the accounting policies of the Group.

3.3 Going concern assumption

In recent years, the Group's performance was significantly affected by the high borrowing costs associated with general funding and re-financing activities and the volatility of the price of crude oil. During the period of six months ended June 30, 2026, the Group incurred a loss of RMB144.5 million. As at June 30, 2026, the Group's current liabilities exceeded its current assets by RMB85.7 million and there was a deficit on the shareholders' fund of RMB2,751.7 million. As at the same date, the Group had total borrowings of RMB3,067.4 million, while its cash and cash equivalents amounted to only RMB136.9 million.

3. 編製基礎(續)

3.2 計量依據

本簡明中期合併財務資料按照歷史成本法編製，惟以下會計政策中解釋的若干以公允價值計量的金融工具除外。

3.3 持續經營假設

近年來，本集團的業績受到一般性融資及再融資目的所發生的借款成本較高以及石油商品價格波動的顯著影響。截至2026年6月30日止6個月期間，本集團淨虧損為人民幣144.5百萬元。截至2026年6月30日，本集團流動負債超出流動資產為人民幣85.7百萬元，股東累計虧損為人民幣2,751.7百萬元。於同日，本集團借款總額為人民幣3,067.4百萬元，而現金及現金等價物只有人民幣136.9百萬元。

3.3 Going concern assumption (Continued)

For the purpose of assessing the appropriateness of the use of the going concern basis for the preparation of the interim consolidated financial information, the management has prepared a cash flow forecast up to December 31, 2027 ("Forecast"). When preparing the Forecast, management has given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial resources to continue as a going concern, and has taken the following measures to mitigate the liquidity pressure and to improve its cash flows:

- (a) the Group will maintain the production for generating sufficient operating cashflows; and
- (b) plan to improve operating efficiency and take step to reduce discretionary expenses and administrative costs and operating costs to improve the Group's liquidity position.

3.3 持續經營假設(續)

為評估使用持續經營基礎編製中期合併財務資料的適當性，管理層已編製截至2027年12月31日的現金流量預測（「預測」）。在編製預測時，管理層已審慎考慮本集團未來流動資金、業績以及其可獲得的融資來源，以判斷其是否具備充足的財務資源維持持續經營並已採取若干措施以減輕流動資金的壓力並改善其現金流量：

In addition, the Group will negotiate with CNPC regarding the continuation of collaboration on the development and production of the Daan Oilfield following the expiry of the existing Daan PSC.

The directors of the Company (the “Directors”) have reviewed the Forecast prepared by management and are of the opinion that, taking into account the above-mentioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations when they fall due within the forecast period. Accordingly, the Directors are satisfied that it is appropriate to prepare the condensed interim consolidated financial information on a going concern basis.

The Directors closely monitor the Group's cash flow projections, which cover a period of not less than twelve months from June 30, 2026, to enable it to meet its liabilities and obligations.
