The Group is principally engaged in the design, manufacture and sale of magnetics used in consumer electronics, data processing appliances and other electronics systems for coupling, isolation, filtering, interfacing and timing control applications. All of the Group's magnetics are sold under its own brand name "Datatronics". A majority of the Group's products are customized magnetics tailored-made according to the requirements and specifications of its customers. The Group also offered standard catalogue magnetics to its customers.

The Group focuses on the high-end segment of the magnetics industry. It has a customer base of over 300 customers comprising manufacturers of telecommunication and data processing equipment, technology equipment, motor vehicles and medical equipment.

The Group's world-class design and manufacturing capabilities, together with the breadth of its product offerings, provide her with a competitive advantage that enable her to anticipate and deliver highly customized solutions for their customers' product needs. In addition, their global presence enables them to participate in many relevant product and geographic markets and provide her with proximity to their global customer base.

管理層討論及分析

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

The first half of 2026 saw steady global growth, supported by strong export momentum and resilient manufacturing activity. Datronix recorded sales of HK\$111.4 million for the six months ended 30 June 2026, representing a 29% increase compared with HK\$86.3 million in the same period of 2025. Cost of goods sold rose to HK\$79.0 million from HK\$62.7 million, reflecting higher input costs and increased production volume.

Gross margin improved to HK\$32.3 million in the first half of 2026, an increase of 36% compared with HK\$23.7 million in the corresponding period of 2025, driven by stronger demand across industrial channels. The Group reported a net loss of HK\$1.9 million, a significant improvement from HK\$6.0 million in the prior period, mainly due to better cost control and higher utilization rates.

Overall, the first half of 2026 delivered solid revenue growth and margin recovery, positioning the business for a potential return to profitability in the second half as operational efficiency continues to improve.

As of 30 June 2026, cash balance for the Group was at HK\$141.8 million, and no issuance of any bank loan.

MARKET REVIEW

Communication and Networking

Communication segment contributed HK\$30.2 million of sales for the first six months of 2026, an increase of 64% compared to HK\$18.4 million for the comparable period of last year. This segment contributed 27% of the Group's total revenue.

Data Processing

Data processing segment contributed 14% of the Group's revenue. Sales increased 74% for this segment were HK\$15.7 million for the first half of 2026, compared to HK\$9.0 million for the six months ended 2025.

Industrial Application

For the first six months of 2026, industrial application segment sales were HK\$39.1 million, compared to HK\$36.9 million, an increase of 6% compared to the same period of 2025. This segment contributed 35% of the Group's total revenue.

業務回顧

2026年上半年全球增長穩定，因受到強勁的出口勢頭和韌性的製造業活動支持。連達科技於截至2026年6月30日止6個月內錄得收入為111,400,000港元，較2025年同期之86,300,000港元增長29%。銷售成本由62,700,000港元增加至79,000,000港元，反映了成本投入上升和生產量增加。

毛利在2026年上半年改善至32,300,000港元，較2025年同期之23,700,000港元增長36%，主要受到各工業管道需求增強的推動。本集團錄得淨虧損1,900,000港元，較上期的6,000,000港元大幅改善，主要是由於更好的成本控制和提高的使用率。

總體而言，2026年上半年實現了穩健的收入增長和利潤率回升，隨著運營效率持續改善，讓業務有可能在下半年重回盈利狀態。

於2026年6月30日，本集團的現金達141,800,000港元，並無發行任何銀行債務。

市場回顧

通訊及網絡

2026年首6個月，通訊市場分部銷售額達30,200,000港元，較去年同期的18,400,000港元，增加64%。該分部貢獻本集團銷售額的27%。

數據處理

數據處理分部貢獻本集團銷售額的14%。於2026年上半年，該分部銷售額增加74%，錄得銷售額達15,700,000港元，2025年首6個月止為9,000,000港元。

工業應用物品

於2026年首6個月，工業應用品分部銷售額達39,100,000港元，較2025年同期的36,900,000港元，增加6%。該分部貢獻本集團總銷售額的35%。

管理層討論及分析

MANAGEMENT DISCUSSION AND ANALYSIS

High Precision and Reliability Segment

This segment demands precise technology, advanced technical know-how and good workmanship by the Group. The segment reported HK\$26.4 million for the first half of 2026, compared to HK\$22.0 million for the first six months in 2025. This segment contributed 24% of our total sales.

FINANCIAL REVIEW

For the six months ended 30 June 2026, Group sales reported HK\$111.4 million, an increase of 29%, compared to same period of 2025. Our gross profit was HK\$32.3 million, compared to HK\$23.7 million for the first half of 2025. Gross margin increased from 27.4% to 29.0%.

Operating result of first half of 2026 decreased from a loss of HK\$5.0 million to HK\$0.8 million when compared to same period of 2025, a decrease of HK\$4.2 million. The net loss reported HK\$1.9 million, compared to a net loss of HK\$6.0 million for the six months ended 30 June 2025. Loss per share for the first half of 2026 was HK0.6 cents, compared to loss per share of HK1.9 cents for the first half of 2025.

The Group maintained a healthy financial position with sufficient cash and no debt instrument was issued.

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 30 June 2026, the Group had a total equity of approximately HK\$722.6 million (31 December 2025: HK\$701.7 million), and cash and cash equivalents of approximately HK\$141.8 million (31 December 2025: HK\$134.3 million), which were predominately denominated in US dollars, HK dollars and Renminbi.

For the six months ended 30 June 2026, the Group had not arranged any banking facilities and other resources for financing. With the above cash on hand, the Group has adequate resources to meet its working capital needs in the near future.

Capital expenditure for the period under review amounted to approximately HK\$3.2 million (six months ended 30 June 2025: HK\$3.4 million).

高可靠度產品分部

該分部需要利用本集團之精密技術、先進技術訣竅及尖端工藝。於2026年上半年，該分部的銷售額為26,400,000港元，而2025年同期則為22,000,000港元。該分部貢獻總銷售額的24%。

財務回顧

截至2026年6月30日止6個月內，集團營業額為111,400,000港元，跟2025年同期比較，增加29%。毛利錄得32,300,000港元，跟2025年上半年的23,700,000港元比較，毛利率由27.4%增加至29.0%。

2026年上半年的營運業績由2025年同期的5,000,000港元虧損減少至虧損800,000港元，減少4,200,000港元。淨虧損錄得1,900,000港元，截至2025年6月30日止6個月內，淨虧損錄報為6,000,000港元。2026年上半年所錄得的每股虧損為0.6港仙，2025年上半年為每股虧損1.9港仙。

本集團之財務狀況穩健並有充裕的資金，以及沒有發行任何債務票據。

流動資金、財務資源及資本結構

於2026年6月30日，本集團之權益總額約為722,600,000港元（2025年12月31日：701,700,000港元），現金及等同現金項目約為141,800,000港元（2025年12月31日：134,300,000港元），主要為美元、港元及人民幣。

截至2026年6月30日止6個月，本集團並無安排任何銀行借貸及其他資源作融資之用。本集團持手上述之現金，已有足夠資源應付其於可見未來之營運資金需要。

於回顧期間內，資本開支約為3,200,000港元（截至2025年6月30日止6個月：3,400,000港元）。

EMPLOYEES AND REMUNERATION POLICIES

As at 30 June 2026, the Group employed approximately 970 personnel around the world, with approximately 40 in Hong Kong, approximately 320 in the People's Republic of China and approximately 610 overseas. The Group has a staff education sponsorship program and also provides training courses to staff on operational system, product and technology development, and product safety.

CAPITAL COMMITMENTS

As at 30 June 2026, the Group has capital commitment contracted but not provided for in the financial statements in respect of property, plant and equipment approximately HK\$1.7 million (31 December 2025: HK\$0.6 million).

CONTINGENT LIABILITIES

The Group did not have any material contingent liability as at 30 June 2026 (31 December 2025: Nil).

LOOKING FORWARD

Driven by sustained demand from data centers and related electronics applications, the Group expects overall business momentum to remain broadly consistent for the remainder of 2026. Barring unforeseen macroeconomic disruptions, we anticipate that revenue performance, order flow, and gross margin levels in the second half will follow a similar trajectory to the first half. The Group will continue to prioritize operational resilience, disciplined cost control, and selective investment in product development to support sustainable long term growth.

僱員及薪酬制度

於2026年6月30日，本集團於全球各地僱用約970人，其中香港約有40人，中華人民共和國約有320人，海外約有610人。本集團設有員工培訓資助計劃，亦向僱員提供有關營運系統、產品及技術開發，以及產品安全之課程。

資本承擔

於2026年6月30日，本集團就物業、廠房及設備之已訂約但未於財務報表撥備之資本承擔約1,700,000港元（2025年12月31日：600,000港元）。

或然負債

於2026年6月30日，本集團無任何重大或然負債（2025年12月31日：無）。

展望將來

受到數據中心及相關電子應用持續需求的推動，本集團預期整體業務勢頭在2026年餘下期間將大致保持穩定。除非出現不可預見的宏觀經濟干擾，我們預計下半年收入表現、訂單流量及毛利率將與上半年走勢相似。本集團將繼續優先注重營運適應力、嚴格成本控制，以及在產品開發上的謹慎選擇性投資，以支持可持續的長期增長。

1. BASIS OF PREPARATION

The unaudited condensed consolidated interim financial statements have been prepared in accordance with the applicable disclosure requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), Hong Kong Accounting Standard ("HKAS") 34 "Interim financial reporting" and other relevant HKASs, Interpretations and Hong Kong Financial Reporting Standards (hereinafter collectively referred to as the "HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA").

2. ACCOUNTING POLICIES

CORPORATE GOVERNANCE

Code Provision C.2.1

Under the provision C.2.1, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual.

The roles of Chairman and Chief Executive Officer of the Company have been performed by Mr. Siu Ronald. Given that all major decisions of the Company would be decided after thorough discussions by the Board (including Independent Non-executive Directors), the Board is of the view that there is sufficient balance of power and the current arrangement maintains a strong management position and consistent leadership of the Company.
