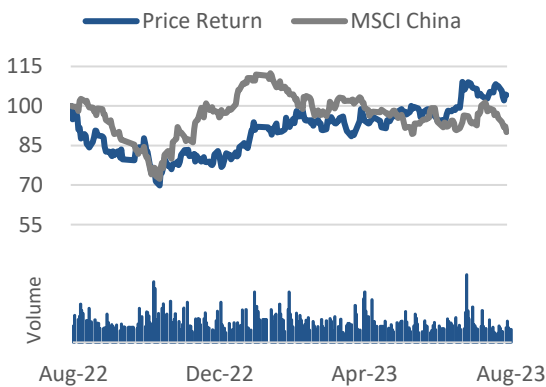

营收及净利润增速符合预期。8月18日思源电气发布 2023H1 财报，公司 2023H1 实现营收 53.03 亿元，同比增长 22.05%，其中 2023Q2 实现营收 31.31 亿元，同比增加 20.14%，环比增加 44.15%，实现归母净利润 7.01 亿元，同比增加 48.08%，其中 2023Q2 实现归母净利润 1.82 亿元，同比增加 50.47%，环比增加 121.6%。

分业务来看，无功补偿业务增速最快。开关类产品营收 26.28 亿元，同比增加 9.2%，占比 49.56%，线圈类产品营收 11.12 亿元，同比增长 28.13%，占比 20.98%，无功补偿类产品营收 7.67 亿元，同比增加 80.25%，增速最快，营收占比 14.46%，智能设备营收 3.48 亿元，增速 0.36%，占比 6.55%。

分区域来看，海外营收超 10 亿，同比增长达 47.5%。公司海外业务营收及占比不断增加，海外市场 23H1 实现营收 10.81 亿元，占比超过 20%，综合毛利率达 32.3%，公司在欧洲、拉丁美洲、非洲、东南亚等市场广泛布局，多款产品通过了法国、英国、西班牙、葡萄牙等超过 10 个国家的认证，有望充分受益于海外电力一、二次设备增量和存量替换需求。

受原材料及汇率双重影响，毛利率大幅提升。2023H1 综合毛利率为 29.06%，较去年同期提升 3.46%，其中开关类产品毛利率为 31.46%，线圈类产品 32.98%，无功补偿类 22.06%，智能装备类 30.39%，工程总包 11.21%，较去年同期分别提升 5.74%、3.15%、1.34%、1.32%、0.19%，主要原因是大宗商品的价格下降，人民币贬值带来的正向影响。

研发投入强度高，研发费用增速达 60%，积极推进多元化战略布局。除深耕传统业务外，公司大力拓展储能相关业务，积极开拓全球表前、表后，储能市场，在柔性直流输电、光电技术、新能源、储能、物联网、汽车电子等方面进行前瞻性技术投入，收购烯晶碳能 19.22% 股权，布局超级电容，不断加深技术护城河。

盈利预测及投资建议：基于公司 2023 年订单、营收增速指引，以及 2023H1 在手订单情况，我们预计公司 2023-2025 年公司营业收入分别为 140.8/181.9/224.0 亿元，对应归母净利润为 16.3/20.8/25.5 亿元，最后根据 DCF 模型，我们维持 57.86 元/股的目标价，并维持“优于大市”评级。

风险提示：1、特高压线路核准开工不及预期；2、市场竞争激烈导致毛利率大幅下降；3、原材料价格大幅上涨；4、汇率风险。

APPENDIX 1**Summary**

The growth rate of revenue and net profit is in line with market expectations. On August 18th, Sieyuan Electric released its 1H2023 financial report, it achieved a revenue of 5.303 billion yuan in 1H2023, a year-on-year increase of 22.05%. In 2Q2023, it achieved a revenue of 3.131 billion yuan, a year-on-year increase of 20.14%, and a quarter-on-quarter increase of 44.15%. the net profit attributable to the parent company is 701 million yuan, a year-on-year increase of 48.08%. In 2Q2023, it achieved a net profit attributable to the parent company of 182 million yuan, a year-on-year increase of 50.47%, and a quarter-on-quarter increase of 121.6%.

From a business perspective, the growth rate of the reactive power compensation business is the fastest. The revenue of the switch business was 2.628 billion yuan, a year-on-year increase of 9.2%, accounting for 49.56%. The revenue of the coil business was 1.112 billion yuan, a year-on-year increase of 28.13%, accounting for 20.98%. The revenue of the reactive power compensation business was 767 million yuan, a year-on-year increase of 80.25%, with the fastest growth rate, accounting for 14.46%. The revenue of the smart devices business was 348 million yuan, with a growth rate of 0.36%, accounting for 6.55%.

From a regional perspective, overseas revenue exceeded 1 billion, with a year-on-year growth of 47.5%. The company's overseas business revenue and proportion continue to increase, achieving revenue of 1.081 billion yuan, accounting for more than 20%, and a comprehensive gross profit margin of 32.3%. The company has a wide distribution in markets such as Europe, Latin America, Africa, and Southeast Asia, and multiple products have passed certification in more than 10 countries such as France, the United Kingdom, Spain, and Portugal. It is expected to fully benefit from the demand for overseas power primary and secondary equipment increment and replacement.

Due to the price of raw materials decreasing and the US dollar appreciation, the gross profit margin has significantly increased. In 1H2023, the comprehensive gross profit margin was 29.06%, an increase of 3.46% compared to the same period last year. Among them, the gross profit margin of the switch business was 31.46%, the coil business was 32.98%, the reactive power compensation business was 22.06%, the intelligent equipment business was 30.39%, and the engineering general contracting was 11.21%, an increase of 5.74%, 3.15%, 1.34%, 1.32%, and 0.19% respectively compared to the same period last year. The main reason is that the price of raw materials decreased significantly, and the positive impact of RMB depreciation.

The R&D intensity was high with the growth rate of R&D expenses has reached 60%, actively promoting a diversified product layout. In addition to delving deeply into its traditional businesses, the company vigorously expands its business boundary, Sieyuan electric actively exploring technological investments in flexible DC transmission, optoelectronic technology, energy storage, Internet of Things, automotive electronics business, etc. It has acquired 19.22% equity in GMCC, laid out its business to supercapacitors to continuously deepened the technical barriers.

Profit forecast and investment suggestions: Based on the order and earning growth rate guidances in 2023, we expect the company's operating revenue to be 14.08/18.19/22.40 billion yuan from 2023 to 2025, respectively, and the net profit attributable to the parent company will be 1.63/2.08/2.55 billion yuan, according to the DCF model, we maintain the target price of RMB57.86 and the rating of "OUTPERFORM".

Risk: 1. The construction of ultra-high voltage lines and policies are not as expected; 2. The fierce market competition has led to a significant decrease in gross profit margin; 3. The prices of raw materials have significantly increased; 4. Foreign exchange risk.

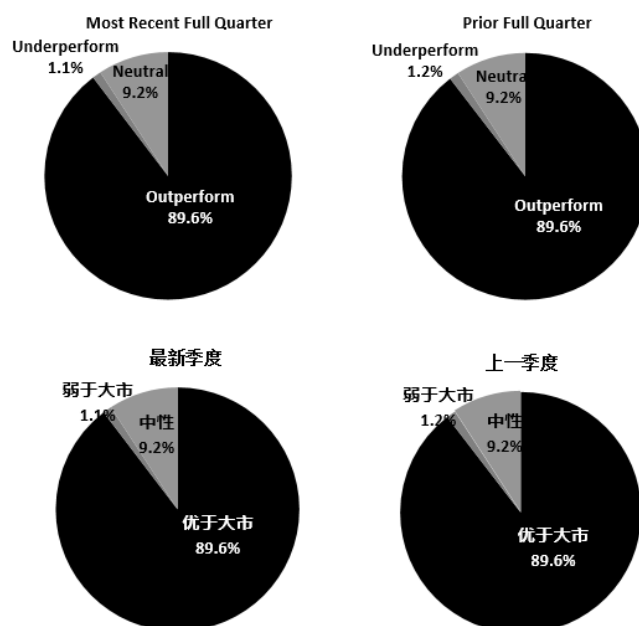
