含硫硅烷领先企业，牵手迈图丰富硅烷产品矩阵

最新动态

- 成立迈图宏柏子公司，与美国迈图加强合作。2025年2月，公司与美国迈图下属的迈图上海等签署了正式合资协议，成立了“迈图宏柏新材料（江西）有限公司”，其中公司占51%股权比例，迈图方面占49%股权比例。公司与美国迈图汇聚在各自领域的综合竞争优势，加速新产品、新技术的突破和应用。2025年12月，迈图宏柏拟与美国迈图签署《技术许可与业务转移协议》，通过授权许可方式取得美国迈图相关关键核心技术和专利、知名品牌商标以及工艺等无形资产的使用权。
- 成立泰国宏柏，拓展海外市场。产品主要外销国家包括欧洲、泰国等，近年对公司毛利润贡献较大，2024年受行业竞争加剧影响，公司外销收入及毛利率有所下滑。为拓展东南亚市场及完善海外功能性硅烷产业供应体系，公司与泰国投资方成立了泰国宏柏，公司持股90.00%。公司产品的生产成本主要是直接材料成本，2024年直接材料占营业成本的比重为65.13%。公司从外部采购的主要原材料包括硅块、氯丙烯、无水乙醇、炭黑等。

动向解读

- 含硫硅烷领先企业，丰富产品矩阵。公司主要从事功能性硅烷、纳米硅材料等硅基新材料及其他化学助剂的研发、生产与销售，含硫硅烷偶联剂产品已经连续六年在全球和国内的市场均排名第一，已成为全球规模最大的含硫硅烷生产企业。近两年新增建设并投产了氨基硅烷、环氧基硅烷、苯基硅烷、巯基硅烷、酰氧基硅烷、高温硅橡胶、二氧化硅气凝胶等系列功能性硅烷产品及硅基新材料产线，大大丰富了产品矩阵。
